#### The Local Option Rules

*Order regarding the postponement of the date of holding the Local Option Poll for the abolition of the licences for arrack, toddy and foreign liquor taverns, bar liquor licences for hotels and the licence for the place licensed for the sale of beer and porter by retail in the Kandy Municipal Council area*

BY virtue of the powers vested in me by rule 4A of the Local Option Rules, published by Excise Notification No. 146 in *Gazette* No. 7,478 of August 14, 1925, as amended by any subsequent rule published by a like notification, and as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Edwin Aloysius Perera Wijeyeratne, Minister of Home Affairs and Rural Development, do by this order, postpone the date fixed for the holding of the local option poll for the purpose of deciding whether or not the licences for all or any arrack, toddy, and foreign liquor taverns, bar liquor licences for hotels, and the licence for the place licensed for the sale of beer and porter by retail in the Kandy Municipal Council area shall be abolished, from January 31, 1950 (the date fixed by notification made under rule 6 of the aforesaid rules and published in the issue of the "Times of Ceylon" and of the "Ceylon Observer" of January 11, 1950) to February 18, 1950
