### Regulations for the Ceylon Civil Service Examination and the Ceylon Overseas Examination, 1950.

THE following regulations, syllabus and form of application for the Ceylon Civil Service Examination and the Ceylon Overseas Service Examination to be held in September or October, 1950, are published for general information.

#### CADETSHIPS IN THE CEYLON CIVIL SERVICE AND THE CEYLON OVERSEAS SERVICE.

##### *Open Competition of 1950.*

1. An Open Competitive Examination for Cadetships in the Ceylon Civil Service and the Ceylon Overseas Service will be held by the Public Service Commission in Colombo in September or October, 1950. The actual dates will be notified later.
2. The number of vacancies for Cadetships in the Ceylon Civil Service will be five. The number of vacancies for Cadetships in the Ceylon Overseas Service will be four. The full number of appointments will not be made unless candidates attain a suitably high standard.
3. The Public Service Commission will maintain a list of the next ten candidates in order of merit below those who secure entry to the Civil Service or Overseas Service. These candidates may be offered appointments to vacancies in Staff Grades of the Public Service which may occur during the year 1951, where it would appear to the Public Service Commission a suitable method of recruitment to such vacancies.
4. Candidates for this examination must be males and must be Ceylonese. For the purpose of this examination a Ceylonese is—
  - (a) A citizen of Ceylon by descent or by registration ; or
  - (b) A person who has applied or intends to apply for citizenship of Ceylon by registration, and is deemed by the Minister of Defence and External Affairs to have a *prima facie* entitlement to such citizenship.
5. (a) Candidates for Cadetships in the Ceylon Civil Service must have attained the age of 22 and must not have attained the age of 24 on August 1, 1950.  
(b) Candidates for Cadetships in the Ceylon Overseas Service must have attained the age of 22 and must not have attained the age of 30 on August 1, 1950.
6. Candidates are required to obtain a written nomination from the Public Service Commission to sit for the examination.
7. Candidates must satisfy the Public Service Commission that they are duly qualified in respect of health and character. They must be of sound constitution, possessed of good sight and physically qualified for service in any part of the Island. Successful candidates will be called upon to undergo a strict medical examination to test these points.
8. A married candidate will not be eligible for appointment to a Cadetship in the Ceylon Civil Service without the special consent of the Public Service Commission.
9. The fee for the examination will be—
  - (a) Rs. 200 for the competitive examination for Cadetships in the Ceylon Civil Service and for Cadetships in the Ceylon Overseas Service. This fee should be paid to Examination Fund (No. 2) account of the Director of Education in the Bank of Ceylon. (See Note 4 of application form). The bank receipt should be attached to the application form.
  - (b) Rs. 10.50 for the medical examination. Successful candidates will be notified later of the manner in which this fee is to be paid.
10. (a) Nomination to sit for the competitive examination for Cadetships in the Ceylon Civil Service and for Cadetships in the Ceylon Overseas Service will be limited to candidates who have passed an Honours or Pass Degree Examination of the University of London or an Honours or Pass Degree Examination of the University of Ceylon or any other examination which may be deemed to be of at least equal standard. Nomination to sit for the examination will also be granted to candidates otherwise eligible, who intend to sit the Final Examination for a University Degree before August 1, 1950. Candidates nominated in these circumstances will not be eligible to sit for the Examination unless they have completed the Degree Examination. Any candidate who competes in the Examination on these conditions will be presumed to do so in the knowledge that should he later be informed that he has not been successful in the Degree Examination he will not be considered for appointment.  
(b) Candidates who are qualified to do so may enter for competition for Cadetships in the Ceylon Civil Service and the Ceylon Overseas Service. Candidates entering for more than one service should indicate their preference in the appropriate column of the application form.
11. Candidates who possess the necessary qualifications and who propose to sit for the examination will, on application to the Secretary, Public Service Commission, be supplied with copies of the Regulations, Syllabus, and Application Form.
12. Nominations for the examination will be considered on the receipt of the forms of application which must be filled in *in duplicate* by the applicants in their own handwriting and must reach the office of the Public Service Commission, P. O. Box 500, Colombo, on or before July 14, 1950.
13. No allegation that an application form or a letter respecting such form has been lost or delayed in the post can be considered. Candidates are advised to send the applications by registered post. Candidates who delay their applications until the last days will do so at their own risk.
14. Acknowledgements of application forms are sent and any candidate who has filled up and returned the printed application form but has not received an acknowledgement of it within a reasonable time should at once write to the Secretary, Public Service Commission, P. O. Box 500, Colombo. Failure to comply with this provision will deprive the candidate of any claim to consideration.
15. Candidates will be notified as soon as possible of the dates and place fixed for their *viva voce* test ; the time table of the written part of the examination will be sent to the address given on the form of application and will contain instructions about the time and place at which candidates are to attend.

## APPLICATION FORM

4. The Civilization (subjects 10, 12, 14, 16, 18 and 26) associated with a language can be taken only by candidates who also offer the language itself.

5. Candidates offering Sinhalese Civilization (10) or Dravidian Civilization (12) will not be permitted to offer History V. (31).

6. In English Literature (subjects 19 to 23 inclusive) a candidate may not offer subjects carrying a total of more than four hundred marks. Thus a candidate who offers English Literature (General) (subject 19) may not offer more than two periods of English Literature (subjects 20 to 23).

7. Candidates who offer a natural science subject (subjects 54 to 61 inclusive) must produce a certificate of laboratory training in an institution of University rank. The certificate must be signed by the head of the institution.

8. Candidates who offer Geography I. or Geography II. (subjects 38 and 39) must produce a certificate of practical training in that subject in an institution of University rank. The certificate must be signed by the head of the institution.

9. Candidates can offer only two of the subjects Philosophy I. (40), Philosophy II. (41), Philosophy III. (42). Candidates cannot offer both Sanskrit Civilization (16) and Philosophy III. (42).

10. Candidates who offer Higher Pure Mathematics (45) or Higher Applied Mathematics (46) will be allowed to take *either* Lower Pure Mathematics (43) *or* Lower Applied Mathematics (44) but not both the lower papers.

11. From the marks assigned to candidates in each subject such deduction will be made as the Examiners may consider necessary in order to secure that no credit is allowed for merely superficial knowledge.

12. If a candidate's handwriting is not easily legible a deduction which may be of considerable amount will be made on this account from the total marks otherwise accruing to him.

13. Credit will be given for good English, including orderly, effective and exact expression, combined with due economy of words in all the subjects of the examination and not only in subjects 1 and 2 which are specially devoted to the English language.

## SYLLABUSES

All papers will be of three hours' duration except where specified.

1. *Essay*.—An essay to be written in English on one of several specified subjects. The essay will be judged not only according to language, style and arrangement but also according to the degree of thoughtfulness and originality in its treatment of the subject.

2. *Précis*.—A paper of one hour's duration requiring the candidate to express in his own words, but more succinctly, the substance of one or more passages of prose.

3. *Intelligence Test*.—A paper of one hour's duration designed to place the candidates in order of merit from the point of view of generally ability. No marks will be assigned, but the result of the test will be used in assigning marks for the *Viva Voce* Examination.

4. *General Knowledge*.—A paper designed to test the candidate's general knowledge. No special syllabus is prescribed.

5. *Viva Voce*.—The candidate will be interviewed by a Board who will have before them a record of his career. He will be asked questions on matters of general interest. The object of the interview is to assess his suitability for the Service for which he is entered, and in framing their assessment the Board will attach particular importance to his intelligence and alertness, his vigour and strength of character and his potential qualities of leadership. The Special *Viva Voce* which will be in addition to the normal *Viva Voce* will be designed to ascertain the suitability of candidates for the Overseas Service taking into account such conditions as his family background, personal qualities, special knowledge of foreign countries and languages, &c.

Only candidates who score an aggregate of 45 per cent. of the marks in the written papers will be called for the *Viva Voce* test.

6. *Sinhalese, Tamil and Arabic*.—A paper of one and a half hours' duration containing translation into English, translation into the language of English sentences chosen to test grammatical knowledge and translation into the language of easy passages of continuous English prose.

*English (Special)*.—A paper of one and a half hour's duration designed to test the candidate's knowledge and command of written and spoken English.

7. *World Affairs*.—A paper of three hours' duration designed to test the candidate's knowledge of world affairs in relation to current problems. No special syllabus is prescribed.

8. *Special Viva Voce*.—See *Viva voce* (5).

9. *Sinhalese Language and Literature* (Two papers).—Candidates are expected to show a knowledge of the language in its various phases of development and of the literature from the earliest times. Passages may be set for translation from and into English.

10. *Sinhalese Civilization* (Two papers).—The life and culture of the Sinhalese from the 6th century B.C. to the present time with special reference to the development of religion, archaeology, art, and architecture in Ceylon.

11. *Tamil Language and Literature* (Two papers).—Translation from Tamil into English and from English into Tamil, an essay and questions on grammar; Tamil Literature from the Sangam age to the end of the 19th Century.

12. *Dravidian Civilization* (Two papers).—The history of Dravidian civilization from the earliest times to the end of the 19th Century with special reference to the Tamils.

13. *Arabic* (Two papers).—A general knowledge of the language, its grammar, literature and history, and of Islamic culture. Questions may be set on the geography, history, and social, political and religious institutions of the Islamic world.

14. *Islamic Civilization* (Two papers).—The life of the Muslims during the 6th to the 13th centuries of the Christian era, with special reference to their contributions in the realm of literature, philosophy, science, politics, economics, art and architecture.

15. *Sanskrit Language* (Two papers).—Translation from Sanskrit into English; composition, in the Devanagari script, which may include an essay on one of several given subjects.

Both Vedic and Classical Sanskrit passages may be set for translation. Questions may be included relating to grammatical forms, both Vedic and Classical Sanskrit, occurring in the passages set for translations, or to grammatical and syntactical problems of a general nature suggested by them. Composition will be required in Classical Sanskrit style.

16. *Sanskrit Civilization* (Two papers).—The history of the culture, philosophy and the thought of India, and Sanskrit literature, from the Vedic period to 1200 A.D.

17. *Pali Language* (Two papers).—Translation from Pali into English and from English into Pali and composition in Pali on one or more specified subjects.

18. *Pali Civilization* (Two papers).—The history of Buddhist Civilization in India from the time of Buddhā to 1000 A.D.

19. *English Literature (General)* (Two papers).—Paper I. 1350–1700; Paper II. 1700 to the present day.

Candidates will be expected to have some knowledge of the social and historical background of English Literature during these periods, and to attempt the criticism of set passages. They will not be expected to study every part of either of the two periods with equal thoroughness. Credit will be given for evidence of first hand knowledge of the work selected for study.

20–23. *English Literature*.—Periods 1 to 4.

*Period 1, 1579–1660*, with the following for special study: Spenser, Lyly, Shakespeare, Ben Jonson, Webster, Donne, Browne and Milton.

*Period 2, 1660–1800*, with the following for special study: Dryden, Defoe, Swift, Pope, Fielding, Dr. Johnson, Gibbon and Blake.

*Period 3, 1800–1880*, with the following for special study: Wordsworth, Coleridge, Keats, Jane Austen, Tennyson, Dickens, Arnold, Hopkins.

*Period 4, 1880 to the present day*, with the following for special study: Yeats, Hardy, Conrad, Shaw, Eliot, Joyce, Lawrence (D.H.), Eugene O'Neill.

Candidates will be expected to have a fair general knowledge of the life and thought of the period selected with a more detailed knowledge of at least *four* of the authors set for special study. Candidates will be expected to identify passages taken from authors set for special study and to comment on them. Credit will be given for evidence of first hand knowledge of the material selected for special study.

24. *Latin Language* (Two papers).—Papers will be set on Composition and Translation. The paper on Latin Composition will be so arranged that candidates may confine themselves to prose composition or to verse composition or may attempt both verse and prose.

25. *Greek Language* (Two papers).—Papers will be set on Composition and Translation. The paper on Greek Composition will be so arranged that candidates may confine themselves to prose composition or to verse composition or may attempt both verse and prose.

26. *Greek and Roman Civilization* (Two papers).—Papers will be set on Greek and Latin Literature and Greek and Roman History. On both papers special credit will be given for knowledge of original authorities. In Greek History the main stress will be laid on the period from 510 B.C. to 323 B.C.: In Roman History on the period from 133 B.C. to 117 A.D.

*Languages and Civilizations*.—Candidates will be expected to show a knowledge of the language and its literature. The papers on civilization will test the knowledge of geography, history, and social, political and religious evolution and developments. Questions may be set which require an acquaintance with archaeological discoveries.

27. *History I* (One paper).—European History from the Renaissance to 1789.

28. *History II* (One paper).—European History from 1789 to the present day.

29. *History III* (One paper).—British History from 1760 to the present day.

30. *History IV* (Two papers).—History of India.

31. *History V* (One paper).—Ceylon History.

In the relevant History papers questions may be asked on Indian and European political theories and institutions, constitutional development and European activities in the east generally.)

32. *Economics I* (Two papers).—Economics, descriptive and analytical (including public finance.)

33. *Economics II* (Two papers).—The principles and practice of currency, banking and international trade.
34. *Economics III* (One paper).—Modern Economic History, to include Economic History of England, France, Germany, Russia and U. S. A. from the middle of the eighteenth century, and Economic History of India and Ceylon during the British period.
35. *Statistics*.—(1) Frequency distributions, averages, percentiles, and simple methods of measuring dispersion, graphic methods, treatment of qualitative data, e.g., investigation of association by comparison of ratios, the practice of graphic and algebraic methods of interpolation.  
(2) Practical methods used in the analysis and interpretation of statistics of prices, wages and incomes, trade, transport, production and consumption, education, &c., methods of dealing with population and vital statistics, miscellaneous methods used in handling statistics of experiments or observations.  
(3) Elements of modern mathematical theory of statistics frequency curves and the mathematical representation of groups generally, accuracy of sampling as affecting averages, percentages, the standard deviation, significance of observed differences between averages of groups, &c., the theory of correlation for two variables.
36. *Political and Social Theory*.—Candidates will be expected to show a knowledge of political theory and its history, political theory being understood to mean not only the theory of legislation, but also the general history of the State and its connection with kindred studies, such as Jurisprudence, Public International Law and Economics. A knowledge of original authorities is required.
37. *Political Organization*.—Constitutional Forms (Representative Government, Federalism, &c.), and Public Administration, central and local. Candidates will be expected to understand the origin and development of existing institutions.
38. *Geography I* (Two papers).—(1) General economic geography, regional geography of Eurasia, with emphasis on Ceylon.  
(2) Practical work, including reading and interpretation of topographical, land utilization and geological maps, the construction and use of the principal map projections, simple methods of land survey.
39. *Geography II* (Two papers).—(1) The physical basis of geography, regional geography of North and South America, Africa and Australasia.  
Candidates will be expected to answer questions on two of the more specialized branches of geography—Cartography, Geomorphology, Climatology and Oceanography, Distribution and Ecology of Plants and Animals, Distribution of Man, Economic Geography, Political Geography, Historical Geography. Choice of subjects should be indicated in the application form.  
(2) Practical work, including more difficult questions on the subject matter of Geography I. (2), critical cartography, the collection of data relating to climatic, economic and population conditions and cartographical and diagrammatic methods of expression of such data.
40. *Philosophy I* (Two papers).—History of Philosophy and Ethics.
41. *Philosophy II* (Two papers).—Logic and Metaphysics.
42. *Philosophy III* (Two papers).—The History of Indian Philosophy including the Vedic Period, the Epic Period and the six orthodox Hindu systems, together with a more detailed study of either the Advaita Vedanta system of Sankara or the Mahayana School of Buddhism.
43. *Lower Pure Mathematics* (Two papers).—Algebra, Trigonometry (including De Moivre's Theorem and its application), Geometry (including Analytical Geometry of two and three dimensions), Elementary Differential and Integral Calculus, and Differential equations in one independent variable.
44. *Lower Applied Mathematics* (Two papers).—Statics of a particle and of a rigid body, Hydrostatics, Dynamics of a particle and of a rigid body, the theory of Potential.
45. *Higher Pure Mathematics* (Two papers).—Geometry (including projective and differential Geometry), Algebra (including Matrices), Mathematical Analysis (including simple functions of a complex variable and contour integration), Differential Equations, Elementary Finite Differences.
46. *Higher Applied Mathematics* (Two papers).—Mechanics of solids and fluids (including equations of Euler and Lagrange) Electricity and Magnetism.
47. *Law of Persons and Property*.—The principles of Roman-Dutch Law, with special reference to their application in Ceylon.
48. *Law of Contracts and Torts*.—The English law of contracts and tort, including the elements of the law of quasi-contract with special reference to their application in Ceylon.
49. *Roman Law*.—Roman private law and its history studied in connexion with the Institutes of Gaius and Justinian, including the history of the legislative and judicial process. Passages will be set for translation and comment, but credit will not be given merely for capacity to translate the texts.
50. *Constitutional Law*.—English constitutional law ; the relations between the United Kingdom and other parts of the British Commonwealth of Nations ; the constitutional law of Ceylon.
51. *International Law*.—The international law of peace, including international organization.
52. *Jurisprudence and Legal Theory*.—Theories as to the nature of law, including the theory of sovereignty. The sources of law and its development, with particular reference to English and Roman law. The character and classification of rights, and duties (legal and equitable). The analysis of the leading conceptions employed in law. The methods of Jurisprudence.
53. *Criminal Law*.—English criminal law and Criminal Law of Ceylon not including Criminal Procedure.
54. *Lower Physics* (Two papers).—The general properties of matter, heat and thermodynamics, acoustics, optics, electricity and magnetism.
55. *Higher Physics* (Two papers).—The general properties of matter and acoustics ; heat, thermodynamics, kinetic theory of matter ; optics, including the electromagnetic theory of light, electricity, physics of the atom.
56. *Lower Chemistry* (Two papers).—General theoretical chemistry, including its historical development ; inorganic chemistry, organic chemistry and physical chemistry.
57. *Higher Chemistry* (Two papers).—The same syllabus as *Lower Chemistry*, but at a higher standard.
58. *Lower Botany* (Two papers).—The general morphology and anatomy of plants ; plant physiology and ecology, cytology and the principles of evolution ; the phylogeny and taxonomy of plants.
59. *Higher Botany* (Two papers).—Botany in all its branches.
60. *Lower Zoology* (Two papers).—Zoology in all its branches.
61. *Higher Zoology* (Two papers).—The same syllabus as *Lower Zoology*, but at a higher standard.

APPLICATIONS are invited from applicants possessing the necessary qualifications as set out in this notice for appointment to Class IV of the Accountants' Service.

*Method of Application*

2. (a) Application on forms to be obtained from the Office of the Secretary, Public Service Commission, must be addressed to the Secretary, Public Service Commission, P. O. Box No. 500, Colombo, and must reach that officer on or before June 30, 1950.

(b) Applicants who are not already in Government Service should name two referees, who, from their personal knowledge of the candidate, can testify to his character and capacity.

(c) Applicants in Government Service should send their application forms through the Heads of their Departments.

(d) No allegation that an application form or a letter respecting such form has been lost or delayed in the post can be considered. Candidates who delay their applications until the last days will do so at their own risk.

(e) Acknowledgments of applications will be sent, and any applicant who has sent in his application but has not received an acknowledgment of it within a reasonable time should at once write to the Secretary, Public Service Commission. Failure to comply with this provision will deprive the applicant of any claim to consideration.

*Number of Vacancies*

3. The number of vacancies will be at least nine. The full number of vacancies will not be filled unless candidates reach a sufficiently high standard.

*Qualifications of Applicants*

4. Every applicant who must be a male, must possess the following minimum qualifications.—

(a) He must, if he is not already in the service of the Government of Ceylon, be a Ceylonese

For the purpose of this examination a Ceylonese is—

- (i) A citizen of Ceylon by descent or by registration, or
- (ii) A person who has applied or intends to apply for citizenship of Ceylon by registration, and is deemed by the Minister of Defence and External Affairs to have a prima facie entitlement to such citizenship.

(b) He must have been born not earlier than August 1, 1908. Any temporary Accountant who has functioned as such at any time from January 1, 1942, for a period of at least one month and is presently in Government Service, will be eligible to apply, whatever his age.

(c) He must be of good moral character and of sound constitution, physically fit for service in any part of the Island. A successful applicant who is not already in Government Service will be required to pass a medical examination.

(d) He must be either—

- (I) A Chartered Accountant;  
Incorporated Accountant;

One who has passed the Final Examination of the Ceylon Board of Accountancy; or

One who possesses qualifications in Accountancy which in the opinion of the Public Service Commission are equivalent to those specified above. Service under articles is essential.

*Method of Selection*

## Examination for Appointment as Clerks and Draughtsmen

## Date of examination.—

1. A Competitive examination for candidates wishing to enter the Survey Department as Clerks and Draughtsmen will be held in Colombo on September 29 and 30, 1950.

## Places for competition.—

2. The number of places assigned for general competition will be about twenty provided there are candidates who attain the required standard.

## Salary—

3. Successful candidates will be appointed on probation for two years, to the General Clerks and Draughtsmen Class, on a salary of Rs 840 per annum rising by annual increments of Rs 72 to Rs. 2,424 per annum. Efficiency bars before Rs. 1,488 and Rs. 2,064.

*Note.*—Ex-service candidates (*vide* para 13 below) will be placed at suitable points in this salary scale if their ages exceed the maximum age specified in paragraph 11.

## Conditions of service.—

4. (a) The grant of leave and other conditions will, in the case of a new entrant to the Public Service, be governed by the recommendations in Sessional Paper VIII of 1934, as modified by the recommendations in Sessional Paper VIII of 1946. Rent allowance is payable.

(b) Successful candidates will be required to enter into an agreement to serve for a period of three years in the department. Candidates will, during such period, diligently and efficiently discharge all duties which they may be required to do, and shall enter into a bond for the payment of rupees four hundred and twenty (Rs. 420) in the event of their leaving the department before the expiration of three years. 7. The Surveyor-General will return those applications which are approved, to the candidates concerned, who, on presenting themselves for examination, must produce to the officer appointed to supervise the examination their forms of application approved by the Surveyor-General together with their signature forms. A candidate not producing these forms will be refused admittance to the examination.

8. (i) Candidates who are already employed in Government departments, whether in a permanent or temporary capacity, must forward their applications

through the Heads of the Departments in which they are serving. If any candidate fails to do so, he will be disqualified.

(ii) CANDIDATES SHOULD SEND IN THEIR APPLICATIONS STRICTLY IN ACCORDANCE WITH THE REGULATIONS. ANY APPLICATION WHICH IS NOT ACCOMPANIED BY THE CORRECT DOCUMENTS REQUIRED TO BE ATTACHED TO THE APPLICATION OR IS DEFECTIVE IN ANY OTHER RESPECTS WILL BE REJECTED.

## Eligibility.—

9. Candidates must be of good character.

10. Candidates must be Ceylonese\*.

13. Demobilized Ceylonese members of the Armed Forces, and full-time members of the Auxiliary Fire, Air Raid Precautions and Civil Defence Services who joined such services before August 15, 1945 (excluding those who had left those services of their own accord) will be allowed the following concessions.—

(a) *Age*—The period of their mobilized service between September 3, 1939, and August 1, 1950, may be deducted from their ages in computing the age for the purpose of age limit.

(b) *Educational qualifications*.—One of the following examinations.—The Cambridge Junior or the Junior School Certificate (English) Examination of the Education Department, Ceylon, or the Junior School Certificate (English) Examination held by a school approved by the Education Department for the Senior School Certificate (English) Examination; or the Commercial Certificate Examination, either Certificate or Higher Stage, either section of the London Chamber of Commerce or Ceylon Chamber of Commerce.

(c) *Vacancies*.—Twenty per cent. of the vacancies will be reserved for competition among eligible ex-Servicemen.

*Note*—(i) The original certificates of educational qualifications together with discharge certificates in proof of their satisfactory service should be attached to their application forms.

\*A Ceylonese is—

- (a) a citizen of Ceylon by descent or by registration; and  
(b) a person who has applied or intends to apply for citizenship of Ceylon by registration, and is deemed by the Minister of Defence and External Affairs to have a prima facie entitlement to such citizenship.

(ii) The concessions referred to above do not apply to civilian employees in Service departments and temporary employees in Government departments.

(iii) Civil Defence Services will be held to include only those Services the members of which were enrolled under the Defence Regulations.

(iv) A person who while serving in one of these Services was also employed otherwise or was a student at school will not be considered to have done full-time service.

14. (i) A certificate of the registration of the candidate's birth must be attached to the form of application.

(ii) Certificates of birth issued for the purpose of the Code for Assisted Schools will not be accepted for this examination.

(iii) Affidavits will not be accepted as substitutes for birth certificates.

(iv) A certificate of registration in the register of past births will be accepted only after consideration of the evidence by which the dates of birth were established. If the name appearing in the birth register differs either by alteration or addition, from the name by which a candidate is known—(a) In the case of a candidate under the age of 21 years, the parent or guardian should, before obtaining the certificate apply to the Registrar-General or his Assistant for such alteration in the manner set forth in section 19 of the Births and Deaths Registration Ordinance (Chapter 94, Legislative Enactments) or (b) in the case of a candidate over the age of 21 years, he should produce evidence to the satisfaction of the Surveyor-General that the certificate of birth forwarded applies to him.
