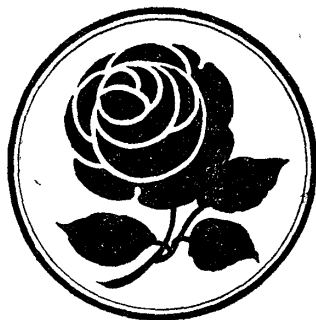

"Semi-automatic weaving loom."

Abstract.—A semi-automatic weaving loom suited for hand and foot operation in which the change of shed and the feed of the piece of work is effected by the movement of the batten while the whips and movement of the shuttle are operated by a separate driving device controlled with the feet. The invention in its essential parts is described with reference to the annexed sheet of drawing.

"Improved chains and trays for tea driers."

Abstract.—The defects in the endless chain driers described in the specification are eliminated by the use of a cham with a hollow pin or bearing and a special tray construction to suit this chain.

The reduced end of the tray is supported in the hollow bush at the centre of a roller. The chain thus becomes the true support for the weight of the tray, the only function of the tray guides being to support the trays in the horizontal plane. This reduces the power required to move trays and eliminates any twisting of chains and consequent sticking of trays.

The specification is illustrated with two sheets of drawings.
