

# Notifications under "The Patents Ordinance, 1906"

THE following specifications have been accepted:— No. 3,629 of April 22, 1949 (Date applied for under section 48 of the Ordinance, May 10, 1948).

"Method and device for the pre-heating of tea leaves before fermentation."

 $Abstract. \\ - {\bf Tea~ leaf~ ought~ to~ have~ an~ optimum~ temperature~ of~ between~ 50-122°F~ at~ the~ moment}$ 

fermentation starts so that full use may be made of the activity of the enzymes at the moment of rupture. According to this invention, the tea leaves are preheated up to the desired temperature between 50—122°F just before starting its rupture or rolling. In case of withering this will be accomplished after leaving the withering installation.

The pre-heating can be achieved in one of several ways preferably in an atmosphere of a desired temperature and relative humidity. One sheet of drawing, showing a device for the purpose schematically, is annexed.

There are six claims.

No. 3,630 of April 23, 1949: Frank Kay.

"Improvements in coupling unions for pipes.

Abstract.—According to the invention there is provided a pipe coupling comprising the combination of a tubular union having a pipe centering bore portion extending from an annular pipe locating shoulder as a diverging taper to a bore portion which receives the pipe with clearance and which terminates in a mouth flaring to the outer-end face of the union, a rigid pipe-gripping thimble which fits over the pipe and has an exterior wadge surface which seats in and has its wider end projecting from the flared mouth. The wedge surface is moved axially into the seating engagement with the said flared mouth by a clamping nut which screws on to the said outer end of the union and which has an abutment which engages on the end of the wedge shaped thimble. The pipe is prevented from rocking and a tight grip is ensured by having the inner end engaging the centering portion which has a taper of the order of 2 to 5 degrees.
