"Improvements in pipe couplings."

Abstract —The invention relates to pipe couplings and in particular to unions wherein a body or union is provided having at least two inter communicating limbs each to receive therein the end of a pipe. A coupling member such as a nut engaging screw threads on the outer surface of the limb with a wedge like thimble or sealing ring having a cylindrical bore is provided for each limb. When the nut is tightened the ring is forced into a shaped recess in the end of the limb thereby forming a seal. The sealing ring or thimble has a tapering outer surface and the coupling is constructed so that the thinner end of the thimble is forced into a complementary recess in the union when tightened. On the inner surface it has a number of serrations which bed into the embraced pipe surface upon tightening. The serrations are formed by cutting V grooves, the included angle of the ridges being between 60° and 110°

Abstract.—The rain guard is made of sheet metal or other suitable material comprising a collar of semicircular shape with an out-turned extension which when affixed to a rubber tree at a suitable angle above the tapping cut forms a channel which protects the tapping panel and the tapping cut below it and the latex from the action of rain water flowing down the tree by directing the water away to a side.
