The Urban Councils Ordinance, No. 61 of 1939

Local Government Notifications

BY virtue of the powers vested in me by sections 2, 6 and 30 of the Urban Councils Ordinance, No. 61 of 1939, as modified by the Proclamation published in Gazette Extraordinary No. 9,773 of September 24, 1947, I, Solomon West Ridgeway Dias Bandaranaike, Minister of Health and Local Government, do by this Order—

- (1) vary the limits of the town of Kotte (as defined in the Order published in *Gazette* No. 7,910 of March 4, 1932) by the substitution for the Schedule to that Order, of the Schedule set out in the First Schedule hereto;
- (2) vary the limits of the wards of the town of Kotte (as defined in the Order published in Gazette No. 9,215 of December 17, 1943) by the substitution for the Schedule to that Order, of the Schedule set out in the Second Schedule hereto; and
- (3) declare that the provisions of paragraphs (1) and (2)shall-
 - (a) in so far as they relate to any matter connected with the general election of members due to be held in the year 1950, come into effect on the date hereof; and
 - (b) in so far as they relate to any other matter, come into effect on the day immediately following the date of expiration of the term of office of the the members of the Kotte Urban Council who are in office at the date hereof.

FIRST SCHEDULE

Limits of the Urban Council of Kotte

North: By a line drawn from a point on the eastern limit of the Colombo Municipal area eastwards along the northern village limits of Welikada and Yakbedda to the centre of the Kolonnawa Ela.

East: By a line drawn from the last-mentioned point southwards and south-eastwards along the centre of the Kolonnawa Ela to the northern village limit of Madiwala, thence by a line drawn westwards along the northern village limits of Madiwala and Mirihana to a point three chains east of the centre of Kotte-Gangodawila road, thence by a line drawn southwards and south-eastwards parallel to and at a distance of three chains from the centre of Kotte-Gangodawila road and Mirihana-Kottawa road to the southern village limit of Udahamulla, thence by a line drawn southwards along the said limit till it meets the southern boundary of the Kelani Valley railway line.

South : By a line drawn from the last mentioned point northwards and westwards along the southern boundary of the Kelani Valley railway line to a point three chains east of the centre of Wijerama Temple road, thence by 1221-J. N. A 22139-1,602 (8/50)

a line drawn southwards parallel to and at a distance of three chains from the centre of the said road to a point five chains south of the centre of the Avissawella road, thence by a line drawn westwards parallel to and at a distance of five chains from the centre of the said Avissawella road, to the eastern limit of the Dehiwala-Mount Lavinia Urban Council area, thence by a line drawn northwards and westwards along the said limit to the southern boundary of Colombo-Avissawella road. Thence by a line drawn westwards along the southern boundary of the Colombo-Avissawella road to a point in line with the centre of its junction with the Nugegoda-Kirillapone road.

West: By a line drawn from the last-mentioned point northwards across the Colombo-Avissawella road to the northern boundary of the Nugegoda-Kirillapone road, thence by a line drawn eastwards along the northern boundary of the said road to the western boundary of Kirillapone burial ground, thence by a line drawn northwards and eastwards along the western and northern boundaries of Kirillapone burial ground till it meets the western boundary of Kirillapone-Narahenpita road, thence by a line drawn northwards along the western boundary of the said road to the eastern limit of the Colombo Municipal area, thence by a line drawn northwards along the said limit of the Colombo Municipal area to the starting point of the northern limit of the area.

SECOND SCHEDULE

Wards of the town of Kotte

Ward No. 1-Rajagiriya West

North: By a line drawn from the western extremity of the northern limit of the Urban Council area eastwards along the said limit to a point in prolongation of the centre of Rajagiriya road.

East : By a line drawn from the last mentioned point southwards along the said prolongation and along the centre line of Rajagiriya road to the centre of the junction with Cotta road.

South : By a line drawn from the last mentioned point westwards along the centre line of Cotta road to the western limit of the Urban Council area.

West: By a line drawn from the last mentioned point northwards along the western limit of the Urban Council area to the starting point of the northern limit of the ward.

Ward No. 2-Rajagiriya East

North: By a line drawn from the eastern extremity of the northern limit of Ward No. 1 eastwards along the northern limit of the Urban Council area to its eastern extremity.

East: By a line drawn from the last mentioned point southwards along the eastern limit of the Urban Council area to the centre of the western tributary of Kolonnawa ela which flows into the Cotta lake.

South : By a line drawn from the last mentioned point south-westwards along the centre line of the western tributary of Kolonnawa ela to the centre of the bridge

on Cotta road, thence by a line drawn north-westwards along the centre line of Cotta road to the southern extremity of the eastern limit of Ward No. 1.

West: By a line drawn from the last mentioned point northwards along the eastern limit of Ward No. 1 to the starting point of the northern limit of the ward.

Ward No. 3---Welikada

North: By a line drawn from the western extremity of the southern limit of Ward No. 1 eastwards along the southern limits of Ward No. 1 and Ward No. 2 to the centre of the junction of Cotta road and Nawala road.

East: By a line drawn from the last mentioned point south-westwards along the centre line of Nawala road to the centre of Kirillapone canal.

South : By a line drawn from the lastmontioned point north-westwards along the centre line of Kirillapone canal to the western limit of the Urban Council area.

 \vee West: By a line drawn from the lastmentioned point northwards and north-eastwards along the western limit of the Urban Council area to the starting point of the northern limit of the ward.

Ward No. 4---Nawala

North: By a line drawn from the eastern extremity of the northern limit of Ward No. 3 north-eastwards and south-eastwards along the southern limit of Ward No. 2 to the centre of the bridge over the western tributary of Kolonnawa Ela.

East: By a line drawn from the lastmentioned point south-westwards along the centre line of the western tributary of Kolonnawa Ela to the western village limit of Etul Kotte, thence by a line drawn south-westwards along the western village limits of Etul Kotte, Pita Kotte and Pagoda to the centre of Kirillapone canal.

South : By a line drawn from the lastmentioned point westwards along the centre line of Kirillapone canal to the southern extremity of the eastern limit of Ward No. 3.

West: By a line drawn from the last mentioned point north-eastwards along the eastern limit of Ward No. 3 to the starting point of the northern limit of the ward.

Ward No. 5-Etul Kotte

North: By a line drawn from the eastern extremity of the northern limit of Ward No. 4 north-eastwards along the southern limit of Ward No. 2 to the eastern limit of the Urban Council area, thence by a line drawn south-eastwards along the said limit to the centre of Battaramulla road.

East: By a line drawn from the lastmentioned point south-eastwards along the eastern limit of the Urban Council area to the northern village limit of Pita Kotte.

South : By a line drawn from the last-mentioned point south-westwards and north-westwards along the northern village limit of Pita Kotte to the eastern limit of Ward No. 4.

West: By a line drawn from the lastmentioned point north-eastwards along the eastern limit of Ward No. 4 to the starting point of the northern limit of the ward.

Ward No. 6—Pita Kotte

North: By a line drawn from the western extremity of the southern limit of Ward No. 5 south-eastwards and north-eastwards along the said limit to the eastern limit of the Urban Council area.

East: By a line drawn from the last mentioned point south-eastwards along the eastern limit of the Urban Council area to the northern village limit of Madiwala.

South By a line drawn from the last-mentioned point south-westwards and westwards along the eastern limit of the Urban Council area to a point on the northern village limit of Mirihana, 3 chains east of Cotta road, thence by a line drawn westwards along the northern limit of the said village to the northern village limits of Pagoda, thence westwards along the said limit to a point 8 chains west of the western boundary of Cotta road.

West: By a line drawn from the lastmentioned point north-westwards along the northern village limit of Pagoda to the eastern limit of Ward No. 4, thence north-eastwards along the said limit to the starting point of the northern limit of the ward.

Ward No. 7—Pagoda

North: By a line drawn from a point on the eastern limit of Ward No. 4 where it meets the western limit of Ward No. 6 south-eastwards along the western and southern limits of Ward No. 6 to the eastern limit of the Urban Council area.

East. By a line drawn from the lastmentioned point southwards along the eastern limit of the Urban Council area to the centre of Ekwatta road, thence by a line drawn south-westwards along the centre of the said road to its junction with the Mirihana road, thence by a line drawn southwards along the centre of Mirihana road to the northern village limit of Gangodawila.

South: By a line drawn from the lastmentioned point westwards and south-westwards along the northern village limit of Gangodawila to the centre of Nugegoda-Gangodawila road, thence by a line drawn north-westwards along the centre of the said road to the eastern village limit of Nugegoda at the junction of the said road and Cotta road.

West: By a line drawn from the lastmentioned point north-wards along the eastern village limit of Nugegodaand the eastern limit of Ward No. 4 to the starting point of the northern limit of the ward.

Ward No. 8—Nugegoda North

North: By a line drawn from a point on the western limit of the Urban Council area at the centre of Narahenpita-Kirillapone road, eastwards along the said limit and the southern limits of Ward No. 3 and Ward No. 4 to the western limit of Ward No. 7.

East: By a line drawn from the lastmentioned point southwards along the western limit of Ward No. 7 to a point in prolongation of the centre of Nugegoda Lane No. 1.

South: By a line drawn from the lastmentioned point north-westwards along the centre of the 1st lane Nugegoda and Kandawatta lane, south-westwards along the centre of Kandewatta road to the centre of Nugegoda-Kirillapone road, thence by a line drawn westwards along the centre of the said Nugegoda-Kirillapone road and south-westwards along the centre of Railway Avenue across the Colombo-Avissawella road to the southern limit of the Urban Council area.

West: By a line drawn from the lastmentioned point north-westwards along the western limit of the Urban Council area to the starting point of the northern limit of the ward.

Ward No. 9-Nugegoda South

North: By a line drawn from a point on the southern limit of Ward No. 8 at the centre of the junction of Kandewatta road with Kandewatta lane south-eastwards along the said limit of Ward No. 8 and the southern limit of Ward No. 7 to its extremity at the centre of Mirihane road.

East: By a line drawn from the lastmentioned point southwards along the centre of Mirihana road to the centre of its junction with Nugegoda-Gangodawila road, thence by a line drawn south-eastwards along the centre of the said road and Nugegoda-Kesbewa road to the southern limit of the Urban Council area.

South: By a line drawn from the lastmentioned point westwards along the southern limit of the Urban Council area to a point in line with the centre of the Railway Avenue.

West: By a line drawn from the lastmentioned point northwards across the Avissawella road and along the southern limit of Ward No. 8 to the starting point of the northern limit of the area.

Ward No. 10-Gangodawila

North: By a line drawn from a point on the eastern limit of Ward No. 7 at the centre of the junction of Cotta road with Mirihana road eastwards and south-eastwards along the said limit till it meets the centre of the road leading to Madiwala.

East: By a line drawn from the lastmentioned point south-eastwards across the road leading to Madiwala and along the eastern limit of the Urban Council area to its extremity.

South: By a line drawn from the lastmentioned point westwards and southwards along the southern limit of the Urban Council area to the eastern limit of Ward No. 9.

West: By a line drawn from the lastmentioned point north-westwards and northwards along the eastern limits of Ward No. 9 and Ward No. 7 to the starting point of the northern limit of the ward.
