CLEAN DRINKING WATER FOR EVERY HOUSEHOLD BEFORE 2025 - PRESIDENT

COMMUNITY BASED WATER PROJECTS TO A HIGH STANDARD ROAD CONSTRUCTION JOINTLY WITH WATER BOARD

Thursday reviewed future stages of the programme to provide clean drinking water to all households 24-hours of the day, before the end of 2025.

President Rajapaksa pointed out to the relevant officials the need to expedite the programme while paying special attention to the cleaning and conment areas. The President made these remarks at a discussion held at the Presidential Secretariat on Thursday on the future activities of the State Ministry of Rural and Regional Drinking Water Supply Projects Development.

"Water for All" is a flagship pledge made to the people by the National

The Government expects to provide drinking water facilities to 4.7 million families in the next four years. The project is being implemented with local and foreign funds and will require the laying of 40,000 km of new water supply pipes. TO PAGE **02**

Committee to look into alleged extremist views in Islamic textbooks - Muslim Religious Affairs Director

Department of Muslim Religious and Cultural Affairs Director Adam Bawa Mohammad Ashraf told the Presidential Commission of Investigation (PCoI) in to the Easter Sunday attacks that an 11-member Committee has been appointed to look into the alleged extremist views contained in the textbooks that teach Islam to Muslim students.

He told the Commission that the Committee was scheduled to meet today and that he was ready to hold discussions with the Ministry of Education regarding this matter.

Meanwhile, a question was raised by the Senior State Counsel that Grade 13 texts books on Islam teach that it is appropriate to read books written by Yusuf al-Qaldari, an extremist and Wahhabi leader who is supposed to have made statements stating that those who oppose Islam are against Allah and against suicide bombers.

Replying to the question, Mohammad Ashraf said that it is not appropriate to print books in this manner and the Committee consisting of 11 experts appointed by three representatives who were appointed by Prime Minister Mahinda Rajapaksa will hold discussions regarding this matter today. TO PAGE 02

Parliament Goods Receiving Officer remanded till Sept. 17 over bribery case

The Goods Receiving Officer in the Parliament canteen who was arrested by officials of the Commission to Investigate Allegations of Bribery or Corruption (CIABOC) while soliciting a bribe of Rs.60,000 from a fruit supplier, was remanded till September 17 by Colombo Chief Magistrate Lanka Jayaratne yesterday.

When the matter was taken up, Bribery Commission officials informed the Court that the arrest was made in the Kaduwela area, when the suspect was allegedly soliciting the bribe from a fruit supplier.

Colombo HC stays proceedings in Avant Garde case

The Colombo High Court was Thursday ordered to stay the proceedings of the case filed against Avant Garde Chairman Nissanka Yapa Senadhipathi and Major General Palitha Fernando in the Avant Garde bribery case due to an Interim Order issued by the Court Of Appeal.

At a previous occasion, the defence had filed preliminary objections before the

Colombo High Court and fixed a date for

Accordingly, a writ petition was filed before the Court of Appeal by the defence challenging the Colombo High Court's order to reject the preliminary objections raised by them. After considering the petition, the Court of Appeal had issued an Interim Order staying the Colombo on July 31.

When the case was yesterday taken up before High Court Judge Champa Janaki Rajaratne, President's Counsel Ajith Pathirana appearing for the defence informed court that the Court of Appeal stayed the High Court case and issued notice to the relevant parties to appear before the Court of Appeal for the hearing of the appeal on September 7.

of the Indian Coast Guard Vessel reported to his headquarters that he observed this fact. "He has reported a two-metre crack in the port quarter of the ship and the same report has come to us. These cracks are caused by the intense heat. When there is intense heat in one place for quite a long time naturally the steel plates get deformed. It's natural. But it doesn't mean that the ship is breaking apart and an oil spill is about to occur.

"These cracks are very important to analyze the ship including the hull condition, heat condition and what type of heat is generated inside the ship," he added.

Chief of Defence Staff and Army Commander Lt. Gen. Shavendra Silva said the tanker which was initially located about 38 nautical miles off the coast of Sri Lanka, had floated about 22 nautical miles off the Eastern coast of Sri Lanka and is now floating towards the south and so far there is no risk of any oil

"We believe that we are capable and nothing is impossible. We are trying our best to protect our people and marine

resources," he said.Marine Environment Protection Authority (MEPA) Chairperson Dharshani Lahandapura said that with the assistance of 15 other institutions, MEPA is prepared to avert any harmful impact of any oil

"We have divided this particular incident into two parts and the first part is that we are quite confident that the Sri Lanka Navy, Sri Lanka Air Force, Sri Lanka Ports Authority, the Indian Navy and the Indian Coast Guard who are currently working together to control the fire would be able to prevent oil spills. If not then there will be a severe threat to our marine environment if any kind of oil leakage occurs.

"In the case of an oil spill, 270,000 metric tonnes of oil could mix into Sri Lanka waters, which would be a massive environmental disaster - the capabilities and resources of Sri Lanka to address such a situation are very low. As the national authority which is responsible to handle such kind of situation we are developing a comprehensive plan with the assistance of Disaster Management Centre, Sri Lanka Navy, Port Authority and many

other organizations to combat any kind of oil spill. This will be one of the biggest environmental disasters that would happen in the world," she further added. It was just a couple of weeks ago that a large-scale oil spill occurred off the coast of Mauri-

She further said that the fishing community will be informed to stay at least five nautical miles away from the vessel as the fire could emit harmful gases.

"We have very minimum resources at the moment. The country alone cannot face any such disastrous situation of an oil spill. So we have already taken measures to seek local, regional as well as international support to mitigate the damage of any oil spill.

If an oil spill occurs, we will definitely have to take legal action against the connected parties. We have already sought the Attorney General's advice on that. Since we are part of civil liability convention there is a possibility for us to claim the insurance for any loss occurring to Sri Lanka directly or indirectly. We are also in the process of preparing for legal action based on instructions of the Attorney

General, in case of a massive oil spill," she added.

According to Sri Lanka Navy sources, a Sri Lanka Air Force MI 17 helicopter carried out several aerial operations. Meanwhile, a Beechcraft plane is conducting periodic air surveillance and a Dornier aircraft of the Indian Coast Guard also monitored the unfolding situation from the air.

Further, Sri Lanka Navy Ships Sayura, Sindurala and Ranarisi with two Fast Attack Craft have been deployed in this disaster management operation. The Indian Coast Guard Ship "Shaurya" which arrived at the location of the distressed oil tanker, joined hands with the Sri Lanka Navy Ship 'Sindurala' in carrying out the cooling effect from both sides of the ship in distress. The mission was also augmented by two tugs 'Rawana' and 'Wasamba'.

The mission was also joined by the ALP 'Winger' another tug provided by the foreign company that owns the ill-fated ship. Apart from that, the Indian Navy Ship (INS) 'Sahyadri' joined the disaster management operation and two other Indian Coast Guard ships were scheduled to join the operation by yesterday (4) afternoon. The two Russian ships that took part in the disaster relief operation left the scene of action after providing necessary support, Thursday evening.

Meanwhile, 21 crew members of the distressed oil tanker including the 19 persons who were initially retrieved by the MV Helen were taken aboard SLN ships and have been safely isolated adhering to health guidelines. The health condition of the third engineering officer of the ship who was admitted to the Kalmunai Hospital after sustaining injuries is also stable. The fire on the ship has so far had no effect on the 270,000 metric tons of crude oil stored there and necessary steps are being taken to prevent the fire from spreading to those crude oil storage facilities. Meanwhile, there is still no risk of the ship leaking oil into the ocean due to the unfortunate turn of events. However, Sri Lanka Navy, the Sri Lanka Coast Guard, the Sri Lanka Ports Authority and the Marine Environment Protection Authority and other stakeholders are geared up to take necessary steps to mitigate and manage the risk of a possible oil spill in future due to this disaster.

The project is to be completed at half of the cost spent so far on water supply.

Water generation and conservation and water source identification are some of the features of the programme. Tree planting is also planned to ensure the conservation of water sources.

In the Colombo district alone, 45% of the total water supply is wasted due to water leaks. Laying of new water supply pipes in the past few months has resulted in reducing it to 15%. In order to preserve water new pipes are now being laid to replace old ones that cause water leakage, officials said.

During the meeting, the President also focused attention on resolving the issues of the employees of the community water projects.

It was also agreed that the Road Development Authority and the Water Supply Board must jointly implement development plans with the aim of preventing wastage of national wealth in laying water pipes damaging the roads. It was highlighted that it could help save about 30% of the total cost of meeting the country's drinking water needs.

Rainwater harvesting and the expansion of capacity of tanks and reservoirs in the island and construction of a new tank and reservoir network were also discussed. The new plan also includes the introduction of projects with new canals and pipelines to carry water to water-deficient areas.

"The President had issued a gazette notification summoning a new Parliament on August 20. My client's name was published in a gazette as an elected Member of Parliament. It is the prison authorities' duty to bring him to Parliament," de Silva PC said.

De Silva argued that his client would remain as a remand prisoner until a higher court determined his

"He was not brought to Parliament even after several requests were made. Since his name has been gazetted as a Member of Parliament, the prison authorities have to bring him to Parliament. Once he is brought before Parliament, the Speaker will take a decision regarding his qualification", Silva argued.

Romesh de Silva further stated that the Speaker had also given instructions to bring the petitioner before Parliament.

When the accused filed an appeal, the execution shall stay and he shall be kept under remand custody. At this moment, he is not under the sentence of death. He has not been disqualified by a Court of Law," said

Senior Deputy Solicitor General Nerin Pulle appearing for the Attorney General submitted to the Court that a person who is under the sentence of death is disqualified to sit and vote in Parliament.

He argued that the accused continues to be under death sentence and Parliament privileges are not applicable to criminal proceedings.

He argued that in terms of Article 89 (d) of the Constitution, a person who is under a death sentence is disqualified to sit and vote in Parliament.

Nerin Pulle stated that the interpretation regarding the Article 89 (d) should be done by the Supreme Court and this matter can be referred to the Supreme Court.

He further argued that the Constitution, the Supreme Law of the country does not authorize a convicted person to be brought before Parliament.

President's Counsel Uditha Egalahewa appearing for the Secretary General of Parliament informed the Court that the petitioner can enjoy his rights since he is now considered as a remanded prisoner.

"The Government needs to ensure the safety of the lives of people living in Sri Lanka.

Addressing a group of senior officials of the National Institute of Education on Thursday evening, Prof. Peiris said that this method of learning does not stay with the children for life.

This method does not focus on the development of a child's analytical and critical thinking skills.

"It does not focus on getting students to apply what they have learned to overcome future challenges," he

The Education Minister added that the school curriculum will be revised after obtaining views from all stakeholders including teachers, principals, professionals, students and parents. "We will conduct seminars at district level to educate

the public on the importance of school curriculum revision. Views are expected from all sectors of the country to identify and rectify the shortcomings in the school curriculum," Minister Prof. G.L.Peiris said. The Minister added that an in-depth study needs to be

done to ascertain whether university graduates are fully satisfied with the employment they receive after gradua-

"We should look into whether there is any parity between their educational standards and the demands in the job market," he said.

He said that business community is ready to make more investments in the country but the education system should be capable of producing human resources to meet their demands.

The Minister also stressed the importance of creating an atmosphere for all graduates in the country to live with dignity.

"Plans are under way for the construction of 10 new universities in the country with the assistance of Asian Development Bank," he said.

The Minister said that President Gotabaya Rajapaksa has given priority for development of the human resources sector through the Education Ministry.

He said five ministries which were functioning separately, have been brought under the Education Ministry to achieve this objective.

The youth from Tangalle as agreed upon had come to Galle with another friend from Ragama on February 23, 2019 to pay cash.

On arrival in Galle they had been informed that on that day Manusha Nanayakkara could not be met as he was out of Galle. Moreover, the youth had been asked to pay them Rs.200 000 as an advance for the provision of jobs in Japan.

However, the youth from Tangalle who was suspicious over the conduct of the job agent had inquired about the deal from another friend who had instructed him not to give money. Thereafter, the youth from Tangalle had lodged a complaint with the Galle Police explaining the whole drama. The Police who initiated inquiries over the complaint

had arrested a 62-year-old man from Hapugala, Galle. The youths had met at a Japanese language class held

Subsequently, the Police instituted a case against the suspect citing Galle MP Manusha Nanayakkara as the first witness but he was not present in Court. The Magistrate who issued warrants on the Parliamentarian fixed further hearing of the case for November 6.

"It is indeed a point of the sine qua non element regime," said Dr. Costa, adding," the political parties should back the process of repealing the 19th Amendment, which had sparked a constitutional crisis in the country during the Good Governance Government.

"The people had to suffer chaos because of the situation created by the 19th Amendment," he said.

"The people were forced to endure large scalestruggles between Government branches during that period with the previous regime's President Maithripala Sirisena and Prime Minister Ranil Wickremesinghe showing disdain of their powers in the context of the 19th Amendment, as neither side backed down on their powers.

The people have dislodged that Government giving an unprecedented two-thirds majority power in Parliament to the present Government.

There are several clauses that contradict each other in the 19th amendment in the sense of the Constitution, such as the Prorogation of Parliament, which must be resolved, among other confusions," he added.



he fire onboard the ill-fated oil tanker MT New Diamond was still raging as of last afternoon and out of the 23 crew members onboard, 22 were rescued while one Filipino crew member is presumed dead, Navy Spokesman Captain Indika de Silva told the Daily News.

The Sri Lanka Navy, Sri Lanka Air Force, Sri Lanka Ports Authority, the Indian Navy and the Indian Coast Guard are engaged in a joint operation to control the fire that erupted after an explosion of a boiler in the main engine room of the MT *New Diamond*, sailing 38 nautical miles off Sangamankanda Point, east of Sri Lanka last Thursday.

The Navy Spokesman said currently there are eight vessels engaged in the operation to arrest the fire onboard the oil tanker carrying around 270,000 Metric Tonnes of crude oil. Among them are three vessels of the Sri Lanka Navy - Sayura, Sindurala and Ranarisi with two Fast Attack Craft, two vessels belonging to the Indian Coast Guard including Indian Coast Guard Ship Shaurya and (INS) Sahyadri. In addition, two tugs Rawana and Wasamba also joined the efforts to curb the fire from the Hambantota Port last morning (4). "The mission was also joined by the ALP Winger, another tug which was sent by the foreign company that owns the ship in trouble," the Navy Spokesman said.

However, the two Russian warships that had rushed to assist from the Hambantota Harbour had left the operation as it was beyond their capabilities to be of any assistance.

The Navy Spokesman said, however, the tug boats are the best bet at this point to handle the operation. He said water is being pumped for cooling while special fire retardant chemicals mixed with water are being sprayed onto the area of the fire to control it. He said the main aim is to prevent the fire from reaching the inflammable cargo and avert an explosion.

Captain Silva also noted that so far there is no danger of any oil leakage as the oil storage compartment is well sealed and there is a large ballast tank between the engine room and the cargo section which could be filled with water or sand. Two tugs are also holding the flaming ship from drifting towards the Sri Lankan coast.

Accordingly, an MI17 helicopter of the Sri Lanka Air Force carried out several aerial operations, dropping water on the ship which had caught fire. Meanwhile, a Beechcraft is conducting periodic air surveillance and a Dornier aircraft of the Indian Coast Guard also monitored the disaster situation from the air.

There were five Greek and 18 Philippine nationals among the crew. One of them was injured and he was airlifted out of the ship and the rest were accounted for.

The ship had sailed from the Port of Mina Al Ahmadi in Kuwait, loaded with Kuwait Export Crude, Refinitiv Eikon tracking data showed. It was heading to the Indian Port of Paradip, where the state-run IOC has a 300,000 barrel-per-day refinery. It was scheduled to reach India on September 5.

Meanwhile, 21 crew members of the distressed oil tanker including the 19 persons, who were initially retrieved by the MV Helen M were taken aboard Sri Lanka Navy ships and have been safely isolated adhering to health guidelines.

OPERATIONS UNDERWAY TO MINIMIZE LIFE AND MARINE DAMAGE

Addressing a media briefing at the Government Information Department yesterday, Army Commander Lt. Gen. Shavendra Silva said although the ill-fated ship is currently 38 nautical miles off the coast of Sri Lanka, it had drifted towards the coast and was at around 27 nautical miles off Sri Lanka's coast.

However, he said all possible efforts have been taken to douse the fire onboard but, in the event there is a leakage all measures are being taken to prevent any catastrophic effect.

Meanwhile, Navy Director General Operations Rear Admiral Y.N. Jayaratne said the ill-fated ship is currently around 22 nautical miles off Sri Lanka's coast, adding that the main priority right now is to douse the fire. "However, the smoke may last for some time. The ship's owners are in contact with the Navy and once the fire is doused they will take steps to take the ship away."

However, he said as the ship is in deep waters and based on the currents, there is no danger of an oil spill at present. But, the Sri Lankan Navy is on alert. By last evening, the Navy expected more ships to join the efforts. He said three tugs capable of handling large ships are currently deployed and more were expected by last evening.

Rear Admiral Jayaratne commenting on the condition of the injured sailor said he had sustained serious burn injuries but was still stable. The Captain of the ill-fated ship and some other crew members are onboard another vessel at sea to assist in the efforts to douse the fire.

He said with regard to the missing crew member, they have not been able to get him out and they suspect that he could have died in the explosion. He said although the ship is 20 years old, it is a strong ship with a double hull.

He said all possible assistance has been received from other countries in the region in the effort to douse the fire.

Joining the media briefing, Dharshani Lahandapura, the Chairman of the Marine Environment Protection Authority (MEPA) said as long as the fire can be doused there is no issue, but they were concerned about the possibility of an oil spill. Hence, together with the Disaster Management Center (DMC), preparations are being made to face a worst-case scenario and in such an event, international assistance would be sought. She also noted that in the case of an oil spill, Sri Lanka would claim compensation from the ship

President Gotabaya Rajapaksa and Prime Minister Mahinda Rajapaksa have been monitoring the situation and have been in discussion with the MEPA regarding the situation.

Currently, around 15 institutions, including the MEPA which is under the purview of the Urban Development Authority, Coast Guard Department, Sri Lanka Navy, Air Force, Port Authority, Environmental Authority, Fisheries Department, Disaster Management Department, Meteorology Department, Wildlife Department and Petroleum Corporation are jointly engaged in coordinating efforts to handle this situation.

Clearing section of Anavilundawa Sanctuary

Nishantha rebuffs allegations of involvement

State Minister of Rural and Regional Drinking Water Supply Projects, Sanath Nishantha, while denying any involvement in the recent clearing of an area in Anavilundawa Sanctuary for shrimp cultivation, said he will take legal action against any reports connecting him to the incident and tarnishing his image.

Highlighting the speculation on social media, Nishantha said the allegations are hearsay and do not provide any names, and that he will not hesitate to take legal action against any individual or media spreading false reports.

"It has already been entrusted to a well known law firm in Sri Lanka to look into it. Accordingly, they are scrutinizing all media reports and news on the subject. If such propaganda tarnishes my reputation, I will take legal action without hesitation," the state minister said to a group of media personnel in Puttalam, a communiqué issued by the minister's media unit stated.

He said that this was not a direct protest but the beginning of a foreign propaganda aided by some local political elements to attack and discredit the government.



The state minister said he had inspected the bulldozed area of Anavilundawa Sanctuary for shrimp cultivation and informed President Gotabaya Rajapaksa that it had not caused any eco-damage in the area.

The state minister said he had told the President that he is ready to face any form of penalization, had he involved in such event at any capacity. "All that has happened here is the removal of silt from the existing prawn pond," he added.

State Minister Nishantha said before the sanctuary was legalized in 1998, there were a number of shrimp ponds. "Most of them belonged to the Carson Multina-

tional Company, which was formed during the United National Party (UNP) Government from 1984 to

"Due to the white spot disease, the company left its farmland about 2,000 acres and went abroad and villagers then resumed shrimp farming under the annual license obtained from the Divisional Secretary," the statement read.

"Even today, some people continue to cultivate prawns, but after legalizing the bird sanctuary, the licenses for the ponds in the area were stopped. The government too lost a lot of tax revenue because of it," it added.

State Minister Nishantha further said although there were no licenses, some continued to cultivate without giving up; and that not only prawn ponds, but there were hundreds of acres of paddy fields as well within the reserve.

"Indigenous peoples have been living on land for hundreds of thousands of years. The root cause of the problem is the fact that the government's during the last 20 years has not given alternative lands to the traditional people. We have to give a permanent solution

without applying further temporary plaster treatments," he added.

The state minister said that there was no doubt that the Ramsar wetland is a valuable asset not only to Arachchikattuwa, but also to the entire Puttalam District.

State Minister Nishantha said he was one of the first politicians to talk about the protection of the sanctuary and had even presented a paper in this regards as a local councilor.

"However, the Ramsar wetland is not just a makeshift sanctuary for migratory birds or a wildlife sanctuary that can be confined to a wildlife sanctuary.

"Nearly 2,000 traditional families depend on the lands for their livelihood in four Grama Niladhari Divisions in the area.

"While preserving the sanctuary, we must provide a permanent solution to the issues faced by these people with regards to their livelihoods," he said.

The state minster added that both the responsibility of safeguarding the sanctuary, as well as that of providing livelihood avenues to the people, lie in the Government's hands.

29 persons arrested over illegal fishing

In special operations conducted last week, the Navy managed to apprehend 29 individuals along with their fishing gear for engaging in illegal fishing.

As such, the naval operations carried out in the Northern, Eastern and North-Central Naval Command resulted in the apprehension of 29 persons for engaging in unauthorized diving, using and storing banned fishing nets, and practicing light course fishing.

These arrests had been made in the seas off Vethalaikeni by Northern Command, off Norway Point, Salpayaru, Nayaru, Black Point, and in the Batticaloa lagoon; in Tuduwa by the Eastern Command; and in the seas off Nochchimunai by the North-Central Command. Along with the suspects, 11 fishing vessels and several other fishing gear were also seized by the Navy.

During another special search operation conducted by the Navy in Narivilakulam, Mannar, about 600 conch shells of less than 70mm in diameter had been recovered at the Narivilakulam Public Cemetery.

The suspects arrested in connection with these incidents, along with the seized items, were handed over to the Directors of Fisheries in Jaffna, Trincomalee, Mullaitivu, Mannar, Kilinochchi, and Batticaloa.

Reports point towards high turbidity, alkalinity levels

the major reservoirs of the Anuradhapura District is found to be on the rise due to the adverse effects of illegal in Rajanganaya, 1,464mg/l in Angaactivates. The levels of turbidity and alkalinity, as well as those of iron, tank, 998mg/l in Hurulu Wewa, nitrate, phosphate, and sulfate in major reservoirs are higher than the permissible levels according to the laboratory reports of the Water Quality Monitoring Unit of the Irrigation Department. As an example, although the permis-

sible level of total alkalinity shall be < 200mg/l, the level of same at Abhaya

Wewa is 760 mg/l, 494mg/l in the Tissa wewa, 1,344mg/l in Mahavilach-The contamination rate of water in chiya, 680mg/l in the Nuwara Wewa, 1,113mg/l Mahakanadarawa, 709mg/l in the Nachchaduwa tank, 1,576mg/l muwa, 624mg/l in the Manankattiya 590mg/l in the Padaviya tank, and 654mg/l in Wahalkada.

Furthermore, iron concentrations at several reservoirs such as Manankattiya, Wahalkada, Mahakanadarawa, and the Nuwara Wewa are found to have exceeded the permissible level; that is < 0.3 mg/l.

Meanwhile, an evaluation conducted by the Water Safety Plan Advisory Unit of the National Water Supply and Drainage Board (NWSDB) on the adverse effects of illegal human activities on tank water quality in Nuwara Wewa, Tissa wewa, Thuruwila, Rajanganaya, and Nachchaduwa, has shown that contamination levels of E. coli bacteria has been gradually increasing in them from 2013 onward.

The NDSDB has submitted a report to the Government, urging it to implement a mechanism to restrict human activities in tanks which are used to divert water to be used for water treat-

ment plants and the introduction of a comprehensive catchment management system under the implementation of a water safety plan, immediately, to ensure acceptable water quality in all reservoirs.

Anuradhapura irrigation engineers emphasised that the contamination of water in major tanks, along with rising levels of heavy metals, is mainly caused by illicit human activities such as the clearing of tank reservations, largescale illegal cultivation, use of chemical fertiliser and other agrochemicals, and the disposing of sewage into

DEEP CRISIS IN MALI AFTER MUTINY

CHANNA SANJEEWA in Mali

Following a mutiny that broke out on August 18 morning at the Soundiata Kéita camp in Kati, before spreading to the capital, President Ibrahim Boubacar Kéita and his Prime Minister as well as many civilians and officers were arrested. In the evening, President Kéita announced on national television from the Kati camp the dissolution of the National Assembly and his own resignation. For many observers, this coup is the logical consequence of the socio-political crisis that has paralyzed Mali since the beginning of last June 2020.

President Ibrahim Boubacar Kéita's power was regularly contested by a crowd assembled by the Movement of June 5-Rassemblement des forces patriotiques (M5-RFP), which demanded his resignation. As a result of this undemocratic way to dismiss the regime, there will be several political, socio and economic consequences affecting the Malian mutinies along with CNSP from the ECOWAS and other international

During the last stage of the discussions with ECOWAS delegation headed by the former Nigerian president Jonathan Goodluck, with Junta and CNSP it was suggested to begin a civilian transition immediately and to quickly establish a government to prepare for legislative and presidential elections within 12 months. This transition should be led by a recognized civilian, not a military, and no military structure should be above the president of the transition, and subsequently sanctions imposed against Mali at the first extraordinary ECOWAS summit on the issue on August 20, two days after the coup, will be lifted gradually according to the implementation of these decisions.

But Mali's ruling junta demanded a militaryled transitional body to be set up for three years and agreed that ousted President Ibrahim Boubacar Keïta should return to his home and if he wants to travel for medical care it can be facili-

tated. Further the junta has expressed that it wants to make a three-year transition to review the foundations of the Malian state. This transition will be led by a body chaired by a soldier, who will at the same time be head of state and as for junta's proposal the entire government will also be predominantly made up of soldiers. Due to these junta's demands, the discussions were concluded without a concrete conclusion for the restoration of peace for the Malians. It could create a huge economic and social crisis for the entire sub region. Its ripple effects can also spill over into neighboring Niger and Burkina Faso.

Meanwhile after the collapse of negotiations efforts with ECOWAS, sub regional leaders vehemently condemned the military coup and decided to close all land and air borders with Mali until the Junta along with CNSP comes to

The Coup in Mali took the world by surprise.

a decision to conduct legislative and general elections during the one year transition period. It is important to remember that the continent has a strong impact on Mali in such situations. Having no outlet to the sea, to transport the products from the ports to the country, it will take the help of countries such as Côte d'Ivoire, Senegal, and many other countries of the said community. Since most of the manufactured products of these countries which closed their borders at the request of ECOWAS, are sold in Mali, this would undoubtedly be a real problem for these production units of the sub region.

Mali supplies the Ivory Coast, Senegal, and many other countries with meat. It is true that Mali will suffer in many ways especially vis-à-vis land transport but the billions that the ports earn from Malian imports will constitute a shortfall during the embargo period. So, it is also an economic conflict and, hence it is important for ECOWAS to review its conditions in favor of entire sub region.

Just over two weeks after the coup, Mali is still plagued by terrorism. Last week, Malian soldiers were victims of a jihadist attack on Kona in central Mali. At least four Famas (Malian Armed Forces) died on August 27. The fight against terrorism continues, and regime change is not having too many consequences on the operational front. With the August 18 putsch and the imprisonment of several generals, including the Minister of Defense, General Dahirou Dembélé, who is still detained in Kati, the chain of command was disrupted. But according to the French force Barkhane, operations were not affected.

Brigadier General Oumar Diarra, who was appointed Chief of the General Staff of the Armed Forces on 31 Friday, was arrested along with several high-ranking army officers on

August 18 in the early hours of the overthrow of President IBK. Not for long, since a few days later he was released and promoted to the head of the Malian army. He now has the heavy task of oiling the war machine, of conducting victorious operations in the field. Last Monday the United Nations Security Council meeting had decided to renew sanctions against Mali for one year, unanimously adopting a resolution that also extends the work of the group of experts created to study the issue.

In adopting resolution 2541 (2020), the Council decided to renew until 31 August 2021 the measures set out in paragraphs 1 to 7 of resolution 2374 (2017), which include the imposition of a travel ban and assets freeze on those who impede progress in the implementation of the peace and reconciliation agreement in Mali. In the terms of the resolution, it reaffirmed that these measures shall apply to the persons and entities designated by the Sanctions Committee established pursuant to resolution 2374 (2017). The Security Council decided that all Member States shall, for an initial period of one year following the adoption of this resolution, freeze immediately the funds and other financial assets and economic resources which are on their territories owned or controlled, directly or indirectly, by the persons or entities designated by the Commit-



Throwing the dragnet far and wide

he unrelenting war waged against the underworld and the narcotics trade by President Gotabaya Rajapaksa certainly is paying dividends, with almost daily arrests of key figures of the underworld and the collapse of drug empires as reported in the media.

The latest detection relates to the seizure of 900 perches of land worth Rs. 4,000 million together with other prime assets and 26 motor vehicles including luxury brands, following the arrest of leading underworld figures in the Western Province. The suspects have been maintaining 102 bank accounts where Rs. 2600 million worth of transactions had been carried out.

What is more, the arrest of key collaborators within the law enforcement arms and the drug running conduits where the role of members of the Police Service has been brought to light, the unraveling of the dark underbelly of the prisons which have turned out to be havens for drug kingpins to carry out their business from behind prison walls, is clearly indicative of the outstanding success achieved by the Government in taming the underworld and ridding the country of this deadly spectre.

What is appalling in this whole sordid saga is the extent of the involvement of the police, including Police Narcotics Bureau (PNB) sleuths, in the drugs business. Newspapers reported that a brother of a Police Constable of the Colombo Crimes Division (CCD) had been arrested with 46 kilogrammes of heroin, with investigations currently on to ascertain if the Constable concerned too was involved in the racket.

During the Coronavirus pandemic a police officer was nabbed transporting heroin in a three-wheeler which clearly shows the active involvement of the law enforcement members in the drug trafficking business. No wonder the Narcotics trade has been growing exponentially over the years with the authorities none the wiser as to the underlining cause for their failure all these years to successfully tackle the drugs underworld.

Certainly, now that war against the underworld is fought in earnest more details are bound to transpire as to the full extent of the involvement of law officers in the drugs trade. This is not to belittle the efforts of police officers who are working with dedication and commitment to see an early end to this menace. But like in almost every department there are rotten apples who bring to naught the dedicated efforts of others by their venal conduct. At least now these elements should be identified and got rid of in any overhaul carried out in the Police establishment, which just celebrated its 154th anniversary.

In all probability we are here only seeing the tip of the proverbial iceberg. Given the extent and magnitude of the involvement of law enforcement officers (with two employees of the Government Analyst's Department too in the net) there is no knowing how far and wide the operation has spread. If so, total eradication will be some time in coming.

In this context it is a wise move to get the STF in the forefront of the battle against the drugs underworld with the stellar reputation of the outfit for combat and daring during battles with the LTTE. Not just the Police, the dragnet should be thrown far and wide if complete success is to be achieved in the fight against the narcotics trade.

One is compelled to ask how the banks accepted such large sums without asking any questions. We say this because any ordinary depositor is subject to close scrutiny when he/she deposits even Rs. 100,000 in a bank. All kinds of questions are asked by the bank authorities to satisfy themselves that everything is above board. Here we have a scenario where a cumulative Rs. 2600 million not only being deposited (laundered actually) with the banks but also being freely moved around.

Ditto for the Motor-vehicle Registrations Department (RMV). How were all these vehicles registered? No questions have apparently been asked on the source of wealth and the Department of Inland Revenue too has apparently been bypassed. How did the 900 perches of land purchased by the underworld gangs pass muster without any questions by the Land Registry? These transactions could not have taken place overnight, but over a long period of time

The other day a Senior DIG told the media that there were 400 hardcore criminals operating in the Western Province alone and even went on to venture out their numerous aliases. Their crime spree countrywide is well known. If so why are the Police waiting without arresting them and taking legal action against them?

The drugs trade in this country, as elsewhere, has grown into a hydra-headed monster where all agencies suspected of collusion would have to be neutralized if we are to see an end to the problem. We repeat - throw the dragnet far and wide and we are bound to hit on a viable solution before long.

SRI LANKA: TOWARDS A NEUTRAL FOREIGN POLICY

ast month's eagerly awaited General Election in Sri Lanka ended with a landslide victory for the Sri Lanka People's Front (SLPP), led by former President Mahinda Rajapaksa who was formally appointed (earlier last month) as Prime Minister for a five-year term.

The party gained 145 seats to obtain a near two-thirds Parliamentary majority, underlining public support for the Government's successful management of the Covid-19 pandemic and securing the mandate of President Gotabaya Rajapaksa, the younger brother of Mahinda elected in November 2019.

Speaking with the Asia Society after the younger Rajapaksa's triumph last November, Dinusha Panditaratne, an expert on Sri Lankan foreign affairs, said the new President's view of Sri Lanka's place in the world could be summarised as "Sri Lanka must develop itself," alluding to an emphasis on the word "development" which appeared over 100 times in President Gotabaya Rajapaksa's election manifesto.

Central among the Government's domestic challenges will be to revive a heavily indebted economy expected to contract by 3.2 percent, with the Coronavirus pandemic hitting the country's tourism industry, which had already faced a downturn after the Easter terrorist attacks in 2019.

To do so, Colombo plans to drive an economic development agenda by itself and as a partner with other countries while leveraging its strategic importance. "The new administration will be able to take more decisive steps given the ideological alignment of the Prime Minister, the President and Parliament," Dr. Kadira Pethiyagoda, a foreign policy expert and author of 'Indian Foreign Policy and Cultural Values', told TRT World.

Pethiyagoda suggested that a development-led engagement with China and its flagship Belt and Road Initiative (BRI) would feature prominently, as a realist approach to foreign policy that balanced great powers like the US, China and India while its own interests were likely to be pursued.

A crushing US\$ 55 billion debt burden, coupled with geopolitical competition underway in the Indian Ocean, are likely to be significant factors in determining the direction of Sri Lanka's foreign policy.

ASIA FIRST?

In the immediate aftermath of the August election, a number of developments might indicate that the orientation of the Government's foreign policy has begun to take shape.

One has been the responsibilities assigned to the newly appointed Minister of Foreign Relations Dinesh Gunawardena, who now wields the ability to reevaluate existing bilateral agreements and remove clauses considered economically or socially harmful.

Another is the creation of the 'State Minister of Regional Cooperation' portfolio, to be helmed by Tharaka Balasuriya, a Member of Parliament known for his focus on financial and economic issues.

Among Balasuriya's duties will be to foster trade links with Asian nations and strengthen ties with regional multilateral bodies like the South Asian Association for Regional Cooperation (SAARC) and Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC). Pethiyagoda believed that the new ministerial portfolio "sends a signal of the focus the administration will place on South Asia and Asia more broadly."

"An Asia-first approach aligns with the Government's ideals and the views of much of its political base," he said.


An Asia-centric foreign policy was echoed by retired Navy Admiral Jayanath Colombage, part of a reshuffle that saw him appointed as Secretary to the Ministry of Foreign Relations, a post traditionally held by career diplomats

In an interview last week, Colombage declared that Sri Lanka should focus on its neighbourhood and pivot away from "Western-oriented diplomacy". He advocated the Foreign Service corps to align with changing global dynamics that favour an Eastward shift, while balancing great power rivalries in the strategic theatre of the Indian Ocean.

Gareth Price, Senior Research Fellow at the Asia-Pacific Programme in Chatham House, observed a reorientation was being aimed not so much at the nation's Western-centric foreign policy but a diplomatic tendency that

centres the West. Given Sri Lanka's desire to acquire much-needed investment to jumpstart its ailing economy, forming expedient partnerships in Asia presents less hurdles than it does in the West.

"If you look to the US or Europe, the issue of human rights crops up, which is less the case with potential Asian partners," Price told TRT World, adding that Colombo's tilt towards Asia would take place while resisting a binary choice between India and China. A Senior Analyst at Control Risks, Hemant Shivakumar maintained that these developments will not come at the expense of economic ties with Western nations.

"Countries like the EU and the US will remain key export destinations for the majority of Sri Lankan goods and products, and it is unlikely that the Government will imperil these economic avenues," he told TRT World.

COMPETING INTERESTS

Ultimately, Colombo will have to reconcile the competing interests of two Asian giants vying for influence in the Indian Ocean.

In an attempt to assuage New Delhi's fears of Colombo being ensnared by Beijing, Colombage reiterated that "as far as strategic security considerations go, it's an 'India first' approach." The stance will be welcomed by Indian Prime Minister Narendra Modi's Government, who was the first to congratulate Prime Minister Mahinda Rajapaksa following August's elections.

For India, Sri Lanka is increasingly viewed through the prism of its strategic maritime objectives, and it has long harboured concerns over the growing Chinese footprint on its southern neighbour's shores, heightened after a controversial 'debt-equity swap' of the Hambantota Port to Beijing in 2017.

Fears that China is practicing 'debttrap diplomacy' are unfounded; a Chinese State Owned Enterprise (SOE) paid the Sri Lankans to lease Hambantota Port and provided Colombo with liquidity to repay Western creditors, to which it owes the majority of its debt.

"It was poor decision-making on the Sri Lankan side that led to the debt more than any kind of Chinese scheme," said Price. "The problem with the previous Rajapaksa Government was that there were a lot of projects, and Chinese investment poured in because they wanted them to."

If there is an underlying logic that will drive Sri Lankan diplomatic strategy, it is economic – and India might be at a disadvantage despite the positive rhetoric coming from the new Government.

The overriding imperative for the Rajapaksas is to reduce the country's foreign debt burden and partners will be prioritised on the basis of who can provide funding to stimulate commercial activity. If India cannot deliver on implementing projects and spurring investment, the administration will look elsewhere.

"Sri Lanka needs financing and infrastructure investment, and China can do it better than India. China's capacity to build is greater than India's, and its pockets are deeper. Particularly now with India's economy taking a major hit," Price noted. "If Sri Lanka was not looking to be beholden to China, looking to the Southeast Asian countries would make a lot of sense."

There is enough evidence to suggest that Sri Lanka will continue to deepen engagement with other Asian states.

"The previous Government between 2015 and 2019 had stepped up economic and commercial relations with Singapore and Malaysia," Shivakumar said, highlighting that Singapore was among the top ten investors in Sri Lanka and Malaysia had indicated in 2018 plans to pursue a Free Trade Agreement (FTA). Bangladesh and Japan could follow soon.

Shivakumar also believed that the Rajapaksa administration will continue to favour economic ties with China,

despite security objections from countries like India.

"Effectively, though the (Sri Lankan) Government will seek to pursue commercial opportunities with India and Japan to help offset domestic criticism over dependence on China, this will remain limited."


In May 2019 India and Japan signed a Memorandum of Understanding (MoU) with the Sri Lankan Government for a high-profile Colombo Port project worth US\$ 500 million, which faced domestic opposition from parties who saw India and Japan following China's lead in trying to "spread their tentacles" in the country's strategic assets. The Government assured both sides that the project would be expedited after the elections were over, but questions remain.

Foreign ports are a transshipment hub for nearly 30 percent of Indian export-import cargo and the Colombo port accounts for a large chunk of it, making Sri Lanka an invaluable "blue water" access point for India. Washington's US\$ 480 million [MCC - Millennium Challenge Corporation Compact] grant for development projects has also faced setbacks.

"Alternatively, the Government will likely intensify efforts to secure a moratorium from foreign lenders on debt repayments even as it initiates fresh negotiations for a new International Monetary Fund (IMF) Loan Programme," Shivakumar added.

While the Government hardly wishes to get involved in a Sino-Indian or US-China power struggle, it may not have a choice as it seeks to preserve its long practised policy of Non-Alignment. With heightened external geopolitical fissures in the region, balancing infrastructure diplomacy between China, India and the US will be a daunting challenge. For the ruling Rajapaksas, it's a balancing act motivated by economic development — a pragmatism likely to be at the centre of Sri Lankan statecraft.

India - China tensions in Himalayas

fter months of efforts to defuse the tensions in the Himalayan Region, India's Defence Minister Rajnath Singh called a high-level meeting this week to discuss the ongoing situation and future strategy for the Line of Actual Control (LAC) in eastern Ladakh.

The meeting comes a day after 500 Chinese troops had reportedly attempted to intrude in the Indian Territory near the southern bank of the Pangong Tso Lake. Its agenda was to discuss the way forward and further negotiations with the Chinese in the wake of the latest developments.

Earlier this week, the Indian Army had said the Chinese troops carried out "provocative military movements" to "unilaterally" change the status quo near Pangong Tso Lake in eastern Ladakh on the intervening night of August 29-30. However, China has denied provoking any conflict between the

Chinese foreign ministry spokesperson Hua Chunying said People's Liberation Army (PLA) troops "never crossed" the Line of Actual Control and never occupied any terri-

Reports from foreign media personnel and defence analysts said despite the efforts to defuse the tensions in the region, soldiers from both countries had rushed to shout in each other's faces again. Though the confrontation wasn't bloody, where it happened was significant.

Indian and Chinese troops have locked horns again along their disputed border, Indian officials said Monday, in a sign that the deadly tensions that erupted in June between the world's two most populous

countries are not going away. India's defense ministry said the Chinese Army had "violated the previous consensus" and "carried out provocative military movements" near Pangong Tso Lake, in the remote Ladakh region.

Indian Army officers and security analysts said Chinese troops landed a few days ago on the southern side of the lake, which traditionally has been considered Indian Territory a move the Indians saw as the latest example of Chinese aggression in a long string of provocations.

The New York Times reported that troops from both sides yelled at each other and surged to within a yard or two before commanding officers from both sides pulled them apart. No punches were thrown and no one was injured, the analysts said, and the incident was much less severe than the situation that exploded in June in roughly the same area, when 20 Indian soldiers and an unknown number of Chinese troops were killed.

But China was emphatic that it had done nothing wrong. Chinese troops respect the border, known as the Line of Actual Control, said Zhao Lijian, spokesman for China's foreign ministry, and Chinese troops "never crossed the line.

Senior Col. Zhang Shuili, a spokesman for the Western Theater Command of the People's Liberation Army, went further, accusing the Indian military of "blatant provocation" and ruining the agreement the two sides had reached over the area by making illegal incur-

"This action by the Indian side has seriously violated Chinese territorial sovereignty, and seriously damaged the peace and stability of the Chinese-Indian border region," Colonel Zhang said, according to Xinhua, China's official news agency. He demanded that India immediately withdraw its forces and "strictly control and constrain frontline

"Chinese troops are taking necessary measures in response and will closely monitor developments," he said.

The latest situation shows that despite all the diplomatic activity between the two countries, ongoing meetings between Chinese and Indian generals, the border remains a raw flash point in an increasingly nationalistic era in both major Asian countries.

Both countries are led by dominant, nationalistic leaders — India's Prime Minister Narendra Modi and China's President Xi Jinping.

The two countries are locked in a tense, deadly struggle for advantage on their disputed mountain border. Each nation has sent in thousands of reinforcements, supported with tanks, artillery, helicopters and fighter

In June this year, the worst clash between the two nations in decades erupted. High up in the mountains, in the rocky and isolated Galwan Valley, hundreds of troops raged at each other with rocks, sticks, clubs and their bare fists. Indian officials said Chinese soldiers even used specially made iron clubs, with spikes welded to their tips, to inflict maximum damage.

For more than half a century, this border has been a sore spot. In 1962, the two Asian giants fought a brief war over this same region. China wrested away a chunk that India still claims.

Though the border has never been demarcated, the two sides eventually worked out protocols on how to patrol it, advising their soldiers not to shoot at each other. This kept the occasional border confrontation or dispute from turning deadly, up until the enormous brawl in June.

On Monday, the Indian media swung into action, running wall-to-wall television coverage and raising jingoistic feelings. Maps broadcast by Indian channels showed two lines cutting through Pangong Tso Lake one to the east, which India believes is the border, and one that lies several miles to the west, which is what China claims.

"The Chinese are playing their usual game of surprise and deception," said Brahma Chellaney, a professor of strategic studies at the New Delhi-based Center for Policy Research. "They have opened a new front."

Residents in Ladakh, which is a mountainous region historically connected to Tibet, said that Indian soldiers had shut down one of the area's main highways — again — and that troop convoys were chugging up the windy roads on their way to the border.

Indian analysts said the Chinese were stepping up their campaign to change the facts on the ground around Pangong Tso Lake,

with fortified bunkers and two new marinas. Bharat Karnad, an Indian national security expert, called China's latest move "a probing action" that the Indians had successfully

Indian economy drops

India's economy has been adversely affected by the Covid-19 crisis and continuing weakening of the economic status in the

India's GDP contracted 23.9% on a yearly basis in the first quarter (April-June 2020) of the financial year '21, which captured the full effect of the pandemic-triggered national lockdown. It grew at 5.2 percent during the same quarter last year. Quarterly (gross value added (GVA) showed a contraction of 22.8 percent year-on-year (YoY).

This is the sharpest decline in the economy since the nation started publishing the quarterly figures in 1996, and reportedly the worst among all Covid-hit G20 econo-

As per the National Statistical Office (NSO) of the Ministry of Statistics and Programme Implementation (MOSPI) which released the estimates of GDP for Q1 of FY21 on Monday this week, the economy (at constant prices) during the quarter under review was pegged at Rs 26.90 lakh crore, as against Rs 35.35 lakh crore in Q1 of 2019-20.

As largely expected, agriculture was the only silver lining among all sectors as it grew by 3.4% in the April-June quarter.

Manufacturing, construction and trade (hotels, transport, communication and services related to broadcasting) shrank by 39.3%, 50.3% and 47% during the quarter. Government expenditure during the quar-

US Polls - new collisions

With just a little more than eight weeks for the US Presidential Election on November 3, and after conventions of the Republican and Democratic Parties that chose the Donald Trump and Joe Biden candidates, the campaigns are getting more intense with increasing protests on Black Lives Matter, and the new Trump policy of Law and Order, moving away from the negative effect of his failures on Covid19 spread.

President Donald Trump took his tough Law and Order message to Kenosha city, in Wisconsin state, the latest US city roiled by the police shooting of a black man. President Trump has branded recent anti-racism protests there as "domestic terror" by violent

Trump has been hoping for months to shift the election battle against Democrat Joe Biden from a verdict on his widely panned handling of the coronavirus pandemic, to what he sees as far more comfortable territory of Law and

"These are not acts of peaceful protest but really domestic terror," Trump said after touring damage in the city, describing multiple nights of angry demonstrations last week that left two people dead. Crowds lined the barricaded streets where the president's motorcade passed, with Trump supporters on one side and Black Lives Matter protesters on the other, yelling at one another from a distance and in sometimes tense face-to-face encoun-

"These gentlemen did a fantastic job," he said, in reference to law enforcement units that quelled the violent protests.

Kenosha is where the shooting of Jacob Blake, with seven shots fired by a policeman on an unarmed man, had paralysed him, and Black Lives Matter protests, riots, and also

the arrival of armed, white vigilantes - culminating in an incident in which a 17-year-old militia enthusiast, Kyle Rittenhouse, allegedly shot dead two people and badly injured anoth-

Democrats and police reform advocates view Kenosha as a symbol of institutional racism. They see Rittenhouse, a Trump supporter, as emblematic of right-wing militias increasingly brazen about brandishing weaponry in political settings.

Trump, however, came with a different priority: countering what he has repeatedly described as the "anarchy" in Democratic-led cities. He has refused to condemn the growing presence of armed vigilantes on the streets, calling the alleged killings by Rittenhouse "an interesting situation."

Trump for his part accuses Biden of weakness in addressing violent protests in cities like Kenosha and Portland, seeking to paint the Democrat as incapable of controlling the party's left wing.

The US now faces more Black Lives Matter protests in Los Angeles, California, following the fatal shooting by sheriff's deputies of a black man, identified as 29-year-old Dijon Kizzee, after a violent altercation, but carrying no weapon. Last week's unrest in Kenosha rekindled a months-long surge of protest against police violence and racism, unleashed by the death of an unarmed African American, George Floyd, at the hands of police in Min-

President Trump and the Republicans show some gains with the new slogan on Law and Order, with opinion polls giving Trump a rise in some states where Joe Biden has been in the lead. The Republicans are also attacking Joe Biden as being senile, and a fall in the economy if Democrat Joe Biden in elected. The US voters will get a better chance to compare and contrast the two candidates with the debates due to begin on September 29.

Navalny poisoning

There is a widening international call for Russia to probe the medical reports that Russian opposition politician, Alexei Navalny, has been poisoned by the nerve agent Novichok.

German Chancellor Angela Merkel said Navalny was a victim of attempted murder and the world would look to Russia for answers. He is being treated in a German hospital, and is reportedly in a serious condi-

A Novichok nerve agent was used to poison former Russian spy Sergei Skripal and his daughter in the UK in 2018. While they survived, a British woman later died in hospital, due to accidental contact with the nerve agent. The UK accused Russia's military intelligence of carrying out that attack.

Russia's Kremlin spokesman called on Germany for a full exchange of information on Navalny's condition, and foreign ministry spokeswoman complained the Novichok allegations were not backed up by evidence. "Where are the facts, where are the formulas, at least some kind of information?" she asked.

UK Prime Minister Boris Johnson condemned the latest attack as "outrageous". "The Russian government must now explain what happened to Navalny - we will work with international partners to ensure justice is done," he tweeted.

"Someone tried to silence (Navalny) and in the name of the whole German government I condemn that in the strongest terms," Chancellor Merkel said, adding that Germany's NATO and EU partners had been informed of the results of the investigation and they would decide on a common and appropriate response based on Russia's reaction.

The European Union has demanded a "transparent" investigation by the Russian government. "Those responsible must be brought to justice," a statement read.

NATO Secretary-General Jens Stoltenberg also called for an inquiry in a tweet, while the US National Security Council (NSC) said the suspected poisoning was "completely reprehensible". "We will work with allies and the international community to hold those in Russia accountable, wherever the evidence leads, and restrict funds for their malign activities," an NSC spokesman said.

Lebanon

Lebanese leaders have promised to form a new government within two weeks, visiting French President Emmanuel Macron said on Tuesday after talks with political blocs who designated a new prime minister a day earlier.

"What I have asked for, what all political parties without exception have committed to this evening right here, is that the formation of this government will not take more than a fortnight," Macron said in a speech in Beirut.

He said the cabinet would be composed of 'competent personalities" and would be an "independent" entity with the backing of political parties.

Mustapha Adib, who had been Lebanon's ambassador to Berlin since 2013, was named on Monday as the country's second new prime minister since Saad Hariri resigned in the face of mass protests in October. He will now have to form a reform-oriented government in record time in a crisis-hit country where the process usually takes months.

Adib "can only obtain legitimacy by quickly forming a mission government made up of professionals, the strongest possible team", Macron said.

Macron toured the Beirut area two days after the warehouse explosion on August 4 that killed at least 190 people. He arrived in Beirut on Monday to follow up on reconstruction efforts and hammer home the need for urgent reform in the Middle East nation that is collapsing under the weight of a crippling economic crisis, and to mark the centenary of the modern Lebanese state.

Belarus

Three Baltic States Lithuania, Latvia and Estonia have imposed travel bans on President Alexander Lukashenko and 29 other Belarusian officials, signalling impatience with the West's cautious approach, by announcing sanctions without waiting for the rest of the EU.

The three small Baltic States have led calls for firm measures against Lukashenko, who is accused by opponents and the West of rigging an August 9 election to prolong his 26-year rule. The sanctions target officials they accuse of having a role in vote-rigging and in violence against protesters since the election. The inclusion of Lukashenko was a prod to other European countries, so far reluctant to back measures against him personally.

This comes as Belarusian authorities resumed arresting protesters in the capital, Minsk, where students have taken to the streets against President Lukashenko. Belarusian media reported that at least 18 students were arrested as police moved to break up the demonstration.

Lukashenko, who turned 66 on Sunday, is struggling to contain weeks of protests and strikes since winning an August 9 election his opponents say was rigged.

Russian President Vladimir Putin used a birthday phone call to invite Lukashenko to visit Moscow, a sign of the Kremlin's willingness to back Lukashenko as he grapples with the unrest and the threat of new Western sanc-

Belarus is Russia's closest ex-Soviet ally and its territory is an integral part of Moscow's European defence strategy. Nevertheless, Lukashenko is seen in Moscow as a prickly partner. In the biggest sign yet of Russia's willingness to intervene to prop up Lukashenko, Putin has said the Kremlin had set up a "reserve police force" at Lukashenko's request, although it would be deployed only if neces-

As the European Union is gearing up to impose new sanctions on Belarus, Lukashenko has threatened to cut off European transit routes across his country in retaliation.

Israel-UAE flight

The historic flight from Israel to the United Arab Emirates (UAE) took place this week. It was the first commercial flight of an Israeli aircraft direct to the UAE across Saudi Arabia.

Prime Minister Benjamin Netanyahu said Monday's historic first commercial flight of an Israeli aircraft direct to the UAE across Saudi Arabia will not be the last. "Now there is another tremendous breakthrough," he wrote shortly after Saudi Arabia said it would allow UAE flights to "all countries" to overfly the

kingdom. 'Flights will be cheaper and shorter, and it will lead to robust tourism and develop our economy," he said.

Monday's groundbreaking flight on an aircraft of Israeli national carrier El Al carried a US-Israeli delegation headed by White House adviser Jared Kushner, President Trump's sonin-law. The visit was aimed at charting the relationship between the Emirates and the Jewish state after their landmark deal to normalize relations.





The new edit, retitled "Mario Puzo's The Godfather, Coda: The Death of Michael Corleone,' will be released in limited theaters in December - marking the original film's 30th anniversary -- before moving to streaming platforms. It "is an acknowledgement of Mario's and my preferred title and our original intentions for what became 'The Godfather: Part III," said Coppola. Despite failing to earn the critical acclaim of the first two, "The Godfather: Part III" was still nominated for seven Oscars including best picture. Coming 16 years after the second installment, the 1990 film followed Al Pacino's Michael Corleone in his 60s as he tries to extract his family from the mafia world.

The new version entailed a "painstaking, frame-by-frame restoration" of the original film and previously unseen footage over the course of six months. Work including repairing scratches and stains on the original negatives was interrupted by the coronavirus pandemic and had to be completed remotely. - AFP

Biden meets Jacob Blake's family

US: US Presidential hopeful Joe Biden met with relatives of Jacob Blake, the black father shot multiple times by a white police officer in Wisconsin in an incident that sparked days of violent unrest.

The Democratic nominee and his wife Jill Biden entered a private meeting at the Milwaukee airport with several members of Blake's family, including his father and three siblings, the Biden campaign said. Blake's mother participated via telephone.

The meeting comes two days after President Donald Trump also visited Kenosha, the nearby city where the shooting occurred.

During his trip Trump did not meet or speak with the family of Blake, who survived the shooting but is likely paralyzed from the waist down.

While in Kenosha the President pushed a message of law and order as he met police, other first responders and residents whose businesses were damaged or destroyed in the violent protests that followed the shooting of 29-year-old Blake.

After talking with the Blakes, Biden travelled to nearby Kenosha.

Kenosha is one of the latest in a series of US cities shaken by racially charged unrest.

Violent demonstrations occurred in May and June in Minneapolis, in the neighboring state of Minnesota, and elsewhere after a police officer there killed an unarmed black man, George Floyd, by kneeling on his neck for more than eight minutes.

Protests also hit south Los Angeles this week after sheriff's deputies shot and killed a black man during a violent confrontation.

And demonstrations have rattled Portland, Oregon for weeks, prompting Trump to threaten to send in federal forces to cities where "weak" Democratic leaders have failed to quell violence. - AFP








he new Tourism Skills Strategy and Action Plan 2020–2023 (SSAP 2) for the Batticaloa District was launched recently at the auditorium of the Batticaloa District Secretariat under the patronage of Government Agent Kalamathy Pathmarajah.

COVID-19 has created an unprecedented health challenge. Not only the Government but also donors, NGOs, foundations and the private sector are giving priority to the delivery of health and humanitarian assistance and immediate support towards the strengthening of fragile health systems globally. 
Government, training providers and the private sector in the Batticaloa District.

Brazil tops 4 mn COVID-19 cases

IPPR probe into origin of virus

Over 7,000 health care workers dead worldwide

BRAZIL: Brazil surpassed four million coronavirus cases on Thursday, as an international panel looking into the global response to the pandemic vowed to uncover how it was able to spread worldwide.

"This is a strong panel poised to ask the hard questions," said former Liberian President Ellen Johnson Sirleaf, co-chair of the Independent Panel for Pandemic Preparedness and Response (IPPR), which will rake over the heavily criticized World Health Organization-led response.

Meanwhile, Amnesty International said more than 7,000 health care workers have died of the virus worldwide, including more than 1,300 in Mexico alone, the most for any country.

Brazil topped four million cases with 124,600 deaths, second only to the United

There were almost 44,000 new cases over the previous 24 hours alone, and 834 fatalities. However, some experts saw a silver lining in the statistics -- the South American giant could be on the verge of improvement.

"In the last two months, we have seen a curve that mixes regions that are increasing, with others that are decreasing," said Paulo Lotufo, professor of epidemiology at the University of Sao Paulo, pointing to spikes in the south and center-west, while cases were falling in the major cities of Sao Paulo and Rio de Janeiro, as well as in

But experts warned the situation could suddenly worsen again if local and regional governments give in to pressure from business groups to reopen the economy too soon, and if social distancing measures are abandoned.

As the death toll rose, the IPPR said its

The social media giant vowed to fact check premature claims of victory, stating that if a candidate tries to declare himself the winner before final votes are tallied "we'll add a label to their posts directing people to the official

The moves follow sharp criticism of Facebook's handling of the 2016 Presidential election, when it failed to restrict disinformation from Russian operatives that spread conspiracy theories and discouraged voting in some cases.

The US is gearing up for what is expected to be a bruising campaign season against the backdrop of the coronavirus pandemic and mass protests for racial justice that have led to violent conflict in some cities between civil rights groups and armed right-wing vigilantes.

Zuckerberg has long favoured a largely handsoff approach to candidate statements, but he said a new policy was needed for last-minute ads because "In the final days of an election there may not be enough time to contest new claims." The restrictions do not affect political ads posted more than a week before Election Day that have given opposing candidates enough opportunity to rebut inaccurate information. Zuckerberg said he and his wife donated \$300 million to groups working with election officials to provide protective gear or other resources to poll workers.-AFP

'Batman' star Pattinson tests positive for COVID

US: Filming for the latest Batmancentered film, starring Robert Pattin son, has been halted in Britain after the actor reportedly tested positive for the coronavirus, just days after shooting had resumed.

"A member of 'The Batman' production has tested positive for COVID-19, and is isolating in accordance with established protocols," Warner Bros. said in a statement to AFP. "Filming is temporarily paused.'

The studio did not name the person infected or indicate when filming would resume.

however, said it had confirmed through "highly placed sources" that 34-vear-old Pattinson was the sick cast member.

Pattinson's representative could not be immediately reached for comment. Production for the new film - a dark, detective-style mystery take on the "Caped Crusader" -also had to shut down midway through production in March due to the COVID-19 pandemic.- AFP

Britons brace for higher 'virus' taxes

UK: Britons face the prospect of higher taxes as the government looks to claw back vast sums spent during the pandemic -- but the move risks harming economic recovery according to experts.

While Finance Minister Rishi Sunak on Wednesday vowed that there would not be "a horror show of tax rises with no end in sight", he stressed that the government "will need to do some difficult things".

Analysts said this was a clear signal that tax rises were on the way. Reports suggest that Sunak is mulling hikes to raise between £20 billion and £30 billion (\$26-\$39 billion, 22-33 billion euros).

This could be in the form of increasing income and corporation taxes, analysts said.

Helen Miller, deputy director at the Institute of Fiscal Studies, warned against acting too soon.

"Now is not the time to raise taxes," she said in response to Sunak's tax-raising signals.

Sunak, whose official title is Chancellor of the Exchequer, warned however that the state cannot "simply borrow" its way out of the current financial hole.

British government debt has exceeded £2 trillion for the first time following massive state borrowing as the coronavirus pandemic pushed the UK economy into a record recession.

That is equivalent to more than 100 percent of the country's annual gross domestic product, or total economic output, for the first time since 1961. - AFP

MADRID builds NEW HOSPITAL for SECOND COVID-19 WAVF

SPAIN: Near Madrid airport, an army of cranes works round the clock to build a new pandemic hospital which is expected to open in November.

But a second wave of the COVID-19 outbreak is already under way in Spain, straining the capital's public health care system.

Around 400 builders have been working round the clock since July to build the 45,000-squaremetre (484,000-squarefoot) Isabel Zendal hospital, which will be able to care for over 1,000 patients during a health emergency

The opening of the new hospital however will come too late to deal with a surge in infections in the Madrid region, which Prime Minister Pedro Sanchez has called "worrying".

Spain was one of the hardesthit countries when the coronavi-

rus struck Europe this year before a strict lockdown helped

reduce the outbreak's spread. But infections have surged since the lockdown measures were fully removed at the end of June, especially in Madrid, with the rise in infections often linked to the return of nightlife and social gatherings.

COVID-19 patients already fill 16 percent of all hospital beds in Madrid, compared to just six percent nationwide.- AFP

Beirut rescuers detect 'heartbeat' in rubble one month after blast

LEBANON: Rescue workers dug through rubble in a wrecked district of Lebanon's capital Thursday in search of possible survivors from a mega-blast at the adjacent port one month ago, after scanners detected a pulse.

A sniffer dog used by Chilean rescuers on Wednesday night responded to a scent from the site of a collapsed building in the Gemmayzeh area, the city's Governor Marwan Abboud told reporters at the scene.

"There could be survivors," he said, explaining that scanners had detected a pulse, however faint the hope of finding anyone alive more than four weeks after the explosion.

"We hope someone will make it out alive," Abboud said.

Michel al-Mur of the Beirut Fire Department also said a pulse was detected about two metres (six feet) below the rubble.

"One person, according to

The building has completely collapsed as a result of the blast that killed 191 people, wounded more than 6.500 others and destroyed swathes of Beirut. Seven people are still missing,

Speaking to local broadcaster LBCI, a rescue worker said scanners had picked up a

respiratory rate of "19 breaths a minute".

Lebanon on Friday marked one month since the blast that authorities say was caused by a shipment of ammonium nitrate left to languish for years at Beirut's port. - AFP

Ibex return to French Pyrenees

FRANCE: With a bumper litily scamper up cliffs in search of ter of new kids, the recently introduced ibex population in more than a century after the native species of wild goats was wiped out in France.

Officials have counted 70 newborn ibex this year at the Pyrenees National Park (PNP) and nearby Ariege Regional Park in the craggy mountains that separate France and Spain.

The French population now stands at some 400 animals, though they are not the original Pyrenean Ibex, the last two of which in France were shot and killed in 1910.

The Pyrenean Ibex became totally extinct in 2000, when the last known female was found dead on the Spanish side.

The new goats are Western Spanish Ibex, another subspecies of the Iberian Ibex that began to be brought over from a Spanish reserve in 2014.

"In relation to the initial goal the French Pyrenees is thriving of establishing a viable core population, for now we can say the operation has been a success,' Jerome Lafitte, head of fauna operations at the Pyrenees park, told AFP.

For Matthieu Cruege, director of the Ariege park: "These are majestic animals, and it really is exciting when you're able to see them. The ibex really adds to the mountain tourism industry."

New introductions are planned this fall in the Aspe valley closer to the Atlantic Ocean, while next year officials will attempt to diversify the genetic pool by adding ibex from other areas. "We'll have to wait another 30

years to see ibex all across the Pyrenees," said Jean-Paul Crampe, a member of the PNP's scientific committee.

"It's a popular species - and it's much easier to re-introduce Recognisable by their long, than bears or wolves," he said.

Germany-based former national karate champion in kata and kumite Shihan Athula Minithanthri who emigrated to Great Britain in 1987 is offering his services to the land of his birth recalling his origins as committee member of the founding group of the Sri Lanka National Karate-Do Federation in 1975.

Serena advances to US Open last 32, Murray crashes out

NEW YORK, FRIDAY: Serena Williams continued her hunt for a record seventh US Open title with a straight-sets win on Thursday as Andy Murray crashed out in the second round at Flushing Meadows.

Williams, the tournament's third seed, dispatched unseeded Russian Margarita Gasparyan 6-2, 6-4 under the roof of a near-empty Arthur Ashe Stadium on a wet New York evening.

The 38-year-old closed out the first set with ease before a slight wobble in the second when she was broken twice by Gasparyan, before progressing into the third round.

"I'm just happy to get through it and try to focus on the next round," said Williams, who will take on 2017 champion Sloane Stephens in the last 32.

Williams is seeking a record-equalling 24th singles Grand Slam title at a subdued, spectator-free Billie Jean King US National Tennis Center in New York.

A tournament victory next week would also see her break away from Chris Evert, on six titles, as the most decorated US Open champion of the women's game in the modern era. Williams' chances have been improved by the absence of

several top players, included top-ranked Ashleigh Barty and Simona Halep, over coronavirus fears or injury.

She was handed a further boost on Wednesday when top seed Karolina Pliskova tumbled out of the tournament.

The Czech was stunned in straight sets by France's world

number 50 Caroline Garcia. Williams' American compatriot Sofia Kenin, the number two seed, continued her impressive form this year with a

straightforward 6-4, 6-3 victory over Canadian Leylah Fernandez to progress into the third round. The reigning Australian Open champion Kenin is yet to drop a set at Flushing Meadows as she bids for her second

Grand Slam title of the year, and of her career. "I feel like I found a groove. I'm really focused on every shot," said the Moscow-born player who will take on 27th

seed Ons Jabeur of Tunisia in the next round. In the men's draw Andy Murray, slumped to a 6-2, 6-3, 6-4, defeat against a dominant Felix Auger-Aliassime

The 15th seed Canadian smashed 24 aces and 52 winners in a one-sided affair that saw Murray muster just two and nine respectively.

"I just felt like everything was coming in, my toss, my rhythm. Everything was going well through the whole match," said Felix Auger-Aliassime.

Pironkova return

In early men's matches, second seed Dominic Thiem celebrated his 27th birthday with an easy straight-sets win against India's Sumit Nagal. The Austrian triumphed 6-3, 6-3, 6-2 against Nagal, who became the first Indian man since 2013 to reach the second round of a Grand Slam. Thiem will play 2014 US Open champion Marin Cilic for a place in the fourth round after the Croatian advanced in four sets against Slovakia's Norbert Gombos.

"He's one of the big champions of the last decade, Thiem

said of Cilic. "It's not a guy I want to face in the third round."

Third seed and beaten finalist last year Daniil Medvedev made light work of Australia's 116th-ranked Christoper O'Connell, easing into round three 6-3, 6-2, 6-4.

Elsewhere, sixth seed Italian Matteo Berrettini brushed aside France's Ugo Humbert 6-4, 6-4, 7-6 (8-6) while Spaniard Roberto Bautista Agut progressed against Serbian Miomir Kecmanovic. In the women's competition Thursday, Tsvetana Pironkova, returning after a lengthy time away from the game following the birth of her son, advanced at the expense of Garbine Muguruza.

The unseeded Bulgarian knocked out the 10th Spaniard 7-5, 6-3 in 1hr 21 min.

"Coming from three year of absence on the tour, you always have your doubts. Right now my results actually make me really happy because it shows that I did the right things preparing for this comeback," said Pironkova.

Seventh seed Madison Keys of the USA also progressed, making light work of Spain's Aliona Bolsova 6-2, 6-1, while Stephens easily overcame Belarusian Olga Govortsova 6-2, 6-2. British ninth seed Jo Konta became another high-ranking woman to be sent packing, losing in three sets to Romania's Sorana Cirstea after going a set ahead. - AFP


