"An improved method of obtaining cellular structures of rubber and the like."

. Abstract.-The invention relates to a method of obtaining a cellular structure of rubber or the like and more particularly to the coagulation or gelation of a foamed aqueous dispersion of rubber or the like. The foam is preferably cooled to the moderate freezing temperature quickly, the rapid drop in temperature causing a rapid increase in viscosity which arrests the detrimental natural "drainage" of foam with the con-current weakening of the cell walls. The "ice-foam" so formed is either immersed in a bath of coagulating fluid or exposed to an atmosphere of coagulating gases. A partial vacuum may be suitably applied prior to permeation with the coagulating liquid or gases. The well known reaction of sulphur dioxide and hydrogen sulphide may be conveniently applied in this case whereby active sulphur is deposited, producing vulcanization at low temperature.
