The Village Communities Ordinance

ORDER made by the Minister of Health and Local Government under section 6 of the Village Communities Ordinance (Chapter 198), as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947.

ORDER

With effect from the first day of January, 1951, the limits of the Henaratgoda village area in the Divisional Revenue Officer's Division of Siyane Korale West (Meda Pattu) in the Colombo District are hereby altered and redefined by the exclusion from that village area, of the area specified in the Schedule hereto.

Schedule

All that area of land situated in the Divisional Revenue Officer's Division of Siyane Korale West (Meda Pattu) in the Colombo District and bounded as follows:—

North: By a line drawn from a point on the centre of Henegedara Oya in line with the landmark on the south-western corner of the southern boundary of lot 341 in T. S. P. 23 south-eastwards along the landmarked southern boundaries of lots 341, 342, 344, across the Railway line to its eastern boundary, thence southwards along the eastern boundary of the Railway line to the south-western corner of lot 353, thence eastwards along the landmarked southern boundaries of lots 353, 356, 358, 359, 328, 328A, 327, 326A, 326, 325, thence north-eastwards along the eastern boundary of lot 325 to the southern boundary of the road from Moragoda, thence eastwards along the southern boundary of the said road across it to a point in line with the eastern boundary of lot 319, thence northwards along eastern boundary of lot 319, thence eastwards and northwards along the southern and eastern boundaries of lot 316, eastern boundary of lot 315, southern boundaries of lots 296, 298, 302, 314, 313 to the western boundary of the Church Road, thence southwards along the western boundary of the said road eastwards across it to the eastern boundary of the lot 307 in T.S.P.

23, thence eastwards and southwards along the southern boundaries of lots 307, 310, 216, 214, 213, 211, northwards along the eastern boundaries of lot 211 across road to Miriswatta, thence north-eastwards along the eastern boundary of lot 209, thence north-westwards along the western boundaries of lots 209, 208, 208A, to the southern boundary of Yakkala Road, thence north-eastwards across the said Yakkala Road to the landmark at the south-eastern corner of lot 105, thence northwards along the eastern boundaries of lots 105, 104, 49, and 48 to the western boundary of the V. C. Road to Ihalagama, thence northwards along the western boundary of the said road to the centre of Kanukétiya Ela, thence eastwards along the centre of the said Ela to a point in line with the eastern boundary of the foot-path to Ihalagama, thence southwards along the eastern boundary of the said path to the centre of the Ela north of the road to Yakkala, thence eastwards along the centre of the said Ela to a point in line with the eastern boundary of the Batalawatta V. C. Road.

East: By a line drawn from the last-mentioned point southwards across the road to Yakkala to the eastern boundary of Batalawatta V. C. Road, thence southwards along the eastern boundary of the said road to the eastern limit of Bendiyamulla Village, thence southwards and westwards along the said Village limit to the eastern boundary of the P. W. D. road to Miriswatta at culvert No. 28/1.

South: By a line drawn from the last-mentioned point westwards across the P. W. D. Road to Miriswatta and along the centre of the P. W. D. Road north of Midellagahawatta claimed by S. B. de Saram to a point in line with the eastern boundary of Midellagahawatta claimed by S. B. de Saram, thence westwards in continuation of the centre line of the said Ela to a point 200 ft. southwest of the western boundary of the P. W. D. Road to Miriswatta, thence north-westwards parallel to and at a distance of 200 ft. from the western boundary of the said P. W. D. Road to a point on the southern boundary of Maradagahadeniya claimed by S. D. A. Dissanayake, thence westwards along the southern boundaries of Maradagahadeniya and Davatagahawatta claimed by S. D. A. Dissanayake, the southern boundary of Medolghalanda claimed by S. Jayakodi to the southern boundary of the cart track, thence southwards to a point 200 ft. from

the southern boundary of the said cart track westwards, north-westwards, and south-westwards parallel to and at a distance of 200 ft. from the southern boundaries of the said cart track, the Church Road and the Henegedara-Bendiyamulla Road across the Railway line on its western boundary to a point 200 ft. south of the culvert No. 16/2, thence south-westwards along the western boundary of the said Railway line to the south-eastern corner of Elowita Group claimed by H. G. E. Perera, thence westwards along the southern boundary of the said Elowita Group to the centre of Henegedara Oya.

West: By a line drawn from the last-mentioned point northwards and north-eastwards along the centre of the Henegedara Oya to the starting point of the northern limit of the area.

ORDER

With effect from the first day of January, 1951, the limits of the Kotte-Galkissa village area of the Divisional Revenue Officer's Division of Colombo in

the Colombo District are hereby altered and redefined by the exclusion, from that village area, of the area specified in the Schedule hereto.

Schedule

All that area of land situated in the Divisional Revenue Officer's Division of Colombo in the Colombo District and bounded as follows:—

North: By a line drawn from a point on the centre of the junction of Cotta Road with Mirihana Road eastwards to a point 3 chains east of the said junction, thence south-eastwards parallel to and at a distance of 3 chains from the centre of the Mirihana Road and Mirihana-Kottawa Road till it meets the centre of the road leading to Madiwela.

East: By a line drawn from the last-mentioned point southwards parallel to and at a distance of 3 chains from the centre of Mirihana-Kottawa Road till it meets the southern boundary of the Kelani Valley Railway Line.

South: By a line drawn from the last-mentioned point northwards and westwards along the southern boundary of Kelani Valley Railway Line to a point 3 chains east of the centre of Wijerama Temple Road, thence by a line drawn south-westwards parallel to and at a distance of three chains from the centre of the said road to a point five chains south of the centre of the Avissawella Road, thence by a line drawn westwards parallel to and at a distance of five chains from the centre of the said road to the centre of Kesbewa Road.

West: By a line drawn from the last-mentioned point north-westwards and northwards along the centre of the Kesbewa Road and Mirihana Road to the starting point of the northern limit of the area.
