I, Rajapaksha Mohottige Dona Priyadarshani Pushpa Kumari, Divisional Secretary, Hingurakgoda do hereby give notice under Sub-Section (1) of Section 7 of the Land Acquisition Act that actions are taken in respect of acquisition of land for the extension of the Hingurakgoda Air Force Camp as mentioned in the *Gazette* No. 1782/38 dated 02.11.2012 of the Democratic Socialist Republic of Sri Lanka.
