Number of National Schools to be increased to 1,000

A decision was taken to increase the number of National Schools to 1,000 and provide equal facilities to every School, the President's Media Division said. Issuing a statement, the

PMD said several decisions pertaining to the welfare of the public and the progress of society were taken during a meeting between President Gotabaya Rajapaksa and all State Ministers at the Presidential Secretariat on Thursday (10).

"Increasing the number of National Schools to 1,000 in the country is one such decision.

Some of the existing National Schools are there only in name. They lack

adequate facilities. These schools will also be developed expeditiously," the statement said. During the meeting

between the President and the State Ministers it was decided to appoint District **Educational Committees** for the development of the school network.

A decision was also taken to improve coordination between zonal offices and divisional offices.

The opportunity to contribute to any activity that will ensure the progress of the school system except the transfer of teachers and admission of students is available for politicians. TO PAGE 02

World Bank supports Sri Lanka With \$56 mn to mitigate COVID-19 impacts



The World Bank has reallocated \$56 million from ongoing projects in Sri Lanka to protect the most vulnerable in the agriculture sector, improve COVID-19 protection measures on public transport, facilitate tele-education for school children, and provide digi-

tal solutions to improve delivery of public services. This new financing complements the \$128.6 million Sri Lanka COVID-19 Emergency Response and Health System Preparedness Project, which was approved on April 2.

"We have been working closely with the Government of Sri Lanka to support its COVID-19 emergency response and prepare for a resilient recovery," said the World Bank Country Director for Maldives, Nepal and Sri Lanka Faris H. Hadad-Zervos.

"We're moving fast to reallocate financing from existing projects to improve food security and children's education, ensure that people can use public transit without getting sick, and harness digital solutions to continue delivering public services."

The financing will help poor and vulnerable farming households purchase seeds and rehabilitate storage facilities to help ensure food security. It will help facilitate learning at home by tele-education and e-learning for school children, especially in rural, smaller and underresourced schools. TO PAGE 02

PCol probing alleged political victimization reveals

Yahapalana 'Anti-Corruption Committee' wasted over Rs.33 mn

DILSHAN THARAKA The 'Anti-Corruption Committee',

which was set up with the approval of the Cabinet of the Yahapalana Government to look into corruption, has wasted Rs.33,714,807.59 million of government money by committing large scale corruption for 29 months.

This was revealed before the Presidential of Inquiry investigations allegations of political victimization (PCoI) yesterday.

Further, it was revealed that the Anti-Corruption Committee which was set up by former Prime Minister

Ranil Wickremesinghe on January 21, 2015 has paid Rs. 22, 714, 079.27 million to 44 officers who worked for the Anti-Corruption Committee from February 2015 to June 2017.

Evidence also showed that the money was spent on telephones, electricity, overtime, vehicles, fuel, stationery and other expenses.

Accordingly, the Commission has instructed officials of the Prime Minister's Office to expose to the public the massive corruption that established an Anti-Corruption Commission to look into corruption. TO PAGE **02**



Death sentence for drug peddler

A person who was found guilty of possessing and peddling around 30g of heroin was sentenced to death by the Colombo High Court on Thursday.

The accused, Nuwan Sanjeewa (28), a resident of the Mattakkuliya area in Colombo was arrested with 29.71g of heroin in his possession by the Ports Anti-Corruption Division on or about April 16, 2018 from the Inguru Kade Junction area in Colombo.

When the case was taken up before the Colombo High Court Judge, he issued the verdict after a lengthy trial while observing that the prosecution had proved the case beyond reasonable doubt.

Considering the facts, the Colombo High Court

sentenced the accused to death.

Main railway stations to be modernised

SLMC's delisting of three prominent State Universities

Russian Govt. expresses serious concerns

The Russian Government has expressed serious concerns over the Sri Lanka Medical Council (SLMC) decision to delist three prominent State Universities including world renowned Patrice Lumumba University.

The Russian Government has been awarding Sri Lanka with scholarships from State universities since the establishment of diplomatic ties between the two nations and thousands of Sri Lankan students have graduated from Universities of Soviet Union and Russian Federation since then. A Senior official of the Russian Cultural Centre who wished to be anonymous told the Daily News yesterday that the two countries had signed an agreement recognising the degrees offered by the Russian and Sri Lankan

He said over 1500 students who have excelled in the Advanced Level examinations are presently studying in

Sri Lanka and the Russian Federation have signed a number of agreements promoting almost all sectors including education since the establishment of diplomatic relations 60 years ago. The SLMC decided to delist three prominent state universities, namely the People's Friendship University of Russia (Formerly known as Patrice Lumumba University), Pirogov Russian National Research Medical University and the Tver State Medical University.

SLMC sources said that this decision was taken following a thorough review. He said that the Council had arrived at this decision before the COVID-19 pandemic and the decision was announced at the SLMC Annual General Meeting in June.

Meanwhile, the Russian Centre in a media communique yesterday said that this decision has been taken by the SLMC without prior information despite the fact that the SMC held several meetings with the officials of these Russian Universities who visited Sri Lanka throughout the past years, and regular payments to the SLMC were made by the universities in order to maintain the membership.

'The Cultural Section of the Russian Embassy hopes that the SLMC's decision will not influence the practice of providing Russian State Scholarships to Sri Lankan citizens in future, causing a loss of opportunities to young individuals to pursue their higher education free of charge in prominent Russian universities," the statement said.

It will also help create a safe and hygienic school environment for students once in-person lessons resume.

The financing will also help ensure that essential public transport is disinfected and equipped with hand sanitizers, protective gear and body temperature screening equipment, and also support a digital document management system to improve public services to

improve collaboration across government using digital technology and video conferencing to facilitate

work from home. These funds were made available by activating the Contingency Emergency Response Components (CERC) of four active projects. CERCs allow funds to be reallocated from existing projects to address emergency response needs. Funds for a total amount

The President made an open invitation to all the pharmaceutical importers to invest in manufacturing medicine locally.

An Investment Zone for local investors will be established in a 100-acre land at Oyamaduwa, Anuradhapura. Twenty-five medium scale businessmen are prepared to invest a sum of US\$ 300 million in this endeavour. A considerable improvement is evident in local pharmaceutical production owing to the efforts of the incumbent government. It has been revealed that currently there is no shortage of essential medicine within the country. Producing a new medicine each month

had already been commenced. The target is to elevate this practice in the future to one new medicine every fort-

It takes nearly a year to process the documents of registration in pharmaceutical manufacture. The President highlighted the significance of making legal amendments to expedite this process immediately. It was decided to establish a new unit within the Medicines Regulatory Authority to address issues including the registration of locally manufactured pharmaceuticals.

In addition, it was also discussed to set up 100 pharmacies in islandwide network of Sathosa and Coop Supermarkets to sell medicine manufactured by the State Pharmaceuticals Corporation of Sri Lanka(SPC). Moreover, a procedure to supply pharmaceutical requirements of the households to their doorstep was taken into consideration as well.

The Commission recalled the testimony of Ranil Wickremesinghe and Mangala Samaraweera who testified before the Commission recently that the Anti-Corruption Office was an institution with no legal status and did not know whether such an office was opera-

The commission also said that former Prime Minister Ranil Wickremesinghe and former Minister Mangala Samaraweera should know whether such an office was functioning at Tem-

According to the sub-Cabinet report in Ranil Wickremesinghe's Cabinet Memorandum, the Commission's Presiding Judge, former Supreme Court

Justice Upali Abeyratne stated that there was nothing wrong with publishing this massive corruption in the media as it was one of the functions of the media to publish office activities. At a previous occasion, The Presi-

dential Commission of Inquiry investigating allegations of political victimization issued notice to Secretary to the Prime Minister, Gamini Sedara Senarath to testify before the commission regarding whether wages had been paid to the office bearers of the 'Anti-Corruption Committee' which set up by former Prime Minister Ranil Wickrem-

The charge sheet in the Magistrate's Court contained five counts as follows: culpable homicide not amounting to murder, failure to avoid an accident, reckless driving, driving under the influence of liquor and driving a vehicle which is not roadworthy.

The accused pleaded not guilty for each and every count and the case was fixed for trial. When the case was fixed for trial, the Attorney-at-Law on behalf of the accused pleaded guilty for the aforementioned charges. The accused alleged that the Attorney-at-Law appeared for him had pleaded guilty without the instructions of the accused. Also the accused submitted that he is a native Tamil Language speaker and was unable to understand the discussion in Sinhala between the Magistrate and the Attorney-at-Law. Soon after the particular incident the accused has filed an Affidavit with the instructions of another Attorney-at-Law stating that the plea of guilty was without the knowledge of the accused.

However, the Kesbewa Additional Magistrate rejected the application and proceeded to convict the accused and sentenced by his order dated 29.07.2019. Being aggrieved by the said order of the Additional Magistrate, the accused filed a revision application in the Provincial High Court of Homagama and the High Court Judge of Homagama refused to issue notice to the Respondents by his order dated 04.09.201 9. Being aggrieved by the said order the accused filed this revision application before the Court of Appeal.

The Court of Appeal observed that in terms of Section 182 (2) of the Criminal Procedure Code, the Magistrate should read the Charge to the Accused and ask him whether he has any cause to show as to why he should not be convicted. In response to it, if the accused makes a statement which amounts to an unqualified admission that he is guilty of the offence which he is accused of, his statement shall be recorded then and there in the same words used by him. Thereafter, the Magistrate shall record a verdict of guilt and pass the sentence upon him according to law and shall record such sentence in light of Section 183.

"When considering the above mentioned sections, it is evident that the Magistrate should record what the accused had stated in his own words. Specially, a plea of guilt should come from the mouth of the accused person and not the Attorney-at-Law," the Court of Appeal

The Court of Appeal further observed that the accused promptly took actions to submit an affidavit stating that such plea of guilty was without his knowledge.

Accordingly, the Court of Appeal ordered to set aside orders of the Homagama High Court dated 04.09.2019 and the order of the Additional Magistrate of Kesbewa dated 02.07.2019. The accused was ordered to be discharged. The Court of Appeal Registrar was directed to send copies of the orders to the relevant High Court and the Magistrate's Court with the case record.

Counsel Ashan Nanayakkara and Subhani Abeysekere instructed by Anil Bandara appeared for the Accused. Senior State Counsel Maheshika Silva appeared for the respondents.

"Of course we have not deprived them of any facility," he said.

"Of about 45 prisoners who were on strike since Thursday morning, 15 have abandoned their protest,

Even today, the CWC and other political parties representing the Upcountry Tamil people are fighting for their basic rights and privileges to be recognized. Therefore, when such fundamen-



tal nature of those people's cries is even prevalent today, to have to represent those people for decades is not a very easy task, by any means," the TNPF Leader said.

Referring to Arumugam Thonadam's grandfather, Saumyamoorthi Thondaman, and his contribution to the upcountry Tamil people, Ponnambalam said, "He was a colossus and an

institution in his own right; not only in building up the trade union movement into a political party, but also going beyond to command the respect of all sections of society.

"For his grandson to have to fill the shoes of that colossus is the most unenviable task one can be asked to do. Late Arumugam Thondaman did that in a very quiet way," he added.

MP Ponnambalam referred to several comments made in Parliament yesterday during the Condolence Motion for late Arumugam Thondaman, adding that the Thondamans despised the 'Tamil Eelam' struggle.

"Right along, they have both identified themselves with the struggle; late Saumyamoorthi Thondaman was a co-founder of the Tamil United Front, which was formed on May 4, 1972," he added.

"It was in 1976, when the TUF graduated to the TULF after the 'Waddukodai Resolution' that Thondaman decided to take the CWC out of that organization as he felt that when the Waddukodai Resolution was passed; and when the aspirations of certain people was for the creation of a separate state, he felt the Upcountry Tamil people's future was not along that path," the Parliamentarian said. The TNPF leader gave the

assurance while speaking in Parliament, yesterday, that his party will unconditionally support State Minister Jeevan Thondaman or any leader working to address the issues of the Upcountry Tamils in order to win their rights and privileges. He said the Upcountry Tamils are a deserving community living in Sri Lanka.

Too late to object Premalal's Parliamentary appointment: Speaker

Speaker Mahinda Yapa Abeywardena said it was too late to object Premalal Jayasekera becoming an MP and the Opposition had had to raise the matter before the Court of Appeal before it was decided to allow Jayasekera to take oaths.

The Speaker made this observation when Opposition Leader Sajith Premadasa raised objections to Jayasekera taking oaths as an MP in line with the Court of Appeal order. The court informed Parliament of its ruling to permit Jayasekera; "We carried out that order," Speaker Abeywardena said.

Leader of the House Dinesh Gunawardena said that the Speaker has already given a ruling on the matter, and that it cannot be put to debate. "That is against the Standing under the pretext of Points of Order, the Opposition keeps harking back to a past issue. This matter is over. Now these Points of Order are unjust to people who had voted for MP Jayasekera. You cannot raise Points of Order to discuss a matter pertaining to a ruling of the Speaker. If there is a matter against the ruling of the Chair, then there is a procedure. You have to bring it in the form of a Substantive Motion. There you have provisions to raise the issue in a motion. Then we could debate it here," the Leader of the House added.

Opposition Leader Premadasa, raising a Point of Order, said that by allowing Jayasekera to take oaths, the Speaker had set a wrong precedent. "In 1982, Selvarajah Yogachandran, also known as 'Kuttimani', one of the leaders of the TELO, was nominated to Parliament. His name was gazzetted to become an MP. However, then Speaker Bakir Markar, citing the Sections 89 and 91 of the Constitution, did not permit Yogachandran to take oaths as an MP because the latter had been sentenced to death. Yogachandran, too, had appealed against the sentence," he added.

'That is the precedence in Parliament. That should not have been breached. As per Section 91 (1) (a) of the Constitution, no person shall be qualified to be elected as a Member of Parliament or to sit and vote in Parliament if he is or becomes subject to any of the disqualifications specified in Article 89. Section 89 (d) of the Constitution says that no person shall be qualified to be an elector at an election of the President, or of the Members of Parliament, or to vote at any referendum, if he is under sentence of death and he will lose his right to vote under such a sentence. The Speaker, by act of permitting Jayasekera to take oaths, has violated Constitutional provisions," the Opposition Leader

Chief Opposition Whip and Kandy District MP Lakshman Kiriella said that when the court gave an order that former Chief Justice Shirani Bandaranayake could not be subjected to questions of a Parliamentary Select Committee, then speaker Chamal



Rajapaksa ignored it, stating that Parliament is not bound to follow court orders. "Speaker Abeywardena said that it was a separate issue; that it has nothing to do with the issue at hand," he added.

Kurunegala District SJB MP Nalin Bandara Jayamaha said, "The Executive, Legislature, and Judiciary are the three main pillars of Government. The Speaker is the head of the Legislature. This matter should be taken seriously."

Speaker Mahinda Yapa Abeywardena said to move to the business of the day as the debate was deviating from what was in the Order Paper.





Don't overlook **Dengue**

with the nightmare of the Coronavirus largely behind us there could be a tendency on the part of the public to drop their collective guard as regards lesser diseases in our midst that had been common in this country. Dengue appears to be rearing its ugly head once again with 26,000 cases reported up until August and 25 deaths.

The onset of the monsoons and the massive floods that submerged many parts of Colombo City following the heavy downpours is bound to aggravate the situation. Last year a total of 105,000 dengue cases were detected with 95 deaths. All precautions, therefore, need to be taken to avert such a situation during the remaining months of this year. Certainly this is not going to pose a problem for the health authorities given that the Covid-19 defence apparatus is still very much intact which could be depended upon to act in an emergency although dengue is a different kettle of fish that is far widespread in this country as an epidemic.

The Epidemiology Unit has warned the public to be vigilant of all types of mosquito breeding sites and to destroy them regularly. Construction sites are one of the most congenial spots for mosquito breeding together with abandoned structures and old rambling and unoccupied homes that could be found in many cities. Schools that were closed down for over four months may also be vulnerable. It is not known if these schools did a proper cleanup before reopening or if the mosquito breeding spots received due

President Gotabaya Rajapaksa won high praise from all quarters for taking steps to promptly deal with the Coronavirus pandemic before things got out of hand by deploying health teams together with the Tri-Forces to tackle the emergency. A similar response will be anticipated from the health officials to deal with the dengue epidemic as well, perhaps with greater intensity. While the Coronavirus cases numbered only a little over 3,000 and 12 deaths in this country dengue is known to claim a far heavier toll. Hence, the same efficiency, commitment and dedication shown by the health officials is called for in dealing with dengue, if not more, since, as already mentioned, more monsoonal rains have been forecast giving rise to a spike in the number of the vic-

Initial measures should be promptly put into operation that would minimize the impact. All construction sites, neglected buildings, dilapidated structures etc. should be smoked out to destroy the mosquito larvae. All polluted canals should be cleaned up especially those lying alongside shanty dwellings. The cleanup ought to start from Government offices and buildings which appear to be the worst offenders. Stiff penalties should be slapped on residents and households who willfully neglect their surroundings, inviting the breeding of mosquitoes.

The Grama Sevekas should be asked to keep a constant vigilant eye for signs of dengue risks in the designated divisions and work in tandem with the PHIs. It will be ideal if the relevant health officials fan out across the country to curb the dengue threat. Special programmes should be conducted in schools to educate the children on the dangers of the denque epidemic and precautionary steps to be adopt-


A Presidential Task Force should be set up for the Prevention of Dengue. Nothing will move faster in getting into action unless it is under the watchful eye of the President as we have seen during the Coronavirus pandemic and other emergencies.

Reforming the Police

he physical assault on a police party who went on a drugs raid to a house in Bandaragama on Wednesday, no doubt would have appalled many who witnessed the scene on television and left many wondering if the police would be able to perform the task of protecting the ordinary public anymore. Such a scenario would certainly have been incomprehensible decades ago when the khaki uniform evoked awe and respect that made criminals and wrong doers running for cover at the sight of a guardian of the law. The manner in which the policemen (including two WPCs) were manhandled and the fierce nature of the assault was a clear indication that the Police no longer held any fears for law breakers. Perhaps, the police have brought this upon itself. The recent spate of arrest of police officers for drug running, collusion with the narcotics underworld, their shenanigans in the prisons, revelation of details of their well stacked bank accounts from illegal activities etc., have all contributed to the esteem of the police service taking a heavy beating with the result that its officers have now lost for them that element that drew fear and dread of the khaki uniform, by breakers of the law. Things should be put right without delay by reforming the Police service and restoring public confidence in it.

ndeniably, one of the most attractive developments witnessed in the city of Colombo of late is the planned improvement of its parks and walking tracks. While the very popular Independence Square walking track is the star of the category, there are several other walks that were developed about the same time: Nawala, near Parliament, Waters Edge, Bellanwila to name a few. These popular facilities have not only positively altered the appearance of what was once a derelict, war-scarred city, they also, while providing the city dweller a pleasant open area for working out, have improved the air

Colombo is changing helter-skelter, high rise buildings sprout up virtually overnight; in a 10 perch plot of land where earlier one family had their residence, now stands an apartment block, perhaps housing twenty families. They demand services; power, water, garbage disposal, parking space for their vehicles. In this urban monstrosity, where space equals big money, clean air and open spaces are losing out in priority.

PARKS AND WALKING **TRACKS**

In the overall scheme of things, one may play down the significance of maintaining parks and walking tracks. But you would not do that after experiencing a Government which could not even manage that minimum, relegating parks to the insignificant, neglecting them; left with rutted walks, overgrown grass and burnt out lights. Recent history has taught us that Governments that cannot deliver on small things, will invariably fail on the large matters; peace, economy,

In this country, good examples are overlooked, while any shoddy deed is eagerly copied and multiplied. When once neglected parks are cleared, enclosed and walled public spaces are opened up and made wholesome, there is no response from counterpart sports grounds occupying other Government, ultimately public lands. These various grounds, in the different parts of the city, are generally sport specific; mainly Cricket, some managed in the form of clubs, others claimed by schools. In these places, walls are not coming down, barricades are going up.

Most cricket grounds in the city are now being turned into stadiums, ugly concrete structures are constructed around, constricting them; where once sparkling green expanses soothed the eye, the gloomy rear side of the stadium now glares; forbidding, hostile and grimy. In my youth, the area bordered by Park Road, Havelock and Greenland Roads was park like, beautiful greenery extending away in every direction. In this one invaluable location we had several

sports clubs: the BRC, the Havelock, the Colts, a Soccer ground and even a children's park. We saw hockey, a lot of softball cricket for the youngsters, even tennis at the Colts, and there were no ugly walls. The different grounds were ringed by thoughtfully planted Cassia, Flamboyant and Neem trees; majestic, provid-

ing a cool shade, the gentle breeze rustled the leaves.

The very philistine idea now prevailing seems to be that Cricket will become a massive spectator game, raking in the millions. It is not enough that we have in Colombo, the SSC, the Tamil Union and the Khettarama stadiums; any ground will swell with thousands coming to watch 22 young men battling it out occasionally. It matters not how often these contests are held. Every club committee is eager to build stadiums, a venture, temptingly open to not so sportsman like motives.

SPORTING ACHIEVEMENTS

Like in many other things, have we lost our way here? Even is sports, such a disorganised, mutinous development bodes ill. No one sport can thrive, if the spirit of the outdoors, the exhilaration of the green, the joy of a gentle walk is denied to the millions. One cannot conceive of sporting achievements, when to the average person in the country, a green is something he can only see inside a concrete stadium, and that, only after paying to enter the enclosure.

It is clear that while we have placed all bets on one game, Cricket, the overall sporting standards have dropped drastically. Sri Lanka hardly counts in other sports and athletic events, reduced to celebrating an occasional Bronze; due to its rarity, the celebrations for the consolation prize going over the top. In most athletic events, we have steadily retreated below international standards, often failing to even qualify to participate, performing below entry level competence.

Even in Cricket, an extremely chancy sport, achievements are few and far between. A nation not given to a general outdoor sporting culture, simply cannot thrive on a myth of

Of all the grounds that have lost their way, probably the most pathetic is the fate of what is referred to as the Shalika, formerly known as CTB grounds at the Lanka Hospital (Apollo) end of Park Road. This area used to be semi-marsh, in an earlier era I am told, eager golfers practiced here. Later, during the socialist days of the early 1970s the grounds ended up with, of all institutions, the Ceylon Transport Board (CTB).

Those who in the 1960s and 70s were victims of its deplorable service, will tell you that the CTB was one of the reasons for the drubbing the then Government received at the 1977 General Elections. When it was floundering so badly in providing public transport, its core service, how it managed a sports ground, needs no elaboration.

This is a very residential area; for the residents of the adjacent Anderson Flats (Golf-links Flats) Park Road,

application for a National Identity Card.

A visit to the corner photo shop is necessary as two 'stamp size' photographs must be attached to the form. Before submitting the form, it needs certification by "an amortized person", perhaps half a day spent searching for a Justice of Peace. In addition to this unbelievable run-around, there is a Rs. 1,000 being levied annually from the "jogger'.

WORSE MAINTAINED GROUNDS

Primarily a transport provider, the CTB, can be forgiven for being a poor groundsman. Shalika must be one of the worse maintained grounds in the city; uneven surface, grass growing wild, often water logged and mosquito infested, they are clearly challenged in the art of park maintenance. Even in design, the complex is primitive. The main gate at the Anderson Flats end opens into the "jogger's toilet", a good fifty years old, unmistakable, the stench hits you yards away.

One evening, about two years back, I was at the Shalika Grounds, there were only a few walkers at the time, when I saw some men hastily opening the gate on the Park Road side to allow a convoy of impressive looking cars to drive in. There were several men, in the standard white shortsleeve shirt and dark trouser of security staff. They were waiting for something to happen or someone to

After about half an hour, we heard the drone of a helicopter which appeared presently, landing in the middle of the green. The cars drove even closer to the helicopter. A few persons alighted from it and quickly got into the cars, which then drove off. Making inquiries, we learnt that it was a well- known businessman who was also a leading personality in the then Government. The helicopter was privately owned we were told. I do not know whether landing rights were previously arranged with the CTB or if there was a payment

This scene stayed with me, the suggestion of power, of mystery; the overpowering sound of the helicopter, the cars with tinted windows, the fussing security detail, clashing sharply with the surrounding feebleness, neglect and inefficiency. It could easily be from a Graham Green thriller, a sharp display of power and glitter, all the more effective in that neglected ground, having neither.

As for Shalika Grounds, the only remedy I can see is in the form of an intervention by the UDA (Urban Development Authority); either they run it as a public service, or lease the grounds to an appropriate sports club to develop it, with meaning and purpose for the people of the area.

is not a concern. Surrounded by a dilapidated, mildewed wall built a good fifty years ago, a patch of green guarded by a large squadron of security guards, (while the BRC, Colts, not even a quarter mile away have at most times just one doorman) the ground has become meaningless. Its purpose is not to serve the neighbourhood, the Shalika is a mere grass patch, maintained for no conceivable reason, other than to provide passive employment to a few men.

If you are looking for some fresh air, Shalika grounds is not the place to go, the security will stop you. For entry, you need a 'pass' issued with incredible formality by the CTB. UK THREATENS TO BREAK INTERNATIONAL LAW ON BREXIT

ne UK is drawing up legislation that will override the Brexit Withdrawal Agreement with the European Union on Northern Ireland, a move that threatens the collapse of the EU - UK talks, and is widely regarded as a violation of international law, and so accepted by the Conservative cabinet secre-

PM Boris Johnson will put an ultimatum to negotiators this week, saying the UK and Europe must agree a post-Brexit trade deal by October 15 or Britain will walk away for good.

Progress on the already fragile talks will be threatened by plans by the UK government's controversial section of the internal market bill that will intentionally try to unpick parts of the Withdrawal Agreement signed in January, including elements of the special arrangements for Northern Ireland that are legally binding.

The UK's Northern Ireland Secretary Brandon Lewis told the House of Commons a new bill to amend the UK's Brexit deal with the EU will "break international law". He conceded it would go against the treaty in a "specific and

Senior Conservative MPs and many legal experts urged the government not to go ahead with plans to drive through a change to the Brexit agreement on Northern Ireland, after it has been conceded it would break international

Many analysts see this as moving towards a "No Deal" exit from the EU, which has been a key aim of Boris Johnson from the beginning of the Brexit process. There are also concerns this move would be a breach of the Good Friday Agreement that brought peace between the UK and the Irish Republic.

Former PM Theresa May warned the change could damage "trust" in the UK over future trade deals with other states.

The permanent secretary to the Government Legal Department, Sir Jonathan Jones, has announced his resignation in light of the bill, making him the sixth senior civil servant to leave Whitehall this year. Sir Jonathan, who is the government's most senior lawyer, is understood to have believed the plans went too far in breaching the government's obligations under international law.

Labour leader Sir Keir Starmer condemned the bill and accused No 10 of "reopening old arguments that had been settled", saying the "focus should be on getting a [trade] deal done"

The new UK moves are expected to "eliminate" the legal force of the Withdrawal Agreement in areas including state aid and Northern Ireland customs. As part of the terms of the Northern Ireland Protocol, the region is expected to continue to follow some EU rules after the transition period ends in 2021 to ensure there is

no hard border. Labour said the prime minister was "threatening to renege on the UK's legal obligations" and called it "an act of immense bad faith: one that would be viewed dimly by future trading partners and allies around the world".

The news was condemned by Ireland's Foreign Affairs Minister, Simon Coveney, who helped broker the original Brexit settlement. He said any change would be "very unwise".

It reported that the US will be opposed to this move, as it was very strongly supportive of the Good Friday Agreement, signed in 1998, between the British and Irish governments, and most of the political parties in Northern Ireland. on how Northern Ireland should be governed.

Key figures close to the negotiations have already warned that EU leaders and heads of state must intervene before the end of the month to save the talks from collapse. Industry leaders have previously said no deal would spell disaster for the UK, with tariffs imposed on goods sending costs for industry and consum-

Brexit negotiations reopen in London with a warning from the European commission president that Britain must respect international law. The EU's Ursula von der Leyen said "I trust the British government to implement the withdrawal agreement, an obligation under international law & prerequisite for any future partnership," as posted on Twitter. "[The] protocol on Ireland/Northern Ireland is essential to protect peace and stability on the island & integrity of the single market."

Business leaders warned that a Brexit deal was essential for safeguarding Britain's economic recovery from the coronavirus outbreak and avoiding higher prices in the shops for British consumers as pressure mounts on household finances. Manufacturers have warned that Brexit stockpiles had been depleted during the Covid lockdown and many firms were running out of cash and time to prepare for leaving the EU. Retailers warned that the price of food and drink could rise due to border disruption, the imposition of tariffs and a weaker pound.

The pound fell on Monday as City investors bet on the growing likelihood of the UK leaving the Brexit transition without a deal. Sterling fell about 1% against the US dollar on Monday to trade below \$1.32, and fell by a similar amount against the euro to below €1.12 on the international currency markets.

INDIA - CHINA TALKS

India's External Affairs Minister S. Jaishankar and his Chinese counterpart Wang Yi are set to come face-to-face at least three times in Moscow this week, with the bilateral meeting being seen as key to reducing tensions along the Line of Actual Control (LAC) in the Himalayas.

Jaishankar and Wang will participate in a meeting of foreign ministers of the Shanghai Cooperation Organisation (SCO) on Thursday morning, to be followed by a luncheon meeting of foreign ministers of the Russia-India-China (RIC) grouping.

This will be the first between Jaishankar and Wang since the standoff in Ladakh sector began in May. The two leaders spoke on phone on June 17, two days after the deadly clash in Galwan Valley that left 20 Indian soldiers dead and caused an unspecified number of Chinese casu-

Ahead of his departure for Russia, Jaishankar emphasised the need for political contacts to reduce tensions and end the stalemate in the disengagement process along the LAC. The standoff goes against all understandings on border management dating back to 1993 and the serious situation calls for "very deep conversations...at a political level", he said.

The RIC meeting between Jaishankar, Wang and their Russian counterpart Sergey Lavrov assumes significance as Moscow has pushed for dialogue between New Delhi and Beijing to ease the border tensions. Given its good ties with India and China, Russia also doesn't want

to be forced into taking sides, experts said. Roman Babushkin, the Russian deputy chief of mission, said on Tuesday his country wasn't directly mediating between India and China but was "focusing on the creation of a positive atmosphere through SCO, Brics and RIC for practical cooperation". He added: "Any kind of dialogue would be better than escalation."

China and India have accused each other of firing shots on their flashpoint Himalayan border in a further escalation of military tension between the nuclear-armed Asian rivals.

The situation between India and China has deteriorated since the combat clash in the Ladakh region in June this year, where 20 Indian troops were killed. There are no con-

firmed reports of Chinese troops killed there. Beijing's Defence Ministry accused India of 'severe military provocation' saying soldiers crossed the Line of Actual Control (LAC) in the western border region on Monday and "pened fire to threaten border defence patrol officers". According to the Chinese, Chinese troops approached the India side for negotiations, when some Indian troops fired at the Chinese

New Delhi has given a swift response, accusing Chinese border forces of 'blatantly violating agreements' and 'firing a few rounds in the air' to intimidate the Indian troops. "It is the PLA that has been blatantly violating agreements and carrying out aggressive manoeuvres" the Indian Army said on Tuesday.

Both sides have sent thousands of troops to the disputed Himalayan border, which sits at an altitude of more than 4,000 metres (13,500 ft).

Less than two months to go before the US presidential election, former Vice-President Joe Biden, the Democratic party's nominee, is polling ahead of incumbent Republican President Donald Trump in key battleground states, though he has seen his lead narrow in some states since the summer.

National polls show Mr. Biden at a significant advantage. White seniors in particular, a group that helped propel Mr. Trump to victory in 2016, have shown signs of disapproval towards the president's handling of the pandemic. The Black Lives Matter activist actions have dual reactions, with increased support for Joe Biden among mixed communities, and the anti-Black and Law & Order supporters for Trump, especially from the White communities. Reports of President Trump making disparaging remarks about US soldiers who were captured or killed in battle, have brought a major negative for him in the current polling.

According to *The Atlantic* magazine, Mr. Trump cancelled a visit to a US cemetery outside Paris in 2018 because he said it was "filled with losers". During a visit to France in 2018. Mr. Trump cancelled a visit to the Aise-Marne American Cemetery, and at the time the White House blamed poor weather. However The Atlantic reported he rejected the idea of visiting because the rain would dishevel his hair, and he did not believe it important to honour America's war dead.

But in a tweet, the president denounced the claims as "made up fake news". Speaking with reporters, Mr. Trump called *The Atlantic's* report "unthinkable".

"To think that I would make statements negative to our military and our fallen heroes when nobody's done what I've done with the budgets, with the military budgets, with getting pay raises for our military," said the president. "It is a disgraceful situation by a magazine that's a terrible magazine."

These reports and the responses to them from US Forces personnel, and some Republicans too, have placed Trump in a tough situation in drawing voter support, which is also affected by has bad handling of the Covid 19 pandemic, with the US having the highest numbers infected more than 6,350,000 and more than 190,869 dead.

September 7 - the Labour Day holiday, signifies the beginning of the most aggressive stretch of campaigning in the presidential poll. In the campaigning from this day Trump is largely engaged in claims of a sooner-thanexpected coronavirus vaccine, and the hurling of insults at rival candidate Joe Biden, and his Vice President candidate Kamala Harris. He has called Biden a 'stupid person'.

Joe Biden is attacking Trump as one who is 'not made of the same stuff' as working Americans, and has obtained support of the country's largest trade union federation. Biden has said that Trump, a billionaire, 'lives by a code of lies, greed and selfishness' and is 'not made of the same stuff' as the US working

The National polls are a good guide as to how popular a candidate is across the country as a whole, but they're not necessarily a good way to predict the result of the election. In 2016, for example, Hillary Clinton led in the

polls and

won nearly three million more votes than Donald Trump, but she still lost - that's because the US uses an electoral college system, so winning the most votes doesn't always win you the election. In the electoral college system the US uses to elect its president, each state is given a number of votes based on its population. A total of 538 electoral college votes are up for grabs, so a candidate needs to hit 270 to win.

Mass protests continue in Belarus against President Alexander Lukashenko who claimed to win a national election by 80 percent more than a month ago.

Amidst protests this week, Maria Kolesnikova, a prominent female Belarusian opposition leader, resisted efforts to deport her to Ukraine, by ripping up her passport at the border. The Interfax-Ukraine agency reported: "When attempting to deport her, she tore her passport and could not be allowed into the territory of Ukraine by border guards.'

Deputy Ukrainian Interior Minister Anton Gerashchenko said in a Facebook post that Ms. Kolesnikova, who had been missing for the past 24 hours, successfully prevented "a forcible expulsion from her native country".

"Maria Kolesnikova was not able to be deported from Belarus as this brave woman took steps to prevent herself from being moved across the border," he said. "She remained on the territory of the Republic of Belarus. Alexander Lukashenko is personally responsible for her life and health."

Since the contested vote on August 9, large protests have taken place in the former Soviet country, which borders Russia and has been ruled by Mr. Lukashenko since 1994.

Some 100,000 demonstrators took to the streets at the weekend and the protest movement shows no sign of waning after four weeks of mass demonstrations and strikes.

Emboldened by the backing of Russian President Vladimir Putin, Mr. Lukashenko has denied vote-rigging and accused foreign powers of trying to topple him in a revolution.

It is now reported that Belarusian, Russian and Serbian military forces will take part in joint military exercises in Belarus, the RIA news agency cited Belarus' defence ministry as saving on Tuesday.

The Russian and Serbian forces would arrive

in Belarus from September 10 to 15. Opposition candidate Sviatlana Tsikhanouskaya who claimed to have won a decisive firstround victory with at least 60% of the vote, and called on Lukashenko to start negotiations. Her campaign subsequently formed the Coordination Council to facilitate a transfer of power and stated that it was ready to organise "long-term protests" against the official results.

She has called for people to demonstrate peacefully over the weekend while accusing the authorities of turning the protests into a "bloodbath". Tikhanovskaya fled to Lithuania after publicly denouncing the results which handed victory to the incumbent Alexander Lukashenko, who has been in office for 26

INDIA - FRANCE - AUSSIE TALKS

India, France and Australia on Wednesday jump started a new strategic alliance proposed by French President Emmanuel Macron two years ago, with the first meeting of top foreign ministry officials of the three countries. Maritime security in the Indo-Pacific region got the

top billing at Wednesday's video conference.

The officials spoke about "enhancing maritime security cooperation" including maritime domain awareness, mutual logistics support and capacity building of other friendly countries in the Indo-Pacific region.

There was broad agreement among the three partners that they should look at a multipolar world where countries join hands for mutual benefit and support rather than a unipolar or multipolar world.

China did figure in the discussions but the meeting wasn't focussed on one country. The virtual meeting was co-chaired by India's Foreign Secretary Harsh Vardhan Shringla, secretary-general in French ministry for Europe and foreign affairs François Delattre, and secretary in Australian department of foreign affairs Frances Adamson.

French President Macron was among the first to call for building a strategic alliance between the three countries that could respond to challenges in the Asia-Pacific region and the growing assertiveness of China. On a visit to Australia back in May 2018, President Macron had spoken about the need for the partners to 'organise' themselves. "We're not naive: if we want to be seen and respected by China as an equal partner, we must organise ourselves". He also said: "This new Paris-Delhi-Canberra axis is absolutely key for the region and our joint objectives in the Indian-Pacific region".

Visiting India later, President Macron and Prime Minister Narendra Modi unveiled a blueprint to step up cooperation in the Indian Ocean to counter China's growing influence in the region. "The Indian Ocean, like the Pacific Ocean, cannot become a place of hegemony," President Macron said, as the two countries signed pacts that gave Indian warships access to French naval bases in the Indian Ocean.

At Wednesday's meeting, Indian Foreign Secretary Shringla underscored PM Modi's vision for the Indo-Pacific that he had articulated at the Shangri-La Dialogue in 2018 to promote the concept of Security and Growth for All in the Region or SAGAR.

SOUTH AFRICA / INDIA - COVID IMPACT

South Africa has become the worst hit country on its economy and growth due to Covid 19. South Africa's gross domestic product (GDP) contracted 51.0% in the second quarter of 2020, due to the impact of COVID-19 lockdown restrictions which were imposed from late March 2020 until June.

The manufacturing industry contracted by 74.9% in the second quarter, and all ten manufacturing divisions reported negative growth rates in the second quarter," the statistics agency said. The trade, catering and accommodation industries decreased by 67.6%.

The mining and quarrying industry decreased by 73.1% contributing to -6.0 percentage points to GDP growth.

South Africa's latest Covid 19 infections are

642, 431 and 15, 168 deaths.

India on Thursday recorded its biggest oneday COVID-19 case rise yet, with nearly 96,000 fresh cases in the last 24 hours bringing the total number to date to 4.4 million. Indian Health Ministry figures Thursday morning showed that 95,735 new cases and 1,172 deaths were recorded in the country.

This is for the first time India has witnessed such a huge increase on a single day. With a massive increase of coronavirus cases on a daily basis, the country recently surpassed Brazil to become the country second-worst hit by the virus. Total COVID-19 related deaths in India have now reached 75,062.

Indian experts say that by the end of September India may even surpass the US - the worst-affected country worldwide - in the severity of the pandemic.

NAVALNY

Doctors treating Russian opposition figure Alexei Navalny say he is out of an induced coma and his condition, since being poisoned, has improved.

Mr. Navalny, 44, was flown to Germany after falling ill on a flight in Siberia in August. German doctors say the Putin critic was poisoned with a Novichok nerve agent.

The US Secretary of State Mike Pompeo has said there was a "substantial chance" the poisoning of Navalny was ordered by senior Russian officials. Pompeo reiterated that the United States and its European allies all wanted Russia to "hold those responsible for this accountable" and said Washington would also try to identify the perpetrators.

The UK Foreign Secretary, Dominic Raab, said the Russian ambassador was being summoned over the incident. "It's completely unacceptable that a banned chemical weapon has been used and Russia must hold a full, transparent investigation," he said in a statement. The German chancellor, Angela Merkel, said last week there was "unequivocal evidence" that Navalny, a vocal critic of Vladimir Putin, had been poisoned using the Soviet-era nerve agent. The Kremlin has repeatedly denied responsibility, with a spokesperson on Monday denouncing "absurd" attempts to link the poisoning to Putin.

group of enterprising women in Sudarshana Village, Padaviya, Anuradhapura, have turned to organic farming in a big way, helping to feed their entire village with wholesome food, free of pesticides and chemical fertiliser.

"We enjoy nurturing organic gardens. Now our children and husbands do not have to consume harmful chemicals with their food. We used to spend about Rs. 5,000 a month on vegetables. Now that money too is saved. Everyone in the house is now happy to help with our organic cultivation," says W.S Dhammika, who pioneered the concept in the village.

"A gentleman who works for a newspaper came and informed us about the potential of organic farming. Nimal Padmasiri of the Institute of Rural Society Development helped us to realise that dream. Previously we were under the impression that vegetables could not be made without chemical fertilizers and chemical oils. But we did as they told us to do. At first, we were wary of the project. Now it is successful and vegetables are freely available all over the village and they have no toxins. The value of growing vegetables and fruits using organic fertilizers cannot be overstated. Now there is no possibility of us eating poisoned food and falling ill. The mental healing that is felt is invaluable. Also, in the morning, we have a beautiful garden to look at."

Dhammika also thanked President Gotabaya Rajapaksa for promoting the idea of a localized economy sans imports of essential food items that can be grown locally, possibly without using chemical fertilisers and weedicides.

"Thanks to his astute leadership during the Coronavirus crisis, we did not suffer. In fact, the Coronavirus crisis was a blessing in disguise for us, as we tended to our gardens more during the lockdown. The entire village participated in our home gardens programme. We now invite the President to come to Sudarshana Village in Padaviya and look at our home gardens and encourage us even more."

A.W. Achini Sadamali, another organic farmer, said she could well remember the time when weeds had grown around the house and they had other work to do every day. "So when these gentlemen informed us about organic home gardening, we thought we could take to it. We started work and now it is successful. Now we do not eat poison. A successful harvest is becoming a reality. The person who works for the newspaper told us that 25 vegetables could be grown easily in our plot of land. The gentle-

man said that it is sufficient to apply fertilizer only once for the plants. We could not believe that. But we did not give up. Actually, he is right."

"In a three-foot plot of land we have now planted 15 to 20 varieties of vegetables. The harvest can be reaped now. Organic manure made from dung, straw, garbage, water hyacinth (Japan Jabara), albizia leaves and neem leaves in our village is now available in every home. I think the women who live in Sudarshana Village are lucky. Now we do not eat poison anymore. We are grateful to the person who works for the newspaper, Nimal Padmasiri and all those who supported this programme and to all those who contributed to this programme in Sudarshana Village."

The village has another programme to produce organic fertilizer. Speaking on this ecofriendly project, H. Pathma Mayadunne of Sudarshana Village said, "We are using the aquatic plants and cow dung that we could access easily in this area to produce the organic fertilizer. The leftovers in our home kitchens will also be used. Today, with the coordination of a journalist, the Institute of Rural Social Development taught us how to make money by utilizing everything disposable and environmentally friendly. Following the project, now we understand the amount of resources we wasted due to lack of knowledge. Now we understand that all we disposed of earlier can be turned into a source of income. We would like to extend our gratitude to those who made us aware of this means of livelihood."

Another villager who is part of the project, W.M.G.M. Daya Kumari said, "Since we are using all the unnecessary aquatic plants, the lake will be beautiful in the future. Our houses and home gardens will be beautiful. We will also get an income. Also, the women in our village who will consume organic vegetables will be beautiful."

Nimal Padmasiri, the Executive Director of the Institute of Rural Social Development, speaking on the occasion said, "When the President tries to give organic fertilizer to the farmers, we have to produce the organic fertilizers from the village. That is our duty. The President hopes to provide non-toxic food to the people of Sri Lanka in the future. We would like to thank all these women in Sudarshana Village who have contributed to the success of this project. We are happy to provide guidance for this project. These women are talented. Organic fertilizer will be produced in 50 houses in this village. The women who claimed to be poor will get an income as well," Padmasiri said.



Finland's new virus app puts PM in isolation

FINLAND: Finland's 34-year-old Prime Minister Sanna Marin will work remotely until further notice, officials announced after the country's new coronavirus app warned that she may have been exposed.

Marin was tested for COVID-19, her office said in a statement. "She is asymptomatic and feeling fine." Finland launched its coronavirus tracing app on September 1, allowing smartphone users to receive an alert when they have been in close contact with

someone who tested positive for the coronavirus. The app has since been downloaded approximately 1.8 million times, equal to one-third of Finland's 5.5 million population.



NORTH KOREA ISSUES SHOOT-TO-KILL ORDERS TO PREVENT VIRUS

US: North Korean authorities have issued shoot-to-kill orders to prevent the COVID-19 coronavirus entering the country from China, according to the commander of US forces in the South.

North Korea whose crumbling health system would struggle to cope with a major virus outbreak -- has not confirmed a single case of the disease that has swept the world since first emerging in China.

Pyongyang closed its border with China in January to try to prevent contamination, and in July state media said it had raised its state of emergency to the maximum level. US Forces Korea (USFK) commander Robert Abrams said that the bor-

der shutdown had increased demand for smuggled goods, prompting authorities to intervene. The North introduced a new "buffer zone, one or two kilometers up on the Chinese border," Abrams told an online conference organized by the Center for Strategic and International Studies (CSIS) in Washington on Thursday.

"They've got North Korean SOF (Special Operations Forces) out there. ... Strike forces, they've got shoot-to-kill orders in place." The border closure had effectively 'accelerated the effects" of economic sanctions imposed on the North over its nuclear programmes, he added, with imports from China plunging 85 percent.

The isolated country is also grappling with the aftermath of Typhoon Maysak, with its state media reporting more than 2,000 houses have been destroyed or inun-

As a result, Abrams did not expect to see any major provocations from Pyongyang in the near future, although he said it might show off a new weapons system at next month's celebrations of the 75th anniversary of the founding of Kim Jong Un's rul-

WATERGATE journalist Bob Woodward's **RAGF** tops bestseller list

US: Nearly 50 years after Watergate, Bob Woodward is still breaking front page news and rattling

His reporting about the Watergate scandal as a journalist for The Washington Post brought down Richard Nixon.

Now a best-selling author, the 77-year-old Woodward's latest book, "Rage," is shaking the White House of President Donald Trump less than two months ahead of the November 3 election.

In one of the 17 on-the-record interviews Woodward conducted with Trump for the book, the President admits to minimizing the threat from the COVID-19 coronavirus at the outset of a pandemic which has gone on to take nearly 200,000 lives in the United States.

"I wanted to always play it down," Trump said in one conversation with Woodward. "I still like playing it down, because I don't want to create a panic."

Trump also told Woodward that he understood early on that the virus was "deadly stuff" and far more dangerous than the common flu. At the same time, he was reassuring the American public the virus would just "disappear."

Woodward, in an interview with the CBS show "60 Minutes," described as a "tragedy" the President's failure to inform the public early on about how deadly the virus was.

"The president of the United States has a duty to warn," he said. "The public will understand that but if they get the feeling that they're not getting the truth, then you're going down the path of deceit and cover up." It was the unraveling of a cover-up --Watergate -- that made the reputation of Woodward and his colleague Carl Bernstein. Woodward studied at Yale University and did a five-year tour in the US Navy, before turning to journalism.

After a stint at a local paper in the Washington suburbs, he got his shot at the Post in 1971.


Woodward had barely a year of reporting experience when he and Bernstein stumbled into the story of a lifetime - the 1972 break-in by Republican operatives of the Democratic Party offices in Washington's Watergate compound.

Their classic gumshoe investigation prompted congressional hearings and led to Nixon's resignation in 1974.

Woodward and Bernstein wrote a best-selling book, "All the President's Men," about the scandal which was turned into a hit 1976 film starring Robert Redford as Woodward and Dustin Hoffman as Bernstein.

'Rage" is already topping the Amazon bestseller list even before it goes on sale on September 15. Since leaving daily journalism, Woodward has put out 20 books, including authoritative tomes on Bill Clinton, George W. Bush, Barack Obama and Donald Trump.

His in-depth reporting about Washington's corridors of power is unmatched, and his ability to back up whatever insider tales he hears has earned him grudging respect in the US capital. Why Trump agreed to conduct 17 on-the-record interviews with Woodward -- 16 of which were recorded -- is something of a mystery, particularly after his previous book portrayed the president in an unflattering



After troops had disembarked on April 9, 1940 the ship was hit by Norwegian artillery then torpedoed by a metres (571 feet), took part in British submarine. Badly damaged, it was finally ordered sunk by the German captain off the port of Kristiansand, at Norway's southern tip. Three years ago, Statnett's sonars detected an unidentified wreck close to a high-tension cable between Norway and Denmark, but the company's engineers did not have time to investigate further at the time, Statnett said. But on June 30, after a storm in the area, a team was sent out to inspect the wreck with a remotelyoperated vehicle (ROV).

About 15 metres from the underwater cable, the ROV "showed a huge shipwreck that was torpedoed. But it was not until the cannons - and Nazi symbol -- became visible on the screen that Ole Petter Hobberstad and the crew understood it was from the war," Statnett said in a statement. Norway's Maritime Museum later confirmed that there was no doubt: the wreck was indeed that of the Karlsruhe, which had never been found.

The sunken ship is located 13 nautical miles off Kristiansand. It lies upright on the seabed, a rare sight for warships with a high centre of gravity which normally list over, according to experts. Built in Kiel in northern Germany, the cruiser was launched in 1927. - AFP

NASA wants to buy MOON ROCKS

US: NASA on Thursday announced it was in the market for Moon rocks, and wants to pay companies to scoop out the dirt, take a photo, and then have it ready for

collection by a future mission. The contract doesn't actually involve getting to the Moon itself - a feat only achieved by the national space agencies of three countries - but instead envisages companies designing a robot that NASA or major private sector players can then launch.

"NASA is buying lunar soil from a commercial provider! It's time to establish the regulatory certainty to extract and trade space resources," tweeted administrator Jim Bridenstine.

The US wants to become a leader in the exploitation of resources found in the soil or subsoil of asteroids and the Moon, a policy outlined in an executive order by President Donald Trump last year, despite an absence of international or legal consensus on the best way

to manage extraterrestrial mining. The major space treaties are

vague on the question.

For the current tender, it has asked companies from around the world to present proposals to collect 50 to 500 grams of Moon rock, or regolith, from anywhere on the surface, provide imagery to prove it, then transfer sole ownership to

Companies would set their own

bids, and be paid 20 percent up front with the remainder upon successful completion of their mis-

NASA anticipates that the contracts will be worth some tens of thousands of dollars, according to the tender documents.

The mission represents a proof of concept as NASA looks to return humans to the lunar surface by 2024 and then set its sights on Mars, harnessing the resources of the Moon and using it as a waypoint.

NASA hopes to excavate lunar ice from the polar regions to supply both drinking water and to split the molecules apart to make rocket fuel for the onward journey. - AFP

Eight deaths reported

Firefighters battle 900,000 acres of wildfires

US: California firefighters battled the state's largest ever inferno Thursday, as more than half a million people fled blazes up and down the US West Coast and officials warned the death toll could shoot up in coming days.

At least eight people have been confirmed dead in the past 24 hours across California, Oregon and Washington, but officials say some areas are still impossible to

The August Complex Fire became the biggest recorded blaze in Californian history on Thursday, after multiple fires in the state's northwest combined in high temperatures and winds to rip through 470,000 acres of dry vegetation.

Half a million people have been evacuated in neighbouring Oregon, authorities said.

"Firefighters are prioritizing life (and) safety as they battle a record 900,000 acres of wildfires," said an Oregon government statement.

Oregon Governor Kate Brown said that the amount of land incinerated by fires in 72 hours was twice the state's annual average, and that at least five towns had been "substantially destroyed." "We have never seen this amount of uncontained fire across our

state," she told a press conference. "We know that there are fire

related fatalities. And as soon as we are able to provide confirmed information, we will do so." Local Oregon officials have confirmed two deaths in the Santiam Canyon region, 60 miles (95 kilometers) south of Portland, and another was recorded in the Ashland area, near the California border.

Police went door to door to make sure that residents were evacuating the Molalla, marking their driveways with spray paint to show they had left.

"It's one thing to leave your house, it's another thing being told that you have to leave," said Denise Pentz, a resident of the town for 11 years, who was loading her family belongings into a camping trailer. In northern California's Butte County, where three people have been killed, firefighters battled flames through the night after a day of apocalyptic orange skies over the Golden State.

Another dozen people were reportedly unaccounted for in the

Californian teen learns to drive the hard way

Ruben's family had two days to prepare for a possible evacuation, and in that brief time his aunt and uncle managed to show him some basics of driv-

"It's like a video game, Ruben," the teenager recalled his uncle Josh telling

The fateful call came Monday at midnight. The flames were approaching --

evacuate immediatly. Ruben's aunt and uncle, his three younger cousins and his wheelchairbound brother piled into the family's

Aunt Jamie led the pack driving the family Kia SUV, followed by Ruben in a Chevrolet with his brother at his side. Uncle Josh took up the rear driving a pickup truck with busted front lights.

"When it came down to when I had to drive, I was really nervous, scared," Ruben told AFP, speaking from the safety of a hotel room in the town of Clovis. The flames were moving right behind the small convoy. "I didn't want to look because I was so focused, I didn't want to crash or anything," he said. But if you looked out the side window there was "a really big steep hill," he recalled.

Ruben said that he started feeling comfortable behind the wheel only halfway into the 20-mile trip. - AFP

"She was at home with her family who have asked for privacy at this difficult time," he added, calling her "an icon of theatre, film and television".

Rigg's daughter Rachael Stirling said her mother had been diagnosed with cancer in March and "spent her last months joyfully reflecting on her extraordinary life, full of love,

BRAZIL: Brazil's Environment Minister Ricardo Salles challenged Hollywood star Leonardo DiCaprio to "put your money where your mouth is," after the actor and environmentalist criticized President Jair Bolsonaro's policies on the Amazon rainforest

DiCaprio had shared a video on Twitter Wednesday from a campaign called DefundBolsonaro.org, which claims that "Bolsonaro's government has taken the destruction of the Amazon to unbearable levels," and calls on investors to pressure the president to take

steps to protect the world's biggest rainforest. Environment Minister Salles fired back with a taunt.

"Dear @LeoDiCaprio, Brazil is launching 'Adopt-1Park' preservation project which allows you or any other company or individual to pick one of the 132 parks in the Amazon and directly sponsor it at 10 euros per hectare per year. Are you going to put your money where your mouth is?" Salles wrote on Twitter. Bolsonaro retweeted the mes-

The president, who took office in January 2019, has

presided over a surge in fires and deforestation in the Amazon, which scientists say is a vital resource for curbing climate change.

DiCaprio, who has called for stronger action to protect the rainforest, has become a favourite target of the Bolsonaro administration. Last month, Vice President Hamilton Mourao challenged the "Once Upon a Time... in Hollywood" star to an eight-hour hike in the Amazon, saying he wanted to show him the rainforest was not actually burning.

Salles landed in a new row Thursday when he

tweeted a video by a Brazilian agricultural lobby group that claims, "The Amazon is not burning," with images of verdant forest, smiling indigenous people and cute animals. However, it soon emerged the video featured animals that do not actually live in the Amazon.

Though Bolsonaro has called reports on the Amazon fires "a lie," figures from his own government show there were 29,307 fires in the rainforest last month, just slightly shy of the crisis levels that triggered international condemnation last year.- AFP

Rugby star Sisira did Navy and Sri Lanka proud

To become a prominent figure in any field, one should possess some extraordinary talent A man who sailed through life in the sporting field from childhood until maturity, contributing immensely to become the cynosure of all eyes, both in Schools, Clubs and the International arena as a top sportsman, was Sisira Henakankanamge, better known as HK, Sisira who was called a five-star player while in school due to his involvement in all major sporting activities.

Sisira Henakankanamage started and ended his academic career at Isipathana College, Colombo. He started his sporting career at the age of ten, engaging in Cricket and Rugby. While being a schoolboy he was mostly involved with his friends in playing rugby using tennis balls or a shoe.

According to HK, Rugby was like a religion at Isipathana, and was the favourite sport amongst most of the children who studied there.

The story behind being named HK is an interesting one.

When he was playing under-12 cricket the Master-in-charge found it difficult to write his name in the score book as it was too long and difficult to pronounce. As a result, he decided to shorten his

name to HK, which has ultimately remained unchanged.

From the age of 12 up to senior level he played cricket for his alma mater, and ended up captaining the first eleven team in 1976. With his all-round ability, whilst still a school boy he was invited to play for Colts Cricket Club and went on to be a member of the Rahman Hathy championship winning team under the captaincy of Beverly. Paul. He gradually blossomed and turned out to be one of the dynamic figures in school, where he donned the college jersey in all sporting events, excluding hockey. Along with cricket he also captained the senior college athletic teams, was a Cadet Sergeant and later was appointed head prefect in 1977.

HK's rugby career started with the under-15 team. At the time he entered the field it was a tough task to find a place in the side, as the whole team was filled with highly skilled players. Nevertheless, HK proved his mettle and became a regular member of the side in 1974, when he was a mere 17-years-old. He recalled that it was his former school coaches Kamal Javawardena and Dan Ratnam who transformed him into a quality rugby player, and expressed his sincere gratitude to the two of them.

In 1976, when he was vice-captain of the first fifteen team, he established a record in school's rugby by scoring 25 tries in seven matches in that particular season, which his school mate Hisham Abdeen equalled in eight matches in 1980. Due to his belligerent performance in the season, he was appointed captain. He rates the team under his captaincy as a star-studded

side comprising players like M.P.F. Salley, Gamini Gunawardena, Mohin Buhary, Aruna Samarajeewa and Anuruddha Bowala to name a few.

Halfway through his tenure as captain, he got an appointment with Sri Lanka Navy as an officer cadet in 1977. After considering his sporting and academic performance Navy chose him along with another 13 personnel out of 20,000 applicants.

HK says departure from school was due to a very unfortunate incident. When they took on Royal College in their annual rugby

fixture the match was evenly poised with the score reading 12-6 in favour of the visitors. HK got an opportunity to grab the ball and covered 40 metres and almost scored, but was brought down by Susantha Ratnayake just a few yards away from the line due to the crowds

shouting and enormous pressure, when victory was within sight if he had scored the try and converted.

After joining the Navy he was based in Trincomalee, but just two days later the management requested HK to come to Welisara immediately. He then joined the rugby team and made his debut

against Kandy Sports Club at Galle Face team which consisted of 8 from Army, 3 The Sailors won the match comfortably and HK ended up scoring two tries. In his 12-year tenure as a player for Sailors he holds a rare honour of captaining them on four occasions, 1983, 1986, 1987 and 1988, occupying the centre three quarter position. One year after he was recruited, he was sent to India for further training (in 1980) and on his return was asked to rejoin the rugby squad. He also represented the Sailors in cricket for over five years.

He made his international debut in 1982 at the Cathay Pacific Hong Kong sevens under Saman Jayasinghe's captaincy. From then onwards he was a regular member of the sevens and fifteens teams. In the same year he was chosen to play in the Rugby Asiad held at Singapore under the same skipper. He toured Hong Kong in 1983 to play in the sevens tournament under C.P. Abeygunwardena. Next year he was compelled to dedicate his attention to his job with the outbreak of terrorism, and had to withdraw from the national pool which was preparing to tour Fukuoka, Japan for the 1984 Asiad followed by the Hong Kong sevens. He virtually gave up rugby due to National duties. In 1983 he led the Defence Services

fromNavy and the rest from Air Force, which trounced the touring Blacknell team from UK in Colombo, which game was officiated by the late General Denzil Kobbekaduwa.

HK hung up his boots in 1989 and decided to engage himself in coaching the Navy team from 1990 onwards. In 1993 the Navy administration appointed him Rugby Chairman.

He was then promoted to the rank of Commander of the Navy for his unstinted contribution. Sri Lanka Rugby appointed him as one of the National Selectors under the chairmanship of Lionel Almeida (1996 to 1998) and continued again from 1999 to 2000 under Tikiri Marambe.

He prematurely retired from the Navy in April 1998 and devoted his time to

His two sons Navod and Naveen Henakankanamge excelled in sports at S. Thomas' College, Mount Lavinia. His younger son Naveen followed in the footsteps of his father and has transformed himself to be a top player and donned the National jersey as a school boy, which is a rare achievement. He was awarded the Thomian Blue for rugby for his achievement.



Sri Lanka Rugby outlines future work plan

Sri Lanka Rugby (SLR) headed
by incumbent President Rizly Illyas, and his team of officials, revealed their immediate work plan which they hope to execute to revamp rugby in the country, which was disclosed at a press briefing held in Colombo, yesterday.

After being elected to office uncontested at the Annual General Meeting held last month, Illyas briefed the media about the new plan they have drafted to conduct the new look domestic tournament, which has prioritized promoting the seven-a-side rugby arena. This proposal will be submitted to the relevant authorities for their perusal and final approval. "From the inception, I wanted to

have a change in all our activities. As an initiative, I got my team which will work indefatigably towards achieving the goals. We have some strategic plans segregated among my team members who will strive hard in developing the game to the next level," said a confident looking Illyas, who is to embark on the all important aspect of finding sponsors in the upcom-

While preparing our domestic tournament calendar, we are also in the process of doing the spade work in formulating the documents to meet the Sports Minister to get his blessings and support. We are pretty confident he will not only help us, but also guide us on the right path," added Illyas.

Briefing the media Nazeem Mohamed, the Deputy President and the Tournament Committee Chairman, emphasized on the importance of prioritizing the sevens tournament by pruning down the time span of the 15-a-side tournament to 11 weeks from 18 weeks. The whole idea behind the reduction is to give more prominence to sevens rugby where Sri Lanka has shown great potential in reaching the pinnacle.

The domestic tournament will kick off with the commencement of the sevens tournament at the end of October, and will comprise two legs - Colombo and Southern Province respectively. All matches are to scrum down only on Friday's and

Saturdays commencing from 4.00 p.m. to 10.00 p.m. each day under lights. SLR is to accommodate a limited number of spectators provided the concerned authorities grant them permission. They will make adequate arrangements to live stream the matches on internet based channels, while telecasting in some channels, which will be notified in due course. The eight 'A' division teams and six women's teams will be in the fray for hon-

SLR has also drawn up a plan to popularize the game in the outstation. As an initiative they will play the remaining two legs in Kandy venues will be notified later.

The SLR Tournament Committee is to reintroduce the under-24 XV-a-side tournament which was withdrawn from their annual calendar for the last decade. They are mainly focusing to accommodate the school leavers who were forced to give up rugby soon after school due to stiff competition to get into clubs. This too will involve the 'A' division clubs where the competiand which will be more or less a semi league. This tournament is to scrum down in mid-January.

The Dialog Rugby League is scheduled to commence in the latter part of February, and at the completion of the first round the eight teams will be divided into two groups depending on their performance. The top four will play each other and proceed to the "Cup Championship" while the bottom four will compete in the "Plate Championship" and the respective winners will be honoured as Cup and Plate winners. The super round which was played until last season will be scrapped from the tournament calendar. The prestigious Clifford Cup will be held soon after this tournament in Colombo next

Meanwhile, HAUD Hettiarachchi, who is the Vice President and the Chairman, Women's Development Committee, elaborated on women's rugby. They too have drawn up several programmes with a view of spreading the game to all provinces. There are over 150 schools playing the game in this segment currently and they are in the process of increasing it to 250 schools. With a view of developing this entity they are scheduled to conduct over 70 tournaments in the 2020/21 season to unearth hidden talent to form a strong National side. Hettiarachchi was very confident of achieving his target with

the support of his colleagues. SLR introduced two new faces in their ranks, with the inclusion of big business tycoon and great rugby lover Ranjith Weerasinghe as Director SLR, sevens arena, and Kevin Herft, as Executive Director of SLR replacing Rohan de Silva.

Former Sri Lanka cricketer Anthony Marinon Opatha better known as Tony died yesterday at the age of 73 A right-arm medium pace bowler, he played five One Day Internationals at the 1975 and 1979 Cricket World Cups. He played for CCC and SSC at the domestic level

He was educated at St. Peter's College, Colombo later joined the Royal Ceylon Volunteer Air Force in 1968. He played for his college cricket team from 1965 to 1967 captaining in his final year and went on to play for the Air Force cricket team till 1977.

He first played for Ceylon in 1971 and was a member of the Sri Lanka teams which played in unofficial tests till 1979. He later played club cricket in Ireland for one season in 1979 and was offered the post

of coach of the Holland team. As player/manager

of the rebel tour to South Africa in 1982-83 in defiance of the sporting ban against apartheid, he and the other members of the team received a life ban from international In September 2018,

he was one of 49 former Sri Lankan cricketers felicitated by Sri Lanka Cricket, to honour them for their services before Sri Lanka became a full member of the International Cricket Council (ICC).

Azarenka stuns Serena to set up US Open final against Osaka

NEW YORK, FRIDAY: Victoria Azarenka came from a set down to stun recordchasing Serena Williams on Thursday and set up a US Open final against Japan's Naomi Osaka.

Azarenka recovered from a 6-1 hammering in the first set to win the next two 6-3, 6-3 and schedule her first Grand Slam final appearance in seven years. The former world num-

ber one is enjoying a remarkable renaissance in New York that the Belarusian credits to finding humility, following several years disrupted by injury and a custody battle over her son.

"I think when you're coming up from kind of nothing, then you become a number one player in the

world, sometimes you can start to think you're invincible and that you're better than everybody, and it's not true," Azarenka

"So the ego starts to grow. It's very hurtful when it gets damaged. Instead of getting the ego damaged, I tried to remove that and learn from my mistakes," she added.

After a first set plagued by double faults and unforced errors, Azarenka turned the tide in the second, upping her service game and getting more returns in play as she began to dictate lengthy

"I knew I needed to step up with my aggressivity, play a little smarter, play

with a little bit more width of the court and bring the intensity up," Azarenka explained.

Two-time Grand Slam winner had never beaten Williams before in a Grand Slam. Her last appearance in a

Grand Slam final came in the US Open in 2013 when Williams beat her.

Azarenka also suffered a heartbreaking loss to Williams in the 2012 US Open final, when she served for the match at 5-3 in the third set only to lose 7-5.

Azarenka was determined that history would not repeat itself. Serving for the match,

she hit a double fault before smashing her fastest serve of the night at 109 mph.

'Responsibility' When Williams then challenged and lost an ace

that was called in on the next point, it was Azarenka's match. "I've been there before.

Today was gonna be different," Azarenka said.

Williams said she started the 1 hr 56min-match "really strong."

"(But) then she just kept fighting. She just changed and started playing better and better. Maybe I took a little too much off the gas pedal at some point," the American added.

The defeat ended Williams' hopes of winning a record-equalling 24th singles Grand Slam at Flushing Meadows. - AFP



PADDY MARKETING BOARD (PMB)

Invitation of Preliminary Proposals for Possible Utilization of Paddy Silo Storage Complexes

Paddy Marketing Board (PMB) is in possession of four reinforced concrete silo complexes located in Hasalaka, Inginiyagala, Polonnaruwa and Galgamuwa. Paddy storage and processing activities of some of these complexes started in 1976/7, continued for a few years and abandoned in 1983/4,



The concrete works are still in good condition but would require coating for water proofing. Most of the mechanical works are in poor condition or non existent. PMB is interested in renovation and augmentation of these sites for possible beneficial uses. Initial thoughts on possible uses are;

- 1. Paddy storage and milling: it is possible to use silos with new or reconditioned mechanical Conveying systems for storage of paddy. Several options are;
 - Storage with bulk transport to large mills with weigh bridges
 - Storage with automatic weighing/bagging for transport to smaller mills Storage and milling complexes with new or relocated ~4 tph rice mill
- Maize and Soybean storage and processing: It is also possible to use silos for storage of maize and soybean for human consumption or animal feed. This requires mechanical conveying systems. The storage capacity should be derated by about 25% due to property differences between physical properties of paddy and maize. Some possibilities are;

Storage with automatic weighing/bagging

Storage and processing

Other Possibilities:

PMB is open to other potential uses not mentioned here.
