THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, hereby declare under sub section (1) of section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions, of that Act.

The Allotment of land depicted in Surveyor General's Advance Tracing No. MA/NUL/2017/62 and dated 29. 04.2017, situated at Kumbiyangahaela Village (F.V.P.284) in Gamimayaya Grama Niladhari Division, Wagapanaha Udasiya Pattuwa Minor Division of Naula Divisional Secretary's Division, Matale District, Central Province and bounded as follows ;

 North: Canal, Dikyaya claimed by I.G. Seelawathi, Dikyaya
 calimed by D.G. Sumanasiri, Dikyaya calimed by Medagedra
 Piyadasa, Lot E, F, G, N and Q; East: Lot Q and R Kalugallewa river
 and Lot S and Canal; South: Canal, Dikyaya claimant not Known,
 Dikyaya calimed by L. V. M. Thilakarathna and Dikyaya calimed by
 R.W. R. G. G. Indrawathi; West: Canal.

17. Lot AF – Katuwetiya – Extent : 1.8737 Hectares
 North: Road (Pradeshiya Sabha), Dikyaya calimed by I. G.
 Seelawathi; East: Canal; South: Canal, Dikyaya calimed by R.W.R.
