RULES

1. In any case where the Registrar determines to prepare a re-constructed folio of any volume of the Register of Trade Marks he shall, in the first instance, prepare a provisional folio in accordance with the provisions of rule 2.

2. (1) The provisional folio shall, as far as possible, be of the same size and form as the existing folios in the volume of the Register of Trade Marks for which the re-constructed folio is to be prepared.

(2) For the purpose of ascertaining the particulars originally contained in the folio which has been lost or in that part of a mutilated or damaged folio which is missing or is illegible, no evidence shall be admitted or used other than the evidence furnished by the *Gazette* or by the documents or records in the custody or under the control of the Registrar.

(3) The material particulars of every entry which are proved by the evidence admissible under paragraph (2) to have been contained in the original folio shall be inserted in the appropriate places in the provisional folio, and no other particulars shall be included on any other ground whatsoever.

3. The Registrar shall, as soon as may be after he completes the preparation of the provisional folio or as much thereof as it is possible to prepare with the evidence admissible under rule 2, publish a notice in the *Gazette*. Such notice shall—

- state such particulars as may, in the opinion of the Registrar, be necessary for facilitating the identification of the folio which has been lost or is mutilated or damaged;
- state the extent of the re-construction that has been carried out in the provisional folio;
- specify the period and the hours during which, and the place at which, the provisional folio may be inspected by any person interested therein; and
- specify the manner in which, and the date before which, objections may be made in respect of the provisional folio.

4. The Registrar shall send by registered post a copy of the notice referred to in rule 3 to the registered proprietor of the trade mark in respect of which the provisional folio has been prepared, if in the course of the preparation of the provisional folio, the name and address of the registered proprietor have been ascertained.

5. Any person whose right to or interest in any trade mark is or is likely to be affected by any entry or particulars in an entry included in or omitted from, any provisional folio in respect of the preparation of which notice has been given under rule 3, may, in the manner and within the time specified in the notice, make an objection by affidavit against the inclusion or for the insertion, of such entry or particulars, in that folio.

6. The Registrar shall not entertain any objection in respect of any provisional folio made after the date specified in the notice referred to in rule 3 provided, however, that the Registrar may entertain any objection received within fourteen days after that date if he is satisfied that the delay was due to any unavoidable circumstance or reasonable cause.

7. For the purpose of disposing of every objection duly made under rule 5, the Registrar shall hold an inquiry. He shall fix a date for the inquiry and notify the person who has made the objection, of the date, time and place at which the inquiry will be held.

8. (1) After every inquiry into an objection, the Registrar shall make a decision in respect of that objection.

(2) The decision of the Registrar on every objection shall be final.

(3) The Registrar shall communicate in writing to the person who made an objection his decision thereon.

9. (1) Where the decision of the Registrar on any objection made under rule 5 renders necessary any alteration, insertion, omission or other amendment of any entry or the particulars in any entry included in the provisional folio, the Registrar shall, as soon as may be after his decision is communicated to the objector, make or cause to be made such alteration, insertion, omission or other amendment in the provisional folio.

(2) Where no objection is made, or where an objection is made and the provisional folio is amended in consequence of the decision of the Registrar thereon, the provisional folio or the provisional

folio as so amended, as the case may be, shall be deemed for all purposes to be the re-constructed folio.

(3) The Registrar shall authenticate the re-constructed folio by endorsing thereon a certificate under his hand to the effect that the folio has been prepared in accordance with the provisions of section 56a of the Ordinance.

10. In these rules—

“Ordinance” means the Trade Marks Ordinance (Chapter 121), as amended by the Trade Marks (Amendment) Act, No. 4 of 1952; and

“Registrar” means the Registrar of Trade Marks.
