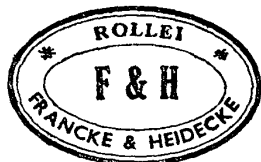

## Notifications under "The Patents Ordinance, 1906"

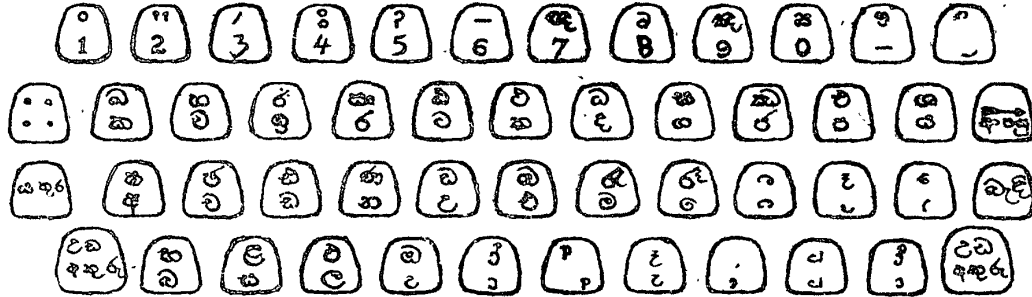
THE following specification has been accepted :—

"A practical typewriter keyboard for the Sinhalese Language".

*Abstract.*—The inventor describes and claims a practical typewriter keyboard as follows :—



The keyboard is based as far as possible on the positions of corresponding letters in English typewriters, while aspirated consonants and long vowels are placed also as far as possible about the corresponding consonants and short vowels and are obtained by lifting the typing position, namely, by the shift key. A typist accustomed to an English typewriter will therefore be able to adapt himself to the keyboard with a little practice.

There are 8 claims and 1 sheet of drawings.
