APPROPRIATION STATUTE

2016

FOR THE YEAR 2015

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation Statute No. 06 of the 2016, and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.
2. The limits of Advanced Accounts 81002 and 84002, mentioned in the Second Schedule of the Appropriation Account No. 10 of 2014 as amended by Appropriation (Amendment) Statute No. 03 of 2015, No. 07 of 2015 and No. 03 of 2016 is hereby amended as per the First Schedule hereof.
