A STATUTE TO AMEND THE APPROPRIATION STATUTE No. 02 OF 2006 AS AMENDED BY APPROPRIATION (AMENDMENT) STATUTE No. 01 OF 2007 OF THE SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

BE it enacted by the Sabaragamuwa Provincial Council of Democratic Socialist Republic of Sri Lanka as follows :

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation Statute No. 07 of the 2016, and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.
2. The limits mentioned in the Advanced Account namely 8501 in the Second Schedule of the Appropriation Account No. 02 of 2006 as amended by Appropriation (Amendment) Statute No. 02 of 2007 is hereby amended as per the First Schedule hereof.
