**LAND ACQUISITION ACT (CHAPTER 460)**

**Notice under Section 7**

*My Reference No.:* MCUDP/LA/KOL(W16)/16/01.

I hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as mentioned by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the lands described below for the construction of Kiththampahuwa Canal, Maintain the Canal Bank and Construction of Service Road under a sub Project of Metro Colombo Urban Development Project.

*Land use of the land to be Acquired:*

One hundred fifteen (115) allotments of lands in following names and extent and total extent of 1.0500 Hectare, depicted as Lot No. 01 to 115 in the Preliminary Plan Co 9726 dated 12.01.2018 prepared by the Surveyor General situated in the village called Welewatthha (within Kolonnawa Urban Council) and Wellampitiya in the Grama Niladari Division of 508A Welewatthha, 510B Kuruniyawaththa and 511 Wellampitiya in the Divisional Secretary's Division of Kolonnawa in Colombo District of the Western Province and more fully described as follows:-
