# DO NOT ALLOW BRAND NAME "CEYLON TEA" TO BE TARNISHED

**SUPPLY HIGH QUALITY TO GLOBAL MARKET** 

President Gotabaya Rajapaksa urged the tea factory owners not to pave the way to tarnish the image of the Ceylon Tea brand which has attracted many countries in the world for a long time.

The Media recently reported instances of adulterating the quality tea by mixing sugar, glucose, sodium bicarbonate and ferrous sulfate. The rejection of such tea in the world market has caused a huge setback to the tea industry.

President Rajapaksa emphasized that the country's reputation as well as the global demand for Ceylon Tea could not allow it to be harmed in the future.

The President stressed that no room will be left for the tea industry to suffer the same fate that the pepper had met with.

President Rajapaksa made these comments during a discussion with small and medium scale tea factory owners and exporters held at the Presidential Secretariat yesterday

The deterioration of the quality of tea has resulted in the decline of its demand from 65% to 45% among the global consumers. TO PAGE 02



# 33,000 kgs of turmeric illegally removed from Customs seized; 10 suspects arrested



Bloemendhal Police has seized 33,000 kilograms of turmeric and 3,000 kilograms of Oried illegally imported into the country and smuggled out of Customs.

# Motorbikes for over hundred PHIs

The Government gave motorbikes to over one hundred Public Health Inspectors (PHIs) under Health Ministry's Sri Lanka COVID-19 Emergency Response and Health Systems Preparedness Project, yesterday.

Another 749 PHIs are to receive the motorbikes on priority basis, Health Ministry sources told the Daily News. The bikes, each of which will cost around Rs.300,000, will be distributed to the other PHIs under the project, Health Ministry sources said.

The Health Ministry is distributing these motorbikes to strengthen the coordination and timeliness of national and regional response in emergencies of pandemic nature under a longterm health systems strengthening project, according to Ministry sources.

The ministry carries out the project with a soft loan extended by the World Bank.

President Gotabaya Rajapaksa presided over the distribution of 107 bikes among the PHIs yesterday at the Presidential Secretariat. He was accompanied by Health Minister Pavithra Wanniarachchi and other ministry officials.

The bikes were distributed free of charge among the PHIs. According to sources this was the first time that the bikes were issued without obtaining any money from the PHIs. The bikes were given among these PHIs in recognition of their excellence in carrying out their duties to pre-

vent the spread of COVID19 virus, said Sri Lanka COVID 19 Emergency Response and Health Systems Preparedness Project Director Jayasundara Bandara.

There are many plans on track to invigorate the health service to face future contingencies including infectious diseases such as COVID-19, including construction of an isolation centre within the National Institute of Infectious Diseases premises, which will have facilities such as negative pressure rooms, Intensive Care Units (ICUs) and separate waste disposal and drainage systems, according to Bandara.

# India, Lanka to deepen partnership in capacity building and skill development

Indian High Commissioner Gopal Baglay called on State Minister of State for Skills Development, Vocational Education, Research and Innovation Dr. Seetha Arambepola on September 15 and discussed ways to deepen partnership between the two neighbouring countries in areas such as capacity building and skill development during the meeting.

Discussions focused on aspects such as training of trainers in vocational institutes in Sri Lanka, strengthening infrastructural capabilities of these institutes and generating interest among school-going children and youth in advanced space technologies. It was decided that both sides would work towards early realization of augmenting existing capacities and creating newer ones in chosen fields in an expeditious manner. Guided by the 'Neighbourhood First' Policy, the Government of India offers capacity building modules across a range of fields to Government Officials and other eligible Sri Lankan citinical and Economic Cooperation Programme, around 400 slots are reserved for Sri Lanka annually. Shortlisted personnel from Sri Lanka receive unique, fully-funded training programmes under this rubric. In addition, several other customized modules are also organized by Government of India. It also provides scholarships to more than 200 Sri Lankan students each year to pursue courses spanning from under graduate to doctoral studies in various academic streams in prestigious institutes in India including IITs and NITs. To support students from disadvantaged back grounds, financial assistance is provided to around 650 students from among Universities and Schools in Sri Lanka. Government of India is also committed to strengthening infrastructure in educational institutes in Sri Lanka. Accordingly, infrastructural activities in several institutes across the island are being undertaken as High Impact Community Development Projects.

The number of tea factories in this country stands at 705. Improper activities have been reported from 45 factories and production has been stopped in 18 among them following investigations, Chairman of Ceylon Tea Board JayampathiMolligoda said.

Based on intelligence information the Special Task Force of the Police and the Police raid tea factories which produce garbage tea and use harmful chemical components.

No room should be left to hamper the revenue of the country or the tea industry due to substandard tea production. Tea factory owners as well as the exporters should ensure the supply of high quality tea to the world market. "Production of low-quality tea will not be allowed" said the President while giving instructions to officials to close down the factories that do not adhere to this rule.

The President also instructed the acting Inspector General of Police to continue to raid such factories after conducting investigations with the assistance of intelligence services.

State Minister Kanaka Herath, Principal Advisor to the President LalithWeeratunga, secretaries to Cabinet and State Ministries, acting IGP and other officials, tea factory owners and exporters were present during the discussion.

The Minister said that certain paddy mill owners hoard paddy and rice stocks without releasing to the market and attempting to create an artificial rice shortage in the country. If these paddy mill owners continue to do so, the government will have to take a decision of importing rice to maintain a buffer stock.

He further said that it is expected to seek the approval of the cabinet of ministers at the next cabinet meeting to import 100,000 Metric tons of rice as a solution for the artificially created rice shortage.

"If anybody attempting to increase the price of rice by creating an artificial shortage, the government is not ready to fulfill their narrow objective and will take measures to import rice." the Minister stressed.

Meanwhile, speaking to the Daily News, Customs Director Sunil Jayaratne said that the turmeric had been imported from India through Letters of Credit and therefore, as of now the decision was to re-export the turmeric back to India.

He also noted that another consignment of around 1000kg of turmeric had been detected which were imported concealed in small quantities among other goods in 62 containers.

The Customs Spokesman added that the stock of turmeric would be destroyed and not released into the local market based on the government's policy of protecting the local farmers and promoting locally manufactured produce for the export market and promoting an agriculture based economy.

In addition to the above mentioned detections, the Sri Lanka Coast Guard had detected a stock of around 1058 kg of dried turmeric being smuggled into the island, in the estuary of the Deduru Oya, Chilaw yesterday (18).

"During a special patrol in the estuary of Deduru Oya, the Sri Lanka Coast Guard detected the 1058 kg consignment of dried turmeric stuffed in 21 gunny sacks, upon inspection of a suspicious dinghy.

The stock of dried turmeric and the dinghy was handed over to the Customs Office of Sinnapadu for further investigation. Meanwhile, operations are currently underway in search of

the suspects involved in this racket," the Navy Media office stated.

The 10 arrested suspects are of the ages of 22,28,38, 42, 43, 45 and 52 and are residents of Mattakkuliya, Keselwatta, Maligawatta, Wellampitiya, Narahenpita, Kotahena, Akmeemana, Malwana, Kadirana and Colom-

"It is observed that the contents of the answer given by Co-Cabinet Spokesman Minister Keheliya Rambukwella in response to a question of a journalist on the statement of the UN High Commissioner for Human Rights regarding Sri Lanka and the response of the Permanent Representative to sri Lanka have been misinterpreted by few media outlets. During the press conference, Hon. Minister Keheliya Rambukwella did not mention Sri Lanka's withdrawal from the UNHRC. He only mentioned that Sri Lanka has already taken the necessary steps to withdraw from the co-sponsorship of Resolution 30/1. Sri Lanka

withdrew from Resolution 30/1 in February and informed the UNHRC of the decision during the March session in Geneva." Director General of Government Information said.

Responding to a query by a journalist at the cabinet media briefing held on Thursday at the Government Information Department, Co-cabinet Spokesman Mass Media Minister Keheliya, co-cabinet spokesman Minister Keheliya Rambukwella said that the government is not ready to fully accept the remarks made about Sri Lanka at the 45th sessions of the United Nations Human Rights Council (UNHRC), The Minister made this

observation He further said that since the end of civil war in 2009 the UNHRC has been making false allegations about war crimes.

Referring to a comment made by UN Human Rights High Commissioner Michelle Bachelet about the appointment of senior army officials to key positions in the government, Minister Rambukwella said that certain army officers retire before the age 55, so if they had performed exceptionally when considering their background then there should be some fairness in giving them some position in the government following standard procedure.

Showers or thundershowers may occur at a few places in Uva province and in Ampara district after 2.00 pm.

Strong gusty winds about (50-60) kmph can be expected

across the island, particularly in the Northern, North-central and North-western provinces, Trincomalee and Hambantota districts and in the western slopes of the central hills.

Meanwhile, showers or thundershowers may occur at several places in the sea areas off the coast extending from Puttalam to Hambantota via Colombo and Galle. Heavy rainfalls are likely at some places.

Winds will be South-Westerly in the sea areas around the island and the wind speed will be (30-40) kmph. Wind speed can increase up to (60-70) kmph in the deep and shallow sea areas off the coasts extending from Trincomalee to Negombo via Kankesanturai and Puttalam and in the sea area extending from Matara to Pottuvil via

Hambantota.

Wind speeds can increase up to (50-55) kmph in the deep and shallow sea areas off the coasts extending from Negombo to Matara via Colombo and Galle

There is a possibility that near shore sea areas off the coast extending from Kalpitiya to Pottuvil via Colombo, Galle and Hambantota may experience surges due to the effect of swell waves, having 2.5-3.0 m height.

The sea areas extending from Trincomalee to Negombo via Kankesanturai and Puttalam and the sea area extending from Matara to Pottuvil via Hambantota can be rough or very rough at times.

The other sea areas around the island can be fairly rough or rough at times.

Investments in human capital—the knowledge, skills, and health that people accumulate over their lives—are key to unlocking a child's potential and to improving economic growth in every country.

In comparison to neighbouring India, Sri Lanka's adult survival rate is at 0.90 against India's 0.83. In addition, Sri Lanka scored higher in terms of the Probability of Survival to age 5 at 0.99 in comparison to India's 0.96.

World Bank Country Director for Maldives, Nepal and Sri Lanka Faris H. Hadad-Zervos states that, "In the wake of the COVID-19 pandemic, investing in people is more vital than ever, as it can lay the strong foundations needed for the recovery and for resilient growth."

He added that, "Stunting due to chronic under-nutrition and the need for higher quality learning are the two areas of the Human Capital Index in which Sri Lanka has an opportunity to accelerate progress, especially as a country on the threshold of upper-middle income status."

To help address these gaps, a strategic

focus on improving nutrition and enhancing learning in less developed regions of the country is needed, along with consistent measurement of stunting and internationally comparable learning outcomes to inform policy development and track progress in human capital development over time.

Globally, due to the pandemic's impact, most children – more than 1 billion – have been out of school and could lose, on average, half a year of schooling, translating into considerable monetary losses in the future. Data also shows significant disruptions to essential health services for women and children, with many children missing out on crucial vaccinations. The economic impact of the pandemic has been particularly deep for women and for the most disadvantaged families, leaving many vulnerable to food insecurity and poverty.

The 2020 Human Capital Index includes health and education data up to March 2020 for 174 countries covering 98 percent of the world's population, providing a pre-pandemic baseline on the health and education status of children.



The analysis finds that human capital outcomes for girls are on average higher than for boys. However, this has not translated into comparable opportunities to use human capital in the labor market. On average, employment rates are 40 percentage points lower for women than for men in South Asia. Moreover, the pandemic could exacerbate risks of gender-based violence, child marriage and adolescent pregnancy, all of which further reduce opportunities for learning and empowerment for women and girls. Country Manager for Sri Lanka and

the Maldives Chiyo Kanda stated, "Sri Lanka and the World Bank have worked together for decades to invest in human capital and today these hard-won gains are at risk."

However, she said, "We will continue supporting Sri Lanka to expand the coverage and quality of health services in underserved areas, boost early childhood development and learning outcomes, improve higher education, and support vulnerable families with social protection measures to mitigate the impacts of the COVID-19 pandemic."

The World Bank Group is working closely with governments all over the world to develop long-term solutions to protect and invest in people during and after the pandemic. In Sri Lanka the Bank is supporting initiatives to increase access to early childhood education and care, to improve learning in general education, and to strengthen the relevance of higher education for economic development. The Bank is also helping strengthen the efficiency of social safety nets to support vulnerable families and households. In addition, the Bank is assisting the government to strengthen health systems, including to respond to the challenges of the Covid19 pandemic.

# Five more COVID-19 patients detected

The National Operation Centre for Prevention of COVID-19 (NOCPC) said that five new COVID-19 patients were detected as of yesterday morning. One of them was a returnee from the United Arab Emirates (UAE) who was being quarantined at the Five Star hotel, one from Qatar who was being quarantined at the Jetwing Blue quarantine center, another three from Madagascar and Oman respectively.

Issuing a media release, the National Operation Centre for Prevention of COVID 19 also stated that 22 patients returned home after recovering as at 6 am yesterday morning. Newly recovered 22 patients are returnees from abroad. The NOCPC further stated that 5895 persons were undergoing quarantine at 59 centers under the Tri-Forces as at yesterday.

Meanwhile, a total of 320 persons concluded their quarantine process at the military-run quarantine centers yesterday and a total of 42,582 persons had returned home after completing the quarantine process. Thus, a total of 111 persons arrived in Sri Lanka yesterday morning. Among them, 22 returnees are from Dubai, 52 from Qatar, 30 from Japan and 7 from Australia. All those returnees will be directed to quarantine centers controlled by the Tri-forces upon their arrival," the NOCPC further stated.

The number of patients reported from the Kandakadu cluster has increased to 649, out of which 528 are detainees, 67 are staff, 5 invited staff members, 48 close contacts and 1 close contact of the patient found from Welikada prison. A total of 638 have recovered from the Kandakadu Cluster and another 11 are still undergoing treatments, the centre highlighted.

While the contribution of green and renewable energy should be increased by 70% by the year 2030 and the current 32% contribution of diesel electricity should be reduced to 5%. Obstacles to the implementation of generation plans should be removed. Our current contribution to renewable energy is only 900 MW and we hope to double this by 2023," Minister Dullas Alahapperuma said.

# Prepare for development revolution backed by attitudinal change: President

President Gotabaya Rajapaksa stated that he has observed that country's common problem is the unwillingness of the people to work. He lamented slow moving pace of action on the part of both the government and private sectors, the President's Media Division stated in a press release.

The President cited the state of stagnation seen in the construction work in Colombo and suburbs as an example. He instructed each on-going construction to be completed immediately and requested all the parties to prepare themselves for a development revolution, backed by an attitudinal change, the statement read.

President Rajapaksa made these comments during a discussion with the State Ministry of Rural Home Constructions and Building Material Industry Promotion to review its future activities at the Presidential Secretariat, yesterday, the statement added.

The National Policy Framework "Vistas of Prosperity and Splendour" envisages in guaranteeing a "comfortable house for every family". The need of a residence is faced by many and construction of a house on their own is difficult. The President emphasized that it was absolutely necessary to meet the housing requirement of the people in urban, rural and estate sectors elevating their living standards.

State Minister IndikaAnurudda, in response expressed that his ministry under the concept of "A House for You: a Future for the Country", has commenced building 14,022 residences at Grama Sevaka Division-level for the families with low incomes. It is expected to complete 70,100 houses thorough this project at the end of coming five years, the President's Media Division stated.

The State Minister added that to coincide with the World Habitat Day on October 5, they have devised plans to commence the construction of 1,500 housing units in Werellawatta, Mihindupura, Parangiyakumbura, Dahaiyyagama, MattegodaSoizapura, and Tangalle under the "Multi-Facility Apartment Programme", the statement read.

President Rajapaksa highlighted the importance of participation of the private and state sectors in all the constructions. A long-term loan scheme with a repayment period of 30 years at 6.25% interest rate to purchase houses is to be introduced soon, the statement added.

"Steps will be taken to provide lands free of charge for the ministry to construct apartment complexes suitable for middle-income earners." the President added. He directed the officials to build houses for 409 displaced families now sheltered in 22 welfare camps in the Northern Province.

Pointing out that more than 526,000 households across the country are without toilets, Basil Rajapaksa, Head of the Presidential Task Force on Economic Revival, urged to accelerate the process to provide sanitary facilities for them.

State Minister Indika Anuruddha stated that the sewerage systems in the old apartment complexes need to be repaired and maintained and Prime Minister Mahinda Rajapaksa said that the Building Materials Corporation should be revived. The President suggested that the regional branches of the Corporation should be used as agents for supplying building materials, the press release

The present status of the Department of Buildings, Department of Government Factory, National Machinery Institute, State Development & Construction Corporation, State Engineering Corporation and Construction Industry Development Authority, as well as the steps to be taken to develop these institutions, were discussed at length at the meeting, the statement added.

Basil Rajapaksa stressed that all these institutions should work with great enthusiasm as a revolution in the fields of construction, agriculture and sports is expected from next

The government plans to build and renovate a large number of houses, roads, bridges and tanks, the President's Media Division

He instructed the relevant officials to involve all government and private sector institutions under the Ministry of Urban Development and Housing in the process of construction.

President's Secretary P.B. Jayasundera, Secretaries to Cabinet and State Ministries, Heads of Line Institutions, and Private Investors in the Construction Sector participated in the meeting.

### Industries Ministry calls for local manufacturing of Bhikku robes

The Industries Ministry plans to manufacture robes required for Buddhist monks locally instead of importing them from Thailand, Industries Ministry sources said.

During a discussion held recently with Industries Minister Wimal Weerawansa at his Ministry, the Anunayake of the Kotte Sri Kalyani Samagri Maha Sanga Sabha, Ven. Prof. Kotapitiye

Rahula Thera pointed said it is required to have more than 100,000 standard robes for more than 40,000 Buddhist monks currently living in the country, and that a significant amount of robes is annually imported to Sri Lanka to see to that demand.

Ven. Rahula Thera also briefed the minister about the possibility of manufacturing robes locally to cater the demand. "A few decades ago, quality robes required for Buddhist monks were produced locally through 'Lanka Salusala', but later, production was not sufficient to cater the demand. As a result, a large amount of robes were imported from Thailand," Ven. Rahula Thera said.

He further said Buddhist monks in countries such as Myanmar and Laos have their own unique identity, and that it is also required to maintain such an identity in Sri Lanka as well. After considering all the information pointed out by the Anunayake Thera, Minister Weerawansa instructed relevant authorities to take immediate measures to produce robes locally and further instructed Sri Lanka Institute of Textile & Apparel to do a comprehensive study on the manufacturing of robes using high-qual-

ity raw materials.



### **Court of Appeal rejects bail for Ajith Prasanna**

A bail application filed by retired Army Major, Attorney-at-Law Ajith Prasanna, requesting to enlarge him on bail, has been refused by the Court of Appeal. Prasanna had been remanded by Colombo Magistrate's Court over an allegation that he had intimidated witnesses in a case before Magistrate's Court during two media conferences. Court of Appeal two-judge-bench comprising Justice Achala Wengappuli and Priyantha Fernando decided to dismiss the bail application, citing that there is no exceptional circumstances

er on bail. The petitioner had filed this application requesting that he be enlarged on bail under Section 10(1)(a) of Assistance to and Protection of Victims of Crimes Act No. 04

The Petitioner stated that he had organised two media conferences in December 2019 "to educate the public about the harassment faced by individuals and their families attached to various intelligence branches of the armed forces due to subjective, arbitrary, and uniustifiable arrests of the security personnel by certain individuals

Subsequent to these two media conferences, the Petitioner was directed to make a statement to the Criminal Investigations Department after it had commenced investigations into a complaint by the Registrar of the Magistrate's Court of

He stated that he became aware that an Attorney-at-Law who appeared for the aggrieved party in a case Magistrate's before court had brought to the notice of Court that the Petitioner had intimidated witnesses during the media conferences.

President's Counsel Anil Silva, appearing on behalf of the Petitioner, submitted that the emotional and social impact on the daughter of the Petitioner due to the continued incarceration of her father had resulted in a psychologically termed illness of Ad-

justment Disorder. He invited the attention of the Court to the fact that she entertains suicidal thoughts. In the circumstances, he contended that her illness is qualified to be accepted as an exceptional, a factor in favour of the Petitioner, in the consideration of

bail.

sel Janaka Bandara, appearing on behalf of the Attorney-General, submitted that although he was sympathetic towards the young girl's psychologically traumatic experience, he is unable to concede to the position that such circumstances are exceptional in nature, since an arrest and detention of a family member will undoubtedly results in varying degrees of adverse impact, both psychological financial, on his immediate family; and therefore, the daughter of the Petitioner too is not placed in a situation that is different to the one faced by a daughter of any

another detainee. 

### Government to step up engineering faculty enrollments: GL

The government is taking steps to increase the number of students enrolled in engineering faculties. Education Minister Prof. G.L. Peiris said yesterday at his ministry during a discussion that they have stepped up actions to enable enrollment of additional 405 stu-

dents to the country's universities, which have six engineering faculties in each.

Accordingly, steps will be taken to enroll additional 405 students in the engineering faculties of the Universities of Peradeniya, Jayawardenepura, Jaffna, Ruhuna, Moratuwa, and South Eastern, this

year, Prof. G.L.Peiris said. He said neither he nor the government intends to interfere with the country's university administration. "We are only only working to achieve the objectives set out in the President's 'Visions of Prosperity and Splendor' Policy Statement," he said.

"We are planning to address inconsistencies that exist between the job market trends and the courses conducted by our universities," he said. "The enrollment of 405 additional engineering students to these universities is a forward step taken by us in that direc-

### 'Private buses to continue operations as long as there are no hindrances'

Private buses will continue operations as long as there are no hindranceswithout any congestion. However, if lane rules are implemented and the movement of private buses is hampered in any way, they would be removed from operation, Lanka Private Bus Owners' Association President Gemunu Wijeratne, told the Daily News.

He said the lane rule enforced by the police is an utter failure, and that it had only served to further complicate the traffic congestion. "Yesterday, we did not face any traffic blocks as the motorcycles and three-wheelers had been assigned a separate lane. However, if we have to face traffic congestion as we did when the lane rule was implemented, we will definitely pull out of operations." He said that the Lanka Private Bus

Owners' Association had planned to invest in low-floor buses, but under the current situation, where they allege that the police is hampering their operations, a decision had been taken not to invest in low floor buses at this stage.

According to Wijeratne, the solution

to the traffic congestion is not merely implementing the lane rule. "Merely implementing the lane rule is insufficient to address the traffic congestion on our roads; we have discussed this with the government and the relevant authorities In order to reduce congestion, it is vital to change the school times by dividing the times into two sections," he said.

"Furthermore, even office times need to be changed where private sector and state sector off times are divided in order to ease the traffic blocks. Heavy vehicles should be restricted on main roads, especially during peak rush hours. These are the ways that solutions to the traffic congestion issue needs to be found and not by merely herding all the buses, three-wheelers, and motorcycles onto one lane and accommodating only the private vehicles to operate smoothly," Wijeratne added.

"The police is also playing havoc. Hence, without proper mechanisms in place, we will not invest in better buses in order to improve the private bus service. We cannot invest when we have to face this uncertain future," he said.

## **'SL** to halt turmeric imports and grow its own'

The Agriculture Ministry has decided to halt the importation of turmeric from India in order to grow it here. Furthermore, aside from encouraging farmers to grow the crop, the ministry has also planned to encourage residents to grow turmeric in their home gardens.

The Agriculture Ministry said it plans to grow turmeric in the Northwestern Province (NWP). They added that they have received several complaints from consumers who allege that certain traders were mixing flour with yellow dyes and selling it as turmeric.

Turmeric is also a product widely used in the cosmetic industry. There is a high demand for turmeric in Sri Lanka that is one the rise and, therefore, cultivating it here would be profitable to the agriculture sector, the ministry said.

Raids are being carried out by the Consumer Affairs Authority against traders who are selling overpriced turmeric as well, the Agriculture Ministry added.





# Dropping the guard - Lankan style

n typical Sri Lankan style, the public seem to have forgotten that only three months ago the country was in the throes of a deadly pandemic that has now claimed nearly a million lives the world over and have let down their guard and going about their business, like in the old days, with nary a care in the world.

Despite regular warnings by the authorities, over the media, that the Coronavirus, though conquered for the moment in the Sri Lanka, could make a comeback in the form of a second wave, the people appear to take no notice, if one were to observe the passing scene.

The CTB and private buses are back to carrying their full loads, despite strict instructions that only seating accommodation is permitted, hotels, eateries and kiosks are serving meals indoors, although, as per the guidelines, only 'takeaways' are allowed, cinemas are back to their full capacities, and musical shows, sporting events, including bicycle races, are back with a vengeance in clear violation of the health regulations.

Not only that. Protest demonstrations too are gradually picking up reminiscent of the pre-Coronavirus days. A full blown protest was observed on television, the other day, where several hundred agitators sans the regulation face masks were battling with the Police who too were 'bare faced' over the shifting of the Labour Office in Ratnapura to Avissawella, while another protest was staged by University students opposite the University Grants Commission (UGC) calling for the release of colleagues in Police custody.

The situation is obviously was getting out of hand ,which, no doubt, prompted Army Commander Lt General Shavindra Silva to sound the alarm to drive some sanity into the general public. Lt.Gen. Silva who is also the Head of the National Operation Centre for the Prevention of COVID-19 outbreak, bemoaned that the health guidelines issued by the Health Ministry to prevent the spread of COVID-19 were being ignored and violated by the public as well as the organisers of the various events. "Unfortunately, at some events people behave like there are no Coronavirus patients in Sri Lanka. That is dangerous" he told a newspaper pointing out that COVID-19 patients had risen to 3,274, though there were no Coronavirus patients within society.

The Lt. General, no doubt, is echoing the sentiments of the various health authorities who had warned of the very real possibility of the Coronavirus re-visiting us if the guard is let down and the health guidelines ignored, which is exactly what is happening at present.

Although we talk glibly of a "new normal", from all appearances, its back to business once again for all. Most people have even dispensed with face masks even when traveling in buses despite strict guidelines issued to bus crew not to allow any persons board their buses sans the face mask. There is also the annual Book Fair to mark the Literary month at the BMICH where thousands are bound to congregate. In fact the organisers, the other day, boasted about 500,000 attending the event this year, though down from one million in previous years. Who is to ensure the health guidelines, particularly, social distancing, will be observed in the melee. In the same breath certain musical bands too have already put out their year-end programmes such as the traditional new year bashes, which, needless to say, is fraught with risk. One recalls the staging of a famous annual Big Match in the early days of the Coronavirus in defiance of health warnings, only to see a group of school boy participants contracting the virus. Hence, precautions are in order in instances where large gatherings flock, Dinner dances and New Year bashes cannot be exceptions although one might feel that worst is behind us.

There had been warnings from the GMOA too that the threat was far from over and the social spread of the pandemic was a very real possibility if the guidelines were not followed. Regrettably though after the initial compliance with the regulations caution was thrown to the winds by the public.

Perhaps the apparent leniency shown to offenders has made sections of the public disregard the regulations. It is time the authorities acted firm with those ignoring the health guidelines.

What was upon us was not an enemy you fight with guns and swords but a hidden menace of a deadly pandemic that has wreaked havoc across the world. The number of COVID-19 affected the world over has risen to an astonishing 30 million, with the death toll closing upon the one million mark. In India 5 million persons have contracted the virus which is too closer home for Sri Lanka to remain complacent. One cannot be more careful under the circumstances. This country won much encomiums and plaudits from the world's health authorities including WHO for the success achieved in combating the pandemic and preventing its spread by the measures taken by President Gotabaya Rajapaksa. It would be well to keep this record intact, by the public adhering to the same kind of discipline observed in the early days of the Coronavirus in this country.

# COVID 19: The new 'South Asian Enigma'?

outh Asian countries have been typically known for the high population density, with a large number of people surviving in compact spaces in urban slums and rural areas, making it a typical breeding ground for the Novel Coronavirus pandemic. Home to a half of the world's multidimensionally poor people in 2017, South Asian countries lack in various health and nutrition indicators, with inadequate public healthcare facilities. Some of South Asia's human development indicators, especially in the area of nutrition, have been worse than Sub-Saharan Africa, despite impressive poverty reduction and better economic growth, resulting in experts calling it the "South Asian Enigma". The persisting inequality and gaps in provision of basic amenities further cemented the belief that Covid-19 could be deadly for this region. However, six months into the Covid-19 pandemic, South Asia's fatality rates have left most confused.


One month into the pandemic, the world's most developed economies witnessed an unprecedented surge in Covid-19 cases as well as deaths, seemingly unable to cope with the virus. Meanwhile, the South Asian regioncomprising of Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka-when compared to the North American, East Asian or Western European region saw far lesser infections and deaths. On April 20th, South Asia, while accounting for 23.4 percent of the world's population, only contributed to 1.25 percent of the infections, and 0.5 percent to the deaths. Interestingly, Africa's morbidity and mortality burden from COVID-19 are similarly low, with experts talking about an "African Enigma" as well.

As of September 15, 2020, South Asia contributes to 19 percent of the global reported cases and 10 percent to the global reported deaths, skewed due to India's contribution of 87 percent of South Asia's cases and 86 percent to South Asia's deaths. When taking into consideration the large population size of South Asia, it seems to show a somewhat optimistic figure of 3,054 infections per million population and 50 deaths per million population, on completion of half a year of the pandemic.

### Low death rates in South Asia

It has been argued that the low numbers could have been the result of a delayed onset of community transmission in these countries, and perhaps an earlier adoption of country-wide lockdowns and international travel bans, given the healthcare system deficit. It has also been hypothesized that the mandatory BCG vaccination against Tuberculosis or the prevalence of other coronaviruses in these countries could have strengthened the immune system. On the other hand, lack of testing kits and infrastructure, leading to testing of symptomatic patients only, could also partly explain this paradoxical situation. However, it remains clear that death rates in South Asia remain surprisingly low.

A look at the South Asian countries reveals that, while cases have been rising and seem frightening when observed in absolute terms, the same numbers when looked at as population proportions reveal a different story. Graph 1 shows a comparison of the cases and deaths per million population in South Asian countries and the Top 10 most infected countries (except India). South Asian countries clearly indicate a lower spread of infection and the subsequent deaths caused by the disease. The most infected country with respect to population, Peru's deaths per million population (932) is 15 times higher than that of the most infected South Asian Country, Maldives (61). The low number of infections in South Asia could be hypothesized to be

a result of low testing, but the lower number of deaths indicate a different story altogether.

Currently, only three out of the eight South Asian countries—namely, India, Bangladesh and Pakistan—are in the top 20 most infected countries across the world. In terms of deaths, India is the only one to be in the top 20 list of the world.

### A sub-country analysis

When comparing the case and death per million population, Maldives seems to be performing badly, but these numbers can be misleading due its very low population base making clusters of cases result in higher per population figures. In absolute terms, Maldives seems to be performing adequately, considering the limited health infrastructure. The Covid-19 trend line (graph 2) seems to be showing a gradual flattening of the curve. While the nation seems to be strongly fighting and coping with the virus, the pandemic has offset other alarming issues. Two-thirds of the country's GDP is generated through its tourism industry, and the worldwide lockdown, travel bans and panic may threaten the country's immediate economic future.

India, while showing surprisingly low levels of infections and deaths during the initial few months of the pandemic, has now become the second most infected country in terms of cases, and third in terms of deaths. India has a

population of 1.3 billion, therefore the high number of cases in country vis-àvis rest of its South Asian counterparts is not surprising. The figures when adjusted for population seem less alarming, but the rising number of cases and deaths in India is concerning nevertheless. Graph 2 shows the upward trend in India's infections, without any particular sign of a flattening in the near future. The entire month of September has observed record-high increase in daily cases (more than -90,000) and deaths (more than -1000). Although cases and deaths are steadily rising in India, it is imperative that India ensures they fight not only Covid-19, but also the other infectious diseases that plague the country, especially with the disruption of health care services and livelihoods of Indians, due to one of the most stringent lockdowns. While it picked up pace rather late after allowing the infection to spread, India has been testing aggressively lately, reaching 42,000 tests per million.

Bangladesh and Pakistan present similar scenarios, wherein Covid-19 infections have surpassed 300,000 and death per million population is 29 for both the countries. Both countries have been demonstrating a flattening trend in terms of cases as well as deaths, however, they have also shown a lower testing per million population—Pakistan (13,510 tests per million) and Bangladesh (10,645 tests per million)—which could be one of the possible reasons for the lower number of

cases. Similarly, Afghanistan has as low as 38,772 confirmed cases and 1,425 confirmed deaths, as of September 15th, but Afghanistan has one of the world's lowest testing statistics, with a total of 107,167 tests conducted, which make up 2,740 tests per one million population. The low level of tests and the subsequent fall in the cases has raised questions regarding the reliability and transparency in the data being


The trajectory of Nepal and Sri Lanka has been completely different. Nepal has observed a lower number of cases as well as fatalities from the beginning, while maintaining strong testing capabilities, but the month of September has seen a surge in cases. The surge in cases has raised some concerns, but at just 12 COVID-19 deaths per million, the mortality burden is low, and the government seem confident that the spread can be effectively contained. Amongst the South Asian countries, Sri Lanka has the lowest levels of infection (152 cases per million population), with only 13 recorded Covid-19 deaths so far. The country has been applauded for its strict quarantine rules and robust contact tracing, effectively curbing the spread of the disease.

Termed as the 'Coronavirus Success Story', Bhutan has been successfully detecting and containing the spread of the disease by strongly imposing quarantine on returning international citizens, and deployment of tech-based solutions to enhance contact tracing. Bhutan has also borne the cost associated with testing, quarantine and treatment, in addition to providing financial assistance to its citizens to ease the pandemic stress. With only 246 cases and no deaths, Bhutan has devised an effective prevention and control system.

In the global comparison sheet, South Asia's performance has been more or less positive, but with no vaccination in the picture, these countries must remain vigilant. South Asia also constitutes a large conflict-affected population, in addition to a considerable poor and highly immune-compromised population, making it extremely volatile to the future events. It was recently suggested by an industry leader that at least four to five years will be needed to provide vaccinations to the global population.

Moreover, multiple barriers still need to be overcome to determine whether the emerging vaccine will be able to effectively reach the masses. Given the high population densities and low income in the South Asian countries, a vaccine may not present the perfect solution. Past experiences have taught us that lesser developed countries need to be prepared for delayed availability of the vaccine and therefore need to dedicate resources in to preventive measures; while at the same time restarting their economies cautiously to maintain the levels of human development that have been achieved in the past decade, and to prevent a parallel human tragedy.

# Major US-led ME accords with Israel

srael signed two normalization agreements with the United Arab Emirates (UAE) and Bahrain this week in what is seen as a historic move in Middle Eastern relations. Earlier only Jordan and Egypt had such relations with Israel.

The signing took place at the White House in Washington, with President Donald Trump and Israeli Prime Minister Benjamin Netanyahu joining the foreign ministers of the UAE and Bahrain.

President Trump hailed the occasion, claiming it will "change the course of history" and marks "the dawn of a new Middle East".

"Together these agreements will serve as the foundation for a comprehensive peace across the entire region, something which nobody thought was possible, certainly not in this day and age," Trump said. "These agreements prove that the nations of the region are breaking free from failed approaches of the past. Today's signing sets history on a new course and there will be other countries very soon that will follow these great leaders."

Netanyahu described the day as a "pivot of history, a new dawn of peace"

"Since the moment of its birth, Israel has yearned for peace with our Palestinian neighbours and peace with the broader Arab world. For decades, that peace has proved elusive, despite so many well-intentioned plans. One after the other, they failed. Why did they fail? They failed because they did not strike the right balance between Israel's vital security and national interests, and the Palestinians' aspirations for self-determination," Mr. Netanyahu said.

The UAE and Bahrain are close allies of the US, with each country hosting a significant US military presence. The US Air Force has deployed F-35 fighter jets to an air base in Abu Dhabi, while the Navy's Fifth Fleet and Central Command are based in Bahrain. That military presence has drawn the leaders of the UAE and Bahrain closer to the US, and because of the anti-Iran alliance, closer to Israel.

The last time such a ceremony took place in Washington was in 1994, when President Bill Clinton looked on as Israeli Prime Minister Yitzhak Rabin and Jordanian King Hussein signed a declaration that paved the way for a peace deal months later.

For Trump, the timing was crucial. Less than two months before an election in which he trails in the polls, normalization agreements between Israel, the UAE, and Bahrain are considered major foreign policy achievements.

The UAE has made clear that one of the benefits it sees from the normalization agreement with Israel is that it should be easier to acquire F-35s from the United States, a view also shared by Trump's senior adviser Jared Kushner. That would give the Emiratis the latest fighter jet in the US inventory and a significant edge over any other military in the region, with the exception of Israel.

The UAE called for a suspension of Israel's intended annexation of parts of the West Bank, and made it clear this was one of its conditions for normalizing relations. Though it's unclear how long the suspension lasts, for the UAE, this kept alive the possibility of a two-state solution, which it says is the only possible end to the Israeli-Palestinian conflict

Speaking at the White House, the UAE Foreign Minister Sheikh Abdullah bin Zayed thanked Israel for "halting" the planned annexation of Palestinian territories, saying it "reinforces our shared will to achieve a better future for generations to come."

For both the UAE and Bahrain, the agreements also open up the possibility of purchasing Israeli high-tech, including military technology such as the Iron Dome missile defense system, as well as cooperation on economics, health, tourism and more.

Israel's Netanyahu gets to show a major foreign policy achievement, one that only two other Israeli leaders have been able to achieve. Menachem Begin signed a peace treaty with Egypt in 1979. Yitzhak Rabin signed a peace treaty with Jordan in 1994

The White House ceremony also helped distract from Netanyahu's domestic issues: a tattered economy dealing with 18% unemployment, a coronavirus crisis that has forced Israel into a second general lockdown, and his own trial on corruption charges. He has repeatedly proclaimed his innocence.

For decades, Washington has

been the key broker of peace in the Middle East and the crucial moderator in Israeli-Palestinian negotiations. It was President Jimmy Carter who stood between Menachem Begin and Anwar Sadat, and Bill Clinton between Yitzhak Rabin and King Hussein.

The Palestinians feel betrayed by current developments. The 2002 Saudi-led Arab Peace Initiative called for an end to the Israeli-Palestinian conflict before Arab states normalized relations with Israel. The Palestinians cut off contact with the White House after the Trump administration moved the US Embassy to Jerusalem and took other pro-Israel steps.

While the Palestinians have the support of Iran, Turkey, and a few others, but its traditional Arab partners are moving closer to Israel. In a sign of that movement, the Arab League failed to pass a resolution backed by the Palestinians that would have condemned the UAE-Israel agreement.

Iran's President Hasssan Rouhani has said the UAE and Bahrain would be responsible for any 'consequences: resulting from their normalisation of relations with Israel. He said Israel is 'committing more crimes in Palestine every day'.

#### UK - No Deal?

The United Kingdom is moving ahead with its legislation that would break international law, in the departure agreement with the European Union (EU).

The Internal Market Bill giving Boris Johnson's government the power to override parts of the Brexit agreement with the EU was passed in its first reading in the Commons, with 340 votes for and 263 against.

Ministers say it contains vital safeguards to protect Northern Ireland and the rest of the UK, if negotiations on a future trade deal break down. But critics, including a number of Tory MPs, warned it risks damaging the UK by breaching international law.

There's increasing concern of a dangerous no-deal exit from the European Union, of the Good Friday Agreement with Ireland unraveling in Northern Ireland and of the U.K. needing to take back control of its sovereignty.

Prime Minister Boris Johnson is fully supportive of the new legislation, the U.K. Internal Market Bill, which seeks to override key provisions in that deal over the future of Northern Ireland. Under the withdrawal deal with the EU, Johnson agreed to keep Northern Ireland aligned to EU rules and regulations, an arrangement seen as critical to keeping an open border between Northern Ireland and Ireland, an EU member.

In a stunning reversal, Johnson now claims the protocol over Northern Ireland can be annulled and that the U.K. cannot be bound by the deal. He says the new legislation "clarifies" the U.K.'s position.

His stance has opened up a ferocious legal debate about the limits and boundaries of international laws and Parliament's sovereignty. At the time when he negotiated the agreement, Johnson called the deal "oven ready" and he touted it as a "great deal" during a successful election last December which gave him a wide majority in the House of Commons and ended the hopes of those seeking to stop Brexit.

Now, evoking hardline pro-Brexit language, the Tory prime minister says the deal his government agreed to threatens to "carve up" the U.K. He even stated that the deal, if enacted, would threaten peace in Northern Ireland.

All five living former prime ministers have come out against the bill, arguing that it would damage the U.K.'s reputation as a paragon of the rule of law and jeopardize the fragile peace in Northern Ireland. They are John Major, David Cameron - Conservative, and Tony Blair and Gordon Brown - Labour.

The EU leaders are calling Johnson untrustworthy. Unless the Internal Market Bill is withdrawn, the EU is threatening to take legal action against the U.K. Regardless,

Johnson's move to torpedo the withdrawal agreement is seen as damaging the prospect for a trade agreement even though both sides say they want one to avoid economic disruptions and damage.

EU Commission chief Ursula von der Leyen stressed that both the EU and Britain negotiated and ratified their Brexit divorce deal and warned the UK that it "cannot be unilaterally changed, disregarded or disapplied". "This is a matter of law, trust and good faith... Trust is the foundation of any strong partnership," she said, referring to the UK government's stated intention to breach elements of the pact.

US presidential candidate Joe Biden also warned of the new bill's implications for a future UK-US trade deal, adding to concerns among senior US politicians that changes associated with the Internal Market Bill will undermine the Good Friday Agreement, which many US leaders were associated with negotiating.

### Japan - New PM

Japan's parliament has elected Yoshihide Suga as the country's new prime minister, following the resignation of Shinzo Abe.

A close ally of Mr. Abe, the new prime minister is expected to continue his predecessor's policies. Mr. Suga easily won a poll for prime minister in the Diet, Japan's lower house, receiving 314 out of 462 vetes.

A veteran politician and long-time cabinet member he takes the lead at a difficult time for the world's third-largest economy. Japan is struggling with the coronavirus pandemic which has caused the biggest economic slump on record following years of economic stagnations.

The country is also dealing with a rapidly aging society, with nearly a third of the population older than

Mr. Suga has served for years as Chief Cabinet Secretary, the most senior role in government after the prime minister. He has already promised to carry on much of the previous administration's agenda, including the economic reform programme dubbed Abenomics.

The son of a strawberry farmer, the veteran politician comes from a humble background that sets him apart from much of Japan's political elite. The 71-year rose only slowly within the political ranks.

### **EU - Green Deal**

EU Commission chief Ursula von der Leyen announced plans to relaunch Europe's coronavirus-devastated economy through a Green New Deal, in her maiden State of the European Union address. With wildfires, drought and collapsing glaciers wreaking havoc around the world, von der Leyen said decisive action to tackle climate change could create millions of extra jobs, aiding Europe's economic recovery. She said the EU should set a target to cut its greenhouse gas emissions by at least 55% by 2030, up from a current target of 40%. The upgrade would put the EU "firmly on track" for its plan to reach net zero emissions by 2050.

She acknowledged the proposal would divide the European Parliament and member states, who must approve the legally binding target but who disagree on how ambitious it should be. "I recognise that this increase from 40 to 55 is too much for some, and not enough for others," von der Leyen told European lawmakers in Brussels.

The goal will require huge investments in transport, heavy industry and energy — where businesses will also face higher carbon costs under EU plans to revamp its carbon market. Von der Leyen said 30% of the bloc's 750 billion euro coronavirus recovery package of grants and loans, which the EU as a whole will borrow, should be raised through green bonds.

But in July the EU agreed on a stimulus plan that paved the way for the European Commission to raise billions of euros on capital markets on behalf of them all, an unprecedented act of solidarity in almost seven decades of European integration

She added: "This is the moment for Europe to lead the way from this fragility towards a new vitality."

### **Belarus protests**

The Belarus opposition activist Maria Kolesnikova has been officially charged with incitement to undermine national security. She is currently in jail in Minsk after ripping her passport last week to thwart an attempt to expel her to Ukraine. She is a strong critic of President Alexander Lukashenko and played a key role in the continuing mass demonstrations by protesters who accuse Lukashenko of rigging the recent election that saw his re-election, with 26 years in office.

With more than 400 protesters now in custody, more than 100,000 demonstrators calling for the authoritarian president of Belarus to resign, marched through the capital of Minsk on Sunday as the protests that have gripped the nation entered their sixth week.

The embattled President Lukashenko, held lengthy talks with his Russian President Vladimir Putin, on Monday, in a meeting seen as crucial to determining whether or not Lukashenko can survive a protest movement against him.

Putin said Russia would offer a loan of \$1.5bn to Belarus, which could help Lukashenko avoid an economic crisis in the short term. He stands ready to send Russian police into Belarus if the protests turn violent, stoking fears that Moscow could use the political dissent as an excuse to annex its neighbour as it did in Crimea in 2014.

Svetlana Tikhanovskaya, who was defeated by Lukashenko in the now questioned election in August, and now in exile in neighbouring Lithuania, in a statement said: "I want to remind Vladimir Putin, whatever you agree on in Sochi will not have legal force, any agreements signed with the illegitimate Lukashenko will be revisited by the new government. Because the Belarusian people withdrew their trust and support for Lukashenko at the elections. I regret that you have decided on dialogue with a usurper, and not with the Belarusian people."

### India - China

India and China have agreed to "quickly disengage" from a standoff that has seen gunfire at a disputed border and accusations of kidnapping. Their foreign ministers said they would ease tensions.

Soldiers from both countries have periodically skirmished along the poorly demarcated border, called the Line of Actual Control. Both sides have accused each other of straying into their territory, and the clashes have sometimes turned deadly.

In a joint statement, the neighbours said the "current situation is not in the interest of either side". "They agreed, therefore, that the border troops of both sides should continue their dialogue, quickly disengage, maintain proper distance and ease tensions," said the statement, released by Indian Foreign Minister S. Jaishankar and his Chinese counterpart Wang Yi.

They added that they would expedite new measures that would "maintain and enhance peace and tranquillity", but did not explain further what these would entail.

India's Defence Minister Rajnath Singh who addressed the Lok Sabha on the border tension with China, said India is "very serious about issues of sovereignty" and the country is "prepared for all outcomes" to ensure that it is maintained. India remains committed to resolving the current issues in our border areas through peaceful dialogue and consultations. The Chinese actions reflect a disregard of our various bilateral agreements. The amassing of the troops by China goes against the 1993 and 1996 Agreements, he said.

### Venezuela

UN investigators have said the government of Venezuelan President Nicolas Maduro has committed systematic human rights violations including killings and torture amounting to crimes against humanity.

The report says reasonable grounds existed to believe that Maduro and his interior and defence ministers ordered or contributed to the crimes documented in the report to silence opposition. Specifically they had information indicating Maduro ordered the director of the national intelligence service SEBIN to detain opponents "without judicial order".

The report was based on more than 270 interviews with victims, witnesses, former officials and lawyers, and confidential documents.

Most unlawful executions by security forces and state agents have not been prosecuted in Venezuela, where the rule of law and democratic institutions have broken down, the investigators said. They said other national jurisdictions and the International Criminal Court (ICC), which opened a preliminary examination into Venezuela in 2018, should consider prosecutions.

"The Mission found reasonable grounds to believe that Venezuelan authorities and security forces have since 2014 planned and executed serious human rights violations, some of which – including arbitrary killings and the systematic use of torture – amount to crimes against humanity," panel chair Marta Valinas said.

### **US - Fire and rain**

As the fires continue to blaze on the US West Coast the billowing wildfire smoke that has blanketed much of the West Coast with a caustic haze also begins settling into the atmosphere thousands of miles away in New York in the US.

While more favourable weather has allowed firefighters to make some progress against the devastating blazes in Oregon, the crisis was far from over: The largest fires were still mostly uncontained, the air has been some of the most polluted on the planet for a week, and the state was setting up a mobile morgue as crews continued to sift through the rubble for missing people.

In California, where 25 people have died this year and 3.2 million acres — a modern record — have burned, officials had both successes and setbacks: Firefighters there contained two fires, one in Yuba County and the other north of Willits, and were trying to suppress 33 new blazes as stiff winds in the northeast pushed fires into new territory. There was still no significant rain in sight, and lands parched by warm weather remain at risk of igniting.

At the North Complex Fire, which has burned more than 270,000 acres northeast of Sacramento, winds whipped the flames across a clearing that had been plowed by bull-dozers.

Crews back in Los Angeles were working on Tuesday to beat back one wildfire that approached to within 500 feet of the famed Mt. Wilson Observatory, according to the U.S. Forest Service.

West Coast residents from San Francisco to Seattle and beyond have for days suffered from the smoke, which has sent air-quality readings soaring to hazardous levels, closed some schools and led officials to shut parks and beaches while pleading for people to stay indoors.

Meanwhile in the US East Coast Hurricane Sally was moving very slowly with 90-100 mph winds, bringing many hours of rain, wind and a storm surge for the central Gulf Coast, giving heavy rainfall through Friday.

### **COVID** spread

The COVID 19 spread continued strong globally, with the number infected in India passing the five million mark midweek, with India being second to the US in the number of cases confirmed.

The death toll from Covid in India

is much lower than other countries. The midweek figures of the Covid spread shows 29,868,230 globally, with 940,716 dead. In the US it is 6,630,891 infected and 196, 802 dead, approaching 200,000 speedily. The figures for India are 5,118, 253 infected and 83,198 dead. Brazil had 4,419,083 infected and 134,106 dead.

As of Midweek, 2 675 637 cases have been reported in the EU and the UK: Spain -603 167, France -395,104, United Kingdom -374,228, Italy -289 990, Germany -263,663. The numbers of deaths are 184,154, with UK 41,664, Italy 35,633, France 30 999, Spain 30,004, Germany 9,368.

# Registration of supplier community for e-GP System

The Government of Sri Lanka is inviting the supplier community to register with Electronic Government Procurement System (e-GP System) who wish to supply goods, works and consultancy and non-consultancy services to the Government, the Finance Ministry said yesterday.

This system has been developed with all the essential modules such as Vendor Registration, Procuring Entity Registration, Announcement of Bids, Calling and Receiving of Bids, Electronic Bid Opening, Electronic Bid

Evaluation and Contract Awards, facilitating Shopping and National/International Competitive Bidding procurement procedures, the ministry in a statement said.

All Government organizations have been requested to use the e-GP system in procuring goods, works and services at earliest. Therefore, all the suppliers are requested to register with the e-GP system by 31 December 2020 as the use of e-GP system will be made mandatory in due course.

Firms that are registered with

the system are eligible to participate in bidding for all procurements of all the government entities, without registering manually with each Procurement Entity.

Annual Registration Fee: Firms who wish to register before 30 November 2020 are given a concessionary registration fee of Rs 5000. Also international suppliers are charged USD 50 as the registration fee. Each registration is valid for a 12 calendar months period. Payment should be made via credit/debit cards through the

Meeting the Registration Criteria: Firms wishing to register are required to logon to the website and follow the process as required.

# No evidence to back sexual harassment claims - SriLankan Airlines

Responding to a New Delhi court case against one of its former senior officials, SriLankan Airlines yesterday said it was not a party to the legal action and that an Internal Committee was of the view that the former Sales Executive's complaint of "sexual harassment" could not be justified and her transfer to Cochin would stand.

Issuing a statement in regard to the Delhi court case against a former senior official of the airline and the subsequent media reports that are currently being circulated, SriLankan Airlines said an inquiry had found there was no evidence

to support sexual harassment allegations made by a former employee against a former airline official.

SriLankan Airlines had received a complaint from the Sales Executive in 2011 alleging an incident took place in 2009 involving the former Regional Manager and she had been transferred from the airline's office in New Delhi to the office in Cochin.

Upon receiving the complaint, the airline had conducted an inquiry in terms of the Company's special policy against harassment in 2011 and the Committee had determined that her transfer to Cochin had been based on commercial requirements. As the former Sales Executive had been dissatisfied with the outcome of the inquiry and she wanted another inquiry, the airline had conducted a further inquiry into her complaint in 2014 in line with the Sexual Harassment of Women at Workplace Prevention, Prohibition, and Redressal Act of 2013 in India, where the Committee had been of the view that her complaint of "sexual harassment" could not be justified and her

transfer to Cochin would stand. However, SriLankan Airlines stated that as the former Sales Executive did not comply with

the requirement of the Company to report to the office in Cochin, the airline was compelled to terminate her services on disciplinary grounds following the due procedure in terms of laws in India.

The airline further stated that SriLankan Airlines is one of the first corporate entities in Sri Lanka who adopted a policy against harassment at workplace way back in 2007, adding that they are committed to ensure a safe working environment for all its employees and maintains a zero-tolerance policy against any kind of harassment.

# Japan's red-tape hotline hits a snag hours after launch

JAPAN; Just nine hours after Japan's new minister for administrative reform launched an online system for reporting excessive bureaucracy and red tape, it hit a snag: too many complaints.

Former Defence Minister Taro Kono, now charged with the reform portfolio, said it had been effectively overwhelmed and would be closed temporarily.

Kono, an enthusiastic Twitter user who regularly interacts with people on the platform, announced the complaints system shortly after he was appointed by newly elected Prime Minister Yoshihide Suga on Wednesday. "Please send information, such as unnecessary regulations, rules that are making your job difficult and bureaucratic silos that are problematic," he wrote on his Japanese Twitter account.

Not long after, he proclaimed excitedly on his English-language account that the digital complaints box had "received more than 3,000 emails in just hours!" But the deluge apparently proved too much.

"I received far more emails than I'd expected," he conceded. "I'm suspending reception of new emails to go through what I've received so far." Japan's new leader Suga has said dealing with red tape and excessive bureaucracy will be a top priority for him.

Cutting through red tape was also a key plank of the "Abenomics" economic policy of his predecessor Shinzo

# India to boost defences on China frontier

**INDIA:** A tunnel nearing completion in the Indian Himalayas will slash by hours the time it takes troops to reach the Chinese border, part of an infrastructure blitz by New Delhi that is gathering pace since a bloody border clash.

The nuclear-armed Asian giants blame each other for a brutal highaltitude battle in June that left 20 Indian soldiers dead and an unspecified number of Chinese casualties.

Both have sent massive troop reinforcements, but India has also stepped up its activities behind the frontlines - belatedly so, analysts

Its stepped-up infrastructure programme includes roads and bridges as well as high-altitude helipads and airstrips for civilian and military

The showpiece is a \$400-million tunnel in Himachal Pradesh state, providing an all-weather route for military convoys to avoid a 50-kilometre (30-mile) trudge through mountain passes that are snowbound in winter and subject to frequent landslides.

From late this month, what used to be a four-hour, winding, highaltitude crossing will be cut to a 10-minute dash through the mountains in the state-of-the-art tunnel.

"There have been times on the pass route when vehicles have broken down, causing traffic jams of even six to eight hour," said Lieutenant-General Harpal Singh, head of India's Border Roads Organisa-

"This tunnel and the other infrastructure plans change a lot for the

A decade in the making, freezing winter temperatures meant work could only take place from April to September. Workers wore special microchips to help locate them if they got trapped in an avalanche. Still, India's efforts only belatedly mirror those of China, experts say.

"Earlier administrations wasted two decades," said Harsh Pant, from the Observer Research Foundation think-tank in New Delhi. "China, and its infrastructure, is much stronger today."

Sanjay Kundu, the Himachal Pradesh police chief, has also proposed arming locals and training

spies and drone and helicopter cuts journey times from Ladakh's sightings.

"Ultimately, whether it is at the border or the hinterland, people need to be trained and they need to be trained in defending themselves," he told AFP. The government hopes it will reassure worried villagers.

### Global virus cases top 30 million

### WHO warns of "alarming rates of transmission"

**DENMARK:** Broad new restrictions were imposed yesterday across large parts of Europe to stop the COVID-19 coronavirus, after infections worldwide topped 30 million and the World Health Organization warned of "alarming rates of transmission".

Britain is limiting gatherings and France is set to roll out new curbs for major cities as governments across the continent battle fresh spikes of the disease.

More than 943,000 people have now died from COVID-19 since it first emerged in China late last year, according to an AFP tally, with Europe accounting for more than 200,000.

WHO regional director for Europe Hans Kluge said a surge seen this month "should serve as a wake-up call" after the continent recorded 54,000 infections in a single day last week -- a new

"Although the numbers reflect more comprehensive testing, it also shows alarming rates of transmission across the region," Kluge told an online news conference from Copenhagen.

The Spanish capital of Madrid said it had been overwhelmed by the virus and called for "decisive" action from the central gov-



ernment, which is set to unveil a raft of new restrictions Friday.

Madrid officials warned that the region's healthcare system was coming under increasing pressure, with one in five hospital beds occupied by Covid patients amid a second wave of the illness.

Anxiety has been growing in the city about the prospect of a return to lockdown after a top regional health official on Wednesday raised the possibility for the worsthit areas.

"It would be bad for shops, for small businesses and little bars that survive on people coming in,'

said 55-year-old Maribel Quesada. "People are really sick of being at home, the (spring) lockdown was very difficult.'

In Britain, new curbs came in to effect on Friday, with Prime Minister Boris Johnson warning that pubs may have to close earlier to help avoid a "second hump" of

About two million people in

northeast England, including in the cities of Newcastle and Sunderland, will no longer be allowed to meet people outside their homes. Only table service will be allowed in bars and entertainment venues will have to close by 10pm.

The government already imposed rules across England on Monday limiting socialising to groups of six or fewer, as daily cases reached levels not seen since early May.

French authorities are also preparing tighter restrictions in several cities to curtail a resurgence that has seen nearly 10,000 new cases per day in the past week.

Health minister Olivier Veran said Lyon and Nice would be under new rules by Saturday, after curbs on public gatherings were imposed this week in Bordeaux and Marseille.

Israel is set to become the first developed country in the world to enforce a second nationwide shutdown, beginning Friday afternoon.

The move sparked protests in Tel Aviv late Thursday when hundreds took to the streets against the restrictions, which are set to take effect just hours before Jewish New Year and will cover other religious holidays including Yom Kippur. - AFP

# COVID-19, cash crunch leaves UN in a quandary

**SWITZERLAND:** Meetings postponed and marble-clad hallways echoing empty: The coronavirus pandemic and a liquidity crunch have all but silenced the usual frenzied diplomatic wrangling at the United Nations headquarters in

As the world grapples with multiple towering crises linked to COVID-19, fears abound that the world body is sink ing into lethargia and that the already suffering multilateral system risks buck-

ling.
"The response to the crisis must be multilateral," French Ambassador Francois Rivasseau told the UN Human Rights Council this week, stressing that it was "essential that the international organisations resume their work."

"The resumption of activities is slow and we are beginning to worry," agreed a European diplomat who asked not to be identified.

Usually bustling with delegates and UN staffers from across the world, the UN cafeteria has for weeks been eerily quiet, with a handful of masked people carrying trays of pre-portioned food past a former salad bar draped in plastic.

The dramatic slowdown at the UN's Palais des Nations headquarters has come even as host country Switzerland has remained relatively unscathed by the pandemic, dodging the strict confinement measures seen in neighbouring countries. The UN, which usually houses thousands of staff, delegates, activists, journalists and others on any given day, decided back in March to halt all in-person events and shut its doors to all but a few dozen essential workers.

By early September, only around 30 percent of the UN Geneva Secretariat's some 2,900 staff members had returned to their offices.

The UN has since asked remote workers to come back, but on a rotational basis so as not to pass 60 percent of the pre-pandemic occupancy.

The Human Rights Council is one of the only UN bodies that has maintained physical meetings at the Palais, largely due to the tenacity of council president Elisabeth Tichy-Fisslberger of Austria, who quickly pushed through a hybrid

But only one representative per country delegation is allowed into the meeting hall, and the UN has barred countries and non-governmental organisations from holding their usual slew of side events on its premises during the council sessions.

Trine Heimerback, Norway's deputy permanent representative in Geneva, hailed the UN for doing its best in difficult circumstances, but voiced concern over the reduced access for civil society

"It is not as inclusive as Norway at least would have liked," she told AFP. As for other UN bodies, many have postponed or cancelled their planned assemblies and meetings. Too many,

"When it comes to disarmament, the annual meetings have been postponed,' another European diplomatic source said, blaming some countries who had insisted people from their capitals needed to travel in to participate.

# Biden targets working-class in town hall speech

**US:** Joe Biden on Thursday lashed President Donald Trump over his "close to criminal" handling of the coronavirus as the Democrat fielded questions from voters impacted by the pandemic in a state that is key to his election hopes.

Returning to the gritty city of his birth, the former vice president engaged in an outdoor town hall in Scranton, Pennsylvania, where he painted himself as the champion of hardworking Americans who he said have been ignored by a President more concerned about boosting Wall Street than helping working families. Biden, appearing energized as he handled participants' questions, also accused Trump of knowing the seriousness of the coronavirus threat early this year and hiding it from the nation.

"He knew it and did nothing. It's close to criminal," Biden said in one of several fiery criticisms of Trump. "This President should step down," he added.

The 77-year-old candidate also used a populist inflection, framing the 2020 election between him and billionaire real estate mogul Trump as "a campaign between Scranton and Park Avenue." Blue-collar Americans -like the family Biden grew up in -- "are as good as anybody else," he said. With less than seven weeks before the November 3 election, Biden has ramped up

his public appearances after spending large chunks of time at his Delaware home, even as Trump repeatedly barnstorms swing states.

Now both candidates are hitting the physical campaign trail in earnest, although still in different ways.

Trump returned to Wisconsin Thursday for a public rally fueled by his signature bravado - a contrast to Biden's quieter style. Biden is attempting to project a calming alternative to Trump's fury. At the CNN town hall Biden took questions from a live, socially distanced audience of 100 people, who parked in front of the stage to watch the event.

Trump, talking to supporters in Wisconsin, branded Biden's drive-in town hall "the weirdest thing I've ever seen."

Trump focused on promises of economic growth -- one area where polls consistently show him ahead of Biden -- and claimed that under the Democrat pension funds would "go down like to depression levels.'

Biden has largely kept close to his home in Delaware during the pandemic which has so far killed nearly 200,000 Americans.

He has traveled to swing states like Wisconsin, Florida and Pennsylvania, but has dodged crowds and engages with voters in small, controlled settings.

# WHO urges safety for health workers

SWITZERLAND: Too many doctors and nurses are paying the ultimate price while battling Covid-19, the World Health Organization said Thursday as it launched a charter aiming to boost safety for health workers.

The UN health agency said that the pandemic had exposed health workers and their families to "unprecedented levels of risk".

While the coronavirus crisis has taken a heavy toll overall, data from many countries and regions show that healthcare workers have been infected at a far higher rate than the general population.

Health workers represent less than three percent of the population in most countries and less than two percent in low- and middle income countries, but account for around 14 percent of all Covid-19 cases reported to the WHO.

In some countries, the proportion has been as high as 35 percent, the body said.

On Wednesday, the International Council of Nurses said thousands of nurses had likely died in the pandemic, pointing to numbers from just 44 countries showing 1,097 deaths by mid-

The COVID-19 pandemic has reminded all of us of the vital role

health workers play to relieve suffering and save lives," WHO chief Tedros Adhanom Ghebreyesus told a virtual

"We all owe health workers an enormous debt, not just because they have cared for the sick, but because they risk their own lives in the line of duty.'

The risks are not only physical. The WHO pointed to "extraordinary levels of psychological stress" on health workers, who have been asked to work long, draining hours battling Covid-19, living

in constant fear of being infected. Many are also living separated from their families, and facing social stigma amid fear they are carrying the virus.

These strains are increasing the likelihood of depression among medical professionals, who were already more at risk of suicide than the general public in a number of countries prior to the

One in four health care workers surveyed for a recent study said they were struggling with depression and anxiety amid the pandemic, while one in three said they had suffered insomnia, the WHO said. In its charter presented Thursday, the WHO emphasised the legal and moral obligations governments have to ensure the health, safety and wellbeing of health workers. - AFP

### **Japanese SC rules in favour of tattoo artist**

**JAPAN:** Japan's Supreme Court has sided with a tattoo artist who was fined for practising without a medical licence, in a case that revived debate about the country's uneasy relationship with body ink.

Though tattoos have a long history in Japan and the nation has long boasted leading artists, body ink is still often associated with "anti-social" elements, particularly members of criminal groups known as the yakuza.

People with tattoos are often prevented from using public facilities like swimming pools or baths, and in 2015, Osaka tattoo-

ist Taiki Masuda was arrested for allegedly violating the Medical Practioners' Act by tattooing people without a doctor's licence.

Masuda was fined 150,000 yen (\$1,400) by an Osaka district court, but the ruling was overturned on appeal in 2018. Prosecutors decided to take it

to the Supreme Court, which this week rejected their appeal, a Friday. The Supreme Court backed the earlier ruling that tattooing should not require a doctor's licence because it carries lit-

# Oceanpick donates Seabass fingerlings to fishing communities

In an effort to bolster national fish production as well as to improve the livelihoods and food security initiatives of smallholder farmers in Sri Lanka, Oceanpick (Pvt) Ltd. -South Asia's spearheading oceanic farming operator-, recently distributed free fingerlings to small-scale fish farmers across the island.

Having started off as South Asia's first ever commercial-scale offshore oceanic farm for finfish, and currently still the only offshore aquaculture operation in Sri Lanka which is also BOI-approved.

Operating from its main Seabass and Barramundi hatchery

untouched waters of Trincomalee, Oceanpick is positioned with a geographical advantage, nestled amongst a major aquaculture hub alongside India and Bangladesh. However, the sustainable marine fish farm has taken the lead in Seabass and Barramundi culture, having recently being awarded the Global Aquaculture Alliance's Best Aquaculture Practice (BAP) certification for Barramundi in South Asia; highlighting Sri Lanka on the map as having the first BAP-certified aquaculture facility in the region.

Seabass farming has proven to be an effective and sustainable economic activity; one that has the capacity to increase the income of fishing communities owing to its low environmental and operational costs.

At the Oceanpick facility, Sea Bass fingerlings are first allowed to hatch out and grow in the company's on-shore nursery located close to the sea sites, and are then transferred to sea cages anchored to the ocean floor, where strict biosecurity standards are maintained and the waters consistently monitored for temperature and salinity



# 'Scaling Innovations in Cellulosic Recycling project launched'

With the aim to investigate economically viable and scalable solutions for cellulosic chemical recycling to enable a closed-loop system converting textile waste - of cotton and cotton-blend materials, to produce new man-made cellulosic fibres, Fashion for Good the global initiative set to make all fashion good, launched the Full Circle Textiles Project: Scaling Innovations in Cellulosic Recycling, a first of its kind consortium project.

Focusing on cellulosic fibres, this Project aims to validate and eventually, scale promising technologies in chemical recycling from a select group of innovators as 73% of the clothing we produce is sent to landfill or is incinerated and of all new clothing made, less than 1% of the material used comes from recycled sources.

Leading global organisations Laudes Foundation, Birla Cellulose, Kering, PVH Corp. and Target join the Fashion for Good initiated project, to explore the disruptive solutions, with the goal of creating new fibres and garments from used clothing and ultimately drive industry-wide adoption.

"A bold approach is needed to identify and scale innovations that drive sustainable change in the fashion industry. The unique, first-of-its-kind structure of this committed, multi-stakeholder consortium, addresses some of the key barriers to scaling innovation, setting the precedent for all industry players with ambitions for disruptive innovation to follow." – Katrin Ley, Managing Director, Fashion for Good.

Over an 18-month period, project partners will collaborate with innovators, Evrnu, Infinited Fiber Company, Phoenxt, Renewcell and Tyton Bio Sciences, to validate the potential of their technologies in this still nascent market. The recycled content produced by four of these innovators will be converted at Birla Cellulose's state of the art pilot plants to produce high-quality cellulosic fibres. From there, fibres will move through the project partners supply chains to be manufactured into gar-

Textile recycling is a key focus for Fashion for Good as a crucial lever in driving the fashion industry towards closed-loop production.

A systemic change towards circularity will ultimately reduce the environmental impact of textile waste and potentially eliminate our dependence on virgin materials entirely.

Furthermore, producing man-made cellulosic fibres through chemical recycling can help preserve ancient and endangered forests. Scalable solutions in high-quality textile recycling technologies are therefore urgently needed.

"Financing the Transformation in the Fashion Industry" details further actions required to scale sustainable solutions including a concerted, industry-wide effort to provide the incentives, financial means and focus to accelerate the transformation to sustainable and circular practices.

Thus, through this project and its consortium, Fashion for Good hopes to inspire other stakeholders to follow suit in supporting chemical recycling innovators to trial and ultimately secure off take, catalyzing the transformation to a truly circular economy.

# Fierce fighting as Afghan peace talks continue

Overnight clashes erupted in three districts of Nangarhar province when Taliban fighters attacked several checkpoints of Afghan forces and pro-government militiamen, Ataullah Khogyani, spokesman for the Nangarhar governor told AFP.

He said at least 11 Afghan security personnel were killed in fighting in Hesarak, while eight pro-government militiamen were killed in Khog-

Khogyani said about 30 Taliban fighters died in the clashes – including some foreigners.

The hardline insurgent group has not commented on the fighting.

The latest violence comes as the Afghan government and Taliban are engaged in talks in Doha aimed at ending the long-running conflict. Afghanistan's acting Defence Minister Asadullah Khalid blamed the Taliban for the fighting. - AFP

You know, putting a national lockdown, stay-at-home orders, is like house arrest," Barr said during an appearance at Hillsdale College in Michigan, according to clips posted online.

"Other than slavery, which was a different kind of restraint, this is the greatest intrusion on civil liberties in American history."

Veteran House lawmaker James Clyburn, who is black, lashed out, calling Barr's comment "the most ridiculous, tone deaf, God-awful thing" he'd ever heard.

# **Santa's homeland yearns for tourists**

**FINLAND:** Between November and March, Finland's far north usually throngs with international holidaymakers who come to experience a snowy wonderland of reindeer rides, ice castles and the "real" Santa's grotto.

But despite record visitor numbers in recent years, the coronavirus shutdown will leave many of Finnish Lapland's tourism businesses facing ruin this winter.

Many fear that government moves to ease travel restrictions in the Nordic country will not go far enough to offset the damage

Tour operator Sini Jin said her firm faces hard times if business doesn't pick

Jin has run Nordic Unique Travels for five years, offering Northern Lights safaris and expeditions into the Arctic wilderness to thousands of travellers from Europe and Asia every season.

"Now we've had one or two bookings a week, and mostly we're just doing refunds," Jin told AFP from Rovaniemi, an Arctic Circle town that markets itself as "the official hometown of Santa Claus". Her firm will only employ "two or three" seasonal staff this year instead of the normal 80. Jin's company received emergency financial aid after the government put aside over a billion euros (\$1.2 bn) to help businesses.

A loan has now come through that will see her firm through December, but the future is still precarious.

"Everything we've worked for will be gone so quickly if we don't get help."

Her predicament is shared by tourist companies across Finland's vast Lapland region, where the sector supports 10,000 jobs and generates one billion euros of


A tourist board survey found that without international visitors this winter, around 60 percent of tourism companies expect to lose at least half their turnover and three-quarters would have to lay off staff. "We're not hopeful of getting any significant bookings," Kaj Erkkila, managing director of Husky Park, told AFP.

The 10-person family firm has been a popular dog sledding destination for 'many decades" and keeps 109 Siberian huskies.

"If this winter's revenue stays low, we might not be able to operate in 2021-22 either, as maintaining the dogs is very expensive," Erkkila said.

Tourist board head Nina Forsell said the situation is make-or-break for many firms. "If companies go down this winter it will take a long time for them to rise up again," she told AFP.



# Arnold Schwarzenegger says COVID-19 pandemic 'opportunity' for climate

**AUSTRIA:** Former California Governor Arnold Schwarzenegger on Thursday said the coronavirus crisis was a "tremendous opportunity" to rebuild devastated economies with clean energy.

Speaking virtually at a climate summit that his non-profit organisation holds annually in Austria, the Hollywood star said the pandemic, which has killed almost a million people and caused massive economic downturns worldwide, was "a window of opportunity to act right now"

"Forward-looking decisions are needed right now, right now as trillions of dollars and trillions of euros are being poured into rebuilding economies and infrastructure in the wake of the coronavirus," he said on screen, speaking from a podium surrounded by plants.

"These funds are so massive they are capable of remaking societies. We have a tremendous opportunity here.

Schwarzenegger said money should be invested into building "a clean energy economy", providing 'sustainable jobs" and upgrading buildings to make them more energy efficient.

Schwarzenegger had intended to travel to his birth country Austria for the summit but cancelled his trip following the advice of doctors -- cheering on participants instead from an office with a poster of himself in younger days as a bodybuilder in the background. Among other speakers at the Austrian World Summit, which was launched

four years ago, were Austrian, Slovakian and Croatian leaders, as well as European Commission vice president Frans Timmermans and other international public figures. EU chief Ursula von der Leyen vowed Wednesday in her first annual State of the European Union address that Europe would lead the global search for a coronavirus vaccine while rebuilding its shattered economy with a green recovery plan. -AFP

# Michael Jayasekera ruggerite par excellence

It is very rare to see a person who excels in his career as a sportsman and as an academic who is highly recognized in the community. Michael Jayasekera is one of them who became the cynosure of all eyes by engaging himself in both sports and education, which made him a prominent figure in the country.

Popularly known as 'Mikey' in sporting circles, Michael started his school career with St. Peters College, Colombo from junior school and went on to complete his Ordinary level examination there. He then moved to St.Thomas College, Mount Lavinia for his further studies as most of his family members passed out as Thomians. Michael's first love in sports was cricket and gradually moved in to take part in Rugby, Athletics and Basketball at St. Peters, where he won college colours for participating in these games.

He hails from a sports loving family as his elder brother Ralston Jayasekera was actively involved in Rugby and Athletics in school while his two sisters also excelled in sports at St.Lawrences Convent in Wellawatte.

His father Earle Jayasekera was a great cricket enthusiast and Michaels cousins Mohan and Ajith who played cricket for S Thomas were instrumental in motivating him to take up sports especially cricket. He embarked on his cricketing career way back in 1968 representing the college under-12 team. match winning 96, which earned him

From there he matured as a talented cricketer and established himself as a regular member of the college cricket team. He played in the first XI cricket and First XV rugby teams as well as representing Basketball at the age of fifteen years.

Archibald Perera in Rugby, Mike Chanmugam in cricket remained as coaches at college and these two have played a key role in moulding him as a talented player in the respective sports.

In 1974 he crossed over to St.Thomas College to continue his higher studies. He was compelled to leave out Basketball while remaining in the other sports due to the clash with the Cricket season. He was fortunate to play along with some great players in that era like Saliya Ahangama, Ishak Sahabdeen, the late Guy de Alwis, and Ajith Ganeshan who were members of the school senior

While being there he established a 110-metre hurdles record at the all island schools championship in the under-19 age category. Due to his prolific form in cricket in 1976 he was selected to represent the Sri Lanka school team to tour Pakistan, which got interrupted, after their Prime Minister Zulfikar Ali Bhutto was killed resulting in the tour being cancelled. The administrators opted to take them to Jaffna to take on the combined club team which they won, where he went on to score a

the best batsman award. Former National cricketer Ranjan Madugalle was also a member of that team. Going down memory lane he recalled his swashbuckling innings which guided Thomians to victory against Wesley at home, by scoring 100 runs in 10 overs, which he rates as one of the unforgettable achievements in the school arena.

In rugby he was associated with some top class players like Stefan D' Silva, P.L.Munasinghe who were coached by late legendary Quentin Israel After school he qualified as a Marine engineer which held him back from continuing his cricket career.

His club rugby career started in 1976 as a school boy when he joined Havelock Sports Club to play under Thajone Savanghan. He occupied the fly half

position in the first few games under the watchful eyes of Dr. Larry Foenander and Gamini Fernando as his coaches. Till 1981, he played as a regular member of the Park Club team with Angelo Wickremaratne, Anton Benedict, Hisham Abdeen, Frank Hubert, Jeffery Yu and late Jeffrey De jong, , Sandy Hamid, Hanzil Samad, Lanil Tennakoon, Ronald Rodrigo, Gavin Stevens, Jever Rodriguesz. In 1978 he was a member of the triple crown winning team under Anton Benedict for the first time in their club

After he joined Havies in 1977, he was called for national duty and made his debut against the visiting German Sports Club in a fifteen a side match. In 1978 played at the Hong Kong sevens and the Rugby Asiad under Mohan Balasuirya's captaincy. When he was touring Hong Kong the Hong Kong Rugby picked a combined international side to play a friendly fifteen a side match against their National team. Michael was selected first and later Lanil Tennakoon came into the team after a Fijian player pulled out. He also took part in the 1979 Hong Kong sevens and in 1980 he was compelled to quit the squad due his job commitments.

As a player at Park Club, in 1981 there were two sevens tournaments held in January followed by the other in November. They registered two teams in both tournaments. The January sevens team was captained by Angelo Wick-

ermaratne while Michael was given the nod to lead the Park Club A team in the second sevens tournament in November. The Havies A and B sides met in the finals in the November tournament, which was a rare occasion in history probably, which will be first and the last. Havelock's B was captained by Marco de

He would like to extend his sincere gratitude to Gamini Fernando who was his coach in 1977/78/79 instrumental in moulding him and moved him from fly half to play in as a centre three quarter, whom he rates as an innovative

In that era the National team was represented by two centres, Omar Sheriff and Hafi Abdeen, who were regular Havies centres. Gamini opted to move Omar Sheriff to wing and Hafi Abdeen to Fly half bringing in Michael P. L. Munasinghe as centres. Three of his cousins Ronald Rodrigo, Roger Rodrigo and Leonard de Zilva donned the national jersey,

Due to his job commitments in the field of Marine Engineering he decided to play for his club when time permitted. In 1987 Havies won the sevens tournament and was picked for the National sevens team.

Unfortunately, he pulled his hamstring and was unable to take part in that tournament which was called the World International Sevens in Sydney, Australia led by Hisahm Abdeen.

Michael hung up his boots in 1987 after engaging as a player for eleven years.

In 1996 he came back to the country for good and started his career with John Keells on an invitation extended by Jagath Fernando, another sports loving person. In 1996 he was appointed as a National selector under late Lional AlmeIda. While being there he was elected as the President of his own club Havelocks from 1999 to 2001. Since then he has served as a National selector on and off and was appointed as the vice-president of Sri Lanka Rugby to Priyantha Ekanayake. He was recalled to serve once again as national selector from 2011 to 2018 later turned out to occupy the Chairman Selectors post from 2016 to 2017. During his chairmanship as selector in 2016 the Asian sevens was won by Lankan juniors which was a unique achievement. The National Men's team became the runnerup at the Asian sevens while the under-19 fifteen team became the runner up at

Jason Jayasekere, his elder son, out of his four children played for Thomians. He joined the Junior national team in 1999 to tour Argentina to play in Junior Asiad fifteen a side championship, where they qualified for the Junior World Cup. Jason lives in Australia along with his other children.

At present he is the General Manager of Colombo City Centre located in the heart of the city of Colombo.

# **England hope bubble cricket can be blueprint for world game**



MANCHESTER, FRIDAY: England showed the rest of the world that cricket could still be played during the coronavirus pandemic after a remarkable season that took place entirely behind closed

Large parts of the cricketing world rallied to England's cause, with the West Indies, Pakistan, Ireland and Australia all going ahead with scheduled tours.

There had been fears the entire campaign could be wiped out as

Britain struggled to bring down before Christmas for a white-ball soaring Covid-19 numbers.

rise to 200 million if the pandemic interrupts next season.

But those numbers would have been even higher had not all 18 men's internationals, across all three formats, taken place.

Against the backdrop of concerns over the widening gap between cricket's wealthiest nations -- India, England and Australia - and the rest, the season was also a timely reminder of the global game's need for interdependence.

The West Indies, one of the poorer Test nations, have also sent over a women's team for a Twenty20 series that will be England's only taste of international cricket this season.

"It's been successful here and if we can do it, so can other countries," said England men's coach Chris Silverwood. "Getting cricket on everywhere around the world is what we all want." He added: "There's quite a bit up in the air but we're hopeful after Christmas the Test tours (Sri

Lanka and India) will go ahead. "South Africa we're looking at

tour and then we're looking at a As it is, the English game has red-ball camp in the UAE as well already lost more than 100 million to prepare the guys." Fortunately (\$129 million), a figure that could for English officials the lone breach of lockdown regulations, when England fast bowler Jofra Archer made an unauthorised trip home, did not scupper their careful planning.

And the lack of spectators at Southampton and Manchester, the two bio-secure venues used for the 18 fixtures, did not have the damaging effect on performance some feared.

England's Stuart Broad become just the seventh cricketer to take 500 Test wickets during the West Indies series, which the home side won 2-1, before new-ball partner James Anderson joined an even more exclusive club by taking his 600th wicket on the last day of the series against Pakistan.

England all-rounder Ben Stokes produced heroics with the bat during the second Test against the West Indies, with scores of 176 and 78 not out, while Zak Crawley hit a superb 267, his maiden Test century, against Pakistan.

Yet the visitors shone too. West Indies won the first Test and Pakistan, following a fine 156 from Shan Masood, were poised to fol-



low them when they reduced England to 117-5 chasing a target of

But a stand of 139 between Jos Buttler and Chris Woakes turned the tide in England's favour and ultimately proved the difference as England won the series 1-0.

Ireland, well beaten in the first two one-day internationals, upset England in the third with Andrew Balbirnie and Paul Stirling both hitting hundreds as they chased down 329.

### **US Open champion Osaka withdraws** from French Open with injury

LOS ANGELES, FRIDAY: Naomi Osaka, who captured her third Grand Slam title at the US Open on September 12, pulled out of the upcoming French Open

with a hamstring injury on Thursday. "Unfortunately I won't be able to play the French Open this year," Osaka said

in posts on Instagram and

Twitter.

"My hamstring is still sore so I won't have enough time to prepare for the clay these two tournaments came too close to each other for me this year."

The French Open is due to start on September 27 at

Roland Garros, rescheduled from earlier in the year because of the coronavirus pandemic.

On Sunday, Osaka rallied from a set down to beat Victoria Azarenka 1-6, 6-3, 6-3 in the US Open women's final, adding a third major trophy after her victories at the 2018 US Open and 2019 Australian Open triumphs.

The 22-year-old was the first woman to win the US Open singles final from a set down since 1994, and the victory moved her to third in the WTA rankings.

She also became the first Asian player to win three Grand Slams, overtaking China's Li Na on two.

Osaka had gone into the US Open at Flushing Meadows with fitness concerns.

She pulled out of the WTA final of the Western & Southern Open -- also held this year at Flushing Meadows -- with a left hamstring injury just two days before the start of the Grand Slam in New York.


