

THE following is the Official Programme of the Ceremonial to be observed upon the landing of SIR JOSEPH WEST RIDGEWAY, K.C.B., K.C.S.I., on the 10th instant.

ON the arrival of the ss. "Rome," His Excellency the Lieutenant-Governor, accompanied by the Members of the Executive Council and the Maha Mudaliyar, will go on board the steamer.

2. On landing, the Governor will be received at the Jetty, under a salute of seventeen guns, by the Chief Justice, the Bishop, the Puisne Justices, the Members of the Executive, Legislative, and Municipal Councils, and the Heads of Civil and Military Departments.

3. An Address of Welcome will be presented by the Legislative Council, and this will be followed by an Address from the Municipal Council of Colombo.

4. Under the Pavilion erected by the Sinhalese Headmen, His Excellency the Governor will be received by the Chief Headmen of the Western Province. An Address will be presented by them.

5. A Guard of Honour of the Royal Warwickshire Regiment will be in waiting at this Pavilion.

6. His Excellency the Governor will then proceed by carriage, past the Government Offices, to Queen's House by the southern gate, the road being lined by the Troops and Volunteers.

7. A Guard of Honour of the Ceylon Light Infantry Volunteers and the Ceylon Lascoreens of the Guard will be in waiting at Queen's House.

8. On leaving Queen's House, at a time of which notice will be given, His Excellency the Governor will proceed to the Council Chamber, and there will produce Her Majesty's Com-mission, which will be publicly read by the Colonial Secretary. A Guard of Honour of the Royal Warwickshire Regiment will be in waiting opposite the

Council Chamber.

9. His Excellency the Governor will there, in the presence of the Executive Council, take the Oaths as Governor and Commander-in-Chief, administered by the Chief Justice and announced by a salute of seventeen guns.

10. The Proclamation announcing the assumption of the Government by His Excellency the Governor will thereafter be publicly read by the Clerk of the Executive Council.

THE following amended special regulations made by His Excellency the Lieutenant-Governor, with the advice of the Executive Council, in pursuance of the powers vested in them by the 79th clause of Ordinance No. 17 of 1869, relating to the entry inwards and outwards, to the landing, shipping, and transhipping of goods, and to business generally connected with steamers, are hereby published for general information and observance.

Regulations referred to.

1. In order that steamers may be permitted relaxations of the provisions of the Ordinance No. 17 of 1869 as to the coaling, landing, shipping, and transhipping of cargo, when such provisions may, in the opinion of the Collector, be lawfully relaxed, the local agent of a steamer or the local agent of a Company owning steamers shall enter into a bond binding himself in the sum of ten thousand rupees and by the deposit with the Collector of the sum of one thousand rupees to hold himself responsible for the payment upon the order of the Collector of any fine or penalty to which the master of such steamer or any person employed in any work on behalf of the agent or master of such steamer shall have rendered himself liable of any breach of the Ordinance No. 17 of 1869, and for the payment of any fine or penalty on account of the non-delivery of cargo, and for the payment of any other fine or penalty in or about work performed on behalf of the master or agent of such steamer.

2. The master of any steamer in respect of which a bond has been given as aforesaid may be permitted by the Collector upon the application of the agent of such steamer to begin coaling, landing, shipping, or transhipping immediately upon the arrival of such steamer and before she shall have been entered and reported.

3. The agent of the steamer shall, within twenty-four hours of the arrival of the steamer, enter the steamer and deliver the report and manifest, and all other documents required by law; and shall, within seven days of the departure of the steamer, deliver a correct content outwards of of the said steamer in such form and manner as shall be required by the Collector.

4. All amendments of reports, and all applications required to be made by the master of the steamer, shall be made by the agent of the steamer, who shall for such purposes be deemed and taken to be the agent of the master.

taken to be the agent of the master.
5. The Collector may, on the application of the master or agent of a steamer, permit work to be carried on in respect of the coaling, or loading, or unloading of such steamer, or the transhipping of cargo to or from such steamer after 4 P.M. and before 6 A.M. on any day but Sunday, provided that if required by the Collector the agent or master shall deposit before the granting of such steamer, No work shall be permitted after midnight on Saturday and before midnight on Sunday,

No work shall be permitted after midnight on Saturday and before midnight on Sunday, except upon the payment of a penalty in addition to the charges aforesaid. Such penalty shall be calculated at the rate of 38 cents per ton of the registered tonnage of the steamer, but shall not be less than Rs. 50, and shall not exceed Rs. 200. Ships of war and naval transports shall upon the application to the Collector by the Commander, or of the local representative of the nation to which the ship belongs, be allowed to coal on Sundays without payment of the penalty, but upon payment of the charges leviable in respect of such working.

6. The Collector may allow any person exporting cargo, who shall have deposited with such Collector a sum of five hundred rupees, to ship such cargo before entry has been passed and payment of all dues made, and all requirements and regulations fulfilled. Such persons shall, within four days of shipping such cargo, pass all entries and pay all dues and fulfil all requirements and regulations. The Collector may impose a penalty not exceeding one hundred rupees if such person shall not within the four days aforesaid pass all entries and pay all dues and fulfil all requirements and regulations; and such penalty shall be deducted from the sum of five hundred rupees deposited as aforesaid. The Collector may at any time return the sum of five hundred rupees or the balance thereof, and require the person exporting cargo to pay all dues and make all entries and fulfil all requirements and regulations before shipping such cargo.

ABSTRACT OF SEASON REPORTS FOR THE MONTH OF JANUARY, 1896.

WESTERN PROVINCE.

COLOMBO DISTRICT.

Paddy: the maha harvest has commenced, and preparation is being made for yala cultivation. Dry grain : no cultivation to report.

Other products: the supply of vegetables is good, and prices are moderate, but fruit is rather scarce and dear. Prices of staple products: rice, from Rs. 3 to Rs. 4 a bushel; cocoanuts, from Rs. 32 to Rs. 38 a thousand. Rainfall: scanty and insufficient; there were very few showers during the month. Remarks on harvest prospects generally: on the whole, a fairly good maha is expected.

NEGOMBO DISTRICT.

• Paddy, yala harvest : the fields are being ploughed in Alutkuru korale North ; maha harvest : the fields that were sown early are being reaped.

Dry grain : amu, kurakkan, and kollu are being harvested in Hapitigam korale. Other products : fruits and vegetables are scarce.

Prices of staple products : rice, Rs. 3 to 4 per bushel ; paddy, Re. 1.50 to Re. 1.75 per bushel ; cocoanuts Rs. 30 to Rs. 35 per 1,000.

Rainfall : light.

Remarks on harvest prospects generally, good.

KALUTARA DISTRICT.

Paddy: the maha harvest is now in ear. Its condition in the Totamunes is poor. Preparations are being made in Pasdun korale west for the ensuing yala harvest. Other products : fruits and vegetables are scarce.

Prices of staple products : imported rice, Rs. 3:50 to Rs. 4:50 per bushel ; country-grown rice, Rs. 3 to Rs. 4 per bushel ; cocoanuts, Rs. 35 to Rs. 40 per 1,000.

Rainfall : light.

Remarks on harvest prospects generally, fair.

CENTRAL PROVINCE.

KANDY DISTRICT.

Paddy, maha : the fields in all palatas are blossoming and ripening ; in Uda Bulatgama reaping has commenced. Crop or prospect of crop good in Pata Hewaheta and Udapalata, and in other divisions fair. Yala : the fields in

 Yatinuwara are being reaped. Crop or prospect of crop fair.
 Dry grain, maha : hill paddy chenas in Udunuwara and Harispattu are being harvested, amu is blossoming;
 in Pata Dumbara hill paddy are ripening, and kurakkan blossoming; in Uda Dumbara and in Pata Hewaheta
 blossoming and in ear. Tumpane being threshed. Crop or prospect of crop good. blossoming and in ear. Tumpane be Rainfall : generally sufficient.

Prices : paddy, Re. 1.50 per bushel ; kurakkan, Re. 1.25 per bushel ; cocoanuts, Rs. 40 per 1,000.

NUWARA ELIYA DISTRICT.

Paddy : Kotmale, maha harvest being reaped ; crops good. Walapane and Uda Hewaheta ploughing and sowing for maha cultivation.

Dry grain : Kotmale no work on chenas ; Uda Hewaheta and Walapane kurakkan in ear.

Rain : sufficient throughout the district.

Fruits and vegetables : there was a good supply of vegetables.

Prices of staple articles : paddy, Re. 1.50 per bushel ; kurakkan, Re. 1.75 per bushel ; Indian corn, Re. 1.50 per bushel ; coceanuts, Rs. 7 per 100.

Health : generally good. Health of cattle : a few cases of hoof-and-mouth disease in Uda Hewaheta and Walapane.

NORTHERN PROVINCE.

JAFFNA DISTRICT.

Weather : there were some partial showers of rain during the early part of the month. The rainfall registered

weather : there were some partial snowers of rain during the early part of the month. The rainfall registered at Jaffna by the Public Works Department was 72 inches. Paddy, kalapokam of 1896 : harvesting operations commenced ; the outturn in some divisions is reported to be very good, and in others fair. In some high lands plants are being watered from wells and tanks. Dry grain crops : varaku crop is being harvested, and the outturn is reported to be poor ; kollu, payaru, and ulunthu are in blossom ; prospects fair.

Tobacco : planting on high grounds completed. It is reported that the plants in some divisions do not show signs of vigorous growth.

Prices of staple articles : paddy, Re. 1.621 per bushel ; rice, Rs. 3.25 per bushel ; varaku, Re. 1.371 per bushel ; kurukkan, Re. 1.50 per bushel ; tinasami, Re. 1.50 per bushel ; panisami, Re. 1.50 per bushel ; ulunthu, Rs. 4 per bushel ; payaru, Rs. 4 per bushel ; pinaddu, Rs. 3 per kudai.

VAVUNIYA DISTRICT.

There was some rain at the beginning of the month, and a few showers towards the end. Rainfall registered 3.27 inches. Tanks full. Paddy in blade, blossom, and ear. Crop in Panankamam has suffered from a disease called "chental"; else-where prospects very good. A good crop expected from paddy sown in the beds of some Sinhalese tanks. Prices : paddy, Re. 1.25 to Rs. 2 per bushel; kurakkan, Re. 1 to Rs. 2 per bushel; gingelly, Rs. 5 to Rs. 6 per bushel; rice, Rs. 4 to Rs. 5 per bushel.

General health of people not satisfactory. Much fever prevailed.

Murrain still lingers in Cheddikulam and Panankamam, and there are a few cases of hoof-and-mouth disease n Melpattu.

MANNAR DISTRICT.

Kalapokam (maha) paddy crops on the mainland (there being none in the island of Mannar) are now ripening and reaping will commence in another fortnight. The prospects of the crops are on the whole good. Drygrain crops in the island have been reaped and stacked in some villages, in others they are being reaped ; the

crop generally is good. Paddy sells at Re. 1.50; kurakkan at Re. 1.25.

Health of people not satisfactory. Fever is still prevalent in the district, but of a mild type. Health of cattle generally good. Sea-fishing very good. Rainfall, 3.78 inches.

MULLAITTIVU DISTRICT.

Paddy crop in various stages from blossom to ripe. Kurakkan and varaku in chenas are in blossom and ear.

Faddy Grop in various stages from bioson to ripe. Further and variate in clease in bioson and car.
 Reaping of paddy going on in some villages. Gardens are being manured and tobacco planted.
 Prices of food articles: paddy, Re. 1.75 per bushel; rice, Rs. 4 per bushel; kurakkan, Re. 1.50 per bushel;
 varaku, Re. 1.25 per bushel; manioca, 5 cents per lb.
 Rainfall return not received. There was heavy rain on the 7th, 15th, and 16th. Weather was generally cold.

SOUTHERN PROVINCE.

GALLE DISTRICT.

Paddy and dry grain, maha : the crops are being reaped. The paddy crop in some fields has been fly-blown. But the return on the whole is favourable. Yala operations have begun. Miscellaneous : jak, plantain, breadfruit and other vegetables are scarce. Cocoanut crop is poor, and prices vary from Rs. 30 to Rs. 37:50 per thousand nuts. Prices of staple food : rice, from Rs. 3 to Rs. 3:50 per bushel ; paddy, Re. 1:50 per bushel ; mederi, Re. 1:50 per bushel ; kurakkan Re. 1:25 and amu, Re. 1 per bushel. Rainfall : 7:8 inches. Health : satisfactory. There appeared cases of dysentery and chickopper in gravets. Take, and Wellshede

Health : satisfactory. There appeared cases of dysentery and chickenpox in gravets, Talpe, and Wellaboda pattus, but without deaths. Fever has almost disappeared. Cattle disease has not appeared anywhere in the district.

MATARA DISTRICT.

Paddy : good.

Dry.grain : good. Prices : paddy Re. $1.37\frac{1}{2}$, and fine grain Re. 1.25 per bushel.

HAMBANTOTA DISTRICT.

West Giruwa Pattu.-Paddy : the maha crop is in different stages of growth, and fair. Ripe crop damages partially in some part of the pattu from excess of rain, in consequence of floods; and paddy lands sown for second maha suffered materially.

Dry grain : the heavy showers which fell during the month were beneficial to a great extent for the growth of the crops of lands reported in last month as likely to perish for want of rain, but the ripe crops in a few villages was damaged to some extent in consequence of the rainfall.

Miscellaneous : jak, breadfruit, and cocoanut trees have been greatly benefited by the rains, and helped the growth of the vegetables which would otherwise have perished.

Rainfall : there have been some heavy showers which caused floods in the district, which to some extent injured the young crop.

Health : the health of the inhabitants, regret to say, has been unsatisfactory. Fever, diarrhœa, and dysentery prevailed, and a very few cases of chickenpox appeared in Galahitiya and Kirama Weladagoda.

prevailed, and a very few cases of chickenpox appeared in Galahitiya and Kirama Weladagoda. Cattle: cattle were free from murrain during the month. Prices of staple products: paddy, Re. 1:623 per bushel; rice, Rs. 3:50 per bushel; kurakkan, Re. 1:50 per bushel; sweet potatoes, Re. 1 per cwt.; plantain, Rs. 37:50 per 100 bunches; cocoanuts, Rs. 50 per 1,000; jak fruits, Rs. 25 per 100; pumpkins, Rs. 15 per 100. Magam Pattu.—Paddy: at Tihawa most part of the crops are being reaped, and the rest blossoming. There are about 20 amunams submerged by the storing of Yodawewa. These lands should not have been cultivated for maha, and nothing can be done without loss to the Yodawewa lands, some of which pay water-rate.
Western welckeda crops: most part in blossom and helf grown. Eastern welckeda crops: most part in blossom and helf grown.

Western walakada crops: most part in blossom and half grown. Eastern walakada: part of the ranges have been sown, and some are still being sown for the second maha. Northern and mattala walakadas: some of the tracts have

been sown, and plants are thriving. Fine grain : the few chenas that are successful will be ready for reaping by the end of the month. Prices of articles : paddy, Re. 1 50 per bushel ; rice, Rs. 4 50, per bushel ; kurakkan, Re. 1 50 per bushe' ; sugar, 20 cents per lb.

East Giruwa Pattu.—Paddy: the crop of the fields in the two kanuketiya divisions, and a good harvest is expected. The fields at Modaragam palata are progressing.

Fine grain : the reaping of the chena crops commenced during the early part of the month ; crops fairly good. Prices of articles : same as last month, except price of kurakkan, which has gone low, and a bushel is sold at Re. 1.

EASTERN PROVINCE.

BATTICALOA DISTRICT.

Paddy: early munmari crop in good condition, except that on very low lands damaged by heavy flood and constant rain. Sowing of late munmari is in progress. Indian corn being harvested, and in good condition. Fine grain : in good condition, though a little damaged by heavy rain Rainfall : 8:18 inches.

Health of people : good on the whole, though fever and dysentery still prevailing here and there. Health of cattle : hoof disease on the decline.

NORTH-WESTERN PROVINCE.

KURUNÉGALA DISTRICT.

In all parts of the Seven Korales harvest prospects were very promising. The reaping of fields and chenas had already commenced, and the sowing for maha was completed.

The health of people and cattle was good.

Occasional showers fell all over the district

The rainfall registered in Kurunegala was 4.21 inches.

PUTTALAM DISTRICT.

Paddy: the paddy plants in Akkarai and Pomparippu pattus are in ear, but the plants are being damaged by insects; prospects fair. In Demala hatpattu the fields are in ear, and in some villages the crops have matured, and reaping operations have already commenced; very good crops are reported. In Puttalam, Rajakumara Wanni, and Akkarai pattu south paddy earing, maturing, and being reaped; crops good. Dry Grain : no chenas in Akkarai and Pomparippu pattus. In Demala hatpattu they are being reaped. In Puttalam and Rajakumara Wanni pattus they are being reaped and gathered : prospects very good

Puttalam and Rajakumara Wanni pattus they are being reaped and gathered; prospects very good. Staple products : rice from Rs. 4 to Rs. 450; cocoanuts, Rs. 450 to Rs. 5. Rainfall : the weather has been dry, but for a few occasional showers. The rainfall up to the 25th was only

CHILAW DISTRICT.

Northern Division.

Reaping of kekulan sown in September last has commenced, as well as of fine grain. Mud cultivation in fair condition.

Central Division.

No sowing this month ; paddy and fine grain crops have thriven, and are now being reaped. Weather favourable for harvesting.

Southern Division.

No sowing this month. Crops reaped and threshed. Those raised in low-lying fields are found to have been attacked and damaged by insects.

NORTH-CENTRAL PROVINCE,

There were a few very good showers about the beginning of the month. The rainfall registered at Anuradhapura is 4.25.

The crops on fields and chenas are at various stages : in blade, blossom, and ear. The crops in a few villages in Hurulupalata are being reaped. Meda cultivation has been commenced in some villages in Kalagampalata. Condi tion of crops generally is good. Most of the tanks are quite full.

Cattle murrain is still prevailing. No improvement. Health of the people is not satisfactory. Fever has broken out. Prices: paddy, Re. 1 50 to Rs. 2 per bushel; kurakkan, Re. 1 25 to Re. 1 50 per bushel; rice, Rs. 4 to Rs. 4 50 per bushel; cocoanuts, Rs. 5 to Rs. 6 per 100.

PROVINCE OF UVA.

Yatikinda': yala crop being harvested ; yield middling, having been damaged by rain. Ploughing of maha fields going on. Fruit and vegetables plentiful and cheap. Weather very wet. Fever, sore-eyes, and dysentery prevalent. Health of cattle good.

Health of cattle good. Udukinda: sowing of maha fields commenced. Vegetables scarce. Fruit plentiful, the price of cocoanuts very high. Weather showery. Health of people and cattle good. Wellassa: sowing of maha fields commenced. Chena crops ripe, and prospects good. Fruit and vegetables plentiful. Weather wet. Fever and cold prevalent. Health of cattle good. Vivaluwa: yala crop being harvested; yield so far middling, having suffered from rain. Ploughing of maha fields commenced. Chena crop ripe. Fruit and vegetables plentiful and cheap. Public health good. Foot-and-mouth disease amongst cattle. Weather showery. Bintenna: ploughing of maha fields going on, and sowing has commenced. Sowing of kurakkan on chenas over. Fruit and vegetables scarce. Health of people and cattle good. Weather very wet.

PROVINCE OF SABARAGAMUWA.

RATNAPURA DISTRICT.

Paddy: in Kuruwiti, Nawadun, and Atakalan korales maha crop is ripe, and being harvested. In Kolonna and Kukulu korales maha crops are half grown; prospects favourable. In Kuruwiti and Atakalan korales second maha crops are young. In Atakalan, Kolonna, Kadawata, and Meda korales preparations are being made for yala cultivation.

Dry grain : excepting the Kukulu korale the chenas cultivated for maha throughout the district are ripe, and being reaped ; outturn satisfactory. In the Bintenna of Atakalan, Kolonna, and Meda korales the kurakkan crop is ripe, and is being reaped. Rainfall: registered at Ambanpitiya 2:62 inches, at Ruwanwella 1:01 inches. Cattle disease : on January 20 four buffaloes were attacked with murrain at Yatattawala, in Gandolaha pattu of Beligal korale. Three of the animals died soon after the attack, and the fourth is recovering. The necessary precautions have been taken to prevent the spread of the disease, and there are no new cases reported. Health of the people has been generally good.
