#### Nimal Rupasinghe Friendship Foundation (Incorporation)

#### AN ACT TO INCORPORATE THE NIMAL RUPASINGHE FRIENDSHIP FOUNDATION

WHEREAS an society called and known as the "Nimal Preamble. Rupasinghe Friendship Foundation" has heretofore been formed in Sri Lanka for the purpose of effectually carrying out its objects and transacting all matters connected with the 5 said Foundation according to the rules agreed to by its members:

AND WHEREAS the said foundation has heretofore successfully carried out and transacted the several objects and matters for which it was formed and has applied to be 10 incorporated and it will be for the public advantage to grant such application.

BE it therefore, enacted by the Parliament of the Democratic Socialist Republic of Sri Lanka as follows:—

- 1. This Act may be cited as the Nimal Rupasinghe Short title. 15 Friendship Foundation (Incorporation) Act, No. of 2018.
- 2. From and after the date of commencement of this Act, Incorporation such and so may persons as now are members of the Nimal of the Nimal Rupasinghe Friendship Foundation (hereinafter referred to as friendship the "Foundation") or shall hereinafter be admitted as members Foundation. 20 of the "Nimal Rupasinghe Friendship Foundation" (hereinafter referred to as the "Corporation") and by that name may sue and be sued with full power and authority to have and use a common seal and to alter the same at its pleasure.

- 3. The general objects for which the Corporation is The general 25 constituted are hereby declared to be :
  - objects of the Corporation.
  - (a) To implement programmes and to give guidance to create a good atmosphere to build up peace and harmony in all communities and ethnic groups to live as Sri Lankans;

- (b) to implement programmes to educate the Sri Lankan society of the field of Law without any discrimination giving priority to the fact that "Ignorance of the Law is not an excuse";
- 5 (c) to provide necessary educational equipments and other relevent facilities for the improvement of the educational knowledge of the children, through the programme of Sisu Sahana Mavupiya Kapakaru Shisya Adara wedasatahana";
- 10 (d) printing publication and distribution of books, Magazines in order to promote the Education;
  - (e) to provide educational facilities and also to give knowledge for the education of the Pre-school children;
- 15 (f) to provide Library facilities including books for the learning children to gain knowledge;
  - (g) to organize seminars and workshops for the G.C.E. O/L and A/L students to improve their knowledge of education;
- 20 (h) to provide facilities for the education of the children with special needs;
  - (i) to conduct lectures, seminars, discussions exhibitions and carnivals to promote the objects of the corporation.
- 25 (*j*) to liaise and co-ordinate with other local and foreign institutions which have similar objectives.

4. Subject to the provisions of this Act and any other General Law, the corporation shall have the power to do, perform powers of the Corporation. and execute all such Acts, matters and things, whatsoever as are necessary or desirable for the promotion or futherance of the objects of the corporation or any of them including the powers to open operate or close bank accounts to borrow or raise moneys with or without security to receive or collect or accept grants and donations to invest its funds to the corporation and to engage employ and dismiss officers and 10 servents required for the carrying out of the objects of the corporation.

5. (1) The affairs of the corporation shall, subject to the Management other provisions of this Act and the rules in force for the time of the affairs of the being of the corporation be administered by a Board of Corporation. 15 Directors Consisting of Chairman and Secretary, Treasurer and another eleven members elected in accordance with such rules.

- (2) The Executive committee which held the office of the corporation before the date of implementation of the Act, 20 shall be the first Executive committeee of the corporation.
- 6. (1) It shall be lawful for the Corporation, from time to Rules of the time, at any General Meeting of the Corporation and by a majority of not less than two-thirds of the members present and voting, to make rules, not inconsistent with the 25 provisions of this Act or any other written law, for all or any of the following matters:-

(a) classification of membership, admission, withdrawal, expulsion or resignation of members and membership fees payable;

- (b) procedure to be observed for the summoning and holding of meetings of the Corporation and of the Executive committee the quorum of such meetings and the exercise and performance of their powers and duties;
- (c) the appointment, power, duties and functions of the various officers, agents and servants of the Corporation;
- (d) qualification required to become a member of the Corporation and the executive committee; and 10
  - (e) the administration and management of the property of the Corporation.
- (2) Any rule made by the Corporation may be amended, altered, added to or replace at a like meeting and in like 15 manner as a rule made under subsection (1) of this Section.
  - (3) Every member of the Corporation shall be subject to the rules of the Corporation.
- All debts and liabilities existing on the day Debts due by preceding the date of commencement of this Act shall be and payable 20 paid and discharged by the Corporation hereby constituted Corporation. and all debts due to and subscriptions and contribution payable to the Foundation on that date shall be paid to the Corporation hereby constituted.

8. The Corporation shall be able and capable in law to Corporation 25 acquire and hold any property, movable and immovable which may become vested in it by virtue of any purchase, grant, gift, testmentary disposition or otherwise and all such property shall be held by the Corporation for the purposes of this Act and subject to the rules in force for the time being 30 of the Corporation, with full power to sell, mortgage, lease, exchange or otherwise dispose of the same.

9. (1) The Corporation shall have its own fund and all Funds of the moneys heretofore or hereafter to be received by way of gifts, bequest, donation, subscription, contribution, fees or grants for or and on account of the corporation shall be deposited in one or more banks as the Corporation shall determine.

- (2) There shall be paid out from the fund, of the Corporation all sum of money incurred from by the corporation in the exercise of its objects.
- 10. The seal of the Corporation shall not be affixed to Seal of the any instrument whatsoever, in the presence of the President, Secretary or the Treasurer of the Corporation and shall sign their names to the instrument in taken of their presence and such signing shall be independent of the signing of any 15 person as a witness.

- 13. (1) The financial year of the Corporation shall be Accounts and Andit. the calendar year.
- (2) The Corporation shall cause proper accounts to be kept of income and expenditure assent and liabilities and 5 all other transactions of the corporation.
  - (3) The accounts of the Corporation shall be audited by a qualified auditors as may be determined by the Board.

- An individual who being a member of the Institute of chartered Accountants of Sri Lanka or any other institute established by law possesses a certificate to practice as Accountant issued by the Council of such institute; or
  - (b) A firm of Accountant each of the resident partners of which, being a member of the Institute of Chartered Accountants of Sri Lanka or of any other institute established by Law, possesses a certificate to practice as an Accountant issued by the council of such institute.
- 14. Nothing in this Act contained shall prejudice or Saving of the affect the rights of the Republic or of anybody politic, or Rights of the Republic and 25 corporate or of any other persons, except such as are others. mentioned in this Act, and those claiming by, from or under them.

15. In the event of any inconsistency between the Sinhala text Sinhala and Tamil texts of this Act, the Sinhala text shall to prevail in 30 prevail.
