Agricultural Products (Regulation) Ordinance, No. 29 of 1939

Notification

The Land Acquisition Act, No. 9 of 1950

ORDER UNDER SECTION 36, PROVISIO (a)

Order No. 141 of 1952

BY virtue of the powers vested in me by section 36 of the Land Acquisition Act, No. 9 of 1950, I, Punchi Banda Bulankulame, Minister of Agriculture and Lands, do hereby direct the Government Agent, Assistant Government Agent or other officer authorized in that behalf by such Government Agent or Assistant Government Agent and referred to in column I of the Schedule hereto, to take possession of the land specified in the corresponding entry in column II of that Schedule.

The Government Agent, Southern Province	.. An allotment of land called Ethamalawila (Fonsekawatta) in extent about 5-acres, situated in Igala in Bentara Walallawiti Korale in Galle District ; and bounded as follows :— North by Kahambiliyagoda Manana ; South by Ethamalawila Field ; East by Motawela ; and West by Ethamalawila Field and Kahambiliyagoda Manana.
