

"Improvements in driving mechanism for crepe rubber Rolling Mills".

Abstract.—The invention relates to an improvement in driving mechanism for crepe rubber rolling mills. The nature of the invention can be ascertained from the claim made, viz:—"A drive mechanism for crepe rubber rolling mills and the like in which one of the rollers is driven by gear wheels from the other, characterised thereby that a motor having an out going shaft running at slow speed (of the magnitude of 50 r.p.m. or less) is directly geared or otherwise directly connected to one of the rollers".

Price's Patent Candle Company Limited.

"Improvements in and relating to the manufacture of candles and like articles".

Abstract.—This invention relates to the manufacture of candles and like articles. The method consists of extruding solid wax under pressure through an orifice around a wick which is guided towards the centre of the orifice and is free to be drawn forward by the extruded wax. Means are provided for uncovering a short length of the wick and cut off the desired lengths of rod to form eardles
