"Improvements in or relating to constructional materials."

Abstract.—This invention relates to the production of new forms of bricks, slabs and similar constructional materials.

According to the present invention the constructional brick, slab or similar material comprises essentially burnt rice husks and a calcium containing material. The process consists of mixing together burnt rice husks and calcium containing cementing material with minor proportions of other ingredients, moistening with water, pressure moulding to required shape, partially drying the moulded product at ordinary temperature, subjecting it to soaking in a dilute solution of an aluminium salt and thereafter drying it at a temperature not exceeding 35°C. One example is given and 12 claims are made.

Abstract.—The invention relates to an ayurvedic tonic for general health, cure of rheumatism and rejuvenation and is made up as follows:—

(a) A decoction is made by boiling 12½ lb. dates, 12½ lb. raisins. 3½ lb. root pavonia odorata, 3½ lb. root winter cherry, 2 lb. cocculus cordifolius, 2 lb. bark nimb tree, 3½ lb. shellac and 2½ lb. of aeruva lanata in 32 gallons (228 lbs.) of water and reducing to 8 gallons (72 lb.).

(b) The following ingredients, viz., Flower of Grislea Tometosa 3½ lb., dry ginger ½ lb, pepper ½ lb, long pepper ½ lb, myrobalon ½ lb., dry fruit of embellic myrobalon ½ lb., nut of beleric myrobalon ½ lb are dried and powdered.

The decoction is filtered and poured into a jar and the powder added to it. To this mixture is added 25 lb. of sugar and 1/80 ($\frac{1}{2}$ tola) of pure musk and the mouth of the jar well secured and left over for one month for fermentation after which the contents are filtered well and bottled air tight for use

Abstract.—The invention relates to an ayurvedic tonic for Kidney troubles, chest pains and cough, heart attacks, nervous breakdown and such complaints.

The following ingredients, viz.—Munthiri Wattal 7 lb., Seenthil 4 lb., Kadukkai 3 lb., Nelli Kai 3 lb., Polkudupala 5 lb., Sandanam 1 lb., Maruthampattai 2 lb., Ammukkarai Kelangu 2 lb., Perichcham palam 5 lb.,

Korai kelangu 1 lb., Pipali 1 lb., Molagu 1 lb., Kottam 1 lb., Thandikai 1 lb., Thalisapattiri 1 lb., Athimathuram ½ lb., Neringil 1 lb., Wellarikottai 1 lb. are pounded together and 24 bottles of water and 2 lb. of bees honey added and the mixture put into a jar, the lid well secured and buried in the ground for 15 days. Thereafter the jar is taken out and the contents distilled. The above quantities will give 24 bottles of 24 ounces.

"A safety oil lamp".

Abstract.—A safety oil lamp comprising of a square or flat or rectangular bottle with screw threaded neck and a lid with a cylindrical tube in the middle and a cone shaped funnel arrangement attached to the lid round the tube, the lid combination being able to be screwed on to the neck of the battle. The inventor states that the cone arrangement prevents the oil from escaping. There are 2 claims and one sheet of drawings.

"A hone or sharpener for rubber tapping knives".

Abstract.—The invention relates to a hone or appliance for sharpening rubber tapping knives and consists of a particular composition of earthenware clay which on analysis yields the following results.—Silica 70.0 per cent., Aluminia 26.3 per cent., Iron Oxide 2.3 per cent., Calcium Oxide 0.3 per cent., Magnesia 0.1 per cent. and Ignition Loss 0.80 per cent. Two slabs of clay of a uniform thickness of 0.4 inches, each 1.2 inches wide and 2 inches in length are cast or moulded together to form one whole so that one of the said slabs forms a horizontal base while the other stands vertical to the said horizontal base bisecting it to represent the letter "T" inverted as shown in drawing sheet 1

The inventor states that the hone is designed for rapid sharpening of the rubber tapping knife resulting in a higher yield of latex and preventing damage to the bark of the Tree.
