#### The Defence (Finance) Regulations

#### Order under Regulation 5 (1)

IN pursuance of the powers vested in me by regulation 5 (1) of the Defence (Finance) Regulations, having the force of law by virtue of the Exchange and Securities Control (Continuation) Act, No. 35 of 1950, I, Junius Richard Jayewardene, Minister of Finance, do by this Order amend the Order under the aforesaid regulation published in Gazette Extraordinary No. 9,872 of June 1, 1948, as last amended by the Order published in Gazette Extraordinary No. 10,298 of September 19, 1951, in paragraph (1) thereof, by the substitution for -sub-paragraph ... (c), of the ---following -newsub-paragraph :---

" (c) the taking out of Ceylon by any person-

- (i) to any part of India, other than Portuguese or French India, of a sum not exceeding Rs. 140 in respect of any one month in currency notes and coin issued by the Government of India; and
- (ii) to any destination (including India) of a sum not exceeding Rs. 140 or the equivalent thereof in respect of any one month in any currency notes and coin other than currency notes and coin issued by the Government of India;"

#### The Defence (Finance) Regulations

#### Order under Regulation 5A (1)

IN pursuance of the powers vested in me by regulation 5A (1) of the Defence (Finance) Regulations, having the force of law by virtue of the

Exchange and Securities Control (Continuation) Act, No. 35 of 1950, I, Junius Richard Jayewardene, Minister of Finance, do by this Order grant exemption under the aforesaid regulation in respect of the payment by money order or bank draft or mail or telegraphic transfer, to any person resident in any territory specified in the Schedule hereto, of a sum not exceeding Rs. 100 or its equivalent in any one month, if the person making the payment shall comply with such requirements as the Controller may specify to show that payments made by him or her under this Order do not exceed Rs. 100 in any one month.

2. The order under Regulation 5A (1) of the Defence (Finance) Regulations published in Gazette Extraordinary No. 10,298 of September 19, 1951, is hereby rescinded.

(a) The United Kingdom and the Isle of Man.

- (b) Any Dominion, Colony or other part of the Commonwealth (excluding Canada, Newfoundland and Ceylon).
- (c) Any territory (excluding Palestine) in respect of which a mandate on behalf of the League of Nations had been accepted by Her Majesty and is being exercised by Her Majesty's Government in the United Kingdom or in any Dominion.
- (d) Any British Protectorate or Protected State.
- (e) Burma.
- (f) Iraq.
- (q) Iceland and the Faroe Islands.
- (h) Eire.
- (i) The Hashemite Kingdom of the Jordan.
