Supreme Court Re-constitution Commission

A Commission has been appointed by the Governor-General-

(1) to inquire into and report on the question whether it is necessary or desirable, in the interests of the more efficient administration of justice, that the Supreme Court be so re-constituted as to consist of two or more Divisions each charged with different powers, functions and responsibilities, and

- (2) in the event of the inquiry disclosing that such re-constitution is necessary or desirable-
 - (a) to make recommendations as to the manner of the distribution, between the proposed Divisions of the Supreme Court, of the jurisdiction, powers, functions and responsibilities which are by law vested in or exercisable by the Supreme Court or the Judges thereof, as to the constitution of each of the proposed Divisions of the Supreme Court, and as to such other matters connected with the proposed re-constitution as may be considered appropriate, and
 - (b) to furnish the draft of the legislation necessary to give effect to such recommendations.

SUGAR

The Control of Prices Act, No. 29 of 1950

BY virtue of the powers vested in me by section 4 of the Control of Prices Act, No. 29 of 1950, read with section 12 (i) (b) of that Act, I, Mukundadura Somasri Perera, Deputy Controller of Prices (Food), Hambantota, District, do, by this Order—

- (1) Revoke with effect from this date all my previous price Orders in respect of maximum wholesale and retail prices of sugar within the Revenue District of Hambantota.
- (2) Fix the prices specified in column 2 of the Second Schedule and column 2 of the Third Schedule hereto to be the maximum wholesale and retail prices of sugar respectively of the description and grade specified in the First Schedule hereto which is sold by one hundredweight gross and retail price per pound, respectively, above which sugar shall not be sold within the Revenue District of Hambantota.
- (3) Direct that the provisions of this order shall apply to the description and grade of sugar mentioned in the First Schedule hereto.
- (4) Direct that for the purpose of this Order-
 - (a) any sale of any quantity of sugar for the purpose of resale or any sale of sugar in a quantity of one hundredweight gross or more at a time shall be deemed to be a sale by wholesale;
 - (b) any sale of any quantity of sugar less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
 - (c) the maximum prices fixed by this Order for sugar of any description and grade mentioned in the First Schedule hereto which is sold wholesale by one hundredweight gross or more at a time shall include the container in which the sugar is sold;
 - (d) "Sugar" shall exclude all forms of jaggery.
- (5) Direct that no trader shall sell sugar of any description and grade mentioned in the First Schedule hereto which is adulterated with any other article or with an article of an inferior description and grade or quantity.
- (6) Direct that every trader who at any premises within the areas mentioned in column 1 of the Second Schedule and column 1 of the Third Schedule hereto, exposes for sale sugar of any description and grade specified in the First Schedule hereto, shall exhibit in a conspicuous place at his premises (store or boutique) a notice on which there shall be set out the maximum prices fixed by this Order in respect of sugar of that description and grade.
- (7) Direct that every trader who within the areas mentioned in column 1 of the Second and column 1 of the Third Schedule hereto, sells any sugar of the description and grade specified in the First Schedule hereto, shall on demand, give to the purchaser of that article, a receipt on which there shall be set out—
 - (a) the date of sale,
 - (b) the quantity of sugar sold by weight,

- (c) the description and grade of sugar sold,
- (d) the price paid for the quantity of sugar sold, and
- (e) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail.

- (6) direct that in every area where maximum prices are fixed by this Order, every trader who has any sugar in his possession or under his control at any place or in any vehicle shall exhibit conspicuously at that place or on that vehicle a notice in which there shall be set out the maximum prices for sugar fixed by this Order in that area;
- (7) direct that in every area where maximum prices are fixed by this Order every person who sells any Sugar by Wholesale shall and every person who sells any Sugar by Retail shall on demand give the purchaser thereof a receipt in which there shall be set out—
 - (a) the date of sale,
 - (b) the quantity of sugar sold (by weight),
 - (c) the price paid for the quantity of sugar sold, and
 - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail.

RULES

Part I-Preliminary

These rules may be cited as the Census (Financial Institutions) Rules, 1952.

2. In these rules, unless the context otherwise requires—"Census" means the Census of Financial Institutions, 1952; "Ordinance" means the Census Ordinance (Chapter 118); "Superintendent" means the Superintendent of Census; "establishment" means an insurance company or a finance company or other establishment carrying on the business of pawnbroking or money lending.

Part II-General

0

- 3. The Census directed to be taken in the year 1952, shall be taken during the period commencing on the 1st day of October and ending on the 30th day of November.
- 4. The Superintendent shall, for the purpose of obtaining information for the Census, serve or cause to be served during the period mentioned in rule 3, a schedule on the owner or manager of every establishment or the person in charge of the place where the business of the establishment is carried on.
- 5. For the purpose of these rules the Superintendent may, in his discretion regard a branch of any establishment as a separate establishment and serve or cause to be served a separate schedule in respect of each such branch establishment.
- 6. Every schedule required to be served under rule 4 shall be deemed to have been duly served—(a) if the schedule is delivered by a census officer to the owner or manager of the establishment, or person in charge at the place of business of that establishment, or (b) if such schedule is sent by registered post addressed to such owner or manager, or person in charge at the place of business of that establishment.
- 7. Every person on whom a schedule is served under rule 6 shall—(a) if the schedule has been delivered to him by a census officer, return, within 21 days from the date of such delivery, the schedule duly filled in and signed to the enumerator or supervisor authorised to collect the schedule, or (b) if the schedule has been sent to him by registered post, return, within 21 days from the date of such posting, the schedule duly filled in and signed by registered post addressed to the Superintendent at his office in Colombo.
- 8. The owner, manager or person in charge of any establishment shall, when required to do so by the Superintendent, furnish any further information or explanation of the particulars entered by him in any schedule relating to that establishment.

III - Duties of Census Officers

- 1. Any power or duty conferred or imposed on the Superintendent by the Ordinance or any rule made thereunder may, under the general or special direction of the Superintendent, be exercised or performed by a Deputy Superintendent of Census throughout the Island or by an Assistant Superintendent of Census within such areas as are allotted to that Assistant Superintendent.
- 2. Any power or duty conferred or imposed on a Commissioner by the Ordinance or any rule made thereunder may be exercised or performed by an Assistant Commissioner of Census within the area for which he is appointed, under the general or special direction of the Commissioner of that area.
- 3. No census officer or other person employed for the purpose of taking any census shall without lawful authority publish or communicate to any person, otherwise than in the ordinary course of such employment, any information acquired by him for filling up a schedule or any particulars entered in a schedule.
- 4. No census officer or other person employed for the purpose of taking any census shall, while he has the custody of any schedule, books or other documents relating to any census, permit any other person without lawful authority to have access thereto.
- 5. Every census officer or other person employed for the purpose of taking any census shall, on employment as such, make and subscribe the following oath or affirmation:
- I, —— swear —— solemnly, sincerely and truly affirm and declare faithfully and honestly that I will fulfil my duties as —— in conformity with the requirements of the Census Ordinance (Chapter 118) and all rules made thereunder, and that I will not without the authority in that behalf publish or communicate any information which I may obtain in the course of my employment as ———.
