



In a preferred method of carrying out the gasification in suspension this is achieved by preforming outside the reaction chamber an homogeneous mixture of the finely divided fuel and oxygen or oxygen enriched air. This mixture is introduced into the reaction chamber in one or more jets with such a speed through nozzle-like openings at such a speed that it ignites not earlier than within the reaction chamber.

The part of the reaction chamber walls (the inlet side) can be formed of water cooled metal surfaces whilst the remainder is made of refractory ceramic material.
