"Improvements in or relating to coconuts".

Abstract.—This invention relates to coconuts. A process is provided for preparing coconut which is tender,

resistant to microbiological spoilage and relatively free from undesirable yellowing which comprises adding to the coconut a humectant from which carbonyl-containing impurities have been removed, said humectant consisting of propylene glycol or butylene glycol.

There are 10 claims and 5 examples.
