The Food Control Act, No. 25 of 1950

Order No. 15

BY virtue of the powers vested in me by section 4 (1) (iv) of the Food Control Act, No. 25 of 1950, I, Oliver Ernest Goonetilleke, Minister of Agriculture and Food, do by this Order prohibit the removal from the Customs premises at any port or place mentioned in the first column of the Schedule hereto, of any rice, paddy, wheat, wheat flour or kurakkan except under a permit issued by the person or any of the persons, as the case may be, mentioned in the corresponding entry in the second column of that Schedule, and except in accordance with such directions as he may issue in regard to the time at which, the manner in which and the place to which such rice, paddy, wheat, wheat flour or kurakkan may be so removed.

The Food Control Act, No. 25 of 1950

Order No. 17

BY virtue of the powers vested in me by section 4 (1) (i) of the Food Control Act, No. 25 of 1950, I, Oliver Ernest Goonetilleke, Minister of Agriculture and Food, do by this Order prohibit the transport or removal of any quantity of any rice or paddy from the place given in Column I of the annexed Schedule to the corresponding place given in Column II of the Schedule except under the authority of a permit issued by or on behalf of the Food Controller or a Deputy Food Controller or an Assistant Food Controller or otherwise than in accordance with such conditons as may be attached to such permit.
