Food Price Order ML 1952

The Control of Prices Act, 29 of 1950

Order

BY virtue of the powers vested in me by Section 4 of the Control of Prices Act, No. 29 of 1950, read with section 12 (1) (b), I, Arthur Rajakumar Ratnavale, Deputy Controller of Prices (Food), Matale District, do by this Order -

(1) revoke with effect from this date all my previous price orders in respect of the maximum wholesale and retail prices of sugar within the Revenue District of Matale;

SUGAR

(2) fix the prices specified in columns 2 and 3 of the schedule hereto to be respectively the maximum wholesale prices and the maximum retail prices above which White Refined Sugar and Raw Brown Sugar shall not be sold within the areas specified in the corresponding entries in Column 1 of the same schedule

(3) direct that the provisions of this order shall apply to the description and grade of sugar mentioned in the schedule ĥereto ;

(4) direct that for the purpose of this order:—

(a) any sale of any quantity of sugar for the purpose of resale or any sale in a quantity of one hundred-

weight gross or more at a time shall be deemed to be a sale by wholesale;

(b) any sale of any quantity of sugar less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;

(c) the maximum prices fixed by this order for sugar of any description and grade mentioned in the schedule hereto which is sold wholesale by one hundredweight gross or more at a time shall include the container in which sugar is sold;

(d) "sugar" shall exclude all forms of jaggery.

(5) direct that no trader shall sell sugar of any description and grade mentioned in the schedule hereto which is adulterated with any other article of an inferior description and grade or quantity;

(6) direct that every trader who at any premises within the areas mentioned in column 1 of the schedule hereto, exposes for sale sugar of any description and grade specified in the schedule hereto, shall exhibit in a conspicuous position at his premises (store or boutique) a notice on which there shall be set out the maximum prices fixed by this order in respect of sugar of that description and grade;

SOUPDINE

(7) direct that every trader who at any premises within the areas mentioned in Column 1 of the Scheudle hereto sells any sugar of that description and grade specified in the schedule hereto, shall on demand, give to the purchaser of that article a receipt on which there shall be set out :—

(a) the date of sale,

- (b) the quantity of sugar sold by weight,(c) description and grade of sugar sold,
- (d) the price for the quantity of sugar sold,(e) and the nature of the transaction, that is to say, whether the sale was by wholesale or retail.
