The Registered Stock and Securities Ordinance

BY virtue of the powers vested in me by section 34 of the Registered Stock and Securities Ordinance (Chapter 289), as modified by the Proclamation published in *Gazette Extraordinary* No. 9,773 of September 24, 1947, I, Junius Richard Jayewardene, Minister of Finance, do hereby—

- (1) declare the registered stock and securities in the form of Government Promissory Notes issued in Ceylon under the provisions of the National Development Loan Act, No. 3 of 1950, for the purpose of raising the 2 year loan of Rs. 40 millions directed to be raised by Order dated October 25, 1950, and published in *Gazette Extraordinary* No. 10,169 of October 31, 1950, to be convertible into registered stock or securities to be issued under the provisions of this Ordinance ;
- (2) for the purpose of the conversion of the registered stock and securities referred to in paragraph (1), authorise the creation and issue under this Ordinance of registered stock or securities (hereinafter referred to as "new stock or securities") of the amount of Rs. 40 millions, upon the terms and conditions specified in the Schedule hereto ;
- (3) declare in terms of paragraph (d) of section 34 of this Ordinance, that the interest payable on any new stock or securities held by any Government referred to in section 7 of the National Development Loan Act, No. 3 of 1950, shall be exempt from all taxes and duties leviable or payable under any written law in force in Ceylon, notwithstanding anything in any such written law to the contrary.

1. The sum of money to be raised by the issue of new stock and securities shall be forty million rupees, and it shall be raised by way of a 3 year loan.

Issue of Rs. 40,000,000**CEYLON GOVERNMENT $1\frac{1}{2}$ % LOAN REPAYABLE AT PAR ON DECEMBER 1, 1952**

THE Central Bank of Ceylon, on behalf of the Government of Ceylon, invites subscriptions to the above loan in cash or by conversion at par of the Ceylon Government $1\frac{1}{2}$ per cent. Loan 1952 due for repayment on December 1, 1952.

Authority.—The loan is raised under the provisions of Section 34 of the Registered Stock and Securities Ordinance, 1937 (Chapter 289).

Purpose.—The loan is raised in conversion of the $1\frac{1}{2}$ per cent. Loan 1952 raised in November, 1950, on the authority of the National Development Loan Act, No. 3 of 1950.

Form of Issue.—The loan will be issued at the option of the applicant in the form of Registered Stock or Promissory Notes. (Leaflets containing the general conditions applicable to Registered Stock and Promissory Notes are available on application to the Department of Public Debt, Central Bank of Ceylon.)

Issue Price.—The issue price is Rs. 100 per cent. payable in full at the time of application. The minimum holding is Rs. 100.

Applications.—Applications from holders of the $1\frac{1}{2}$ per cent. Loan 1952 for conversion into the new loan should be made to the Registrar, Department of Public Debt, Central Bank of Ceylon, Echelon Square, P. O. Box 1149, Colombo 1, on or before November 25, 1952, for conversion as on December 1, 1952. Cash applications will be received by the Registrar from December 2, 1952, and until the list is closed. Applications must be on the proper form and must be accompanied by a remittance in full or in the case of a conversion, by the redemption warrant together with the Stock Certificates or Promissory Notes of the $1\frac{1}{2}$ per cent. Loan 1952, duly received. Depositors of the Ceylon Savings Bank and Post Office Savings Bank may by arrangement with the Savings Banks forward cash applications through those banks.

A commission of 1/16 per cent. will be allowed to bankers (including the Ceylon Savings Bank and the Post Office Savings Bank), recognized stock-brokers and brokers in respect of applications bearing their stamp. A negotiating fee of the same percentage will be allowed to Proctors in respect of applications bearing their stamp.

Payment for stock.—Payment for subscriptions in cash should be made by cheque drawn in favour of the Central Bank of Ceylon and crossed "on account of Ceylon Government Loan".

Scrip.—Stock Certificates or Promissory Notes will be issued after receipt and acceptance of the application.

Interest.—Interest at the rate of 1½ per cent. per annum will be payable half-yearly on the 1st day of June and the 1st day of December in each year. The first payment will be on the 1st day of June, 1953, and will be for the amount of interest due for the period commencing on the date on which the application is accepted up to and including the 31st day of May, 1953, and a warrant for this amount payable on the 1st day of June, 1953, will be attached to the scrip.

Taxation.—All documents used in the issue, exchange, transfer or redemption of the loan will be free from stamp duty. Interest to resident holders will be paid without deduction of income tax, but resident holders liable to income tax should include such interest in their income tax returns. Deductions of tax at source will be made from holdings by non-residents, other than Governments of Her Majesty's dominions. (Current rate of income tax is 30 per cent. in the case of non-resident individuals and 36 per cent. in the case of non-resident companies). Persons who are exempt from Ceylon income tax will be entitled to claim repayment of the tax deducted. Holdings of charities and Governments of Her Majesty's dominions are exempt from Ceylon Income Tax.

Public Debt.—The present public debt of Ceylon is Rs. 809,732,833 (exclusive of Rs. 65,170,550 war loans issued on behalf of the United Kingdom Government). The approximate market value of the accumulated sinking funds amounts to Rs. 185,526,600. The net public debt is thus Rs. 624,206,233.

The Navy Act, No. 34 of 1950*Trincomalee Naval Port Regulations*

ORDER made under regulation 5 of the Trincomalee Naval Port Regulations published in *Gazette Extraordinary* No. 10,187 of December 9, 1950.

ORDER

1. All vessels navigating within the Port of Trincomalee shall observe the following rules:—

- (a) Every vessel not exceeding 1,000 tons displacement, shall keep clear of all vessels exceeding 1,000 tons displacement.
- (b) Every vessel not exceeding 1,000 tons displacement shall keep clear of every sea plane or flying boat when water borne. Every sea plane or flying boat when water borne shall keep clear of vessels exceeding 1,000 tons displacement.
- (c) In a case where two vessels exceeding 1,000 tons displacement meet in the narrows between Eagle Point and Ostenburg Point, the incoming vessel shall keep clear of the outgoing vessel.

2. No person shall anchor any boat or vessel, or fish or lay nets, fishing stakes or other fish traps in any of the areas specified in the schedule hereto:

Provided, however, that the preceding provisions of this paragraph shall not apply in the case of any boat or vessel used by officers of the Government on official duties.

Schedule

- (1) All that area situated within the Port of Trincomalee and bounded on the South East by the foreshore between Dockyard Boundary fence and Ostenburg Point, and on the North West by the line drawn from the foreshore at the Dockyard Boundary fence to the South York Buoy, thence to the Dockyard Shoal light buoy and thence to Ostenburg Point.
- (2) All that area situated within the Port of Trincomalee and bounded on the South by the foreshore between Round Point and the point on the foreshore in Boom Cove situated 266° 1,680 feet from occasional fixed red light on the Boom Shed, China Bay, and on the North by a line drawn from this point to the North East extremity of No. 2 oiling jetty, and thence to Round Point.

RESERVATION OF SLEEPING BERTHS

IN view of the inadequacy of sleeping berths to meet demands and with a view to ensuring that, as far as possible, the limited number of berths is allocated equitably, it has been decided that reservation of berths is confined to persons who have already obtained their tickets (1st or 2nd class, as the case may be) for the journey at Colombo Fort or made a deposit of the requisite berth fees (Rs. 5 and Rs. 2.50 for 1st and 2nd classes respectively) at out stations. In this connection, the following directions are published for general information:—

- (a) At Colombo Fort, requests for reservation will be accepted at the Berth Office ten days in advance of the date of travel, on production of the necessary single or return tickets for the journey which will also be issued

similarly in advance. Berths for return will not be allocated unless the journey is to be performed within 14 days of the outward journey. Berth tickets should be obtained at the time reservation is made. Any passenger wishing to pay for his return berth at the entraining station will be issued a chit for the purpose, provided he has already obtained a return ticket for the journey.

If no berths are available at the time reservation is required, the applicant may leave his name and address and Telephone No., if any, with the Officer-in-Charge of the Berth Office in order that his name may be placed on the waiting list.

Passengers requiring berths at train time should contact the Assistant Station Master on duty who will make reservations, should berths be available.

- (b) In the case of outstations, applicants for berths should contact the Station Master concerned and deposit with him the requisite berth fee, obtaining a receipt therefor in order that he may communicate with the Berth Office, Colombo Fort, and arrange for the necessary reservation to be made. Such deposit may also be made within ten days in advance of date of travel. Should no berths be available, the fee will be refunded on production of the deposit receipt. Warrant holders too are required to make this deposit in cash which will be refunded upon reservation and issue of necessary tickets on warrant.
- Passengers may also apply for and obtain any vacant berths for their use en route on application to the Headguard of train or the Officer-in-Charge of the Station concerned. No others are authorised to allocate berths.

- (c) Passengers failing to occupy their berths at the stations from which they have secured reservations, are liable to have their berths cancelled to be allotted to other applicants, unless notice is given of any change in regard to their travel.

- (d) Berths will normally be reserved for night travel of 150 miles or over except over the Up-country Line where the distance is reduced to 100 miles. Reservation for any lesser distances can, however, be obtained in the event of any berths remaining vacant on day of travel.

- (e) Tickets issued in advance will not be valid on any day other than the date of travel shown thereon by the Booking Officer.

Any passenger wishing to either cancel his journey or alter the date of his travel should produce his ticket on or before that date to the Issuing Officer or the Station Master concerned, for a suitable endorsement. Date of travel will, however, not be altered for a date later than three days of the date for which it has been issued. In the event of cancellation of the journey, an

endorsement of nonuse should be obtained and refund of value of ticket claimed from the Chief Accountant, C. G. R. In the case of a warrant holder, application for credit should be made through the Head of his Department, in terms of F.R. 1483.

The above arrangements will come into force on and after December 1, 1952.
