

hydrolysis under such mild temperature conditions as will produce the N-acylamido diol. The conditions for effecting the hydrolysis are described.

"Process for the manufacture of optically active organic amino diols"

Abstract.—This invention relates to a process for the resolution of the optical isomers of a class of novel amino diol compounds. The racemic amino diols used as starting materials have the formula.

where R₃ is hydrogen or lower alkyl radical, R₄ and R₅ are the same or different and represent hydrogen, halogen, lower alkyl or lower alkoxy radicals and R₅ is hydrogen or a—NO₂ group. The process consists of reacting the racemic amine with an optically active acid, separating the acid addition salts of the (d) and (l)—isomers by fractional crystallisation from an aqueous or anhydrous organic solvent and separately neutralizing the acid addition salts of the separated (d) and (l)—isomers to obtain the corresponding separate (d) and (l) optical isomers of the free base of the amino diol compound. The optically active acids suitable for the process are mentioned.

"Improvements in or relating to motor cycle driven vehicle".

Abstract.—This invention relates to motor cycle vehicles and refers specifically to means for converting a motor cycle into a three wheeled light transport vehicle. The object of the invention is to incorporate means for enabling the outer wheel to take a larger number of turns than the inner wheel when the vehicle takes a turn. This is achieved by fitting an intermediate driving shaft on which are mounted to sprocket wheels, one being driven from the sprocket wheel at the engine end and the other driven by a chain wheel, another sprocket wheel in a differential mounted at the back axle of the vehicle.
