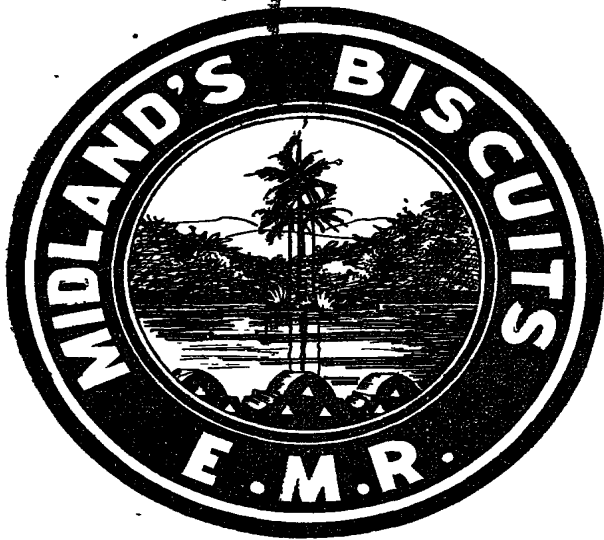

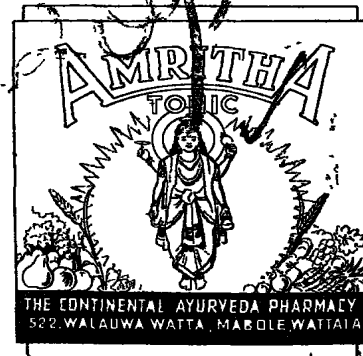

"Improvements relating to nut-husking machines".

*Abstract.*—This invention relates to improvements to nut-husking machines.

This invention is particularly concerned with improvements in or modifications of the nut-husking machine described in Specification of Ceylon Patent No 3,428 generally with a view to extending the mechanisation of the machine whilst simplifying its construction in some respects. The objects are to provide an improved arrangement for cutting the husks of the nuts, preventing the retention of the kernels within the cut halves. The cutting arrangement consists of a series of co-acting opposed cutter discs of small diameter following closely on each other and which comprises successive such cutter discs arranged to rotate in opposite directions and/or cutter discs arranged to reverse their direction of rotation during the cutting of each husk.
