NOTIFICATION MADE UNDER STATE LAND REGULATION No. 21 (2)

It is hereby notified that Trustee Board of Mula Sangha Sathi Arama Buddhist Centre Ghathi has requested on lease a state land containing in extent about 01 Rood, 19 Perches out of extent marked Lot No. 235 as depicted in the Tracing No. F. V. P. 1921 situated in the village of Nagollagama with belongs to the Grama Niladhari Division of No. 227, Rathmale coming within the area of authority of Mahawa Divisional Secretariat in the District of Kurunegala.

02. Given below are the boundaries of the land requested.

On the North by : Access Road ;
On the East by : Encroached Land of H. B.
Chandani Kumari ;
On the South by : Land of Temple ;
On the West by : Land of Temple .

The land requested can be given on lease for the necessary purpose. Therefore the Government has intended to lease out the land subject to other government approved conditions.

- (a) *Terms of the lease* .- Thirty Years (30) (form 23.11.2016 on wards);
- (b) *The annual rent of the lease* .- 1/2% of the Undeveloped value of the land as per valuation of the chief valuer for the year 2016 approved by Hon Minister.
- Premium.- No ;
- (c) The lessee must not use this land for any purposes other than for the Religious purpose;

- (d) The lessee must within one year of the commencement of the lease develop the said land in such a manner as to captivate the mind of the Divisional Secretary;
- (e) This lease must also be subject to the other special conditions stipulated and imposed by the Divisional Secretary and by other institutions;
- (f) The buildings constructed must be maintained in a proper state of repair;
- (g) Once the land is given on lease and in the event of failure on the part of the lessees to substantiate within the specified time frame the purpose for which the land was obtained action will be taken to terminate the lease;
- (h) No sub - leasing can be done until the expiry of a minimum period of 05 years from the date of 23.11.2016;
- (h) Payment of the lease must be regularly made and if defaulted in payment, the agreement will *ipso facto* lapse.

If acceptable reasons are not submitted to me in writing within six weeks of the date which this notice is published in the *Gazette* to the effect that this land must not be given on lease the land will be leased out as requested.
