ORDER UNDER SECTION 22(1)(f) OF THE LAND REFORM ACT, No. 1 OF 1972 OF THE NATIONAL STATE ASSEMBLY

BY virtue of the powers vested in me under para (f) of Sub section (1) of Section 22, of land Reform Act, No. 1 of 1972 of the National State Assembly, which has been amended by Act No. 39 of 1975, Act No. 14 of 1981, Act No. 39 of 1981, Act No. 14 of 1986 and Act No. 18 of 1986, I, John Anthony Emmanuel Amaratunge, the Minister of Lands do hereby this Order declare that,

- the agricultural land indicated specifically in Column II of the Schedule, under this Order shall be alienated to the persons whose names are indicated specifically in Column I of the Schedule ;
- The agricultural lands indicated specifically in the corresponding note of Column II of the Schedule, under this Order were belonged to the persons, whose names appeared specifically in Column I of the Schedule, and the said agricultural lands were included in the extent of lands which were considered to be belonged to the head of the family, in which the above persons were also the members.
- The persons indicated in Column I of the Schedule, under this Order were below 18 years of their age at the time of imposing the ceiling, on agricultural lands in terms of the above Act.
- The agricultural lands indicated specifically in Column II of the Schedule, have not been alienated to any person under Section 22 of the aforesaid Act.
- No compensation has been paid under Section 28 of the aforesaid Act, in respect of the above agricultural lands.
