## Government Notifications

#### **DEFENCE (FINANCE) REGULATIONS**

Order under Regulation 5A (1)

IN pursuance of the powers vested in me by Regulation 5A (1) of the Defence (Finance) Regulations, having the force of law by virtue of the Exchange and Securities Control (Continuation) Act, No. 35 of 1950, I, Junius Richard Jayewardene, Minister of Finance, do by this Order grant exemption under the aforesaid Regulation in respect of the payment by money order, by any person who, not being a citizen of Ceylon, is lawfully resident in Ceylon, to a person resident in any territory specified in the Schedule hereto, of a sum not exceeding Rs. 50 or its equivalent in any one month, if the person making the payment shall comply with such requirements, as the Controller may by notification specify, to show that such person, not being a citizen of Ceylon, is lawfully resident in Ceylon and that payments made by such person under this Order do not exceed Rs. 50 in any one month.

2. The Order under Regulation 5A (1) of the Defence (Finance) Regulations published in Gazette Extraordinary No. 10,474 of November 29, 1952, is hereby rescinded.

#### Notification under the Provisions of the Order issued under Regulation 5A (1)

IN pursuance of the provisions of the Order under Regulation 5A (1) of the Defence (Finance) Regulations published in Gazette No. 10,506 of March 11, 1953, it is hereby notified that a person making a payment under the provisions of that Order shall produce in person to the Postmaster at the Post Office at which the payment is to be made—

- (a) a valid Passport issued to him; and
- (b) a valid Exchange Control card issued to him by a Postmaster on behalf of the Deputy Controller of Exchange.

#### THE DEFENCE (FINANCE) REGULATIONS

#### Order under Regulation 5 (1)

IN pursuance of the powers vested in me by regulation 5 (1) of the Defence (Finance) Regulations, having the force of law by virtue of the Exchange and Securities Control (Continuation) Act, No. 35 of 1950, I, Junius Richard Jayewardene, Minister of Finance, do by this Order amend the Order under the aforesaid regulation published in *Gazette Extraordinary* No. 9,872 of June 1, 1948, as last amended by the Order published in *Gazette Extraordinary* No. 10,445 of September 8, 1952, in paragraph (1) thereof, by the substitution, for sub-paragraph (c), of the following new sub-paragraph:—

- "(c) the taking out of Ceylon by any person—
  - (i) to any part of India, other than Portuguese or French India, of a sum not exceeding Rs. 100 or the equivalent thereof in respect of any continuous period of three months in currency notes and coin including currency notes and coin issued by the Government of India; or
  - (ii) to any destination, including Portuguese or French India but excluding any other part of India, of a sum not exceeding Rs. 100 or the equivalent thereof in respect of any continuous period of three months in currency notes and coin other than currency notes and coin issued by the Government of India."

### THE DEFENCE (FINANCE No. 3) REGULATIONS

#### Order under Regulations 1 and 7

IN pursuance of the provisions of regulations 1 and 7 of the Defence (Finance No. 3) Regulations, having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, of the Imperial Parliament, read with the Supplies and Services (Transitional Powers) Order, 1946, and modified by the Proclamation published in Gazette Extraordinary No. 9,773 of September 24, 1947, I, Junius Richard Jayewardene, Minister of Finance, do by this Order amend the Order under the aforesaid regulations 1 and 7 published in Gazette Extraordinary No. 9,891 of July 31, 1948, as subsequently amended by the Order under the aforesaid regulations published in Gazette No. 10,113 of June 23, 1950, by the substitution, for sub-paragraph (3), of the following new sub-paragraph:—

"(3) grant exemption from the aforesaid regulation 1 in respect of the bringing into Ceylon at any one time, by any person travelling to Ceylon in any ship or aircraft, of the notes mentioned in the aforesaid Second Schedule, if but only if, the total value of all such notes including Pakistan notes and the total value does not exceed Rs. 100 of Pakistan notes does not exceed Rs. 50; and "
