THE HOUSING AND TOWN IMPROVEMENT ORDINANCE

THE following resolution passed by the Senate at a meeting held on January 23, 1948, and by the House of Representatives at a meeting held on January 15, 1948, is published for general information:-

This House resolves under the provisions of section 3 (b) of the Housing and Town Improvement Ordinance (Chapter 199), as modified by Proclamation under section 88 (1) of the Ceylon (Constitution) Order in Council, 1946, published in Gazette Extraordinary No. 9,773 of September 24, 1947, that from the 1st day of February, 1948, the aforesaid Ordinance shall be in force within the area defined in the Schedule hereto:

Schedule

All that area of land representing the former Sanitary Board Town of Hanwella situated in Meda Pattuwa of Hewagam Korale in Colombo District of the Western Province and bounded as follows:-

North: By a line drawn from a point at the centre of the Kelani Ganga due north of the northwestern corner of the cemetery bordering the Low Level Colombo-Avissawella Road eastwards along the centre line of the said river to a point due north of culvert No. 19/1 on the Low Level Colombo-Avissawella Road over the Kuppiawatta Ela.

East: By a line drawn from the last-mentioned point southwards crossing the Kelani Ganga and the Low Level Colombo-Avissawella Road at culvert No. 19/1 to the landmark on the southern boundary of Delgahawatta claimed by Elandaridewage Arnolis Fernando, thence by a line drawn eastwards to the northern wall of the slaughter house, south-eastwards along the northern wall of the slaughter house to a point on the foot-path leading to the Government Dispensary, 6½ chains from the centre of the junction of the said footpath with the Horana-Hanwella Road; thence south-eastwards by a line 10 chains 20 links drawn to a point distant 9 chains 20 links from

the centre of the junction of the Hanwella-Horana Road and High Level Road to Avissawella, thence by a straight line drawn to the centre of the Avissawella High Level Road 6 chains 6 links from the above-mentioned junction, thence by a line drawn southwards to a point on the northern boundary of Mahayayawatta claimed, by E. W. Jayasinghe and others 20 links east of the north-western corner of the said land, thence by a line drawn southeastwards to the south-western corner of Kirikumbura claimed by E. W. Jayasinghe and others, thence by a line drawn southwards to the centre of the D. R. C. Road leading to Pitumpe, 6 chains 6 links east of the junction of the said Road and Avissawella High Level Road, south-eastwards by a straight line to a point on the eastern boundary of Gonnagahawatta claimed by Hettiarachchige Punchi Nona and others 230 links from the south-eastern corner of the said land, thence by a line drawn southwards along the eastern boundary of the said land to its south-eastern corner.
