2. Salary, Allowances, and Conditions of Service.— The salary scale attached to the post is Rs. 356—16 cts.—Rs. 5 per diem.

Note.—The selected candidate may be placed at a point in the scale depending on his skill and experience.

- (ii) Rent allowance, temporary cost of living allowance and a "special living allowance" are payable according to Government Regulations.
- (iii) The appointment will be subject to the Public Service Commission Rules, the Financial Regulations, the Administrative Regulations of the Manual of Procedure, Departmental Orders or Regulations, and any other orders or regulations issued from time to time by the Government.
