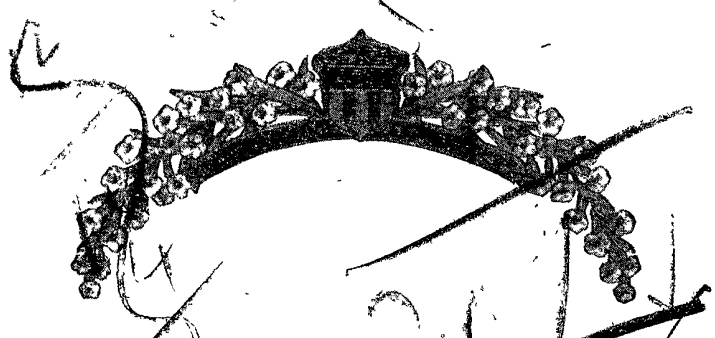

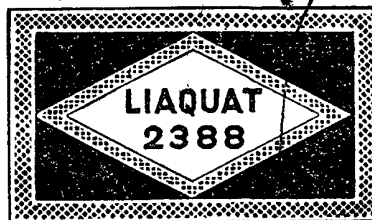

Valiyakath Kunjahamed Hamza.

"Improved record changer and player".

Abstract.—The invention relates to automatic record changers and players.

Its nature can be gathered from Claim I which is as follows.—

1. An automatic record changer and player comprising a record gripper having means for raising the gripper said means being operated through a main shaft driven by a motor, means for turning the gripper through 180°, means for moving the gripper sideways on the table and a record loading arm independently of the gripper and the turn table provided on the platform, the operation of cams mounted on the main shaft and actuating the gripper and the loading arm being so adjusted that after one side of a record has played and the pick up arm moves away the gripper holds the record, is raised and is then turned through 180° to reverse its sides, deposits

the record on the turn table and after the second side has played the gripper again holds the record, is raised and moved sideways to discard the played record and simultaneously the loaded arm moves towards the turn table to deposit a fresh record and then the gripper and the loaded arm return to their respective positions.

"A container for tetrahedronshaped packages".

Abstract.—This invention relates to containers for tetrahedron shaped packages and is characterised by the fact that it is formed as a regular hexahedral prism, the bottom of which is so shaped that its supporting surfaces which rest against a lower most layer of tetrahedrons placed in the container from edge angles against the vertical walls of the prismatic container approximately equal to the edge angle of a tetrahedron.
