



"Improvements in or relating to the manufacture of blocks, slabs or moulded articles or structures".

Abstract.—This invention relates to an improved process for manufacturing a building and constructional material or a mouldable material. According to the invention wood wool, wood shavings, saw dust, grass, hay, coir or other vegetable fibre is cemented together using any oxychloride cement or magnezium sulphate cement characterised further by the addition of metallic ferrous metal in a finely divided state. After the mixture has set sufficiently for handling it is treated with sodium silicate solution.

'Footwear and method of its manufacture'

Abstract.—This invention relates to footwear and methods of their manufacture. According to the invention the shoe is provided with a non-porous rubber sidering which is preferably connected to the upper. The inner part of the sole may consist of porous rubber enclosing a layer of fibrous material. The tread sole may be of rubber composition leather or even rope. It is preferred to manufacture the shoe in a single operation Methods of preferred manufacture are described

"An unspillable safety oil lamp".

Abstract.—This invention relates to a safety oil lamp. The lamp which can be made of tin or any other suitable metal consists of a container for oil, a tube for the wick connected to a lid, a cylindrical tube which extends down half way or slightly more from the top of the container and also above the container with two or more slits on its upper side, a cylindrical ring on top of container encircling the safety tube and the tube which holds they wick serving as a funnel for pouring oil into the container.

"Process of producing coconut oil".

Abstract—This invention relates to the production of coconut oil. The nature of the invention can be ascertained from Claim 1, which is as follows:—

The process of producing coconut oil from whole coconuts which comprises separating the coconut meat from the coconut shells; sub-dividing the whole meat into relatively small particles, and subjecting the small particles to contact with a stream of non-reactive gas maintained at an elevated temperature and not above substantially 165° F. until more than 95 per cent. of the moisture contained in the particles has been removed and then removing coconut oil from the thus dried meat.

"Apparatus for the continuous production of packages from a tubeshaped element".

Abstract.—This invention relates to an apparatus for continuously producing pillow shaped or tetrahedron shaped packages from a tube, sleeve or the like.

The specification describes an apparatus for continuously producing packages from a tube shaped element by compressing and gumming together said tube shaped element along narrow zones disposed at uniform intervals from each other and running transversely to the longitudinal extension of the tube shaped element.

The specification is illustrated with six sheets of drawing and there are 17 claims.

"Improvements in or relating to soldering devices".

Abstract.—This invention relates to soldering devices. This device comprises a body formed from a non-metallic material capable of withstanding a temperature higher than that at which a selected solder melts and formed with a passage which opens into the external surface of the body. The cross section is sufficiently large to accommodate lengths of at least two of the conductors to be soldered lying side by side and a body of the solder so located within the passage that the lengths of the conductors may be readily inserted therein.

"Apparatus for producing hollow plastic articles".

Abstract.—The nature of the invention can be ascertained from Claim 1 which reads as follows:—

1. Apparatus for producing hollow articles of heat setting plastic material, comprising a sectional cavity mold adapted to contain a predetermined quantity of the plastic material, a conveyor for moving said mold in a predetermined path, means for providing compound rotation of said mold to cause criss-cross flow of the plastic material therein and thereby forming a preset article of predetermined wall thickness, and heating means in said path of the mold for thereafter subjecting the same to substantial heat to complete the setting of the material of the article.

where X is a halogen atom and R_1 and R_2 are the same or different and represent lower alkyl or lower hoydroxy alkyl radicals or, when taken together with— , a saturated heterocyclic radical such as a piperidino, morpholino or pyrrolidino group, can be prepared by the condensation of a halogenated 8— quinolinol of formula

with formaldehydle and an amine of formula

or with equivalent products or mixtures of products resulting from first condensing said amine and formal dehyde (X, \mathbf{R}_1 & \mathbf{R}_2 having the same significance as above.)

The method of carrying out the reaction is described. There are 6 claims and 13 examples.
