PROCLAMATION.

By His Excellency the Right Honourable Sir J. WEST RIDGEWAY, Knight Commander of the Most Honourable Order of the Bath, Knight Commander of the Most Exalted Order of the Star of India, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WEST RIDGEWAY.

WHEREAS by the 3rd section of "The Local Board of Health and Improvement Ordinance, 1876," it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation to be for that purpose published in the Government Gazette, to bring any of the towns mentioned in the schedule to the said Ordinance annexed under the operation of the said Ordinance, and to define the limits of such town or towns respectively, for the purposes of the said Ordinance, and such Proclamation to amend, alter, or revoke as and whenever the Governor shall, with like advice, determine:

And whereas by Proclamations dated the 2nd day of June, 1888, and the 3rd day of October, 1894, respectively, the town of Matalé, in the Central Province, a town mentioned in the schedule aforesaid, was brought under the operation of the said Ordinance, and the limits of the said town were, for the purposes of the said Ordinance, defined in the said Proclamations:

And whereas it is expedient to amend the said Proclamations of the 2nd day of June, 1888, and the 3rd day of October, 1894, respectively, in respect to the limits of the said town of Mátalé, and to re-define the limits of the said town for the purposes aforesaid:

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby amend the Proclamations of the said 2nd day of June, 1888, and 3rd day of October, 1894, respectively, aforesaid by further extending the limits of the said town as defined therein, and We do hereby define, for the purposes of the said Ordinance, the limits of the said town of Mátalé to be those set out in the schedule hereto, as from and after the 1st day of January, 1897.

Given at Colombo, in the said Island of Ceylon, this Sixteenth day of December, in the year of our Lord One thousand Eight hundred and Ninety-six.
