# THE DEFENCE (FINANCE) REGULATIONS

#### Order under Regulation 5 (1)

IN pursuance of the powers vested in me by regulation 5 (1) of the Defence (Finance) Regulations, having the force of law by virtue of the Exchange and Securities Control (Continuation) Act, No 35 of 1950, I, Junius Richard Jayewardene, Minister of Finance, do by this Order amend the Order under the aforesaid regulation published in *Gazette Extraordinary* No 9,872 of June 1, 1948, as last amended by the Order published in *Gazette Extraordinary* No 10,506 of March 11, 1953, in paragraph (1) thereof, by the substitution, for sub-paragraph (c), of the following new sub-paragraph

#### "(c) the taking out of Ceylon by any person---

- (1) to any part of India other than Portuguese or French India, of a sum hot exceeding Rs 50 or the equivalent thereof in respect of any continuous period of 6 months in currency notes and coin including currency notes and coin issued by the Government of India, or
- (ii) to any destination, including Portuguese or French India but excluding any other part of India, of a sum not exceeding Rs 50 or the equivalent thereof in respect of any continuous period of 6 months in currency notes and coin other than currency notes and coin issued by the Government of India,

provided that where such person is under 18 years of age, only a sum not exceeding Rs 25 or the equivalent thereof may be so taken out of Ceylon

#### THE DEFENCE (FINANCE) REGULATIONS

### Order under Regulation 5A (1)

IN pursuance of the powers vested in me by Regulation 5A (1) of the Defence (Finance) Regulations having the force of law by virtue of the Exchange and Securities Control (Continuation) Act, No 35 of 1950, I, Junius Richard Jayewardene, Minister of Finance, do by this Order-

(1) grant exemption, under the aforesaid regulation in respect of the payment by money order, by any person who-

(a) not being a citizen of Ceylon, is resident in Ceylon on the authority of a Temporary Residence Permit issued by or on behalf of the Controller of Immigration, Ceylon, (b) is permitted by such Temporary Residence Permit to be gainfully employed in Ceylon, and (c) has not applied for registration as a citizen of Ceylon,

to a person resident in any territory specified in the Schedule hereto, of a sum not exceeding thirty rupees or its equivalent in any one-month, if the person making the payment shall comply with such requirements as the Controller may by notification specify, to show that such person is eligible in terms of this Order to make the payment and that payments made by such person under this Order do not exceed thirty rupees in any one month, and

(2) rescind the Order under Regulation 5A (1) of the Defence (Finance) Regulations published in Gazette Extraordinary No 10,506 of March 11, 1953

#### **THE DEFENCE (FINANCE) REGULATIONS**

#### Notification under the provisions of the Order made under Regulation 5A (1)

IN pursuance of the provisions of the Order under Regulation 5A (1) of the Defence (Finance) Regulations published in *Gazette Extraordinary* No 10,525 of May 12, 1953, it is hereby notified that a person making a payment under the provisions of that Order shall produce in person to the postmaster at the post office at which the payment is to be made

- (1) a valid passport issued to him endorsed by or on behalf of the Controller of Immigration, Ceylon, with a valid temporary residence permit permitting him to be gainfully employed in Ceylon,
- (2) a declaration signed by him to the effect that he has not applied for registration as a citizen of Ceylon, and
- (3) a valid Exchange Control card issued to him by a postmaster on behalf of the Deputy Controller of Exchange
