MINUTES ON PENSIONS

NOTIFICATION under section 51 of the Minutes on Pensions dated February 5, 1934, as amended by the Minutes on Pensions (Amendment) Act, No 13 of 1948

Notification

The Minutes on Pensions dated February 5, 1934, as amended from time to time, are hereby further amended, by the insertion, immediately after section 48, of the following new section—

“48A. Where any pensionable officer or servant of the Government of Ceylon has relinquished his office or post under the Government with its approval and accepted employment as a full-time member of the Board, or as an officer or servant of the Board or on the staff of the Board, he may retain any benefit or qualification that may have accrued to him under these rules, and, accordingly—

(a) in the event of his leaving such employment in any of the following circumstances, that is to say—

(i) retirement on account of age or on the ground of ill-health, or

(ii) abolition of office,

the following award may be granted to him, namely, such award as might have been granted to him under these rules if he had been retired from the service of the Government of Ceylon on the ground of ill-health on the date on which he took up such employment, or

(b) in the event of his death while he is in such employment, the following award under these rules may be granted to the person or persons to whom such award is payable under these rules, namely, such award as might have been granted under these rules, if he had died on the date on which he accepted such employment

Provided, however, that where he leaves such employment in consequence of the abolition of office, such award shall be granted to him on the date on which he leaves such employment or on the date on which he attains the age of fifty-five years, whichever is later

In this section—

“abolition of office” in relation to a member of the Board shall include vacation of office of the member by effluxion of time, reappointment not being offered to him;

“Board” means the Gal Oya Development Board or the Board of Directors of the Co-operative Wholesale Establishment, and

“full-time member” means a member of the Board required to engage himself solely in the discharge of duties imposed on him by or under the Act

The provisions of this section shall be deemed to have come into effect, in relation to a full-time member or an officer or servant of the Gal Oya Development Board, on the date on which the Gal Oya Development Board Act, No 51 of 1949, came into operation, and in relation to a full-time member or a person on the staff of the Board of Directors of the Co-operative Wholesale Establishment, on the date on which the Co-operative Wholesale Establishment Act, No 47 of 1949, came into operation.

NoticesPRELIMINARY REPORT ON THE VITAL
STATISTICS OF CEYLON, 1952

THE Vital Statistics for Ceylon for the year 1952 present the following important features —

- (a) The marriage rate (General and Kandyan) of 12.9 per 1000 of the non-Muslim population is lower than those for the preceding two years 1951 and 1950.
- (b) The birth rate of 39.5 per 1000 of the population is lower than that for any of the years 1948-1951 but higher than those for the years 1929 to 1947 excepting the year 1943.
- (c) The general death rate of 12.0 per 1000 of the population is the lowest on record. The infant mortality rate of 78 per 1000 live births is also the lowest on record. The maternal death rate of 5.8 per 1000 live births is the same as that for 1951.

Population

The estimated population of Ceylon at mid-year 1952 was 7,940,000 and on December 31, 1952, was 8,043,000. The natural increase (i.e. excess of births over deaths) during the year was 218,237 while there was an excess of 16,275 emigrants over immigrants.

Marriages

The total number of marriages registered in 1952 under the General and Kandyan Marriage Ordinances was 47,735 (38,484 General and 9,251 Kandyan) as compared with 48,555 in 1951. The marriage rate per 1000 of the non-Muslim population has also fallen from 13.4 in 1951 to 12.9 in 1952. There is, however, a slight increase in the number of marriages registered under the Muslim Marriage Ordinance. The figure for 1952 is 5,196 as against 5,058 for 1951. The marriage rate among the Muslims has also risen from 19.9 in 1951 to 20.0 in 1952.

Births

313,535 births (159,107 of males and 154,428 of females) were registered in 1952 as against 313,662 in 1951. The birth rate in 1952 was 39.5 per 1000 of the population and the sex ratio was 1,030 males to 1,000 females. The birth rate in the Colombo Municipality in 1952 was 62.3 per 1,000 of the population as against 59.9 in 1951. Births on estates registered in 1952 totalled to 35,263 as against 39,015 in 1951.

Deaths

The number of deaths registered in 1952 was 95,298 (48,549 of males and 46,749 of females) as against 100,072 in 1951. The death rate per 1,000 of the population declined from 12.9 in 1951 to 12.0 in 1952, the lowest on record. The death rate in the Colombo Municipality was 21.2 per 1,000 of the population in 1952 as against 24.3 in 1951. The total number of deaths on estates registered in 1952 was 11,110 as against 11,993 in 1951.

Infant deaths

24,583 deaths of children under one year of age were registered in 1952 as against 25,704 in 1951. The infant mortality rate fell from 82 per 1,000 live births in 1951 to 78 in 1952—the lowest on record. In the Colombo Municipality, too, the rate dropped from 105 in 1951 to 87 in 1952. The infant mortality rate on estates was 111 in 1952 as against 109 in 1951.

Maternal Deaths

The total number of deaths from all causes connected with pregnancy and child-birth registered in 1952 was 1,818 as against 1,810 in 1951. The maternal death rate was 5.8 per 1,000 live births—the same as that for 1951. The maternal death rate in the Colombo Municipality rose from 8.4 in 1951 to 9.2 in 1952. The rate on estates was 5.2 in 1952 as against 4.4 in 1951.
