DRAFT ORDINANCES.

MINUTE.

The following Draft of a proposed Ordinance is published for general information:—

An Ordinance to amend "The Marriage Registration Ordinance, 1895."

Preamble.

WHEREAS it is expedient to amend the Ordinance No. 2 of 1895, intituled "An Ordinance to consolidate and amend the Laws relating to the registration of Marriages other than the Marriages of Kandyans and Muhammadans," hereinafter referred to as "the principal Ordinance," by repealing section 15 thereof: Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Ordinance to be construed as one with Ordinance No. 2 of 1895. 1 This Ordinance and the principal Ordinance shall be construed and read as one Ordinance, and may be cited collectively as "The Marriage Registration Ordinances, 1895 and 1896."

Repealing clause.

2 Section 15 of the principal Ordinance is hereby repealed.

west by Pitakumbura, and on the north by a stone fence, together with everything thereon.

3. An undivided half share of the garden called Ampititennawatta of one kuruny extent, and an undivided half share of the adjoining garden called Hompola alias Gurugalarawehena of four kurunies' extent, situated at Koslandagama aforesaid; and bounded on the east by Ramasamygedarawatta, on the south by the stone fence of Bogahakumbura, on the west by Pahurutenna-ela, and on the north by the limitary ridge of Bogahatennakumbura, together with everything thereon.

4. An undivided half share of the garden called Gonnagahahelahena, of about eight kurumies of kurakkan sowing, situated at Koslandagama aforesaid; and bounded

sowing, situated at Koslandagama aforesaid; and bounded on the east and south by a road, on the west by Pahuru-tennakumbura, and on the north by Ampititenna-

kumbura.
