

THE following specifications have been accepted — No 3927 of July 3, 1952

Miss Phoebe Leembruggen

"A device for lifting cooking utensils off the fire" *Abstract*—A device comprised of a circular shaped grip made of metal or wire to engage the rim of cooking utensils so as to lift them off the fire

In the case of aluminium utensils provided with handles, the grip is in the form of a hook which engages the handles and lifts them off the fire

"A device for locking electric bulbs"

Abstract — The device consists of a piece of sheet metal curved to conform to the shape and adhere

between the cap of the bulb and the holder and having a hole to receive one of the pins of the bulb and also a set (raised cut) made on it to prevent the bulb from being removed once the device is fixed

"A safety device for oil burning lamps chiefly of the bottle lamp type"

Abstract — The nature of the invention can be ascertained from claim 1 which is as follows — A safety device for lamps burning oil through wicks characterised in that the portion of the wick carrying tube above the oil container is encircled by a tank to hold a liquid so that when the lamp falls on its side the said liquid in pouring out of the tank puts out the wick flame
