#### THE URBAN COUNCILS ORDINANCE, No. 61 OF 1939

##### Order under sections 2, 5, 6 and 30

BY virtue of the powers vested in me by sections 2, 5, 6 and 30 of the Urban Councils Ordinance, No 61 of 1939, as modified by the Proclamation published in *Gazette Extraordinary* No 9,773 of September 24, 1947, I, Christopher William Wijekoon Kannangara, Minister of Local Government, do by this Order—

- (1) vary the limits of the town of Kalutara as set out in the second column of the Schedule to the notification published in *Gazette* No. 7,827 of January 30, 1931, by the substitution for those limits, of the new limits set out in Schedule I hereto,
- (2) revoke, subject to the provisions of paragraph (4), the Order relating to the number of members of the Kalutara Urban Council and the number and limits of the wards of the town of Kalutara published in *Gazette* No. 9,108 of April 9, 1943,
- (3) order that, subject to the provisions of paragraph (4), the Kalutara Urban Council shall consist of eleven members and the town of Kalutara shall be divided into eleven wards with the limits as defined in Schedule II hereto, and
- (4) declare that the provisions of paragraph (1), (2) and (3) of this Order shall come into effect on the day immediately following the date of expiration of the term of office of the members of the Kalutara Urban Council who are in office on the date hereof

#### SCHEDULE I

wards along the said boundary of the said Drive to the south-western corner of lot 10 in the said Town Survey Sheet, thence northwards and eastwards along the western and northern boundaries of the said lot 10 till it meets the northern boundary of De Abrew Drive, thence eastwards along the said boundary of the said Drive till it meets the western boundary of Colombo-Galle Road, thence eastwards in a straight line across the said road to a point on its eastern boundary at the 24 3/4 mile post, thence southwards along the said boundary of the said road till it meets the northern boundary of 5th Cross Street, thence eastwards along the said boundary of the said street till it meets the western boundary of the road to Uggalboda, thence due eastwards across the said road to its eastern boundary, thence southwards along its eastern boundary to the north-western corner of lot 8 in Kalutara Town Survey Sheet No L 22/41 2 East, thence eastwards along the northern boundary of the said lot till it meets the western boundary of lot 9 in the said Town Survey Sheet, thence northwards and eastwards along the western and northern boundaries of the said lot till it meets the right bank of Alut Ela or Willegoda Ela

*East* By a line drawn from the last mentioned point southwards along the right bank of Alut Ela or Willegoda Ela till it meets the right bank of Kalu Ganga, thence southwards along a straight line across the said Ganga, to a point on the left bank of Hinatyangala Ela, where it meets the left bank of Kalu Ganga, thence southwards along the left bank of the said Ela till it meets the northern boundary of Nagoda Road, thence south-eastwards and north-eastwards along the northern boundary of the said road till it meets at a point in prolongation north-westwards of the northern boundary of lot 1 (part of Hospital premises) in P Plan A 804, thence south-eastwards across the said road to the north-western corner of the said lot 1, thence south-eastwards along the northern boundaries of lots 1, 3 and 4 (parts of Hospital premises) in P Plan A 804 to the landmark at the north-eastern corner of the said lot 4 thence south-westwards along the eastern boundary of lot 4 and the eastern and southern boundaries of lot 5 (parts of Hospital premises) to the landmark on the north-eastern corner of lot 5 in P Plan A 1656, thence south-westwards and south-eastwards and again south-westwards along the eastern boundaries of lots 5, 6 and 1 in the said P Plan to the south-eastern corner of the said lot 1 and thence south-westwards along the eastern boundary of land called Pitagoneliyawatta claimed by Misses I M Orr, A E Orr and S. R. Orr, till it meets the northern boundary of the road to Katukurunda Teachers' Training College, thence due southwards across the said road to its southern boundary, thence westwards along the said boundary of the said road till it meets the north-eastern corner of lot 4 in P. Plan A 2882, thence southwards along the eastern boundary of the said lot 4 and eastern and southern boundaries of lot 5, southern boundaries of lots 6 and 2 and eastern boundaries of lots 7 and 8 in P. Plan A 1603 till it meets the southern boundary of lot 2 (Road) in P Plan A 1602, thence northwards across the said road to the southern boundary of lot 11 in P Plan A 1602, thence eastwards and northwards along the southern and eastern boundary of lot 11 and the eastern boundary of lot 10 in P Plan A 1602 till it meets the south-eastern corner of lot 42 in P Plan A 1369, thence northwards along the western boundary of the road (lot 39 in the said P Plan) till it meets the southern boundary of the Village Committee Road (lot 35 in the said P Plan), thence south-westwards along the southern boundary of the said Village Committee Road (lot 35) till it meets the south-western corner of the said lot 35 in P Plan A 1369, thence northwards across the said Village Committee Road along the western boundaries of the said lot 35 and lot 26 (Village Committee Road) in P Plan A 1369 to the south-western corner of lot 20 in P Plan A 1369, thence northwards along the western boundaries of lots 20, 23 and 20 in P. Plan A 1369 till it meets the landmark at the southernmost point of lot 30 in P. Plan A 1596, thence northwards along the western boundary of the said lot 30 till it meets the western boundary of T. *North* By a line drawn from a point on the eastern limit of Ward No 1 and on a line in prolongation westwards of the northern boundary of lot 225 in Kalutara Town Survey Sheet L 22/58 1 West, eastward along the said prolongation and the northern boundary of the said lot to the centre of the junction of Colombo-Galle Road and Khetarama Road, thence southwards along the centre line of Colombo-Galle Road to the centre of its junction with Mosque Street, thence northeastwards along the centre line of the said Street till it meets the eastern limit of the Urban Council area.

*East* By a line drawn from the last-mentioned point southwestwards along the eastern limit of the Urban Council area to a point on the northern boundary of lot 12 in Kalutara Town Survey Sheet O 2/2 1 East

*South* By a line drawn from the last-mentioned point westwards along the northern boundary of lot 12 in Kalutara Town Survey Sheet O 2/2 1 East to the north-eastern corner of the said lot 12, thence due northwards to a point on the centre line of the foot-path which runs along the northern boundaries of lot 12 and 10 in Kalutara Town Survey Sheet O 2/2 1 East, thence westwards along the centre line of the said foot-path to the

centre of its junction with Colombo-Galle Road, thence northwestwards along the centre line of Colombo-Galle Road till it meets the eastern limit of Ward No 1, thence northwestwards along the said limit to a point at the centre of the junction of Railway Accident Road and Colombo-Galle Road, thence southwestwards along the eastern boundary of Ward No 1 to a point on the centre line of the lagoon and on a line in prolongation westwards of the centre line of Railway Accident Road

*West* By a line drawn from the last-mentioned point northwestwards along the eastern limit of Ward No 1 to the starting point of the northern limit of the Ward

#### Ward No 3—Heenatiyangala

*North* By a line drawn from a point at the centre of the junction of Hill Street and the path leading to lot 123 in Kalutara Town Survey Sheet No L 22/58 1 West, northeastwards along the centre line of the said path till it meets the southern boundary of the said lot 123, thence eastwards along the said boundary of the said lot 123 to a point on the centre line of Depa Ela, thence northeastwards along the centre line of the said Ela till it meets the centre line of the path leading from Dawapansala Road to lot 7 in Kalutara Town Survey Sheet No L 22/58 1 East, thence northwards along the centre line of the said path to the centre of its junction with Duwepansala Road, thence eastwards along the centre line of the said road to the eastern limit of the Urban Council area

*East* By a line drawn from the last-mentioned point southeastwards and southwards along the eastern limit of the Urban Council area till it meets the eastern extremity of the northern limit of Ward No. 2

*South* By a line drawn from the last-mentioned point westwards along the northern limit of Ward No 2 to a point at the centre of the junction of Mosque Street and Colombo-Galle Road.

*West* By a line drawn from the last-mentioned point northwestwards along the northern limit of Ward No 2 to the centre of the junction of Colombo-Galle Road and Khetarama Road, thence eastwards along the centre line of Khetarama Road to the centre of its junction with Jayasundara Avenue, thence southeastwards along the centre line of the said avenue to the centre of its junction with the path leading to lot 248 in Kalutara Town Survey Sheet No L 22/58 1 West thence eastwards along the centre line of the said path till it meets the centre line of Depa Ela, thence northeastwards along the centre line of the said Ela till it meets the centre line of Hill Street, thence northwestwards along the centre line of the said Street to the starting point of the northern limit of the Ward

#### Ward No 4—Basket Hall

*North* By a line drawn from a point on the centre line of Kalu Ganga and on a line in prolongation northwestwards of the eastern boundary of lot 33 in Town Survey Sheet L 22/50 1 West northeastwards along the centre line of the said Ganga to the eastern limit of the Urban Council area

*East* By a line drawn from the last-mentioned point southeastwards along the eastern limit of the Urban Council area to the eastern extremity of the northern limit of Ward No 3

*South* By a line drawn from the last-mentioned point westwards and southwestwards along the northern limit of Ward No 3 to its western extremity, thence northwestwards along the centre line of the Hill Street to a point at the centre of its junction with Colombo-Galle Road and Old Road

*West* By a line drawn from the last-mentioned point northeastwards along the centre line of Old Road to the centre of its junction with Raverside Road, thence northeastwards in a straight line to the southeastern corner of lot 33 in Kalutara Town Survey Sheet L 22/50 1 West, thence northwestwards along the eastern boundary of the said lot to its northeastern corner, thence northwestwards along a line in prolongation of the said eastern boundary to the starting point of the northern limit of the Ward

#### Ward No 5—Bazaar

*North* By a line drawn from a point on the eastern extremity of the northern limit of Ward No 1 due eastwards across lot 72 in Kalutara Town Survey Sheet L 22/49 4 East and crossing the Railway land to the said point at the centre of the junction of the said roads, thence southwards, southeastwards and eastwards along the centre line of the Goods Shed Road to the centre of its junction with Colombo-Galle Road and Hospital Road, thence northeastwards along the centre line of Hospital Road to the centre of its junction with Gregory's Road, thence southeastwards along the centre line of Gregory's Road to the centre of its junction with Chapel Street, thence eastwards along the centre line of Chapel Street till it meets the western limit of Ward No 4

*East* By a line drawn from the last-mentioned point southwards, southwestwards and southeastwards along the western and southern limits of Ward No 4 and southeastwards and southwestwards along the western limit of Ward No 3 to a point where the centre line of Depa Ela meets the centre line of the path leading to lot 248 in Kalutara Town Survey Sheet No. L 22/58 1 West

*South* By a line drawn from the last-mentioned point northwestwards, northwards and westwards and along the western limit of Ward No 3 and westwards along the northern limit of Ward No 2 till it meets the eastern limit of Ward No 1

*West* By a line drawn from the last-mentioned point northwestwards along the eastern limit of Ward No 1 to the starting point of the northern limit of the Ward

#### Ward No 6—Park

*North* By a line drawn from the southwestern corner of lot No 258 in Town Survey Sheet No L 22/49 2 East, eastwards along the southern boundary of lots 258 and 261 and crossing the Colombo-Galle Road and northeastwards along the southern and eastern boundaries of lot 260 to the northeastern corner of the said lot, thence northeastwards along the centre line of Kalu Ganga to the western extremity of the northern limit of Ward No 4

*East* By a line drawn from the last-mentioned point southwards along the western limit of Ward No 4 till it meets the eastern extremity of the northern limit of Ward No 5

*South* By a line drawn from the last-mentioned point westwards and northwestwards along the northern limit of Ward No 5 to its western extremity

*West* By a line drawn from the last-mentioned point northeastwards along the centre line of Kalu Ganga to the starting point of the northern limit of the Ward

#### Ward No 7—Sri Sumangala

*North* By a line drawn from a point on the western limit of the Urban Council area due west of the centre of the junction of Sri Sumangala Road North and Sri Sumangala Road due eastwards to the said centre of the junction of the said roads, thence eastwards along the centre line of Sri Sumangala Road North to the centre of its junction with De Fonseka Place, thence southeastwards along the centre line of De Fonseka Place to the centre of its junction with Sri Sumangala Road South, thence southeastwards along the centre line of Sri Sumangala Road South to the centre of its junction with Colombo-Galle Road

*East* By a line drawn from the last-mentioned point southwards along the centre line of Colombo-Galle Road to a point on the centre line of the bridge over Kalu Ganga at the right bank of the said Ganga, thence southwards along the centre line of the said bridge till it meets the northern limit of Ward No 6, thence westwards and southwestwards along the northern and western limits of Ward No 6 to the eastern extremity of the northern limit of Ward No 1

*South* By a line drawn from the last-mentioned point westwards along the northern limit of Ward No 1 till it meets the western limit of the Urban Council area

*West* By a line drawn from the last-mentioned point northwestwards along the western limit of the Urban Council area to the starting point of the northern limit of the Ward

*Ward No 8—Ware House*

*North* By a line drawn from a point on the northern limit of Ward No 7 at the centre of the junction of Sri Sumangala Road North and De Fonseka Place, eastwards along the centre line of Sri Sumangala Road North to the centre of its junction with Colombo-Galle Road, thence southeastwards along the centre line of the Colombo-Galle Road to the centre of its junction with 2nd Cross Street, thence northeastwards along the centre line of 2nd Cross Street to the centre of its junction with Temple Road, thence southeastwards along the centre line of Temple Road to the centre of its junction with Distillery Road, thence northeastwards along the centre line of the Distillery Road to a point on the eastern limit of the Urban Council area

*East* By a line drawn from the last-mentioned point southeastwards along the eastern limit of the Urban Council area to the eastern extremity of the northern limit of Ward No 4

*South* By a line drawn from the last-mentioned point southwestwards along the northern limits of Wards Nos 4 and 6 till it meets the eastern limit of Ward No 7

*West* By a line drawn from the last-mentioned point northwards along the eastern limit of Ward No. 7 northwestwards along the northern limit of the said Ward to the starting point of the northern limit of the Ward

*Ward No 9—Asoharama*

*North* By a line drawn from a point on the northern limit of the Urban Council area at the centre of Colombo-Galle Road at the 24 3/4 mile post, southeastwards along the northern limit of the Urban Council area to its eastern extremity

*East* By a line drawn from the last-mentioned point southeastwards along the eastern limit of the Urban Council area till it meets the eastern extremity of the northern limit of Ward No 8

*South* By a line drawn from the last-mentioned point southwestwards and northwestwards and again southwestwards along the northern limit of Ward No. 8 to the centre of the junction of 2nd Cross Street and Colombo-Galle Road

*West* By a line drawn from the last-mentioned point northwestwards along the centre line of Colombo-Galle Road to the starting point of the northern limit of the Ward

*Ward No 10—North Railway Station*

*North* By a line drawn from a point on the western extremity of the northern limit of the Urban Council area northeastwards along the northern limit of the Urban Council area to the western extremity of the northern limit of Ward No 9

*East* By a line drawn from the last-mentioned point southeastwards along the western limit of Ward No 9 to the centre of the junction of Colombo-Galle Road and Sri Sumangala Road North

*South* By a line drawn from the last-mentioned point southwestwards along the northern limit of Wards Nos 8 and 7 to the western extremity of the northern limit of Ward No 7

*West* By a line drawn from the last-mentioned point northwestwards along the western limit of the Urban Council area to the starting point of the northern limit of the Ward

*Ward No 11—Hospital*

*North* By a line drawn from a point on the eastern limit of Ward No 1 at the centre of the junction of Dewata Road and the proposed demarcated road joining

Dewata Road and Lake Road northeastwards along the eastern boundary of Ward No 1 till it meets the western limit of Ward No. 2, thence southeastwards and eastwards along the western and southern limits of the said Ward No. 2 to the eastern limit of the Urban Council area, thence southwards, southeastwards and northeastwards along the eastern limit of the Urban Council area to a point on a line in prolongation of the northern boundary of lot 1 in P. P. A804

*East* By a line drawn from the last-mentioned point southeastwards and southwestwards along the eastern limit of the Urban Council area to the landmark at the southeastern corner of lot 4 in P. Plan A1603

*South* By a line drawn from the last-mentioned point westwards, northwestwards and again westwards along the southern limit of the Urban Council area till it meets the southern extremity of the eastern limit of Ward No 1

(1) vary, subject to the provisions of paragraph (4), the limits of the town of Badulla as set out in the second column of the Schedule to the notification published in *Gazette* No 8,364 of April 12, 1938, by the substitution for all the words and figures from "South—From the last mentioned point southwards" to "thence north-westwards along the left bank of the said Yakdeh-ela to the point where it meets Galgekandura," of the following—

*South* . From the last mentioned point southwards and south-eastwards along the left bank of Hanwella Ela to a point on the centre line of the ravine (dry stream) that passes under culvert No 1/21 on Badulla-Passara Road, thence southeastwards along the centre line of the said ravine (dry stream) crossing the said Badulla-Passara road at the said culvert till it meets the southern boundary of the Urban Council Pipe Line, thence northwestwards, southwestwards, westwards again southwestwards and westwards along the southern boundary of the said Pipe Line (lots 61, 60 and 59) in Sup 6 to F V P 80, Uva to the landmark on the southeastern corner of lot 58½ in Sup 6 to F. V P 80, Uva, thence northwestwards along the southern boundary of the said lot, southwards and westwards along the eastern and southern boundaries of lot 58 in Sup 6 to F V. P. 80, Uva and again westwards along the southern boundary of lot 56 in Sup 6 to F V P 80, Uva to the landmark at the southwestern corner of the said lot 56, thence southwards, westwards and southwestwards along the western edge of tea plantation (boundary between Hingurugamuwa tea estate and native garden) to a point on the centre line of the ravine (dry stream) which forms the boundary between the southern edge of rubber and a second block of tea land, thence eastwards along the centre line of the said ravine for about 3 chains till it meets the centre line of the footpath (which runs through the tea plantation) thence southwestwards along the centre line of the said footpath till it meets

- (2) revoke, subject to the provisions of paragraph (4), the Order relating to the number of members of the Badulla Urban Council and the number and limits of the wards of the town of Badulla published in *Gazette* No 9,185 of October 22, 1943
- (3) order that, subject to the provisions of paragraph (4), the Badulla Urban Council shall be divided into eleven wards with the limits as described in the Schedule hereto; and
- (4) declare that the provisions of paragraphs (1), (2) and (3) of this Order shall come into effect on the day immediately following the date of expiration of the term of office of the members of the Badulla Urban Council who are in office on the date hereof
