The Head of the National Operation Centre for the Prevention of COVID-19 (NOCPC), Army Commander Lt. Gen. Shavendra Silva expressed confidence that the current COVID-19 outbreak could be contained effectively. However, he said that a specific time frame could not be given but currently, all infected persons in the Brandix cluster have been identified and directed to hospitals or placed in quarantine.

Speaking to the Daily News, Lt. Gen. Silva noted that the Periyakadei and Pattithottam areas in Mannar placed under lockdown after several cases were reported, were released from lockdown yesterday.

## Maithri tells PCol probing Easter Sunday terror attacks 'Former DMI Head was removed to prevent his arrest'

The reason behind the removal of former Head of the Directorate of the Military Intelligence (DMI) Brigadier Suresh Sallay from his position was to prevent him being arrested on fabricated charges, former President Maithripala Sirisena told the Presidential Commission of Inquiry probing the Easter Sunday terror attacks vesterday

According to him, there had been a coup to arrest Sallay, but after discussions with the Army Commander, he had taken steps to release Sallay from the position and send him as

the Defence Attaché to Malaysia preventing him being arrested unnecessarily. Sirisena said former Prime Minister Ranil Wickremesinghe and one of the then powerful ministers opposed Sally presenting findings on Islamic Extremism at the National Security Council

(NSC) claiming such information would cause to create a tense situation within the Muslim community.

"The former Prime Minister and that particular Minister proposed to remove Brigadier Sallay from this position too," former President Sirisena said. The former President further said Sally's appointment as the Defence Attaché was approved by him stating that he had security threats from the LTTE as a military officer.





The hospital staff will prepare your drug requirements after verifying your correct address with clinic number, phone number and name of the hospital. Those parcels will be delivered to you by post during curfew period.

The process will commence from the Gampaha and Colombo Districts and will be expanded islandwide.

Patients with chronic diseases and the elderly have been advised not to attend hospital clinics until further notice since they are at a higher risk of contracting the COVID-19 coronavirus due to the congestion at clinic setups. They have also been advised to visit the Emergency Treatment Units of the closest hospital, at any time if they experience any symptoms of the disease.

Patients attending clinics in the Colombo and Gampaha districts have been advised to contact the relevant hospitals to obtain the necessary advice on obtaining monthly medicines.

Meanwhile, the State Ministry of Pharmaceutical Production, Supply and Regulations sources said that pharmacists have been advised not to change the clinical medicines that are taken without checking the patient for any reason.

"State Pharmaceutical Corporation's pharmacies (Osusala) have the facility to deliver medicines to anyone in the Kurunegala and Gampaha districts. Pharmacies have been set up in Kurunegala, Minuwangoda, Negombo, Ragama and Gampaha for this purpose. If there is a need to obtain a photocopy of the prescription from a doctor, you can Viber or WhatsApp to the following numbers in order to get the required medicines delivered to your home," sources said.

This is big irregularity that needs to be investigated and an audit needs to be carried out, said the President of the Government Medical Officers Forum (GMOF) Dr. Rukshan Bellana.

Dr. Bellana said that the post of Health Services Director General is a Cabinet approved appointment who has the authority to implement various acts and ordinances and take firm decisions relevant to the Health Ministry. "There are over 100 acts under the Health Ministry and the Health Services DG is the competent authority on implementing these regulations. But, despite not having legal rights, the Health Ministry Secretary is calling the shots which is in total violation to the laws."

Addressing a media briefing at the Abayaramaya Temple yesterday, Dr. Bellana said that the doctors who played a big role during the coronavirus pandemic earlier have suddenly been transferred since two weeks ago on the grounds that this is the transfer week. "But, there is a proper procedure that is practiced and transfers are generally carried out at the start of the year. But, suddenly a Circular was issued a week ago that certain doctors are transferred. These are punishment transfers and not in accordance with the Establishments Code. Today the health authorities are at the mercy of this certain medical union who is calling the shots. Dr. Anil Jasinghe who was the previous Health Service es Director General was suddenly

He noted that Dr. Bellana was suspended from duties as he had got on a political stage and supported Mahinda Rajapaksa to come to power.

"He was penalized for speaking against former President Maithripala Sirisena. Yet, even after the current government came to power, they have not taken note of the sacrifice he made. Today Dr. Bellana is being penalized again and after he had served as the Director of the Health Department, today he has been placed as the second in com-

I urge Minister Wanniarachchi to serve all unions equally and not to act partially towards only one party," Ven. The Thera said that today the COVID-19 operations have been handed over to the Army Commander and the Health Ministry has been silenced. "During the previous COVID-19 operations, there was Health Ministry representation and involvement, but today that voice has been silenced. At the start our country handled the Covid situation very efficiently due to the involvement and efforts of all concerned. Yet, the same cannot be said for the second wave. The Army Commander alone cannot handle this situation efficiently and there must be an authority from the Health Ministry too. Today there is no Director General of the Health Ministry and the Health Ministry is in disarray and in a pathetic state. 

# A plate of SWEETS, a palate of TASTES



very country has its own sweets which reflect a combination of its available seasonal ingredients, methods of cooking and the cultural influence on that particular cuisine. In addition, we have tasted and seen sweets adapted through various inroads into this cuisine, often through the influence of a wider region, (i.e., Asian), immigrants and even invaders. In the case of Ceylon, the latter influenced our cuisine. The most prominent being the introduction of bakery items during the rule of the Portuguese, Dutch and the British.

Today we will focus on the sweets which are deeply rooted in Sri Lankan cuisine, and a few which over the decades have been amalgamated and duly embraced by us as "authentic Sri Lankan sweets". All of us know the alluring taste of the top echelon konda kavum, halapa, aggala, kalu dodol and bibikkan. Some of the lesser-known and appreciated ones are mung kavum, athirasa, aasmi, weli thalapa and wandu appa (which is not hopper but a muffin-like sweet baked in a leaf). found in cream-filled cupcakes, chocolate brownies, kavums as well as in a slice of dodol. Living in crowded cities and taking on a busy working lifestyle, do our women have time to keep this tradition alive? Well, if you can find time to bake cinnamon buns and red velvet cakes, you can spend the same amount of time to cook anything.

Konda kevum is the alluring queen who reigns supreme. Her "konda" has a class of its own! She is always soft to the touch, and my mother used to warn me not to succumb to her charms!! But I fail. Kalu dodol is the grand duke of Sinhalese sweets. The dark brown exterior gives way to a warm consistency. Making this with jaggery and coconut milk is an art. Hambantota is famous for this wonderful sweet. Halapa is another favourite we used to eat at sunset drinking a glass of ginger-infused tea. Today many city kids do not know what halapa is, they might think it grows on a tree. The green kande kola adds to the aroma of this healthy snack. We loved athirasa and mung kavum - sweets that are loaded with nutrition. The crispy kokis has a unique taste, although it is believed to be of Dutch origin. Rosette cookies from the Scandinavian region is very similar to kokis. The kiribath (milk rice) plate is like a loving grandmother who embraces all these sweets under her shadow. Sweets made by Tamil families include laddu. paitham paniyaram, sugar-coated sippi and mothakam (soft dumplings filled with coconut, crushed green gram and sugar). Some of these recipes can be traced to South Indian kitchens. Finding clean Athirasa banana leaves to place on plates is another challenge for the denizens of Colombo city during traditional sit-down meals. I am not rejecting fast food or foreign cuisine. Fast food is ideal when on road trips or during a very busy day at home. Consuming international cuisine adds zest to life, when you can afford it. We must enjoy all global cuisine and connect to those beautiful cultures, but be prudent to maintain our local culinary identity. All Sri Lankan chefs and hoteliers have a responsibility to promote our own cuisine, especially these sweets. European tourists do not come here to eat tiramisu, lamingtons, custard tarts or crème brulee. They want Sri Lankan delights. At times undue focus is given to fusion cuisine. We must create new presentations when plating our Sri Lankan food. A simple garnish can alter the guest's perception. It is sad to see that these timeless culinary traditions are being replaced in Colombo and other major cities. To a certain extent a valid reason is that people living in high rise apartments cannot be pounding and deep frying as the neighbours' would be disturbed, which is true. However, many flour-based ingredients come in packets today. At times, you cannot buy good jaggery in the city. Some ingredients are a bit expensive - a common element in any regional cuisine. Eating sweets will gradually induce some weight, and most city folks will either drink green tea or enlist in a weekend aerobics class! The bottom line is in this COVID-19 period - we must focus more on eating our own homegrown products. It is true that every housewife cannot make kavum. But mothers can smilingly take an interest in making things like aggala and samaposha which only require mixing by hand. If using turmeric was old fashioned why has it now become a valuable product in the kitchen? When we eat local food, we support local cooks and traders and also teach children to be Sri Lankan in a deeper sense.

Following the outbreak of COVID-19, I received many Whatsapp messages about

housewives (former executives/ managers) who were starting their home-based bakery businesses, into which most of their husbands were involuntarily sanctioned as stakeholders. The products proudly advertised were cupcakes, cookies, cakes and desserts. Some sold curries and pickles as well. This is a good sign in the process of economic recovery. I was surprised that not a single Sri Lankan woman advertised that she was making bibikkan (coconut cake) or kalu dodol. You may ask "so what is the big deal? These food items are for aluth avurudhu (April New Year)". Within this question lies the real answer.

The truth is our traditional sweets have been relegated. They are supposed to be made by village women who cannot speak English and do not have twitter accounts. Interestingly, many Colombo divas who claim they do not know how to make kalu dodal and bibikkan are actually from the same provinces where these sweets are made. Oh! we speak of tradition infused with patriotism, but this has eluded Sri Lankan women in their culinary quest. So should we wait annually to eat kavum and kokis only in April? If this is the case, we were deprived of these sweets last New Year due to the COVID-19 pandemic and did not even get to buy these *rasa kavili*.

In a commercial context, there are only a few venues that make these items throughout the year. This is mainly for tourists and visiting Sri Lankans to take back overseas. With a focus on organic cuisine and a healthy lifestyle, one is subject to a feeling of guilt when indulging in these tempting goodies. May I remind you that almost the same amount of calories

# Release of Riyad Bathuideen in the face of incomplete investigations unjustified - AG

Attorney General Dappula De Livera said that the release of former Minister Rishad Bathuideen's brother, Riyad Bathuideen who was arrested by the CID on suspicion of aiding and abetting the terrorists who carried out the Easter Sunday attacks, in the face of incomplete investigations is unjustified.

Coordinating Officer to the Attorney General State Counsel Nishara Jayaratne told the news media that the Attorney General also given instructions in written to the DIG of CID on the need for further investigations into the incident and the action

instructed him to submit the complete investigation files within a month.

"Attorney General Dappula de Livera has summoned Deputy Inspector General (DIG) of the Criminal Investigation Department (CID) and the Chief Investigating Officer to meet him yesterday along with the investigative materials over the release of Riyad Bathuideen by the CID.

"Following that, DIG of CID Prasad Ranasinghe, Senior Superintendent of Police and CID Director Prasanna de Alwis, Assistant Superintendent of Police Vijitha Perera and Chief Inves-

to be taken in this regard and had tigating Officer Sugath Kumara met instructed him to submit the com-General's Department yesterday.

"During the discussion held with them at the Department, the Attorney General observed that former DIG of the CID Nuwan Wedasinghe had failed to investigate money laundering offences against Riyad Bathuideen such as failure to properly investigate his assets, liabilities, vehicles, bank accounts, banking transactions and business affairs.

"Also, it has been revealed that no extensive investigation has been carried out into the use of funds for terrorist activities by Riyad Bathuideen.

"Furthermore, the CID had failed to the incident were hampered due to find 12 out of the 16 mobile phones used by Riyad Bathuideen and investigations in to the missing phones had not been carried out properly.

"Accordingly, it was revealed that the CID had not carried out proper investigations into the above matters," she said.

She further said that it was revealed that the CID had appointed officers who have no knowledge about Money Laundering to investigate the matter.

"Considering the facts the Attorney General said that successful results of further investigations into

the suspension of the investigations by the DIG of CID Nuwan Wedasinghe and CID Director Prasanna de Alwis and that the release of the suspect could not be justified," she added.

Riyad Bathuideen was arrested on April 14 by the CID on suspicion of aiding and abetting the terrorists based on the 07 phone calls which received from Insaaf Ahamed who carried out the bomb blast at Cinnamon Grand Hotel in the series of Easter Sunday attacks which took place on April 21, 2019.

The CID had obtained two deten-

tion orders against Rivad Bathiudeen on April 17, 2020 and July 13, 2020.

Although the detention orders were due to expire on October 13, the former DIG of CID Nuwan Wedasinghe requested to suspend the investigations over the incident on September 6, 2020 and that the detention order be revoked on September 28, 2020 and release Rivad Bathuideen on September 30, 2020. While there is strong evidence leading to proceed legal actions, the

CID had decided to release Riyad Bathuideen without any legal permission and by not producing him before the Court.



drugs is also expected to be exported. Local investors have close ties with countries in the African region. Therefore, it is easy for us to do this work,' he added. Prof. Jayasumana instructed the relevant officials to carefully go through the plans of the proposed factories and allow them to start construction work without causing any harm to the environment. State Ministry Secretary K.R. Uduwawala and State Ministry officials participated as well.

## A healthy deterrent

he latest move by the authorities to take legal action against violators of the health guidelines in relation to the Coronavirus is a timely one indeed given the runaway nature which the pandemic has assumed in the country. The count from the Minuwangoda Brandix cluster is expanding alarmingly with each passing day, and the pandemic keeps on spreading even to remote corners of the country such as Mannar whose victims could not possibly have been in contact with the Brandix workers, although health authorities assert that there was no community spread of the virus as of now.

- According to Health Minister Pavithra Wanniarachchi, health guideline violators would be firmly dealt with under the law, with a gazette to be issued in the coming days whereby those failing to observe the restrictions would be sentenced to a prison term of six months and an imposition of a Rs.10,000 fine, particularly those ignoring the guidelines in areas where there is a high COVID-19 risk.
- But would this act as a deterrent? Already 120 persons have been taken into custody for defying the curfew in the 18 Police divisions under lockdown, with some 20 motorcycles and a three wheeler too being seized. Television showed how the parents of the children who sat for the Year Five scholarship exam mingled freely without face masks outside the examination centres, oblivious to the risk. Private buses continue to take passengers over and above the seating capacity. In typical Sri Lankan style, people still continue to take a laidback approach like they did after the first outbreak of the pandemic.
- The authorities say that the Brandix cluster has been totally neutralized, but cases appear to be cropping up from time to time in other parts of the country. Top Epidemiologist Dr. Sudath Samaraweera says that the original source that infected the female supervisor of the Minuwangoda garment factory is yet to be traced.
- Isn't it wise then to throw the dragnet far and wide without getting bogged down in Minuwangoda where the cases keep on multiplying, to track down the original carrier, which admittedly will be a Herculean task with nothing short of a total lockdown making this even remotely possible?

# New dimensions in Indo-Lanka ties

or a summit of Government leaders in the traditional format, it was not one. It was widely thought that we had turned the corner following the first wave of the pandemic which gave way to complacency. If only the health guidelines had been seriously followed we would not have been in this predicament today which is all the more reason to strictly enforce the restrictions this time around.

At the time the authorities too were playing safe, not going overboard to claim overall victory over the pandemic knowing that there is still the unknown factor that could change the picture. It appears that their worst fears have come to pass. Lt. Gen. Shavendra Silva who is heading the Special Task Force battling the Coronavirus has laid the onus on the public to salvage the situation.

True, our people need constant reminding because they find it difficult to see a departure from entrenched routines, practices and set patterns of life that are taken for granted. Even offices and workplaces appear to have relaxed their safety procedures with the passage of time. The distance rule was observed in the breach. Hotels and eating houses too started serving meals indoors with customers sitting almost huddled. There can be no question of having meals in groups anymore at a single table as in the past.

How will Parliament adapt without falling foul of the strict laws to be gazetted will be a mystery although Speaker Mahinda Yapa Abeywardena assured that sittings will be subjected to the health guidelines. Even a high-security establishment such as Parliament showed its vulnerability when one of its employees was found to have had contact with a carrier. The chief concern for the Government will be the economy in the wake of the apparent wave that is upon us at a time things were being turned around following the damage caused by the initial outbreak.

Already President Gotabaya Rajapaksa has received the encomiums of world leaders for his successful handling of one of the biggest health emergencies the world has seen at any period of time. Sri Lanka has emerged from worse situations and crises and has forged ahead as a nation. This time too it is certain to wither the storm and come up trumps.

#### Mutual understanding

#### **Deepening linkages**

ealth Minister Pavithra Wanniarachchi told the media on Sunday that a gazette notification is to be issued today (Monday or Tuesday) in connection with making it compulsory to wear face masks in public, keeping at least one metre distance from another person and other health guidelines.

From this gazette notification, it will be compulsory to follow health guidelines issued by the Government in order to prevent COVID-19 and violators of the health guidelines will be arrested without a warrant and could be remanded up to six months or imposed a fine not more than Rs. 10,000 or of both such imprisonment and fine. The health authorities are being forced to do this because of the ignorance of some people and institutions which put the entire population of Sri Lanka at risk.

It is very pathetic to see how some individuals use wrong Sinhala words over mass media misleading the public and how mass media show misleading visuals making it harder to prevent COVID-19 in Sri Lanka. Some such visuals create unnecessary problems. But it is not those individuals who are responsible for all the issues. It is mass media and the media culture in Sri Lanka. We are talking about 'Mouth Masks', decontamination chambers and disinfecting roads and floors. Burying COVID-19 dead bodies is another hot topic created by mass media.

#### COVID-19 control activities

Nowadays a lot of people, especially the young generation do not know the real Sinhala language and they know the language broadcast and telecast over private electronic radio and television channels. Those channels use some type of artificial, wrong and distorted Sinhala language terms. Therefore a lot of people understand and treat this new 'Sinhala language' as the original accurate Sinhala language used in Sri Lanka a few decades ago. It is pathetic to see how it affects COVID-19 control activities.

We can see and hear all the time individuals advise the public to wear Face Masks. In English it is perfect. Everyone understands it all over the world and people wear it. But here in Sri Lanka most of the occasions this Face Masks is being called in Sinhala 'Muka Awarana' which means 'Mouth Covers' and not Face Masks. We can see a lot of people covering their mouth and not their nose. The accurate Sinhala word is 'Muwa Awarana' which means 'Face Masks'.


There is a slight single letter difference between these two Sinhala words 'Muwa' which means 'Face' and 'Muka' which means 'the mouth'. In addition, a lot of people do not know the meaning of this Sinhala word 'Muwa' which means 'face' because it is a type of word mostly used in Sinhala literature and not in day- to-day life. Therefore a lot of people misunderstand 'Muwa' as 'Mouth' which is totally wrong. What cific standard and various chemicals are being used for them. According to local and foreign health experts, disinfectants should be sprayed or applied only on surfaces that are highly or frequently touched by the public, such as hand railings, door knobs, poles on transit vehicles, elevator buttons, park/ street benches etc. It has been proven that the virus can survive from hours to days on these contaminated surfaces. cleaning/ wiping of frequently touched hard surfaces with detergent / disinfectant solution should be done. But when it comes to Sri Lankan mass media what do we see all the time? It is people going through so called 'Decontamination Chambers' installed in many state and private institutions and spraying thousands of litres of disinfectants on roads, on large floor areas, on high walls, etc. and the funniest part of the visuals is showing how people wearing PPE spray disinfectants on surfaces such as ceilings, upper walls where people never touch and cannot reach even if they climb using a ladder.

The chemical disinfectants can have various adverse effects on humans. In particular, spraying of chlorine on individuals can lead to irritation of eyes and skin, bronchospasm due to inhalation, and potential gastrointestinal effects such as nausea and vomiting. Inhaled ozone can damage the lungs, may worsen chronic respiratory diseases like asthma and compromise the ability of the body to fight respiratory infections.

The other pathetic visual shown on television channels every day is how the dead bodies of thousands of COVID-19 victims are buried in some other countries in the world. It was hilarious that some opposition politicians demanded the Government a few months ago to do the same here in Sri Lanka. The television channels never said a word so far where those dead bodies were buried and how big those countries are.

The television channels still show some big countries which are much bigger than Sri Lanka with huge bare lands located hundreds of kilometres away from residential areas bury dead bodies of COVID-19 patients. You should not touch anything, even another part of your own body in between the time you wash your hands and touching your mask or face. Avoiding touching your entire face is another basic and essential requirement to avoid the COVID-19 infection.

# **POST OFFICE DOING CSR AND WATER BOARD LEAKING**

Board are Government or Semi-Government organisations. It is acknowledged that the inefficiency and the corruption at Government institutions is one of the primary drawbacks of Sri Lanka's economic progress.

Without elaborating further, let me recount the factual details of two experiences I had with the above named institutions.

On Monday, October 5, I was delighted to learn that our Post Offices islandwide were doing a community project (Corporate Social Responsibility or CSR) where they were collecting electric and electronic waste (used material) which presumably were to be recycled. Aware of the environmental and other damage (including health) these discarded material can cause if carelessly discarded, I eagerly seized the opportunity to participate in a useful project.

I didn't have much electronic equipment save for an old CD player and some knickknacks like old telephone chargers. They were rather old and had gathered a lot of dust. With difficulty I put them into bags and took them to the Post Office down Dickmans Road, Colombo 5. To my surprise nobody at the Post Office seemed to have heard of the project. Finally, a female officer turned up who told me that my electronic garbage will have to be taken to the rear of the building. When I drove to the rear of the post office again there was no sign of any such collecting going on. On further inquiry a young officer came forward and very officially told me that I will have to write my name, address and NIC number on a file before handing in the material. Perhaps a thank you note was coming This is the first time I have experienced a community-oriented project where the volunteers had to undergo a kind of official scrutiny before handing over garbage. to me from the post office for participating in their project! After this discouraging formality I was directed inside the post office. There is no requirement to provide personal information at the front post office which has hundreds coming in daily.

#### **Community-oriented project**

This is the first time I have experienced a community-oriented project where the volun-

teers had to undergo a kind of official scrutiny before handing over garbage. The Post Office was inviting the public to hand over their electronic discards. We were helping the Post Office to make a success of their project and also helping to keep the country clean and safe.

I was disappointed at this approach to a community project and when I expressed my views one of the employees there said these were the instructions from their superiors. The fact that I had left the safety of my home to help in their

community project did not register on him at all.

It did not seem like a community project in that sense. They were only officiating there. We, the public were clients to be treated with an air of bumptious superiority. All the carrying of the garbage bags (which I had taken in my car) was done by me.

The CSR project has challenged their routine and they simply didn't know the meaning of a community project. And as postal clerks, their job is intellectual, they are too high for any physical exertion, it seemed.

A failed CSR effort by people who have no charity in their make-up.

Then, a few months back, there were some official looking persons making strange markings on my front wall (without any permission). When I inquired they told me they were from the Water Board. The Water Board had decided to install new water meters outside of residences, so as to make life easier for their Meter Readers.

Then, for several months nothing happened. The mark had nearly disappeared from the wall, when suddenly a work gang appeared and dug a biggish hole near the water connection on the roadside. Again a few weeks went by and the hole was flooded with rain water.

Eventually, one day my pipe-borne water was suddenly cut off. When I looked outside, I saw a work gang working near the hole dug weeks ago. They were connecting the new water meter. The work took nearly one whole day. At one point the workers disappeared for a few hours. There was no water at all in the house. It was only towards the late evening that the work was over and the water supply reconnected.

#### New water meter

I now had a new water meter installed on the road side, outside the wall. About two weeks ago I noticed a large spray of water from the meter.

On closer examination I realized that the water was leaking from a joint by the meter. It was late evening so I waited until the next morning to inform the NWSDB Area Engineer (Kirulapone). To my relief, he acted promptly and sent a team to examine the leak.

They repaired it and told me that this was a regular occurrence with the new water meters. Obviously whoever got and did the contract for the new water meters had used inferior material including faulty joints which gave way after a few weeks.

Government contracts are notorious for their corruption. Can contractors be allowed to get away cheating the Government as well as inconveniencing the public in this manner? Are there no quality guarantees in such work contracts?

Over to you Water Board.

We the public can only write about these things. It is for the authorities to take note and address these obvious failings.

# **CORONAVIRUS** 'can survive for 28 DAYS on surfaces' - Study

**AUSTRALIA:** The coronavirus that causes COVID-19 can survive on items such as banknotes and phones for up to 28 days in cool, dark conditions, according to a study by Australia's national science agency. Researchers at CSIRO's disease pre-

paredness centre tested the longevity of SARS-CoV-2 in the dark at three temperatures, showing survival rates decreased as conditions became hotter, the agency said Monday.

The scientists found that at 20 degrees Celsius (68 degrees Fahrenheit), SARS-CoV-2 was "extremely robust" on smooth surfaces -- like mobile phone screens -- surviving for 28 days on glass, steel and plastic banknotes. At 30 degrees Celsius (86 degrees Fahrenheit), the survival rate dropped to seven days and plunged to just 24 hours at 40 degrees Celsius (104 degrees Fahrenheit).

The virus survived for shorter periods on porous surfaces such as cotton -up to 14 days at the lowest tempera-



tures and less than 16 hours at the highest -- the researchers said.

This was "significantly longer" than previous studies which found the disease could survive for up to four days on non-porous surfaces, according to the paper published in the peerreviewed Virology Journal.

Trevor Drew, director of the Australian Centre for Disease Preparedness, said the study involved drying samples of the virus on different materials before testing them, using an "extremely sensitive" method that found traces of live virus able to infect cell cultures. "This doesn't mean to say that that amount of virus would be capable of infecting someone," he told

public broadcaster ABC. He added

that if a person was "careless with these materials and touched them and then licked your hands or touched your eyes or your nose, you might well get infected upwards of two weeks after they had been contaminated".

Drew said there were several caveats including that the study was conducted with fixed levels of virus that likely represented the peak of a typical infection, and there was an absence of exposure to ultraviolet light, which can rapidly degrade the virus.

Humidity was kept steady at 50 percent, the study said, as increases in humidity have also been found as detrimental to the virus. The main message remains that "infectious people are far, far more infectious than surfaces", Drew told the ABC. "But nevertheless, it may help to explain why even when we got rid of the infectious people, we do occasionally get these breakouts again, sometimes even in a country which is considered to be free," he said.- AFP

## **ORLD** Irish locals show their colours in Biden's ancestral home

**IRELAND:** Thousands of miles east of the White House in Ireland, a pop-art portrait of US Presidential candidate Joe Biden towers over his ancestral hometown of Ballina, County Mayo. In the town on Ireland's rugged Atlantic coast, the Democrat's distant relatives are thrilled to have one of their own bidding for America's highest office.

"Obviously we're 100 percent behind Joe Biden," Laurita Blewitt, the former vice-president's third cousin, told AFP. "We've got that family connection and we've got that friendship and relationship with him," the 37-year-old said. Biden's family roots run deep in Ireland, with a heritage described as "roughly five-eighths Irish" by genealogist Megan Smolenyak. She has traced his lineage to east-coast County Louth and Ballina -- a town of 10,000 peo-



ple, which is dotted with brightly coloured shopfronts and

bisected by the River Moy. In 1851, Biden's great-greatgreat-grandfather Edward Blewitt joined the legions of Irish fleeing famine and poverty for a fresh start in New York.

The mural was raised by a band of locals last month, and Ballina is twinned with Scranton, Pennsylvania, where Biden was born in 1942.

The 77-year-old politician has visited twice – first in 2016 when crowds turned out to see President Barack Obama's deputy. In the 20th century, John F. Kennedy was most closely tied to the "Emerald Isle", and had to overcome anti-Irish, anti-Catholic prejudice to win the White House.

But others including Richard Nixon, Ronald Reagan and Barack Obama have all claimed ancestral links to Ireland. - AFP

## China to test over 9 mn residents of Qingdao within 'five days' following minor COVID-19 outbreak

CHINA: China aims to test more than nine million residents of the port city of Qingdao within five days following a minor COVID-19 coronavirus outbreak, health officials said Monday, the first mass testing in months.

The country where the virus first emerged has largely controlled its outbreak, cutting a stark contrast to many parts of the world still afflicted by rolling lockdowns and high case numbers.

On Sunday, six cases were confirmed in Qingdao -- a northeastern city of 9.4 million - originating in a hospital, the Qingdao municipal health commission said in a statement on Monday.

Five districts will be tested "within three days" and the whole city "within five days", the statement said. However, officials did not give a precise figure on how many people would be tested.

China has extensive, quick test capa-

bilities and the health commission said over 140,000 employees of "medical institutions, newly admitted patients and personnel" have already been tested in Qingdao since the cases were confirmed.

In June, large areas of the capital Beijing were subject to mass tests after the city of more than 20 million detected virus cases linked to a food market.

China has bounced back since the virus emerged late last year and forced widespread lockdowns that hammered the world's second-largest economy

Hundreds of millions travelled across China for the 'Golden Week' holiday last week as the country edges back to growth, while rapid tests and swift lockdowns have tamped down secondary waves of the virus. - AFP

## 18 DEAD in **Thailand bus**train collision

THAILAND: At least 18 people were killed and more than 40 injured in Thailand Sunday when a freight train crashed into a bus taking passengers to a religious ceremony, officials said.

The morning collision, around 50 kilometres (30 miles) east of the capital, Bangkok, toppled the bus and sheared off part of its roof.

More than 40 passengers were rushed to nearby medical facilities for treatment, said Provincial Hospital Director Sombat Chutimanukul.

Footage shared by a government department showed the bus edging from the road onto train tracks before a blue cargo train slammed into its side.

There were some 60 passengers in the chartered bus travelling from Samut Prakan province on a pilgrimage to a temple in Chachoengsao, said Province Governor Maitree Tritilanond.- AFP

Sri Lanka has a trade deficit of US\$ 3.1 billion in favour of India however only 5% of India's exports to Sri Lanka only comes on a concessional basis due to the Free Trade Agreement. Sri Lankan exports to India under the FTA accounted for US\$ 490 million while total exports to India accounted for US\$ 763 million. Coomaraswamy noted non-tariff barriers to Sri Lankan exporters.

For the Indo-Lanka Free Trade Agreement to be successful he noted that there should be reciprocity and at the same time understanding the need for differential treatment. The positive list, the negative list, and the transition periods for liberalisation in the agreement showed that India understood this principle. Coomaraswamy said if 'make in India' succeeds then it will be an opportunity for Sri Lankan firms to plug into these supply chains. India and Maldives have increased relations following the recent election in the Maldives. Grid connectivity between the two countries is a possibility. 

## Seaweed yoghurt by undergraduate student

The company has invested substantially in terms of time and money to meet the extremely stringent global standards specified for RSPO certification.'

"Besides Watawala Plantations, AEN Palm Oil Processing, a joint venture between three plantation companies has also received RSPO certification for its factory and we are aware that many other members of the POIA are in the process of obtaining internationally-recognised sustainability certifications, despite the adversity they are facing," Dr Fernando said.

RSPO certification is an assurance to the customer that the standard of palm oil production is sustainable. Sustainable palm oil production is comprised of legal, economically viable, environmentally appropriate and socially beneficial management and operations. At the heart of RSPO certification is the RSPO Principles and Criteria for Sustainable Palm Oil Production, the global guidelines for producing palm oil sustainably.

The POIA encourages all member companies to adopt Good Agriculture Practices (GAP) because the Association's objectives go beyond campaigning for the expansion of sustainable oil palm cultivation in Sri Lanka, Dr Fernando added. "Some of Sri Lanka's most respected business conglomerates have invested in the palm oil industry and are committed to building an environmentally-responsible and socially sustainable business that will enable Sri Lanka to reduce the import of edible oils and the huge outflow of foreign exchange," he said. The Palm Oil Industry

Association represents cultivators as well as refiners, processors, manufacturers, marketers and sellers of palm oil and other products of the oil palm, who have

cumulatively invested Rs 26 billion in the industry. Sri Lanka has less than 11,000 hectares under oil palm just over 1 per cent of the extents under tea, rubber and coconut - and plantation companies had been mandated by a government decision in 2014, to increase the total area under oil palm to 20,000 hectares under strictly-enforced guidelines that ensure the industry is environmentally non-invasive.

The Association has repeatedly stressed that the campaign against oil palm cultivation in Sri Lanka is based on untruths, halftruths, misrepresentation and panic-mongering and that the country's oil palm cultivation is a case study for guilt-free palm oil because lessons learnt from the mistakes of other countries have been implemented in a slow and measured expansion of oil palm cultivation over the past 50 years, with no deforestation, no habitat loss and no adverse environmental or climate impacts scientifically attributable to the crop.

# Saman the athlete turned ruggerite

It is very rare to find a person who had engaged in several sporting disciplines during his school career later turn out to be a quality sportsman representing the country at International level. Pushpalal Saman Kothalawala was one of them who had an enthralling career at school, Club and later ended up as a National player in Rugby.

Saman better known as 'Kottha' in the rugby circles hails from an educated family his father late K.S.Kothalawala was a retired Inspector of Police and mother was Evegin Weeratunge.

He has four brothers and a sister His elder brother Shanthilal Sarath played Rugby for Ananda College and is a retired Manager of Sri Lanka Insurance Corporation. His elder sister Nirmali Shirani is a retired English teacher at Devi Balika Vidyalaya. His younger brother Hemal was a product of Lum-bini College and now serves as a Veterinary Surgeon at VRI in Kandy.

The other two brothers are Mahen and Lakmal who studied at Royal College, Colombo.

Mahen works as Consultant Microbiologist at General Hospital, Kandy while Lakmal is living in USA.

Saman started his school career with St. Aloysius College, Ratnapura until grade five. Due to his father's employment with the Police they had to move to Colombo and joined Lumbini College from grade six for his higher studies. At the inception he took part in athletics at the 100, 200 and 400 metres and high jump events, which earned him several medals at Zonal level. While being there he was also an active member of the College Volleyball team which went on to snatch several awards at district level while being the Vice-Captain of the team. He also had a liking for basketball and represented Ratnams Sports Club at under-14 level, when they were

living at Police quarters at Bambalapitiva. While he was schooling, he used to come and play Rugby in his leisure time with likes of Hisham Abdeen, Hafeel Marso, Palitha Siriwardana, Nizam Jamaldeen at Police Ground. Later his family had to move to

Narahenpita and he started playing at Shalika ground with K.D. Nanayakkara, Aruna Uduwelagedera. He was a rugby fanatic from

his younger days and used to watch all Rugby matches especially involving Police and Havelock's, which were his favourite teams. Charles Wijewardena, Tuan Hajireen, Chandrapalan were his favourite players from Police. Finally, he was chosen to play for the Lumbini College first XV Rugby team from 1977 to 1981.

Soon after his school career he was offered a job with the Sri Lanka Navy to play rugby while working. He was posted as Class I Electrician (sailor) during his tenure of five years from 1981 to 1986. He played for the Navy 'A' division rugby team from 1982 to 1985.

He was associated with some fine players like H.K. Sisira, Samaraweera, Parakrama Nuwan Tennakoon, Bin Galiph, L.P. Perera, P.W. Perera, T.M.S. Sherifdeen, Nawaratne, Jeffrey Jamalon, Sunimal Weerabahu, W. M. Mangalasena, P. Balendran and many more who were coached by Bandula Dahanayake who was a key figure behind his success.

The Navy team withdrew from the Rugby tournaments due to the uncertain situation in the country as all their players were called back to their bases, where he also had to move to his ship in Kachathivu. Later he got special approval to play rugby for clubs in 1984/1985 season. Lt. Commander Suraj Munasinghe the

Rugby Chairman and Lt. Commander Shanthi Bahar, Commodore Mathews had a liking for him and encouraged him to continue his career in rugby.

He was a close follower of Havies rugby especially with the two legends Angelo Wickramaratne and Michael Jayasekera, who were his favourite players.

Subsequently in 1984 he joined the Park Club and made his debut when they went to win the Presidents Cup. Next year he played in the sevens team for them which went to bag the runners-up championship. Coach Quentin Israel and Captain M.P.F. Sallay have been his source of encouragement at Havies.

Since he was in the coastal belt based in ships, Havelock's team offered him a plan to continue his physical fitness in the ship and to join the final session of the matches. This plan was quite successful and continued his rugby career.

Then he joined the Sri Lanka Police as Sub Inspector and played for six years from 1986 to1992, where they won the League Championship on five occasions. At Police Anton Ben-

# Nadal wins 13th French Open, record-equalling 20th Grand Slam

**PARIS, SUNDAY:** Rafael Nadal demolished Novak Djokovic 6-0, 6-2, 7-5 to win his 13th French Open on Sunday and equal the all-time record of 20 Grand Slam titles held by Roger Federer who hailed the victory as "one of sport's greatest achievements".

For world number one Djokovic, the defeat ended his hopes of an 18th Slam and of becoming the first man since Rod Laver in 1969 to win all four majors twice.

Nadal, 34, claimed his 100th match win at Roland Garros against just two defeats since his 2005 debut.

The Spaniard, the oldest champion in Paris since Andres Gimeno in 1972, claimed the title without dropping a set.

He finished the one-sided affair with just 14 unforced errors to his opponent's 52.

"Congrats to Novak for another great tourna-ment. Sorry for today. We've played plenty of times

together - one day one wins, another the other," said Nadal.

"After all the things I have been through in my career with injuries, I could not have done it without my family.

Nadal said he wasn't even thinking about matching Federer's record.

"It's been a very tough year. Winning here means everything to me so it's not about equalling Roger on 20, for me today it's just a Roland Garros victory," said Nadal who had skipped the US Open due to the global health crisis and was playing just his second tournament since February.

"Roland Garros means everything to me. I spent most of the most important moments of my tennis career here.

"Just playing here is a true inspiration. The love story I have with this court and city is unbelievable." For Djokovic, it was just his second loss of 2020 following his default at the US Open.

'Today, Rafa showed why you are the king of clay. I was out-played by a better player."

Nadal also used his victory speech to thank organisers for staging the tournament, pushed back from its traditional May-June slot due to the coronavirus pandemic.

"I want to send a message to everyone around the world. We are facing one of the worst moments that we remember in this world, fighting against this virus. Keep going, stay positive.

"We will get through this and we will beat the virus soon.'

Federer was quick to hail Nadal, his long-time rival and close friend.

"It is a true honour for me to congratulate Rafa on his 20th Grand Slam victory," said the Swiss star who missed the tournament to recover from knee surgery.

"It is especially amazing that he has won Roland Garros an incredible 13 times which is one of the greatest achievements in sport. I hope the 20 is just another step on the continuing journey for both of us." AFP

## De Kock, Yadav help Mumbai reclaim top IPL spot

# LA Lakers crush Miami Heat to capture 17th NBA title

ORLANDO, MONDAY: A Los Angeles Lakers team led by superstar LeBron James dominated the Miami Heat 106-93 on Sunday to win a recordequalling 17th NBA championship but their first in a decade.

James added another chapter to an epic career, fueling the Lakers with a triple-double of 28 points, 14 rebounds and 10 assists and capturing his fourth NBA title with a third different team, as well as earning NBA Finals Most Valuable Player honors for a fourth time.

"It means a lot to represent this franchise," James said, recalling that he told team owner Jeanie Buss when he arrived in Los Angeles in 2018, "I wanted to put this franchise back where it belongs.

"For me to be a part of such a historical franchise is an unbelievable feeling.

Anthony Davis, playing in his first championship series after years of frustration in New Orleans, added 19 points and 15 rebounds as the Lakers completed a four-games-to-two triumph in the best-of-seven championship series more than eight months after the death in a helicopter crash of team leg-

Bam Adebayo led the Heat with 25 points and 10 rebounds and Butler and Jae Crowder added 12 apiece, but Miami simply had no answer for the knockout blow Los Angeles delivered in the first half.

The Montreal Protocol has defined that the average amount of HFC refrigerants to be imported during the period from 2020 to 2022 will be considered as the baseline of HFC quota entitled to Sri Lanka and that Sri Lanka will not be able to import HFC based refrigerants exceeding the determined quota from the year 2024. However, no control mechanism is applicable for the quantity of HFC based refrigerants being imported from 2020 to 2023 and no recommendations of the National Ozone Unit (NOU) are required to obtain licenses for the importation of those refrigerants during the said period. From the year 2024, arrangements will be made by Department of Import and Export Control to issue licences for the importers based on the amount of HFC refrigerants to be imported by each importer during the period from 2020 to 2022 (baseline) with the recommendation of National Ozone Unit at the Ministry of Environment. The new Harmonize Codes (HS Codes) for HFC refrigerants have already been declared by an extraordinary gazette notification numbered 2182/10 and dated 30.06.2020 for the information of the refrigerant importers.

According to this methodology, this Ministry has planned to phase down the use of HFC based refrigerants gradually and systematically during the period from 2024 to 2045. This Ministry will also take appropriate actions in future to introduce alternative refrigerants to replace HFC based refrigerants.
