Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileka, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that, the lands described below is needed for a public purpose and will be acquired under the provisions of that Act.

Twenty (20) allotments of land depicted in following names and extents, in Advance Tracing No. GA/GFG/2017/520 of 13.07.2017 prepared by the Surveyor General, situated in the village called Madawalamulla South, Dangedara, in the Divisional Secretary's Division of Galle Four Gravets in Galle District of Southern Province and bounded as follows.

1. Lot 'A' – Dangahaowita - Extent : 0.0974 Hectare

6. Lot 'F' – Extent : 0.0031 Hectare

North: Road and Dangahaowita claimed by K.B. Saranapala; East: Dangahaowita claimed by K.B. Saranapala and Canal; South: Canal; West: Road.

7. Lot 'G' – Kurunduwatte Pas Havul Owita – Extent : 0.0013 Hectare

North: Canal; East: Kurunduwatte Pas Havul Owita claimed by Badrani Perera and Wilbert Deegala; South: Kurunduwatte Pas Havul Owita claimed by Wilbert Deegala; West: Canal.



8. Lot 'H' - Extent : 0.0019 Hectare

North: Road; East: Road, Lot F, Canal and Kurunduwatte Pas Havul Owita of which the claimant could not be traced; South: Road; West: Koswattadoowa claimed by Wasantha Jinadasa.

9. Lot 'J' - Koswattadoowa - Extent : 0.0098 Hectare

North: Koswattadoowa claimed by U.K.J. Company; East: Road and Lot H; South: Canal; West: Lot K.

10. Lot 'K' - Koswattadoowa - Extent : 0.0047 Hectare

North: Koswattadoowa of which the claimant could not be traced and Lot J; East: Lot J; South: Canal; West: Lot M and Koswattadoowa of which the claimant could not be traced.

11. Lot 'M' - Koswattadoowa - Extent : 0.0024 Hectare

North: Koswattadoowa claimed by A.R.L. Shamel Somasiri; East: Lot K and canal; South: Canal; West: Lot P and Donald Janse road.

12. Lot 'N' - Koswattadoowa - Extent : 0.0020 Hectare

North: Canal; East: Canal and Koswattadoowa claimed by S.L. Siripala; South: Koswattadoowa claimed by S. L. Siripala; West: Donald Janse Road and Lot P.

13. Lot 'P' - Extent : 0.0026 Hectare

North: Road, Koswattadoowa claimed by R. L. Shamel Somasiri, Lot M, Canal and Lot N; East: Lot M, Canal, Lot N, Koswattadoowa claimed by S.L. Siripala and road; South: Road, Lot Q, Canal and Leads International school ; West: Road.

14. Lot 'Q' - Extent : 0.256 Hectare

North: Canal, Lot P and road; East: Road; South: Road and Canal; West: Canal.

15. Lot 'R' - Extent : 0.0086 Hectare

North: Canal; East: Canal and road; South: Road and land belonging to Mahinda Vidyalaya; West: Canal.

16. Lot 'S' - Extent : 0.0028 Hectare

North: Canal; East: Canal and the land belonging to Mahinda Vidyalaya; South: Land belonging to Mahinda Vidyalaya; West: Land belonging to Mahinda Vidyalaya.

17. Lot 'T' - Extent : 0.0002 Hectare

North: Canal; East: Canal and road ; South: Road and canal; West: Road and Canal.

18. Lot 'U' - Ketakalagahawatta - Extent : 0.0008 Hectare

North: Lot V and Canal; East: Canal; South: Canal and Ketakalagahawatta claimed by Salgamuwa Hewage Hiran Chanimda, Maradana Gamage Kamani Samanlatha; West: Ketakalagahawatta claimed by Salgamuwa Hewage Hiran Chaminda, Maradana Gamage Kamani Samanlatha and Lot V.

19. Lot 'V' - Name of the land Can not be found - Extent : 0.0002 Hectare

North: Canal; East: Canal; South: Canal and Lot U; West: Land of which the claimant could not be traced.

20. Lot 'W' - Name of the land Can not be found - Extent : 0.0002 Hectare

North: Canal; East: Canal; South: Land of which the claimant could not be traced; West: Land of which the claimant could not be traced.
