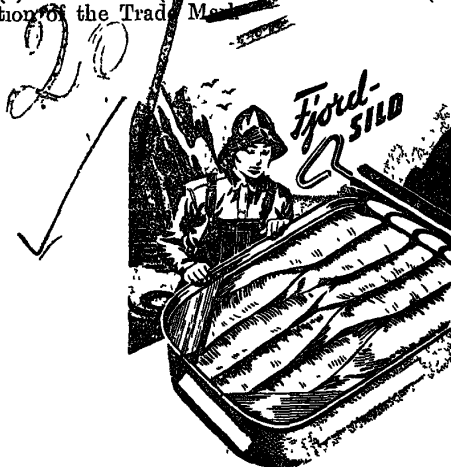

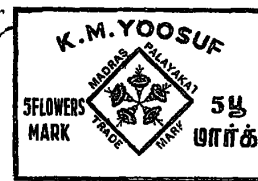

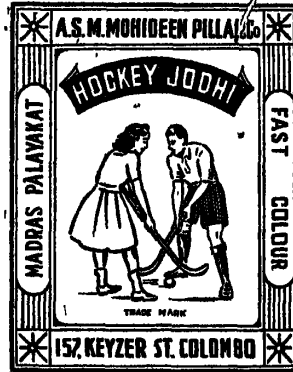

"Improvements relating to the sterilisation of liquid Foodstuffs and Beverages".

*Abstract.*—The nature of the invention which relates to sterilisation of liquid foodstuffs and beverages by heat treatment can be ascertained from claims 1 and 2 which are as follows:—

1. A method of sterilising liquid foodstuffs or beverages by heat treatment, in which the liquid is passed continuously and under pressure through a passage of a heating apparatus where it is heated for a brief time to above 100°C. by introducing a gaseous or vaporous heat carrier into it at the inner surface of the passage, and is thereafter cooled by a sudden lowering of the pressure the passage having an approximately circular free cross-section.

2. A method as claimed in Claim 1 particularly for milk and liquids containing milk, in which the duration of the heat treatment up to the lowering of the pressure is less than one second.

A device for homogenizing liquids comprising an impact system in the form of a plurality of fixed plates each having an aperture therein, these plates being arranged one behind the other with spaces between them and with their apertures so disposed that the liquid to be treated can be passed through these apertures in the form of a jet but so that the edge of each aperture intercepts a part of the jet, whereby partial amounts of the liquid are separated from the jet at each plate and are discharged laterally through the spaces between the plates.
