### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Nineteen (19) allotments of land depicted in Advance Tracing No. GA/GFG/2017/517 and dated 27.07.2017, prepared by the Surveyor-General, situated in the Villages called Attiligoda South and Milidduwa in the Divisional Secretary's Division of Galle Four Gravets in Galle District in Southern Province and bounded as follows:

**01. Lot A – Name of land cannot be found – Extent: About 0.0001 Hectare**

North: Land claimed by P.V.Gunasekara and some others; East: Land claimed by F.W. Gunasekara and Lot B; South: Heen Ela I; West: Heen Ela I and land claimed by M.L. Gayan.

**02. Lot B – Name of land cannot be found – Extent: About 0.0001 Hectare**

**04. Lot D – Endawala Owita – Extent: About 0.0003 Hectare**

North: Endawala Owita claimed by Sairil Kodikara and some others; East: Endawala Owita claimed by Sairil Kodikara and some others and Heena Ela I; South: Heen Ela I; West: Heen Ela I and Endawala Owita claimed by Sairil Kodikara and some others.

**05. Lot E – Endawala Owita Elyes Digapotha Kumbura – Extent: About 0.0001 Hectare**

North and East: Endawala Owita *alias* Digapotha Kumbura claimed by D.H. Ariyasena; South and West: Heen Ela I.

**06. Lot F – Digapotha Liyadda – Extent: 0.0001 Hectare**

North: Endawala Owita *alias* Digapotha Kumbura claimed by S.H. Weerathunga; East: Endawala Owita *alias* Digapotha Kumbura claimed by S.H. Weerathunga and Endawala Owita *alias* Digapotha Kumbura of which the claimant could not be found; South and West: Heen Ela I.

**07. Lot G – Name of land cannot be found – Extent: 0.0001 Hectare**

North and East: Land of which the claimant cannot found; South and West: Heen Ela I.

**08. Lot H – Endawala Owita Elyes Digapotha Kumbura – Extent: About 0.0007 Hectare**

North: Endawala Owita *alias* Digapotha Kumbura claimed by Violet; East: Endawala Owita *alias* Digapotha Kumbura claimed by K.G. Violet and Heen Ela I; South and West: Heen Ela I.

**09. Lot J – Attikkagaha Watta – Extent: About 0.0001 Hectare**

North and East: Heen Ela I; South: Land claimed by U.K.G.Chandane; West: land of which the claimant can not be found and lot K.



**10. Lot K - Name of the land cannot be found - Extent: 0.0003 Hectare**

North: Heen Ela I; East: Heen Ela I and Lot J; South and West: land of which the claimant can not be found.

**11. Lot M - Attikkagaha Watta Elyes Endawala Owita - Extent: 0.0002 Hectare**

North and East: Heen Ela I; South: Attikka watta, *alias* Endawala Owita of which the claimant can not be found ;West: Attikka watta, *alias* Endawala of which the claimant can not be found.

**12. Lot N - Attikkagaha Watta Elyes Endawala Owita - Extent: 0.0002 Hectare**

North and East: Heen Ela I; South: Attikkagaha Watta, *alias* Endawala claimed by Wilmon Kodagoda ;West: Attikkagaha Watta, *alias* Endawala Owita claimed by Wilmon Kodagoda and Lot P.

**13. Lot P - Name of land cannot be found - Extent: About 0.0013 Hectare**

North and East: Heen Ela I; South: Heena Ela I and Lot N ;West: Land of which the claimant can not be found.

**14. Lot Q - Name of land cannot be found - Extent: About 0.0006 Hectare**

North and East: Heen Ela I; South: Land of which the claimant can not be found and land claimed by M.K.Sudath Rasanga ;West: Land claimed by M.K. Sudath Rasanga.

**15. Lot R - Name of land can not be found -Extent: About 0.0002 Hectare**

North and East: Heen Ela I; South: Land claimed by C.Weerasinghe; West: Lot N and Heen Ela I.

**16. Lot S - Name of land cannot be found - Extent: About 0.0001 Hectare**

North and East: Heen Ela I; South: Land claimed by C.Weerasinghe; West: Land claimed by C.Weerasinghe and Heen Ela I.

**17. Lot T - - Name of land cannot be found - Extent: About 0.0002 Hectare**

North: Heen Ela I;East: Heen Ela I and Land claimed by C. Weerasinghe; South: Land claimed by C.Weerasinghe and M.P. Wanasinghe; West: Land claimed by M.P. Wanasinghe and Lot U.

**18. Lot U - - Name of land cannot be found - Extent: About 0.0004 Hectare**

North: Heen Ela I;East: Heen Ela I and Lot T; South: Land claimed by C.Weerasinghe and M.P. Wanasinghe; West: Land claimed by K.P. Sarath and Lot V.

**19. Lot V - - Name of land cannot be found - Extent: About 0.0002 Hectare**

North: Heen Ela I;East: Lot U and land claimed by M.P. Wanasinghe; South: Land claimed by K.P. Sarath; West: Land claimed by K.P. Sarath and Heen Ela I.
