





Abstract.—This invention relates to machines for

sheeting the coagulum of rubber.

This invention is a machine comprised of a single large roller and a plurality of smaller rollers spaced at angular intervals about the periphery of the large roller. The centres of the smaller rollers all lie on an arc which subtends at the centre of the larger roller an angle of less than 90° and radial lines passing through the centre of the large roller and through the centres of the first and last smaller rollers respectively lie at angles of not more than 45° to the vertical.
